They had lived and taught on the Texas Plains for a number of years, in Sanderson several years and then in the oil patch at Kermit, Texas. After nineteen years in Kermit, they retired to their home in San Angelo. Mrs. Lovell had previously taught in San Angelo 1956-57 and 1957-58, while residing with her mother and sister, Nina, who were both ill and passed away during that

Her husband passed away in 1975 and Mrs. Lovell then moved to Irving, Texas, where she now resides.



Modern health fraud includes the promotion of laetrile and the billion dollar-a-year business of arthritis quackery.

Mistreatment of the overweight with scientifically unsound diets, drugs and devices is another common practice in heal-

th frauds. Mind Those Drugs! - Many people know that prescription drugs cause side effects or adverse reactions but probably expect them to be physical in nature. This is not necessarily the case. Reported psychological side effects of drugs prescribed for physical problems range from delusion to suicidal depression. Consumers should be aware of this possibility, since their physicians often are not.

Senator Lloyd Bentsen cast one of the two deciding votes to give away the Panama Canal, April 18, 1978.

He voted not to allow the President to take appropriate action to ensure that the Canal remained secure and open, July 26, 1979.

Prior to the final vote, the Senate considered a number of important amendments intended to protect the interests of our country.

One would have required congressional approval before any U.S.-owned Panama Canal property could be transferred to Panama.

Two others would have (1) withheld payments to Panama from Canal revenues unless the U.S. had first been reimbursed for its costs of implementing the 1978 treaties, and (2) withheld such payments if either the President or Congress determined that Panama was directly or indirectly interfering in the affairs of another nation.

Yet another amendment would have authorized the President to take appropriate action to assure that the Canal remained secure and open, even if it meant overriding actions of the Panama Canal Commission. Senator Bentsen voted against each of these protective amend-

On September 25, 1979 the Senate had a last chance to vote against the Canal giveaway, but Senator Lloyd Bentsen of Texas voted to give it away. If he had opposed the giveaway the U.S. might still own our Canal and enjoy the military (and other) advantages it affords. If it ever closes, the trip around South America must be about 8000 miles further than through the Canal.

Did Senator Bentsen represent you when he voted to give our Panama Canal into the hands of a Communist dictator?




