Pharmacy Feasibility Study Tabled

The Muleshoe Area Hospital District tabled action on a feasibility study to determine if the addition of a pharmacy to the rural health clinic would increase the likelihood of the clinic expansion's success during its July 26 regular meeting.

According to CEO David Burke, a recent study regarding the expansion suggested that it wouldn't pay for itself.

However, Burke also said the study didn't take into consideration the possible increase in patient visits due to the increased number of physicians the space would allow.

"Now we need to look at whether it would benefit the community to have a pharmacy placed in the rural health clinic"

Under the current conditions, Burke said the report indicated the hospital would be working with \$50,000 in net income — the annual cost of bond payments for the facility expansion.

"Now we need to look at whether it would benefit the community to have a pharmacy placed in the rural health clinic," Burke said, estimating the cost of the new study at up to \$25,000 — an

amount and expenditure board member Allen Smyer seemed to have difficulty accepting.

The most recent study was performed at a cost of \$2,500.

Burke also pointed out that if the hospital was going to attempt a passage of a bond issue, or issuing certificates of obligation, a feasibility study was required.

Smyer also pointed out that a pharmacy located in the hospital hadn't worked out, and expressed concerns about a new pharmacy cutting into the business of Muleshoe's existing pharmacies.

"That's business," board member Herb Ramage replied.

Balderrama Drops Out

Democratic Bailey County Sheriff candidate Joe Balderrama officially withdrew his candidacy Monday, according to County Clerk Paula Benton.

As a result, the only candidate to be listed for the position on the November ballot will be incumbent Sheriff Richard Wills.

The deadline for filing for a place as a write-in candidate is Aug. 20, which is also the last day to file for a position on the ballot.

Although no reason was given for the decision to withdraw, it should be noted that in the May 29 Bailey

County Democratic Primary, Balderrama garnered a total of 19 votes, compared to Wills' total of 557 in the county's Republican primary.

Republican candidate Terry Snell received a total of 164 votes in the May 29 Republican primary.

In regards to Tuesday's run off election, due to the *Muleshoe Journal's* press deadline the results from the local elections will be published in the Aug. 9 issue of the *Journal*.

However, the election results were posted on www.muleshojournal.com following their release on Tuesday, July 31.

New Assistant Superintendent Honored

On the job for just a few weeks, and the new assistant superintendent for the Muleshoe Independent School District is already being honored... only not by the State of Texas or for work performed in the Lone Star State.

At the meeting of the MISD Board of Trustees

on July 24 it was noted that Dr. RL Richards, the district's new assistant superintendent, needed to leave prior to the end of the meeting because he had to



drive to Albuquerque, N.M., where he was

being honored as the Administrator of the Year.

This is Richards' second time to receive the award.

Dr. Richards retired after serving for 22 years as superintendent of the Texico School District.

Among the issues addressed at the July 24 meeting, the school

board approved a change to its policy concerning the issue of how to care for students with food allergies who are at risk for anaphylaxis.

"It's not something that we are not doing," Superintendent Dr. Gene Sheets said, "We're just putting a formal plan in place."

Dr. Sheets explained that the school district

has some students with serious food allergies, and noted that Dr. Richards would be working with the district's nurses to ensure the school responds appropriately should an emergency situation arise.

Disgusted With The NCAA

For the first time in years, I can honestly say, "I'm tired of college football."

And to admit this even before the Sept. 1 kick off against El Paso says a lot in itself.

Obviously, by the date and opposing team, the college team that I follow is neither the Raiders nor the Longhorns, but that doesn't have anything to do with the mental exhaustion I've experienced this past week.

Instead, my exhaustion stems from the fiasco at Penn State, its relentless media coverage, and most recently its punishment by the NCAA.

Before I continue, let me note that the events leading up to the problems at Penn State were truly horrible. It is also unfortunate that the victims of Jerry Sandusky have had to deal with the tragic events of their childhood, and will no doubt continue to do so into adulthood.

From what I understand, there were a number of mistakes made in the handling of the situations by school officials, including those listed as witnesses to certain events.

The idea that a witness to such events is absolved of any further responsibilities by reporting his observations, or even suspicions, to other officials and not to law enforcement authorities is asinine.

But the rancor I felt this past week wasn't about the justice due the young victims of Sandusky, but rather the lack of justice for



the students in the Penn State football program, both past and present, by the NCAA.

I have never been a fan of "rewriting history," whether it is used to support changes to the US Constitution and its intent, or merely the expungement of criminal histories. And to carry that into the sports arena borders upon the absurd.

As punishment for the reported actions by the late Penn State football Coach Joe Paterno, the students of Penn State received a massive fine and the "removal" of more than 100 game victories from the stat books. Hence the charge of rewriting history.

While it is my personal belief that the \$60 million fine assessed by the NCAA is over-the-top, it isn't any more ridiculous than the assurance from Penn State officials that, as I recall, non-tax payer dollars would be used to meet the penalty and thus the impact on the university's student population would be minimized.

The truth is it's a "rob Peter to pay Paul" situation that can't help but reach into academic circles and funding.

But the most annoying aspect of the NCAA penalties is the idea that while it was wrong for Sandusky to violate his young victims, it is okay for the NCAA to

violate the students in the football program in the manner it did.

While some may argue there is a difference between the physical violations of Sandusky victims, we agree... up to a point.

But in both cases, the victims of the actions can't and shouldn't be held responsible for

what happened.

While I disagree with the idea of removing victories that weren't actually game-related from Coach Paterno's total, at least he had some voice in the issue at hand.

At what point did the students in the program participate in the actions of the Penn State officials?

Through its actions, the NCAA has primarily punished not the leadership at Penn State, but rather its student athletes, and that's just not right.

Hospital District Board Tables Action On New Survey

Board member Scott Brown noted that it wasn't the first time the board had talked about placing a pharmacy in an expanded health clinic, the last time being when only one privately-owned pharmacy was in operation.

The board is to revisit the issue at its next meeting with additional information about the projected cost.

In his administrative report, Burke talked about the hospital district's financial condition, noting that the district's cash balance was \$518,429.92, of which the majority — \$442,036.21 is the Muleshoe Area Medical Center's.

He also pointed out that the hospital's net accounts receivable had decreased by slightly more than \$43,500, going from May's totals to June's. While the nursing home's revenue during the same period showed a drop of almost \$52,500.

At the same time, Burke said, the hospital's year-to-date revenue was up by \$470,595.87, but its expenses for the same period are also up by \$421,550.61.

Over at Park View, the numbers are down by \$451,869.87 year-to-date for revenue, but also down \$166,992.44 for YTD expenses.

"We have to come up with a solution for the revenue," Burke said, but we're working on it."

"We want both entities to succeed," Burke added. "Nobody at the table doesn't want both entities to succeed."

In other business, the MAHD board:

- Discussed a recent Medicare survey at the hospital in which it was noted the

hospital was "tagged" for dirty, stained or cracked ceiling tiles, and chipped paint at some locations within the hospital.

Burke also said the hospital was tagged for the ER physicians' response time and an issue in which non-licensed personnel had access to a drug cart key.

According to Burke a correction plan is already in place.

- Received a report from Laughton concerning Park View in which it was noted the center is at its highest census in years, adding that the increased skilled nursing training the staff has received has helped increase the census.

"There are a lot of good things that are happening," she noted.

"The building is getting better, and we're doing better," Laughton said, adding that it would take a while to make up the revenue."

Last week, some of the residents were taken to Leal's for lunch, and a few weeks earlier some of the residents had the opportunity to go fishing at Lake Muleshoe.

- Discussed the hospital's bad debt.

"Is there a light at the end of the tunnel on the bad debt," Smyer asked.

Included in the board's written report was a report concerning the hospital's bad debt report for June at \$85,876, of which \$71,702 was from private pay, \$10,598 was from Medicare, and \$3,576 was from Medicaid.

"We're a lot better off than we were four years ago," Burke said.

- Received a detailed report concerning the hospital's participation in the 11-15 waiver.

- Approved hospital privileges to physicians Kevin Funk, MD, Carlos Ricaldi, MD, and Fidel Ogeda, MD, who would be working in the hospital's emergency room on a rotation

including other local physicians after Dr. Grant Nitzel leaves.

- Approved a contract with CEO David Burke after discussion of it and the hospital's QA report. Both items

were also listed on last month's agenda, however, no action was taken because the complete board wasn't in attendance.

- Declared materials from the storm-

damaged car port at Park View Nursing Care Center as salvaged prior to taking bids for its disposal.

- Approved the minutes from the board's June 28 minutes.

She didn't actually give the sermon a title, but that's what the lesson was. For most of the rest of my wife's childhood, two words were all her mother had to say to silence completely any whiny utterance: "Now, Juana..."

More Flexibility For CRP Grazing, Haying Offered

Bailey County USDA Farm Service Agency (FSA) Executive Director Kim Hanlin announced that 229 Texas counties, including Bailey County, are eligible for Conservation Reserve Program (CRP) emergency haying and grazing because of the new provisions announced by Secretary

Vilsack on July 23, 2012. "Previously, only lands classified as 'D2 - under severe drought' according to the U.S. Drought Monitor were eligible for CRP emergency haying and grazing," said Hanlin. "Now lands classified as 'D0 - abnormally dry' will be eligible for CRP emergency haying and

grazing," he said. In addition to the 25 percent CRP payment reduction being reduced to 10 percent for all 2012 emergency haying and grazing authorizations, participants may now sell the harvested hay or lease grazing privileges for profit under the new emergency provisions. However, subleasing of

the grazing privileges will not be permitted. Texas CRP participants who were previously approved for managed haying or grazing may elect to switch to emergency use by contacting the Bailey County FSA office to request approval. Based on a decision

Continued from A7 made by the Texas FSA State Committee, CRP emergency haying and grazing approval will only be available for those CRP lands that were not utilized for haying or grazing during the previous 12 months. Eligible CRP land can be used for emergency haying until Aug. 31, or emergency grazing until Sept. 30.

The eligible CRP acreage is limited to qualified acres located within the approved county. Eligible producers who are interested in haying or grazing CRP under this






