Property
Dear Editor

Ronny Loyd received a bulk email regarding the sale of the land from Sweetwater. By the time he contacted Sweetwater the City of Sweetwater had sold the land to Bronte. Ronny contacted Bronte about buying or leasing approximately 18 acres of land across the road from his home.

Bronte wanted to fence the land that had been used as a dumping ground. Ronny Loyd said he would provide the labor if Bronte would provide the materials.

The City Secretary contacted Sweetwater as requested by a board member and got a copy of the lease that Sweetwater uses for Oak Creek Lake property. This form was used as a basis for the lease between Bronte and Ronny Loyd.

There was also a verbal agreement between Bronte and Ronny Loyd to demolish and remove five abandoned houses in Bronte at \$6500.00 each. There was not going to be payment to Ronny Loyd, only credit in that amount toward the land lease of approximately 18 acres at Oak Creek. The total amount was

The demolition was not included in the actual land lease because the City of Bronte did not want any liability in case something went wrong.





Oncor's rate filing, based on the system-wide financial results for a 12-month test year ending on December 31, 2016, adjusted for known and measureable changes, supports a net increase in transmission and distribution rates of approximately \$317 million over adjusted test-year revenues, or approximately a 7.5% increase over adjusted test-year revenues of \$4,214.2 million. TCOS revenue was adjusted to include the September 15, 2016 interim update rates at 2016 Option 2 ERCOT 4CP. TCRF revenue was adjusted to equal the March 1, 2017 TCRF revenue requirement reflected on Line 2, Attachment A of Oncor's petition filed and approved in Docket No. 46616. 



His plan was to take the usable lumber from the demolitions and build some rental units on the Oak Creek land. These rental units would be of benefit to visitors to Ft. Chadbourne and the City of Bronte.

The proposed lease for the Oak Creek land approximately 18 acres was presented to Ronny Loyd and the Bronte City Council. The Bronte City Council approved it Ronny Loyd unanimously. accepted and signed the lease.

Later it was determined the length of the lease, 99 years, might not be legal. Ronny Loyd was contacted by the City Secretary and agreed to a shorter term on the same day that he was contacted.

The Bronte City Council voted unanimously to terminate the original lease renegotiate a new lease. After much opposition from visitors at the City Council meeting, they rescinded the motion to renegotiate the lease with Ronny Loyd. The council agreed they owed money to Ronny Loyd for his labor and improvements to the approximate 18 acres. The City of Bronte hired an independent company appraise the improvements to the land. In the mid-1950s, research showed that Americans were spending less on books and more on radios, televisions and musical instruments. Fire Season Tips

By Mark Sides, RLVFD Above average temperatures, large amounts of dry fuels, low relative humidity, and strong winds could again set the stage where a careless spark, a lightning strike, or an arcing power line become the opening number in a Texas Firestorm.

Robert Lee, Bronte and outlying communities are no different from other rural Texas towns where rangeland, pastures, and CRP may be near or immediately adjacent to homes and businesses.

These are a few simple items that will reduce the chances of your home going up in smoke:

1) Routinely clean gutters, especially in the fall. Keep your yard clean of leaves, limbs, and dead grass.

2) Remove tree limbs that extend over the eaves of the roof or within 10-15 feet of the

3) Keep your grass mowed to nonprofit citizens organization a 4" height or less, and if possible, well watered during periods of extreme drought. Prune tree branches at least 10 feet from the

4) Landscape using deciduous their increasing leisure time" to trees and shrubs such as oaks,

agarito, eastern redbud, desert willow, and sages. Avoid junipers, pines, and other evergreens unless they are planted 100 feet or further from the house.

5) Make sure your house number and street number are clearly posted to provide firefighters easy identification.

6) Maintain at least 30 feet of open space between your home and the surrounding brush line or

7) Avoid concentrations of shrubbery or ornamental grasses up against the house.

8) Have garden hoses connected at all times and long enough to reach around the house.

9) Store firewood at least 15 to 30 feet away from the house.

10) Maintain roads and entrances to provide easy access and adequate turnaround space for emergency equipment.

11) Exercise extreme caution and keep a reliable, pressurized water source handy when doing any outdoor burning or welding.

12) Don't allow tall grass and debris to accumulate against your house or under your porch or deck.

These items alone may not guarantee that your home will survive, but they will give your home and responding firefighters a fighting chance.
