Neighborhood Watch is one of the oldest and most well-known crime prevention concepts in North America. The program has roots dating back to the days of colonial settlements, when night watchmen patrolled the streets. In the late 1960s, Neighborhood Watch came to prominence due to an increase in crime rates. The National Sheriffs' Association (NSA) saw a need for a neighborhood crime prevention organization and created the National Neighborhood Watch Program in 1972 to assist citizens and law enforcement.

For the last four decades, the National Sheriffs' Association has helped neighbors band together to create Watch Groups. These groups understand that active participation of community residents is a critical element in neighborhood safety. Watch groups make their communities a better place to live simply by looking out for suspicious activity in their neighborhood and reporting that activity to law enforcement.

In the aftermath of the September 11, 2001 terrorist attacks, the need for strengthening and securing our communities has become more critical and, as a result, Neighborhood Watch groups taken have on greater significance. In addition to serving a crime prevention role, Neighborhood Watch can also be used as the basis for bringing neighborhood residents together to focus on disaster preparedness, emergency terrorism response, and awareness.

The national program changed with the transforming role of the Neighborhood Watch groups. That is why in 2002, the National Sheriffs' Association, with a grant from the Bureau of Justice Assistance, Office of Justice Programs, U.S. Department of Justice launched USAonWatch.org.

In 2013, the funding from the grant came to an end and the



National Sheriffs' Association absorbed USAonWatch into National Neighborhood Watch-A Division of the National Sheriffs' Association. National Neighborhood Watch is a membership based program in which citizens can join and gain access to resources to support, start, or re-vitalize their Neighborhood Watch groups.

Water well owner training set

for August 22

A Texas Well Owner Network training has been scheduled for August 22 in San Angelo.

The Texas Well Owner Network, or TWON, program is for Texas residents who depend on household wells for their water needs, allowing them to learn more about how to improve and protect their community water resources.

The Well Educated training, which is free and open to the public, will be from 8 am until noon at the Tom Green 4-H Center, 3168 N. U.S. Highway 67.

"The TWON program was established to help well owners become familiar with Texas groundwater resources, septic system maintenance, well maintenance and construction, and water quality and treatment," said Dr. Drew Gholson, Texas A&M AgriLife Extension Service program specialist and the program's coordinator, College Station.

Gholson said participants may

bring well-water samples to the training for screening. There is a fee per sample, which is due at the time samples are turned in.

"Water samples will be screened for nitrates, total dissolved solids and bacteria," he said.

Well owners who would like to have their well water sampled can pick up two sample containers from the AgriLife Extension offices in the following counties and addresses:

Gholson said bringing water samples to the training is not required, but those wanting to have water samples analyzed must attend. Attendees can register at http:// twon.tamu.edu/training or by calling 979-845-1461.

The training is one of several being conducted statewide through the Texas Well Owner Network project.

"The core content of this program is the same as other trainings, but the information is tailored to local water quality issues and aquifers," Gholson said.



More than a million private water wells in Texas provide water to citizens in rural areas and increasingly to those living on small acreages at the growing rural-urban interface. Private well owners are independently responsible for monitoring the quality of their wells.

"They are responsible for all aspects of ensuring their drinking water system is safe testing, inspecting, maintaining it," Gholson said. "This training will help private well owners to understand and care for their wells."

Funding for the Texas Well Owner Network is through a Clean Water Act nonpoint source grant provided by the Texas State Soil and Water Conservation Board and the U.S. Environmental Protection Agency. The project is managed by the Texas Water Resources Institute, part of Texas A&M AgriLife Research, AgriLife Extension and the College of Agriculture and Life Sciences at Texas A&M University.

The Board of Directors of the West Coke County Hospital District met in regular session on July 31, 2018. Roger Alexander gave the financial report, which was discussed and approved.

The Board agreed to set the yearly budget workshop for August 7, at 9:30 am.

The Board broke for lunch at 11:35 am and reconvened at 12:20 pm.

Future agenda items were discussed and the next regular Board meeting will be August 28, 2018, at 10 am. There will be a budget hearing on the same day at 9:30 am. The public is invited to attend.

A tax rate of \$0.507751 per \$100 valuation has been proposed for adoption by the governing body of COKE COUNTY. This rate exceeds the lower of the effective or rollback tax rate, and state law requires that two public hearings be held by the governing body before adopting the proposed tax rate.

The governing body of COKE COUNTY proposes to use revenue attributable to the tax rate increase for the purpose of Collection Revenue for previous two years of revenue shortage due to decreased values. To cover unfunded State Mandates and Software increase and maintenance..

The effective tax rate is the total tax rate needed to raise the same amount of property tax revenue for COKE COUNTY from the same properties in both the 2017 tax year and the 2018 tax year.

The rollback tax rate is the highest tax rate that COKE COUNTY may adopt before voters are entitled to petition for an election to limit the rate that may be approved to the rollback rate.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS:



Imposing Your Will by James M. Decker

It's no secret that I'm a fan of University of Alabama head football coach Nick Saban. Perhaps the greatest college football coach of all time, Saban is also a master of leadership and management. Far beyond relying on coaching clichés and worn-out motivational tropes, Saban is a student of psychology and management science who truly understands how to make people better for the good of the individual and the larger organization.

Recently, after one of Alabama's August football practices, Saban told the media something that struck me as particularly meaningful right now. Coaches often talk about their team "imposing their will" on an opponent; that is, the team, not the opponent, dictates the outcome of the game. Every team strives for this, but as with all greatness, it's easier said than done. Nick Saban, seeing the big picture, said this: "If you're going to impose your will on someone else, the first thing you have to do is impose your will on yourself." Whether we use this lingo or not, those of us in community leadership desire something akin to a football team imposing its will on its opponent. We have ideas to improve our community that we believe to be worthwhile. We seek to implement those ideas and influence the community's future, rather than sitting back and letting others dictate the future. But before we can influence the future of our community, we have to impose our will on ourselves. Do we have what it

takes to actually accomplish our goals? Plenty of people have great ideas, but do we have the respect and trust within our community that will allow the community to listen to us? Do we have the confidence in our ideas and the necessary selfdiscipline to persevere when the going gets tough? There's a long line of folks who showed up in a new town, or back in their hometown, and, without any respect or trust, their great ideas promptly fell on deaf ears. Others started a great idea, got some support, and then when they hit a wall, rather than persevering, they got frustrated and gave up.

Moreover, do we have the discipline to actually live out the ideals that we're projecting onto the community? Are we junked-up agitating about properties but somewhat lax about mowing our own high weeds? Are we personally encouraging local business by shopping locally? What if we're campaigning for people to visit our town and move here, but we personally spend most of our weekends out of town?

These are not easy, comfortable questions. All of us, myself included, can likely stand to improve in some form or fashion. But when we DO live out the ideals we have for our community and when we ARE willing to do what it takes to improve our community, that's when we start imposing our will on our own lives and great things will blossom around us.
