

Friona Playa Field Day is April 20th

Presentations will cover restoration and recharge efforts

A new season of presentations and training on the vital nature of the playas of the Southern High Plains gets underway on Tuesday, April 20th as Ogallala Commons hosts a Playa Field Day at Friona, in Parmer County, where playa restoration efforts have been underway.

The field day will cover general information about playa ecosystems as well as the restoration program known as the Texas Playa Conservation Initiative (TxPCI) involving a coalition of groups including Texas Parks and Wildlife Department, Texan by Nature, Ogallala Commons, Natural Resource Conservation Service, U.S. Fish and Wildlife Service, Ducks Unlimited, and the Playa Lakes Joint Venture.

The goal of the Texas Playa Conservation Initiative is to create an abundance of healthy playa wetlands across the Texas Panhandle in order to benefit current and future residents and concerns reliant on the Ogallala Aquifer.

Efforts also support resident and migrating wildlife dependent on playa wetland habitat and the surrounding upland grasslands that encompass fully functioning playas. Work includes educating locals about playas and their link to a healthy ecosystem and to the sustainability and integrity of the Ogallala Aquifer. Currently, TxPCI is completing projects with private landowners to restore, conserve, and protect as many fully functioning playas as possible to help sustain residents and wildlife in the High Plains of Texas.

Presenters in Friona will include officials with the Texas Parks and Wildlife Department, Pheasants Forever, and a contractor transferring conservation plans to work on the ground.



In her own words, she "recognizes the centrality and importance of healthy wetland systems to migratory game bird populations."

Jordan Menge, Range and Wildlife Coordinator, Pheasants Forever, will also comment from the perspective of a biologist.

After a short break, Terry Boedeker, owner of Boedeker, Inc. Memphis, Texas, will talk on work he has done in playas. As the contractor who has carried out the pit reclamation work on all the playa restorations in the Panhandle, he will focus on considerations for landowners before a restoration project.

The city will soon solicit bids to remodel the kitchen at the Friona Community Center. This will be a great improvement. This has been discussed for years and we can finally make it happen. Once completed, this will be something that we can all be proud of and will make future events more enjoyable.

The city will make our last bond payment in February of 2022. The payment totals \$240,000. Once paid, this will be a great accomplishment for the city. The city will be debt free once the payment is made.

The city has received a total of \$216,000 in COVID reimbursement money from the Federal Government. We received part of the money in late 2020 and the remainder in early 2021. We have \$180,000 in our Grant Fund account. The city council has approved to spend the money as follows: (1) Police - \$80,000 to be used for portable radios, in-car cameras/computers, desktop

computers and a new server. (2) EMS - \$50,000 to help build a new parking lot, furniture for 4th bedroom, miscellaneous medical equipment. (3) Administration - \$50,000 to be used for office supplies, public works locator, municipal court, and other administrative expenses.

Chief Jimenez and the police department had 163 calls in March. There were 181 stops, 134 warnings, 47 citations, and 8 arrests (2-possession of marijuana, 1-driving with license suspended, 1-driving while intoxicated, 3-warrants, and 1-assault family violence). The officers drove a total of 4,682 miles patrolling and protecting our city.

Friona Volunteer Fire Department responded to nine emergency calls in March. There were five grass fires, one pickup fire, one trailer fire and two car accidents. On each emergency there were a minimum of five fighters that responded and up to twelve firefighters

responding on two of the emergencies. There were two to four fire trucks taken to each emergency.

Accounts Payable for the month of March totaled \$155,529.24. All bills were paid and the city is in good standing. The bills paid were normal operating expenses. There were no large expenditures.

Emergency Medical Service responded to 27 calls in March. There were sixteen calls for 911, three transfers, six calls ended in a "no transport" and two calls were disregarded.

Friona Public Library was open 22 days in March. There were 430 patron visits and 584 total internet uses. There were 325 items circulated and 129 items added to inventory. I had the opportunity to attend the ribbon cutting ceremony for the new Library Bookshop. Thanks to everyone that helped make this happen. This is a great addition to the Library.

Commissioners extend burn ban

The Parmer County Commissioners Court met in regular session on Monday, April 12, 2021 at 10 a.m. in the County Courtroom of the Parmer County Courthouse in Farwell, Texas. The meeting began with prayer and the Pledge of Allegiance to the American Flag and Texas Flag.

There were no public comments. Minutes from the March 22nd meeting were read and approved. Commissioners approved the payment of the accounts payables as presented by County Treasurer Sharon May. The Treasurer's Payroll report was also approved.

Commissioners discussed

the nomination of Cargill Meat Solutions Corporation for the Texas Enterprise Zone Program pursuant to Chapter 2303 of the Texas Government Code. A vote on the matter was tabled until the next meeting. The Court also discussed

a Tax Abatement Agreement with Lazbuddie Wind Energy II LLC pursuant to Chapter 312 of the Texas Tax Code. A notice will be placed in the newspapers and the agreement will be up for discussion and possible action at the next meeting.

The Tax Abatement Agreement is on the Agenda for 9:00 a.m. and the Cargill nomination matter is set for 9:30 a.m.

In light of the ongoing severe drought conditions, Commissioners extended the county burn ban for another 90 days.

Approval was given to maintain the current COVID-19 Administrative Leave Policy for the 2nd Quarter of 2021.

Seven applications for water lines and PVC pipelines to be installed under County roads were approved. Four were in Precinct 3 and one each for Precincts 1, 2, and 4.

Sheriff Randy Geries reported that he was currently housing 21 inmates in the Parmer County Law Enforcement Center. The Sheriff also reported that Bi-Wize Pharmacy of Friona administered ten Covid-19 vaccinations to inmates who had volunteered to receive the shot.

The next scheduled Commissioners Court meeting is Monday, April 26th.

April 15th is National Titanic Remembrance Day when the Titanic sank into the North Atlantic's icy waters in 1912. We remember the more than 1,500 people who died that day. Known as the "the unsinkable ship," the Titanic hit an iceberg at 11:40 pm on April 14, 1912, on her maiden voyage from England to New York City. Later, in the icy waters of the Atlantic Ocean, on April 15, the Titanic sank. Those who perished did so mainly due to an insufficient number of lifeboats on board the ship.

National Kindergarten Day honors the birthday of the man who started the first Kindergarten. Friedrich Wilhelm August Frobel (April 21, 1782 – June 21, 1852) is credited with starting the very first Kindergarten in Germany in 1837. Frobel was a German teacher and a student of Johann Pestalozzi. Frobel laid a foundation for modern education, recognizing that children learn through play and experience.

The first kindergarten (which means garden for the children) was developed in Blankenburg, Germany, in 1837. The kindergarten fostered Frobel's social experience for children, which would allow them to transition from home to school more smoothly.

In 1856, Watertown, Wisconsin, opened the first kindergarten in the United States. Founded by Margarethe Schurz, this kindergarten was a German-language class, as were many in this region. Kindergarten found its way into private English speaking institutions across the country, but it wasn't until 1873 that it became part of any public school system. 



Grilled Cheese Sandwich

It is hard to pinpoint exactly when the grilled cheese made its appearance. But during the 1920s, the open-faced cheese sandwich gained in popularity. Processed cheese, created by James L. Kraft in the early 1900's, added to the ease of making the famed sandwich. These inexpensive sandwiches were popular

Ingredients

- 2 large jalapeño peppers or a handful of jarred pickled jalapeños 1 1/2 ounces cream cheese
- (room temperature)
- 1 scallion (chopped)
- Black pepper to taste
- 2 slices Colby Jack cheese
- 2 slices sourdough bread
- 1 tablespoon butter

Ingredients

- For the Garlic Spread: 8 tablespoons (4 ounces) un-
- salted butter, softened
- 4 cloves garlic
- 2 tablespoons minced fresh parsley
- For the Sandwiches:
- 8 slices bread
- 8 ounces sliced or grated cheddar, mozzarella, or American cheese
- Kosher salt, to taste
- Freshly ground pepper, to taste

Soup or salad, for serving, optional

during the Great Depression and during World War II by the Allied Armed Forces. Soon a second piece of bread was added to make the sandwich more filling. The classic combination of grilled cheese and tomato soup was created when schools needed to meet the Vitamin C and protein requirements for lunches.

Steps to Make It

Roast fresh jalapeños on a grill or burner of a gas stove top, charring all sides. Place the roasted jalapeños in a paper bag to steam and loosen the skin. After 10 minutes, remove the peppers and, wearing rubber gloves, peel the charred skin from the peppers. (Don't try to do this without gloves.) With gloves still on, cut off the top of each pepper. Slice in half and remove the seeds. Now you can slice the remaining pepper into bite-size pieces.

(Note: you can skip this step if you opt for the jarred jalapeños). In a bowl, mix the cream cheese, green onion, and some black pepper. Butter one side of each of the bread slices. Flip over the slices and on one, generously slather the cream cheese mixture. Top with the jalapeños and cheese. Close over with the other slice of bread, buttered side out. Place the pat of butter in a skillet and heat over medium high heat. Grill both sides until golden brown and cheese is melty.

Garlic Bread Grilled Cheese

Steps to Make It

Gather the ingredients. Combine the softened butter with the garlic and parsley. Spread the softened garlic butter on both sides of two slices of bread. Place a large nonstick skillet or griddle over medium-high heat. Place a buttered slice of bread in the pan and cook for about 2 to 3 minutes, or until nicely browned. Turn to brown the other side. Repeat with another slice of bread. Reduce the heat to low. Mound shredded cheese on one slice of bread or arrange sliced cheese on the bread. Season lightly with salt and

pepper. Place the second slice of bread on the cheese layer. Cook the sandwich for about 4 to 6 minutes, or until the cheese melts. Gently press the sandwich with a spatula as it cooks. Repeat with the remaining bread, garlic butter, and cheese. Slice the sandwiches and serve warm with soup or a salad.

Tips: To serve the sandwiches all at once, place the first batches on a rack and place them in a warm—175 F to 200 F—oven.

Scale the recipe up or down depending on how many sandwiches you need.

Gas prices continue downward

Texas gas prices have fallen 1.4 cents in the past week, averaging \$2.60 per gallon, according to GasBuddy's daily survey of 13,114 stations in Texas. Gas prices in Texas are 0.8 cents per gallon higher than a month ago and stands 97.3 cents per gallon higher than a year ago.

According to GasBuddy price reports, the cheapest station in Texas is priced at \$2.24 while the most expensive is \$3.50 per gallon. The national average price of gasoline has fallen 2.1 cents in the last week, averaging \$2.85 per gallon. The national average is down 0.5 cents per gallon from a month ago and stands \$1.02 per gallon higher than a year ago.

"It has been a fairly tame last few weeks at the pump for most areas after a particularly active February and March when prices were screaming higher," said Patrick De Haan, head of petroleum analysis for GasBuddy. "After surging back then, we've seen the price increases fade, and while we haven't seen much of a decline, prices have been holding near their yearly highs. For now, it feels like the risk of seeing the national average climb to \$3/gal has been delayed by a recent surge in COVID-19 cases both here and abroad, limiting the upside to gasoline demand, but should things begin to improve, especially as we get closer to the start of the summer, we still have potential to see summer gas prices at their highest levels in years. Make no mistake, gas prices this year will be tied to the hip of the Covid situation." gins to turn light brown and starts to get semi crispy. Once they're done remove from heat and set aside. On one heart, smear on 1 tablespoon mascarpone, then add the strawberries. On the next heart, smear on 1 tablespoon of Nutella and place that piece, Nutella side down on top of the strawberries. Add more mascarpone and another layer of strawberries and repeat until the stack is complete. Top with a giant squeeze of whipped cream and a dusting of cinnamon and enjoy!

The overall encouragement for the church is to be obedient to Galatians 6:2 as we "Bear one another's burdens, and so fulfill the law of Christ." In doing this, it is for God's glory and one another's good.

Let God Tell His Story Through You



Increased Blood Usage from Hospitals Creates Heightened Need for Blood Donors

Hospital blood usage has surged nearly 10% over previous levels, as our community moves into COVID recovery mode. Blood donors are needed immediately to respond. March was the highest distribution of certain blood products due to recent local traumas.

The dramatic increase in hospital usage comes at a time when local patients return to the medical system for planned and routine medical care that they had been putting off due to COVID. Trauma-related blood needs have also increased dramatically, as people return to vigorous spring activities and travel.

"We're thankful that CO-VID has receded enough for people to create a new normal and get caught up on deferred medical care," said Dr. John Armitage, President and CEO of Coffee Memorial Blood Center. "But, the impact of this return to normalcy has stressed our blood supply in yet another way. The COVID pandemic continues to surprise and challenge us."

The local blood supply typically operates at a threeday supply, but the surge in demand has lowered levels to a one-day supply. Recent vaccination efforts have also challenged giving levels, as some donors mistakenly believe they can't donate after receiving their COVID-19 vaccine.

While COVID-19 vaccines aren't required to donate, those who have been vaccinated can donate immediately, if they're feeling well. Blood donation takes about an hour and can save up to three lives. About 125 donors are generally needed each day to ensure a healthy blood supply.

Donors can make appoint-

ments to donate at yourbloodinstitute.org or walk-in to any mobile blood drive or to our donor center located at 7500 Wallace in Amarillo, to give.

Thank you to everyone who donated at the Friona Community Blood Drive last Thursday. Thirty-one people were able to donate. Twentythree were whole blood donations and eight were via the doubles machine. Special thanks to Subway of Friona providing the meal. The next Friona blood drive is scheduled for June 10th.

Governor'a Statement on Johnson & Johnson Vaccine

Governor Greg Abbott issued a statement following the Centers for Disease Control and Prevention (CDC) and Food and Drug Administration's (FDA) recommendation to pause all administration of the Johnson & Johnson COVID-19 vaccine:

"The State of Texas is working in tandem with the federal government and vaccine providers to temporarily pause all administration of the Johnson & Johnson vaccine. While no cases of blood clots have been reported in Texas, we are taking the reports of rare adverse effects seriously and are working to ensure that COVID-19 vaccines administered in our state continue to be safe and effective. I urge Texans who do experience adverse reactions, such as severe headache, abdominal pain, leg pain, or shortness of breath within three weeks after receiving the Johnson & Johnson vaccination, to contact their health care providers or call 2-1-1 to receive a referral for a health care provider. Vaccines are a crucial tool to mitigating the spread of COVID-19 and remain the most effective way to combat the virus in our communities. I continue to encourage Texans who wish to receive the Pfizer or Moderna vaccines to sign up."

selective collegiate honor society encompassing all academic disciplines. Invitations to join PKP are extended to juniors in the top 7.5% of their class and to seniors and graduate students in the top 10% of their class.

ANNOUNCEMENT REGARDING THE 806 AREA CODE DIALING PROCEDURES

The Federal Communications Commission has ordered that we transition from 7digit dialing to mandatory 10-digit dialing for local calls. Dialing seven digits for local calls for all customers in the 806-area code.

Beginning April 24, 2021, you will need to begin dialing 10-digits when making a local call. As an example, if you currently dial 7-digits to reach another local number, such as 364-3331, you will be required to dial 806 + 364-3331 for a local call or 1 + 806 + 364 - 3331.

10-digit dialing becomes mandatory on October 24, 2021.

Following are frequently asked questions:

Will everyone in the area codes above have to dial 10-digits (or 1+10-digits) for a local call?

Yes. Every customer throughout the area codes listed above will change to mandatory 10-digit (or 1+10-digit) dialing for local calls. Dialing seven-digits for local calls will be prohibited for all customers in the entire area code.

Why is 10-digit dialing going to be required in these area codes?

The FCC ordered that these area codes must be transitioned to 10-digit (or 1+10-digit) local dialing to ensure everyone is able to reach the National Suicide Prevention Lifeline using the three-digit 988 code.

How is this going to happen?

The North American Numbering Plan Administrator (NANPA) developed, based on input from covered service providers, an implementation schedule that will allow all covered providers to meet the transition deadline in an efficient manner that best accounts for the challenges each covered provider faces.

Will I have to change my phone number?

No. One of the reasons for changing to 10-digit local dialing is to avoid the need to change people's telephone numbers.

Will I be able to begin 10-digit (or 1+10-digit) local dialing before it is required?

Yes. Beginning April 24, 2021, if you have a telephone number in one these area codes, you should start dialing 10-digits (area code + telephone number) or 1+10-digit (1+area code+telephone number depending on dialing plan) for all local calls. If you forget and dial just seven-digits, your call will still be completed.


When will 10-digit local dialing become mandatory?

Beginning October 24, 2021, if you have a number in in the 806 area code, you must dial 10-digits (area code + telephone number) or 1+10 digits (1+area code+telephone number depending on dialing plan) for all local calls. On and after this date, local calls dialed with only seven-digits may not be completed, and a recording will inform you that your call cannot be completed as dialed. If you get this recording, you must hang up and dial again using the area code with the seven-digit telephone number.

What other changes need to be made?

In addition to changing your dialing patterns, all services, automatic dialing equipment, or other types of equipment that are programmed to complete local calls using only sevendigit numbers will need to be reprogrammed to complete calls to 10-digit numbers. Some examples are:

- · life safety systems or medical monitoring devices
- PBXs
- fax machines
- Internet dial-up numbers
- · fire or burglar alarm and security systems or gates
- speed dialers
- · mobile or other wireless phone contact lists
- call forwarding settings
- voicemail services and other similar functions
- Be sure to check your website, personal and business stationery, advertising materials.



personal and business checks, contact information, your personal or pet ID tags, and other such items to ensure the area code is included.

What will stay the same?

- · Your telephone number, including current area code, will not change
- The price of a call, coverage area, or other rates and services will not change due to the dialing change
- What is a local call now will remain a local call regardless of the number of digits dialed
- You will continue to dial 1+ the area code + telephone number for all long-distance calls
- You will continue to dial a prefix (such as "9") when dialing from a multi-line telephone system (i.e., in a hotel, office building, etc.) as required
- You can still dial just three digits to reach 711 (relay services) and 911 (emergency services)
- Any 211, 311, 411, 511, 611, or 811 services available in your community can still be reached by dialing their three-digit codes
- · The National Suicide Prevention Lifeline can still be reached by dial-
- ing 1-800-273-8255 (TALK) even after the 988 code is in effect.

Abbott: No government mandated vaccine passports in Texas

Gov. Greg Abbott issued an executive order last week banning state agencies, cities or counties from creating a "vaccine passport" requirement.

In addition, organizations that receive public funds are prohibited from requiring consumers to prove they have received the COVID-19 vaccine. That includes businesses that receive money from the state in return for providing goods and services.

However, nursing homes and other long-term care facilities can still require that their residents are vaccinated under his order.

"Every day, Texans are returning to normal life as more people get the safe and effective COVID-19 vaccine. But, as I've said all along, these vaccines are always voluntary and never forced," Abbott said.

Vaccines continue steady rise across state

As of Sunday, just more than 9 million Texans have received at least one dose of a COVID-19 vaccine, and 5.46 million are fully vaccinated, according to the Texas Department of State Health Services. DSHS urges those who have not been vaccinated to go to the state's Texas Public Health Vaccine Scheduler, which can be found at getthevaccine.dshs.texas.gov.

Meanwhile, the state's weekly shipment of COV-ID-19 vaccines dropped this week after a manufacturing error in a Baltimore plant ruined a 15-million batch of the single-dose Johnson & Johnson vaccine.

Last week, the state received 2.5 million doses from the three manufacturers, an amount that dropped to 1.9 million this week, as J&J plays catchup. The company has pledged to deliver 100 million doses nationwide by the end of May, according to an NPR report. J&J reduced its Texas allocation this week by about 350,000. source Center.

The number of deaths decreased to 512, down nearly 20 percent from the previous week.

At its peak in January, the state recorded more than four-fold the number of deaths with 2,311 recorded in a single week. At this point, nearly 50,000 Texans have died from COVID-19.

The number of lab-confirmed COVID-19 patients hospitalized stayed steady at 2,804, according to DSHS.

Contempt order against salon owner tossed out

The Texas State Supreme Court on Friday threw out a contempt order against a Dallas salon owner who refused to close last year when all non-essential businesses were ordered.

Shelley Luther tore up a cease-and-desist order from Dallas County and was fined \$7,000 and sentenced to a week in jail. The high court ruled unanimously that the restraining order was too vague, and that the contempt of court decree issued by a district judge should be voided as well.

Luther's defiance sparked national coverage, prompting Abbott to reverse part of his order that called for jail time for business owners who did not shut down last year after the pandemic outbreak.

Luther ran as a Republican for state Senate last year, losing in a December runoff to Drew Springer, R-Muenster.

Paxton drawing potential high-profile opponents

Two candidates with famous surnames are planning to run against Texas Attorney General Ken Paxton in 2022, according to several media outlets.

Paxton, under indictment since 2015 on securities fraud charges, is also battling a whistleblower lawsuit filed by former employees accusing him of bribery and improper dealings with an Austin investor. He denies wrongdoing in both cases. Democrat Joe Jaworski, a former Galveston mayor and a grandson of Watergate prosecutor Leon Jaworski, announced his plans to run last summer. And last week, George P. Bush, state land commissioner and grandson of President George H.W. Bush, told a talk-radio host

that he is considering challenging Paxton next year in the Republican primary.

Paxton has indicated he will run for a third term.

Abbott demands shutdown of San Antonio minor facility

The governor's latest salvo against the federally run unaccompanied minor facilities included a letter to Vice President Kamala Harris, who has been tapped to head the effort dealing with a large influx of unaccompanied minors seeking entrance into the United States.

Abbott's letter demanded the Biden administration shut down a facility in San Antonio under investigation by the state for allegations of child abuse and neglect.

"The Biden administration opened the borders and failed to plan for the influx of unaccompanied children crossing the border, and now we are faced with our worst fears—allegations of child abuse and neglect," Abbott said.

To date, there has been no direct response from Harris.

Soon, more Texans will have to dial 10 digits to make local calls Folks living in the Panhandle, El Paso area, South Texas, and Deep East Texas will soon have to join the majority of Texans and use all 10 digits when making local calls.

Last summer, the Federal Communications Commission approved "988" as the abbreviated dialing number for the National Suicide Prevention Lifeline. In Texas, the 254, 361, 409, 806, 830, 915 and 940 area codes all contain the 988 prefix.

A "permissive dialing period" begins April 24, during which seven-digit calls will still go through. But after Oct. 24, in those area codes, only calls dialed with 10 digits will be connected. Property Tax Protest and Appeal Procedures

Property owners have the right to protest actions concerning their property tax appraisals. You may follow these appeal procedures if you have a concern about:

- the appraised (market) value of your property
- the unequal value of your property compared with other properties
- the inclusion of your property on the appraisal roll
- any exemptions that may apply to you
- the qualification for an agricultural or timber appraisal
- the taxing units taxing your property
- the property ownership
- the change of use of land receiving special appraisal
- failure of the chief appraiser or appraisal review board (ARB) to send a required notice
- any action taken by the chief appraiser, county appraisal district (CAD) or ARB that applies to and adversely affects you.

your evidence, facts and argument. If you decide to participate by telephone conference call, you must provide your evidence to the ARB with a written affidavit before the ARB hearing begins. You may use Comptroller Form 50-283, *Property Owner's Affidavit of Evidence to the Appraisal Review Board*, to submit evidence for your telephone conference call hearing or for hearing by affidavit.

You and the CAD representative have the opportunity to present evidence about your case. You may cross-examine the CAD representative. The ARB will make its decision based on the evidence presented by both parties. In most cases, the CAD has the burden of establishing the property's value by a preponderance of the evidence presented.

In certain protests, the chief appraiser has the burden of proving the property's value by clear and convincing evidence. You should review ARB hearing procedures to learn more about evidence and related matters.

Review by the ARB

If you cannot resolve your problem informally with the CAD, you file a notice of protest requesting to have your case heard by the ARB.

The ARB is an independent board of citizens that hears and determines protests regarding property appraisals or other concerns listed above. It has the power to order the CAD to make the necessary changes based on evidence heard during the ARB hearing.

If you file a written request for an ARB hearing (notice of protest) before the deadline, the ARB will set your case for a hearing and send you written notice of the time, date and place of the hearing. If necessary, you may request a hearing in the evening or on a Saturday or Sunday. You may use Comptroller Form 50-132, *Property Appraisal - Notice of Protest*, to file your written request for an ARB hearing.

Prior to your hearing, you may ask to review the evidence the CAD plans to introduce at the hearing to establish any matter at issue. Before a hearing on a protest or immediately after the hearing begins, you or your agent and the CAD are required to provide each other with a copy of any materials (evidence) intended to be offered or submitted to the ARB at the hearing. Evidence may be submitted for any hearing type either in paper or on a small portable electronic device (such as a CD, USB flash drive or thumb drive) which will be kept by the ARB. Do NOT bring evidence on a smart phone. The ARB's hearing procedures regarding all the requirements to properly submit evidence on a small portable electronic device.

To the greatest extent practicable, the hearing will be informal. You or a designated agent may appear in person or you may by telephone conference call or submission of written affidavit to present You should not try to contact ARB members outside of the hearing. ARB members are required to sign an affidavit saying that they have not talked about your case before the ARB hears it.

Review by the District Court, an Arbitrator or SOAH

After it decides your case, the ARB must send you a copy of its order by certified mail. If you are not satisfied with the ARB's decision, you have the right to appeal to district court. As an alternative to district court, you may appeal through binding arbitration or the State Office of Administrative Hearings (SOAH) if you meet the qualifying criteria.

If you choose to go to district court, you must start the process by filing a petition with the district court within 60 days of the date you receive the ARB's order. If you chose to appeal through binding arbitration, you must file a request for binding arbitration with the CAD not later than the 45th day after you receive notice of the ARB order. If you chose to appeal to the SOAH, you must file an appeal with the CAD not later than the 30th day after you receive notice of the ARB's order. Appeals to district court, binding arbitration or SOAH all require payment of certain fees or deposits.

Tax Payment

You must pay the amount of taxes due on the portion of the taxable value not in dispute, the amount of taxes due on the property under the order from which the appeal is taken or the amount of taxes due in the previous year.

Usual Deadline

Not later than May 15 (or within 30 days after a notice of appraised value was mailed to you, whichever is later).

Late protests are allowed for good cause if you miss the usual deadline. The ARB decides whether you have good cause. Late protests are not allowed after the ARB approves the appraisal records for the year.

Special Deadlines


For change of use (the CAD informed you that you are losing agricultural appraisal because you changed the use of your land), the deadline is not later than the 30th day after the notice of the determination was delivered to you.

For ARB changes (the ARB has informed you of a change that increases your tax liability and the change did not result from a



Continuing with observance of National Poetry Month, this week's spotlight is on an Italian Jew who, as a chemist by trade, survived a WWII concentration camp. During his year at Auschwitz, Primo Levi was a slave laborer. After his release in 1945, he found writing vital to his survival.

In her article Hear and Act, Rabbi Dorothy A. Richman says Levi framed these verses around the Shema, often the first prayer a Jewish child is taught.

"[Levi]attempts to redefine this traditional prayer. His poem commands a singleminded focus...on a subset of God's creatures, people living in poverty and chaos. Levi in-





Drought worsens, limited irrigation expected for parts of Texas

Row crop producers in drought-stricken parts of the state are pre-watering fields with the hope crops can establish and timely rains will improve growing conditions, according to AgriLife Extension agents and reports. But there are concerns that irrigation, and in some areas limited or restricted irrigation due to below-normal water levels, may not be enough.

Jourdan Bell, Ph.D., AgriLife Extension agronomist, Amarillo, said row crop producers are being very cautious about planting decisions on both irrigated and dryland acres. Higher prices for corn, sorghum and cotton are a plus, and spring snowfall and scant rains helped moisture levels some, but drought conditions leave tougher decisions ahead.

"We ended 2020 with a moisture deficit, so in many areas we are starting 2021 from behind," she said. "Corn, sorghum, and cotton prices are currently better than they have been in several years, but the drought and extended forecast may negatively impact planting decisions in parts of Texas, so many farmers may not benefit from the current strong markets."

Soil moisture continues decline

A March 26 National Oceanic and Atmospheric Administration drought update for the U.S. Southern Plains, which includes Kansas, Oklahoma and Texas, showed drought conditions worsened in a large swath of the state. Western and southern parts Texas were experiencing extreme to exceptional drought, while drought conditions throughout Central Texas reached moderate to severe levels.

Conditions were not expected to improve by the time summer temperatures set in.

"Precipitation, temperature, and drought condition forecasts all suggest an expansion and intensification of drought conditions is likely over the next three months," the report reads.

John Nielsen-Gammon, Texas state climatologist, Bryan-College Station, said a slight La Niña pattern, which typically delivers warmer, drier weather to Texas, is weakening and will probably become a neutral weather pattern by May. He too expects drier-than-normal conditions to continue and that arid conditions could exacerbate high summertime temperatures.

"We certainly expect warmer temperatures because of the drier conditions this winter," he said. "There's no swamp cooling effect that you get when there's moisture in the soil and air."

Water allotments to shrink

Dryland fields are at the mercy of Mother Nature, Bell said. Timely rains will be critical for dryland crop establishment and ultimate success or failure.

But Bell said drought conditions in the Panhandle will hit irrigated farmers harder than previous droughts. Producers no longer have the well capacity to compensate for increased temperatures and reduced precipitation because irrigation capacities decline with declining groundwater levels.

Similar irrigation shortages are brewing for other dry areas of Texas.

Orlando Flores, AgriLife Extension agriculture agent for El Paso County, said producers there are irrigating fields in preparation for planting but may have to adjust their irrigation according to water district restrictions. He noted water in that area could become limited due to supply rationing.

West Texas is one of the driest parts of the state, and crops are irrigated via canals that feed from the Rio Grande River and Elephant Butte Reservoir to the north in New Mexico. A water-usage agreement provides regional agriculture – mostly Pima cotton, pecan orchards and alfalfa fields – allotted amounts of water each growing season based on available water levels.

Water levels in the Rio Grande River and Elephant Butte are below normal following long-term drought conditions throughout the river basins that feed them. And the Elephant Butte Irrigation District has projected slim water allotments for farmers.

"This year the allotment will be inches of water instead of feet," he said. "Elephant Butte will get some runoff from snowpack and the water districts will determine irrigation availability. We go through this often, and producers will have to adjust, but if we can't get water, we can't get water."


Obituary



The latest drought map for conditions





The Great Outdoors

Intrinsically, Franklin Delano Roosevelt was a conservationist, who once said, "the forests are the lungs of our land [which] purify our air and give fresh strength to our people."

On April 5, 1933 – a year after he was elected President – FDR formed the Civilian Conservation Corps [CCC]. He believed it would put thousands of citizens back to work during "the Great Depression" and ensure the health of America's woodlands.

Those who enlisted in "Roosevelt's Tree Army" got \$30 per month – approximately \$600 in 2021 currency – and access to vocational education to facilitate their re-entry into the job market. Enlistment was intended to be only six months, but many of the recruits stayed longer.

According to History.com, "CCC employees fought forest fires, planted trees, cleared and maintained access roads, re-seeded grazing lands and implemented soilerosion controls. They built wildlife refuges, fish-rearing facilities, water storage basins and animal shelters. To encourage citizens to get out and enjoy America's natural resources, FDR authorized the CCC to build bridges and campground facilities. From 1933 to 1942, the CCC employed over 3 million men."



Distracted driving continues to plague Texas roadways

Sadly, distracted driving is still near the top of the list when it comes to crashes on Texas roadways, coming in at No. 2 for traffic-related crash causes. Last year Texas roadways saw nearly 1 in 5 crashes caused by a distracted driver in which 364 people died and 2,200 were seriously injured.

April is National Distracted Driving Awareness Month, and TxDOT is reminding all Texans to put their phones down and give driving their full attention whenever they are behind the wheel.

"A serious or fatal crash can happen in an instant," said TxDOT Executive Director James ed driving crashes are 100 percent preventable. Driving should be your number one priority behind the wheel – everything else can wait."

Since September 1, 2017, it has been illegal to read, write or send a text while driving in Texas. Violators can face a fine up to \$200. TxDOT offers these tips to prevent distracted driving that can lead to a ticket, or worse, a crash: (1) Always give driving your full attention, (2) Pull off the road entirely and come to a complete stop before you talk or text, (3) Put your phone away, turn it off, or use an app or your phone settings to block texts and calls while driving, (4) Tell friends, family and co-workers you won't respond to texts or calls while driving, and (5) Remember that all distractions are dangerous, so pay full attention when behind the wheel.
