





May is Foster Care Awareness Month

May is Foster Awareness Month. Children are Jennifer and Frank DeAnda for placed in Foster homes when they are removed from their families because of abuse, neglect, or other family problems that endanger their safety. These children range in age from infants to 18 years. They may have special medical, physical or emotional needs or be part of a group of brothers and sisters who need to be placed together. There are different levels of care, according to the needs of the child, and foster homes are trained and certified for these various levels.

According to Darla Ingram, foster-adopt coordinator with Children's Protective Services, There is an increasing need for foster care homes in the Texas panhandle. Child abuse investigations, as well as removals, are increasing. If a child is removed and there are no local foster homes available, he/she must often be placed in facilities as far away as Dallas or Houston. This makes the job of his social worker much harder and much more expensive, as well as complicating the chance of reunification with the birth family.

Sherman County is fortunate to have 1 certified foster home. The Sherman County Child Welfare Board would like to

Care express our appreciation to their service to children of this area. They were interviewed recently to help acquaint Sherman County residents with the Foster Care Program.

Q: Why did you choose to become foster parents?

A: We wanted kids in our home. One of our options was to become foster parents. For those wishing to adopt this is one way through CPS. This is

why we initially started to be foster parents.

Q: What was the process for becoming foster parents?

A :We took a 10-week course in Amarillo which went through all of the areas for certification as foster parents certifying your home, studying different types of cases we might see, the whole certification process. We went once a week for 10 weeks. After the initial classes, a very thorough home study was done. This included a home inspection on various occasions, a couple interviews individual interviews and an FBI check.

Q: Was there any other training that you received?

A: You have to have continuing education hours. Your first aid and CPR have to be current Your training can be online, or articles to read, or speakers to



About a year ago I heard the one word come out of my mom's mouth that I hoped I would never hear-CANCER. My mom had been to the doctor a few weeks earlier and through various tests that were being run on her, a tumor was found on her kidneys. She had no symptoms of anything being wrong with her kidney so it was really by accident that it was found. I still remember the day my mom and dad broke the news to us. When she told us that it was cancer tears immediately began to stream down my face. I sat there in disbelief. This was not what I was hearing. My mom came to my side and very calmly told me she was going to be all right. Here she was faced with the possibility of dealing with this horrendous disease and she was comforting me. She was so courageous and strong. My mom never once doubted that God would take care of her. She underwent surgery and they were able to remove the tumor without having to take her kidney. She also would not have to go through any treatments. That day I also saw the love that my dad had for her and how concerned he was for his wife. The surgery lasted a couple of hours and my dad never once left the seat where he was sitting. The relief on his face was so evident when the doctor came out to tell us that

everything went well. I know that God heard my dad's prayers that day. If you ask my mom about her bout with cancer today, she plays it down. She doesn't think hers is as big an ordeal as others. But if the doctors had not found it when they did things could have been much worse, We were very fortunate. She is the type of survivor that the American Cancer Society hopes for. If cancer is not something we can completely rid the world of. then God willing, it can be a

Q: What is the process of actually placing children in your home?

A: The kids have a social worker and the foster parents have their own worker who looks out for your needs and requests. The foster parent worker contacts us describing the child's needs and why she is in foster care. You get the whole background and then

decide if that child would work out in your home.

O: Do you have to make a quick decision?

A: They can call you in the middle of the night, but with new foster parents they give you time to think about it. You don't initially start with emergency, at-risk kids. The more seasoned foster parents could take them at a moment's notice. Also, being so far from

5-States Playa Lakes Festival

Students grades 3-6th in Sherman County, and adjoining counties in four other states are eligible to register for the Playa Lakes Festival, to be held July 19-21, in Boise City and Kenton, OK. The Festival is a fun way for students to become educated about the High Plains water cycle through the context of playa lakes. During a threeday program, students will be instructed in the main components of our unique water cycle: springs, draws, creeks, playa lakes, and the Ogallala Aquifer. Darryl Birkenfeld, Director of Ogallala Commons, the main sponsor of the Festival, explains why students in the region need to be knowledgeable about the water cycle. "Water is the lifeblood of human and natural ecosystems. Playas are a unique feature of the High Plains country, and they are a tool to teach students, adults, and communities about a healthy and functioning water cycle." According to Loren Smith in Plays of the Great Plains (Texas Tech University Press, 2003), there are 219 playa lakes covering 5,058 acres in Sherman County. In recent years, numerous studies are demonstrating that Ogallala Aquifer recharge is intricately tied to playa basins. Though long treated as a nuisance, playa lakes are not only important to wildlife, but for the long-term viability of the water cycle as well as human communities.

going commitments as the foster parents?

your home because the parents do not know where their child is placed or who the family is. All visitations would be at the CPS office in the county where the child resided. The visits are at the discretion of the court, and are set up by the social worker. Foster parents never have to have contact with the biological parents. You take the children to the CPS office, and the social worker takes them to the visitation area. It truly is a choice how much you want to be involved with the biological parents. We started with once a week. It varies according to the child's needs.

Q: Is that unusual to have that many visits per week?

A: The whole philosophy behind foster parenting and CPS is to reunite families when it is possible. You have as many visits as necessary to make that happen, for any bonding to take place.

Q: Did you have any choice as to the age, sex, etc. of the children you would take?

A: You have the choice of age, sex, race of the child, even down to why they were removed. For example, you might prefer that sexually assaulted children not be placed in your care, and that would be your choice.

Q: Are you a member of the decision making team? Do you have input into what you feel would be the best outcome for the child?
