



Enhancement Committee.

Duane Mungia, a member of the committee, explained that the goal of the enhancement and improvement effort is to visually convey the tremendous pride that Stratford citizens are famous for throughout Texas.

Enhancement and improvement plans include assisting property owners with maintenance tasks such as painting, mowing and disposing of debris.

The committee asks that everyone check their own property for overgrown weeds, debris and other issues. "The next time you drive through other towns look at them as if you were moving there and see what would stop you," said Mungia. "Consider what you can do to help those issues in Stratford," he suggested.

"We would love for people to drive through Stratford and think Wow, that was a great little town," said one committee member.

The committee is ready and willing to do what they can to help residents whether it is providing access to equipment, pitching in with physical labor, seeking funding or simply being there to provide encouragement. "Every event needs cheerleaders," said one

member, "It takes a lot to keep people positive and motivated."

The group plans to seek funding primarily from sources outside of Stratford. They feel that all the businesses here support their fair share of local events and do not want the effort to cost the community.

As part of this effort, city-officials will be enforcing ordinances concerning nuisances such as trash, overgrown weeds and abandoned vehicles.

CONSTITUTIONAL AMENDMENTS SPECIAL ELECTION NOVEMBER 6, 2007

IEF EXPLANATORY STATEMENTS OF P

PROPOSITION 1 (HJR 103)

HJR 103 would update the constitutional reference to Angelo State University to conform with the statutory transfer of that institution from membership in the Texas State University System to membership in the Texas Tech University System.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for the continuation of the constitutional appropriation for facilities and other capital items at Angelo State University on a change in the governance of the university."

PROPOSITION 2 (SJR 57)

SJR 57 would authorize the legislature to permit the Texas Higher Education Coordinating Board to issue up to \$500 million in general obligation bonds to finance educational loans to college and university students, and to enter into bond enhancement

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for the issuance of \$500 million in general obligation bonds to finance educational loans to students and authorizing bond enhancement agreements with respect to general obligation bonds issued for that purpose."

PROPOSITION 3 (HJR 40)

HJR 40 would authorize the legislature to limit the maximum appraised value of a residence homestead for property tax purposes in a tax year to the lesser of the most recent appraisal valuation, or 110 percent, or a greater percentage as determined by the legislature, of the appraised value in the preceding tax year

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide that the maximum appraised value of a residence homestead for ad valorem taxation is limited to the lesser of the most recent market value of the residence homestead as determined by the appraisal entity or 110 percent, or a greater percentage, of the appraised value of the residence homestead for the preceding tax year."

> **PROPOSITION 4** (SJR 65)

SJR 65 would authorize the legislature to permit the Texas Public Finance Authority to issue up to \$1 billion in general obligation

bonds, the proceeds of which would be dedicated to maintenance, construction, repairs. and equipment purchases, as authorized by the legislature for the following state agencies: the Texas Building and Procurement Commission: the Parks and Wildlife Department; the Department of the Adjutant General; the Department of State Health Services: the Department of Aging and Disability Services; the Texas School for the Blind and Visually Impaired; the Texas Youth Commission; the Texas Historical Commission; the Texas Department of Criminal Justice; the Texas School for the Deaf; and the Texas Department of Public Safery

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the issuance of up to \$1 billion in bonds payable from the general revenues of the state for maintenance, improvement, repair, and construction projects and for the purchase of needed equipment."

PROPOSITION 5 (SJR 44)

SJR 44 would authorize the legislature to permit cities with a population of less than 10,000 to hold an election to allow the city to enter into an agreement with a property owner to temporarily freeze taxes on property either in or adjacent to an area approved for funding under the Downtown Revitalization Program or the Main Streets Improvements Program administered by the Department of Agriculture.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to permit the voters of a municipality having a population of less than 10,000 to authorize the governing body of the municipality to enter into an agreement with an owner of real property in or adjacent to an area in the municipality that has been approved for funding under certain programs administered by the Texas Department of Agriculture under which the parties agree that all ad valorem taxes imposed on the owner's property may not be increased for the first five tax years after the tax year in which the agreement is entered into."

PROPOSITION 6 (HJR 54)

HJR 54 would authorize the legislature to exempt from ad valorem tax one motor vehicle owned by an individual that is used by the individual for both business and personal use.

The proposed amendment will appear on the ballot as follows: "The constitutional

amendment authorizing the legislature to exempt from ad valorem taxation one motor vehicle owned by an individual and used in the course of the owner's occupation or profession and also for personal activities of the owner."

PROPOSITION 7 (HJR 30)

HJR 30 would allow a governmental entity sell property acquired through eminent domain to its immediately previous owner at the original purchase price, if the public use of the property has been canceled, if no progress is made toward that public use by a prescribed deadline, or if the property is unnecessary to accomplish that public use.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to allow governmental entities to sell property acquired through eminent domain back to the previous owners at the price the entities paid to acquire the property."

PROPOSITION 8 (HJR 72)

HJR 72 would clarify home equity loan procedures and protections and make conforming changes to the written disclosure provided to the borrower at the loan closing. The amendment would establish that the status of whether property is an agricultural homestead for the purpose of receiving homestead protection, would be "determined by whether it was designated for agricultural use on the date of the loan closing. The amendment would provide that a declared state of emergency (e.g., following a natural disaster) would justify execution of a second home equity loan on the same property less than one year after the first home equity loan. It would provide that non-substantive omissions on a loan application would not affect the agreement. It would require a borrower to receive a copy of all executed loan documents, and a disclosure list of fees and costs at closing. It would prohibit the use of preprinted checks for the use of unsolicited loan advances to obtain a home equity line of credit.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to clarify certain provisions relating to the making of a home equity loan and use of home equity loan proceeds."

PROPOSITION 9

The proposed amendment will appear on the bailot as follows: "The constitutional amendment authorizing the legislature to exempt all or part of the residence homesteads of certain totally disabled veterans from ad valorem taxation and authorizing a change in the manner of determining the amount of the existing exemption from ad valorem taxation to which a disabled veteran is entitled."

PROPOSITION 10 (HJR 69)

HJR 69 would remove constitutional references to the former office of inspector of hides and animals.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to abolish the constitutional authority for the office of inspector of hides and animals."

PROPOSITION 11 (HJR 19)

HJR 19 would require a vote taken in either house of the legislature to be recorded by record vote, if the vote was on final passage of a bill, other than local bills, a resolution proposing a constitutional amendment, or any other resolution that is not purely ceremonial. The record vote must be archived and available for public viewing on the Internet for at least two years.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to require that a record vote be taken by a house of the legislature on final passage of any bill, other than certain local bills, of a resolution proposing or ratifying a constitutional amendment, or of any other nonceremonial resolution. and to provide for public access on the Internet to those record votes."

PROPOSITION 12 (SJR 64)

SJR 64 would authorize the Texas Transportation Commission to issue up to \$5 billion in general obligation bonds for highway improvement projects, the proceeds of which will be used to pay for projects, costs, and payments owed under related credit agreements.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for the issuance of general obligation bonds by the Texas Transportation Commission in an amount not to exceed \$5 billion to provide funding for highway improvement projects.

PROPOSITION 13 (HJR 6)

HJR 6 would authorize the denial of bail to a person who violates conditions of release a family violence case

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the denial of bail to a person who violates certain court orders or conditions of release in a felony or family violence case."

PROPOSITION 14 (HJR 36)

HJR 36 would limit a state justice or judge's service to December 31st of the fourth year of the term if he/she is elected to all or part of a six year term, and reaches mandatory retirement age during the first four years of said term.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment permitting a justice or judge who reaches the mandatory retirement age while in office to serve the remainder of the justice's or judge's current term."

PROPOSITION 15 (HJR 90)

HJR 90 would require the legislature to establish the Cancer Prevention and Research Institute of Texas, and would provide for its management, duties, and powers. It would authorize the issuance of up to \$3 billion in general obligation bonds to be used for operations and grants for the purpose of scientific research of all forms of human cancer.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment requiring the creation of the **Cancer Prevention and Research Insti**tute of Texas and authorizing the issuance of up to \$3 billion in bonds pavable from the general revenues of the state for research in Texas to find the causes of and cures for cancer."

PROPOSITION 16 (SJR 20)

SJR 20 would authorize the issuance of up to \$250 million in general obligation bonds by the Texas Water Development Board to provide financial assistance to economically distressed areas of the state to help provide adequate sewer and water supply services for residential use.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for the issuance of additional general obligation bonds by the Texas Water Development Board in an amount not to exceed \$250 million to provide assistance to economically distressed areas."

Ask the Geek By Kevin McDonald

Office Productivity for Free

Last week we talked about the difference between your operating system (such as Windows XP Home Edition) and your office productivity software (such as Microsoft Office). This week I'll focus on an office suite called OpenOffice.org (OO.org).

From the OpenOffice.org web site: "OpenOffice.org ... includes the key desktop applications, such as a word processor, spreadsheet, presentation manager, and drawing program, with a user interface and feature set similar to other office suites. Sophisticated and flexible, OpenOffice.org also works transparently with a variety of file formats, including those of Microsoft Office, and the vendorneutral Open Document standard from OASIS. Available in over 65 supported languages with more being constantly added by the community, OpenOffice.org runs stably and natively on Solaris, Linux (including PPC Linux), Windows, Mac OS X (X11), and numerous other platforms."

OpenOffice.org contains all the software necessary for you to create documents, spreadsheets, presentations, edit photos and clip art and much more. It also allows you to read those same types of files that were created in other office suites. In other words, the OO.org word processor can open a document that was created by someone using Microsoft Word, and the OO.org presentation module can open a Microsoft PowerPoint presentation.

The big difference, however, is that OpenOffice.org is completely free. You don't pay to download it, install it, register it, use it or keep it updated. Also, when you save a file in an OO.org format, you can rest assured that they're not keeping any secrets - the format that their files are saved in is an approved, "open" format. That means that your files will never be enslaved by corporate copywrites or proprietary formats. Anyone with the gumption could include code in their software that could read an OpenOffice.org file without having to reverse engineer the file to try to "guess" how it's been created. I have used OO.org for many years and couldn't be happier. I write this column using the OO.org word processor, and when I'm ready to submit it, I click one button in the toolbar that creates a "PDF" (otherwise known as "Adobe Acrobat" format) of the file to send to the Star. What you are reading right now looks exactly as it looked on Plainview, Earlier in the week my screen, and the software I used to create it cost exactly zero.

Getting it is easy, just visit their web site: www.openoffice.org. You can join their mailing lists and read user guides and other documentation on their site. Find a bug in the software? Submit it to the developers and take part in the ongoing improvement of the software! When have you ever had that kind of control?

STAY! There are other circumstances when staying put and creating a barrier between yourself and potentially contaminated air outside, a process known as "sealing the room," is a matter of survival. Use available information to assess the situation. If you see large amounts of debris in the air, or if local authorities say the air is badly contaminated, you may want to take this kind of action.

The process used to seal the room is considered a temporary protective measure to create a barrier between you and potentially contaminated air outside. It is a type of sheltering in place that requires preplanning.

To "Shelter in Place and Seal the Room"

- Bring your family and pets inside.
- Lock doors, close windows, air vents and fireplace dampers.
- Turn off fans, air conditioning and forced air heating systems.
- Take your emergency supply kit unless you have reason to believe it has been contaminated.
- Go into an interior room with few windows, if possible.
- Seal all windows, doors and air vents with plastic sheeting and duct tape. Consider measuring and cutting the sheeting in advance to save time.
- Be prepared to **improvise** and use what you have on hand to **seal gaps** so that you create a barrier between yourself and any contamination.
- Local authorities may not immediately be able to provide information on what is happening and what you should do. However, you should watch TV, listen to the radio or check the Internet often for official news and instructions as they become available.

Learn how and when to turn off utilities. If there is damage to your home or you are instructed to turn off your utilities:

- Locate the electric, gas and water shut-off valves.
- · Keep necessary tools near gas and water shut-off valves.
- Teach family members how to turn off utilities.
- If you turn the gas off, a professional must turn it back on. Do not attempt to do this yourself.

Go! There may be conditions under which you will decide to get away, or there may be situations when you are ordered to leave. Plan how you will assemble your family and anticipate where you will go. Choose several destinations in different directions so you

- If there is damage to your home and you are instructed to do so, shut off water, gas and electricity before leaving.
- o Leave a note telling others when you left and where you are going.
- Check with neighbors who may need a ride.

Talk to your local emergency officials. Join with other volunteers in your community to help make your community safer and better prepared.








