W. C. Shelton of Lawton, Oklahoma, was low bidder on general construction, with a bid of \$201,650.00.

Total contracts let so far add to \$239,666.00, which does not include any equipment.

County Judge Bids Voters to Inspect Service Record



Calling attention to WICHITA County as one of the biggest businesses in Northwest Texas, with an annual budget in excess of three quarters of a million dollars, County Judge Arthur Tipps urges voters to inspect the record and consider problems ahead as he solicits their support in his candidacy for reelection.

Difficult and complex problems have confronted county commissioners court, of which the county judge is presiding officer, he points out in his formal announcement.

With the assistance of other officials, Tipps worked for passage of a bill by the last legislature under which counties would keep a portion of the 2 per cent vehicle transfer tax levied by the state on sales of both new and used motor vehicles.

Passed in the closing minutes of the session, the bill contained certain errors and was vetoed. Judge Tipps, if elected, plans to spearhead another fight to

THE FIGHT GOES ON

They are still pressurizing for socialized medicine, in spite of the fact that Great Britain, finding the cost terrific, has slashed her give-away budget. It's been a costly business in more ways than one. The agitation over socialized medicine has made more people conscious of the voluntary health insurance programs available here. Already 50 million people have such coverage and more are becoming policy-holders, daily. Of course not all of the plans have full medical care, have only limited protection. Payments under voluntary medical programs have been only one-tenth of the medical bills paid by patients. So the advocates for socialized medicine ask what about the 100 million people not included. Their's is the strategy of winning friends and influencing people for the government controlled program.

NOT LIKE AT HOME

One of the much publicized pictures of Soviet propaganda, is that of the new Moscow subway. An imposing building it is too, with high vaulted ceilings, vast spaces, elaborate murals, the last word in lighting arrangements. There are five pictures in "Soviet Russia Today", besides others in various papers. They all show the grandiose outlay, but surprisingly, none of them show people in the large underground reaches. One picture of this shows 12 people, but about half of them appear to be subway guards. An American tourist, when shown one of the subterranean passages of the great, grand terminal, exclaimed over the magnificence but asked, "Where are the trains?"

Further Foreign Education

Many who return from study of foreign crises, declare that education of the youth is the logical means of building democratic and friendly relations with them. There is a move to build an international Christian University in Japan to carry out this idea. The U. S. would contribute \$10 million for its creation in Tokyo. War is far more costly, the last one taking \$300 billion from America, just in money. The Far East is a problem as the influence of Communism in China typifies. Japan, if inclined to democratic ideals, friendly to Western conceptions of such, could produce leaders who would be friendly toward America. On international university at Tokyo would be an influence toward this end, a buttress against Communism. No one can be sure of such plans succeeding, but as some one has said, our exchange system of students with foreign countries, is such an objective. The process takes time, but for long-term relationship with countries, such a program would take years in the building and molding.

Revealed By Star Files 10 Years Ago

Texas School Had 1,920 Consolidat'ns

Consolidation of 1,920 school districts the first year Texas' new education laws were in effect has resulted in larger school units and a better school program. J. W. Edgar, state commissioner of education declared at Austin.

Consolidations have made possible better building equipment and facilities, teachers giving instruction in fewer subjects, and a vastly broadened program of vocational agriculture, trades and industries, and home economic instruction which means better schools for Texas children, Edgar pointed out.

The total number of school districts dropped from 4,412 in 1949-50 to 1,492 operating districts during the last school year. A total of 1,920 of these consolidations were mandatory under new school laws.

"Six hundred and twenty school districts, however, voluntarily merged with other districts," Edgar said.

In addition, the total number of county unit systems (one school system for an entire county) doubled, making the total twenty-four.

Edgar also predicted that consolidations for the 1950-51 school year would total an additional 400, bringing the total number in the state down to approximately 1,000.

Most of the smaller schools in the state could not afford adequate library and laboratory facilities, or equipment and teachers for vocational agriculture, trades and industries, and home economic courses, Edgar pointed out.

"While there has been considerable increases in library, visual aid and laboratory facilities, there has been a tremendous expansion in the vocational departments," Dr. Edgar said.

Gaylon Siler's litter of six Chester White pigs placed 20th in the Wichita Falls area heavy litter contest. Total weight of the litter was 225 pounds.

The pigs are from a sow given Gaylon by the Sears Foundation, and at the age of 56 days, the litters are weighed. This contest is open to 56 boys from 7 counties near Wichita Falls, and is a part of the program which gives eight registered Chester White gilts and one boar to 4-H club boys each year. The boys keep records on their sow's demonstration, and are required to give back one suitable sow pig to the club to be passed on to another boy. Prizes given are in the form of equipment needed around the farm and home.

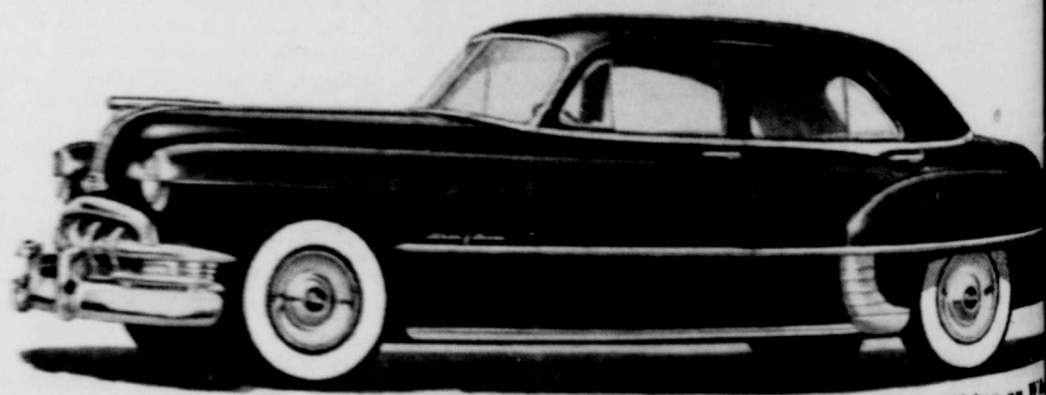

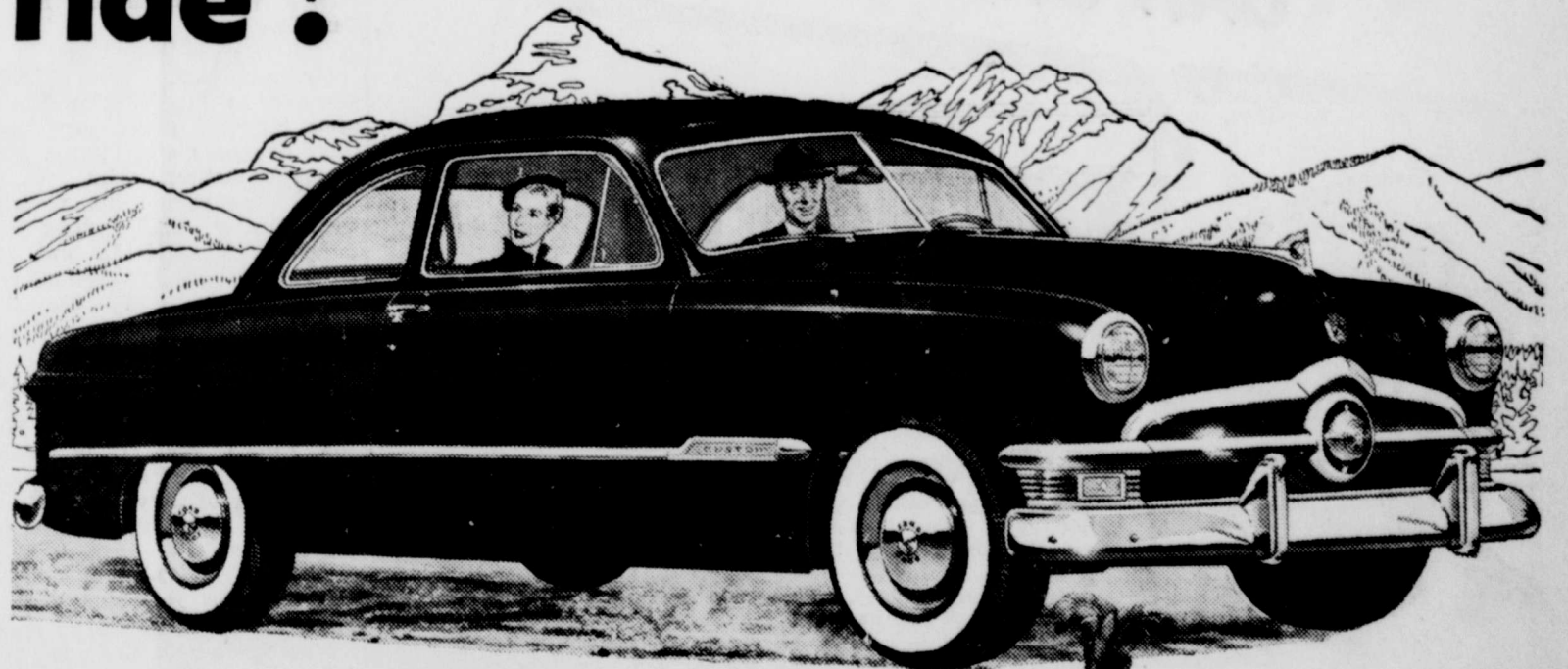

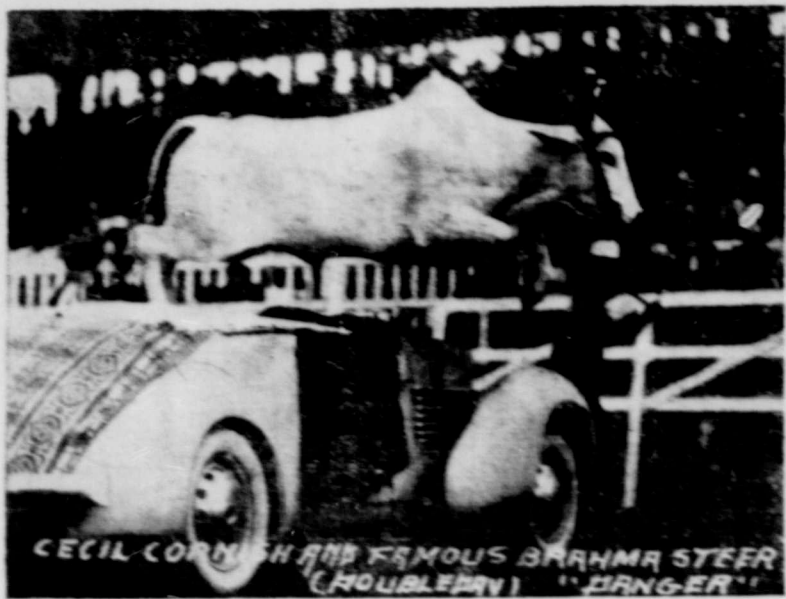

Do Not Neglect Summer Worming

Generally, birds kept in the open during summer months are healthier than those that remain in confinement. But that is no reason to neglect or ignore, the threat of disease or heavy worm infections to a flock. Fresh air, freedom of movement, and plenty of green forage not always can be counted on to guide birds safely thru the summer months.

To keep poultry in good health through the range period requires summer worm control. It is during the range season that growing pullets are expected to build up their body strength and develop into sturdy, ready-to-lay birds. With proper management, they should come off the range well-feathered birds in the best of condition, capable of going into heavy production. If the worm problem is not adequately handled at this time, a weak, poorly-developed flock of pullets may go into the laying house.

Intestinal Worms Costly
A good worm control program during the summer will not only encourage high egg production in the fall, it will also promote uniform growth. Damaging intestinal worms, if they get started in a flock, will spread rapidly. If no method or means of worm control is enforced, an entire flock may soon be ruined.

For such familiar worm species as large roundworms and cecal worms, there are dependable commercial medicines that may be given to birds with effective results. Destructive tape worms may also be controlled. Usually, individual treatments are most successful against these worms.

Monthly Treatments
A systematic control program is the most reliable method of worming. This type of program should include regular cleaning of shelters, runs and equipment, and the use of medications that will remove worms from infected birds.

Many raisers administer worm removers to birds every month. This is usually done with a flock-type worm treatment that can be mixed in the mash. When continued throughout the growing season and also after fall housing, this system is very effective. The cost of the medication is largely offset by the high egg production of a worm clean flock.

Will Wilson for Supreme Court



Austin, July 8—Texas has seen much of Will Wilson of late. The Dallas County District Attorney, who is candidate for the Supreme Court, has campaigned vigorously in West and South Texas since he announced his candidacy in Austin the latter part of May. His plans include visits to East Texas and other sections of the state during his campaign tour.

"Justice is the only thing that a candidate for the Texas Supreme Court can promise voters," Wilson stated in addressing the Army and Navy Association in San Antonio Thursday. "I pledge, if elected, to add my efforts to those of the present court, toward this end."

Wilson, the only veteran in the race, returned from World War II service in the Southwest Pacific with a desire to enter public life. He was elected Dallas County District Attorney in a five-man race in 1946, and re-elected two years later by an overwhelming majority.

His drive in Dallas against organized crime has attracted national attention. Formerly the president of the District and County Attorney's association of Texas, Wilson is now chairman of the Texas Bar Association's steering committee to modernize the State Penal Code.

Wilson attended the Dallas public schools, and then earned a science degree from Oklahoma University and a law degree from Southern Methodist, working as a roughneck in the oil fields to finance his education.

During the war he saw active combat on Biak and Luzon. As commanding officer of the 465th Field Artillery Battalion on Northern Luzon, he accepted the surrender of the forces of General Yamashita, infamous Japanese military leader. During his service with the Army, he earned a bronze star for voluntary patrol behind Japanese lines.

Before the war, Wilson was trial lawyer for a large Dallas civil law firm, later resigning to become Assistant Attorney General under Gerald Mann and Grover Sellers. He specialized in trial work for the state, successfully prosecuting cases involving millions of dollars of endowment

funds for the public schools. "To the Supreme Court, I will bring the vigor of my middle years and the experience of a court room attorney, fresh from the trial of contested lawsuits for the people of Texas," says Wilson. "I hope to carry on the tradition of fine public service to which Judge Taylor has devoted his life." It is retiring Judge W. M. Taylor's place on the Supreme Court bench which Wilson seeks.

McDonald, has definite views on a national farm program.

He believes in a two price system for marketing agricultural products—a full parity price for that portion allotted for consumption in the United States, this allotment to be made in units such as bales, bushels or pounds and NOT in acres—and the farmer left free to produce in excess of American needs for sale in foreign markets at world market prices.

McDonald believes that each commodity should finance its own program.

"Cotton should finance the cotton program," McDonald explained, "wheat the wheat program, etc., making it unnecessary for Congress to appropriate funds out of the Federal treasury."

"This program would enable the American farmer to have purchasing power with which to live by American standards and, at the same time, place him in the best position to maintain and extend foreign markets for our agricultural products, which is so essential for full employment on the farm and in the factory."

"Any farm program that does not benefit other essential American groups as it does the farmer himself will fail and should fail," according to the Texas Commissioner of Agriculture.

"Statistics show that only with a prosperous agriculture can we have national prosperity and full employment," McDonald stated.

to pay its obligations. In fact, only a transfer of \$26,000 from the Building Fund to the General Fund has prevented the county from issuing discount warrants BEFORE ELECTION DAY!

As next County Judge, I will curtail expenses, yet maintain operating efficiency, and I will collect the proper fees of my office and see that the other public officials do the same. I will make every effort to restore the financial stability of the County.

Any legislation, if and when passed, permitting the counties to retain part of the 2 per cent tax on transfer of motor vehicles will furnish some new money for Wichita, but it alone will not be sufficient. The bill passed by the last Legislature (and later vetoed) permitting such action was sponsored by, written by, and presented to the Legislature by the STATE TAX-ASSESSORS and COLLECTORS ASSOCIATION—of which a county judge is NOT a member! As your County Attorney, I also wrote letters to other County Attorneys encouraging them to support the bill, and as next County Judge, will continue to assist them in every way possible, but I will NOT attempt to take credit for their work!

Harmony

For the last four years, it has been my duty to represent Wichita County in all tax, lunacy, juvenile, injunctions, civil and criminal cases. I have worked in close harmony with the Juvenile Board, District Courts, County Court and Commissioners Court, and if you promote me to County Judge, I will continue to work with them for the best interest of Wichita County. I will NOT permit nor lead the Commissioners Court into any political fight with any of the public officials for I realize that unless there is peace and harmony in our courthouse, there can be no progress for Wichita County!

Hospital

Wichita County is fast becoming a great medical center, and rightly so. We are blessed with a group of aggressive, civic minded doctors, who have diligently and faithfully worked to carry out the will of the people. It is they, together with the hospital board, interested citizens, state and federal agencies, who have finally succeeded in getting the hospital started in spite of four years unnecessary delay. Neither should we forget the generous donations made by interested citizens who came to the rescue when during such delay the interest rate of such bonds increased and the bonding company required a bonus before purchasing the bonds. Thanks should also be given to those who have donated and will donate to replace the \$40,000.00 taken from the County

Building Fund to pay for the equipment put back into the building contract in order to secure Federal Funds. It is most unfortunate that the hospital was not built in 1946 or 1947—or even in 1948, before building costs went up so much! Had the hospital been built then the seriously injured woman who could not be admitted recently, could have had a room—and so could hundreds of other sick people the last four years!

Beer Taverns

As your County Attorney, whenever honky-tonks have applied for beer permits, I have secured the witnesses, presented the cases, and contested the honky-tonks in the County Court, District Courts and in the Court of Civil Appeals. In each case that went up on appeal, the beer application was heard by FIVE different judges, and I was able to win a victory over the honky-tonks every time! Any credit for a victory over honky-tonks should NOT go to any one of the five judges, but to the one that did the fighting!

As your County Attorney, I have represented Wichita County in all the local courts and appellate courts. Of all Wichita County cases, both civil and criminal, tried during my two terms, only one has been reversed by a higher court.

Court Charges

In the trial of each jury case, after the attorneys have presented all the witnesses, the judge then reads to the jury the law and its application to that case. This is called the "Judge's Charge to the Jury." During the last four years, I have prepared EVERY charge to the jury given by the Judge in County Court. With my legal training and experience in the trial of cases, together with the experience in preparing the court's charge for the present Judge, I know that I can and will make you a good trial Judge.

As next County Judge, I will enforce the law with fairness, justice and equality to all persons. Every citizen that comes to see me will be treated with courtesy, consideration and respect, and every effort will be made to solve the problems that citizen presents. In enforcing the law, I will not take into consideration any financial, social or other position of the parties, but will decide each case on its own merits—according to the law and the evidence.

Juvenile Cases

I have taken a personal interest in every juvenile case and I have prepared and presented each such case to our courts—without extra pay. As next County Judge, I will be a member of the Juvenile Board and receive twelve hundred dollars a year for such service. I certainly feel that a County Judge should have a real interest in this important work and should attend more than seven meetings of the Board in eighteen months! As next County Judge, I will attend every

meeting of the Board. I will also provide decent sanitary conditions in the Juvenile ward of the Jail! Having worked with boys at the Boys Club for years, having represented hundreds in our courts—and being the father of two children—I feel that I have a definite contribution to make to the work of the Juvenile Board in recognizing, understanding, and working out the problems of children.

I have always worked for everything I ever received. I worked hard to get the job of County Attorney, and I worked hard after elected. I have worked hard for this promotion, and I expect to work hard as the next County Judge. Your vote for Ray Martin will be appreciated."

Other committees reported their affairs in good shape, everything ready for the shove-off next Tuesday.

Another meeting of the various rodeo committees is called for Monday night, July 17, at the Chamber of Commerce office at 7:30 P. M. This is the last chance to yell for help if you need it. Be present.

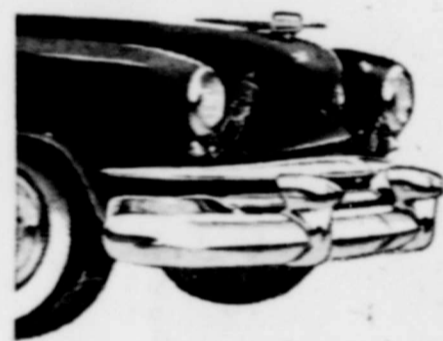

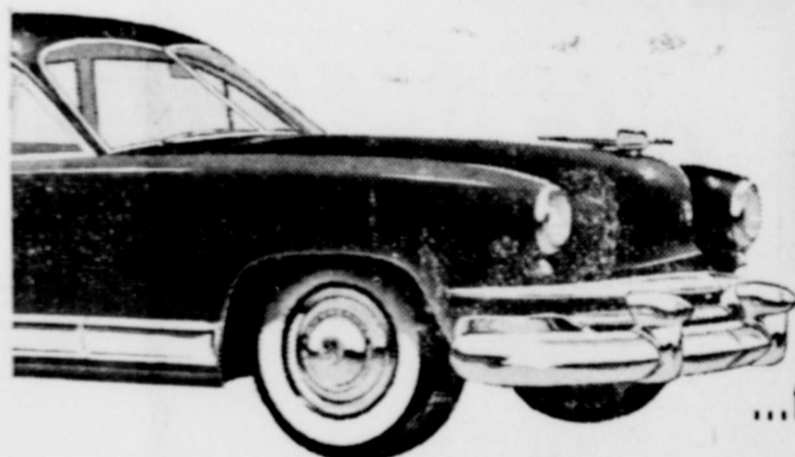

of the First Baptist Church. I am a graduate of high school, a graduate of a Business college, have had a post graduate course in mechanical engineering, a post graduate course in electrical engineering, have completed a course in refrigeration and air conditioning, hold a diploma in the completion of a full course in Electronics and associated subjects, have served our government in both wars for long periods and served as chairman of the Civil Service Commission for the Pyote Army Air Base.

I was employed by a large oil company for years, doing mechanical and construction work for them. I am pleased to have served them and still enjoy their confidence. For the past two and one-half years I have been in the construction business, serving many of my friends in a very satisfactory way. I employ several men in my business, and have spent some fifty thousand dollars in labor and material in our city and immediate communities in the past 18 months.

I feel that the county commissioner is a public servant of the citizens of his precinct and should at all times conduct himself and his business in an intelligent manner, co-operating with other elective officials in their official duties to the public. He should administer the precinct affairs to the best interests of all concerned regardless of any personal feelings that might develop.

He should give consideration to school and mail routes. He should be in daily personal contact with his employees, to render any assistance that may be needed in the maintenance and in the construction of new roads and other problems that are sure to arise.

May I direct your attention to these facts about our present Commissioner, Mr. Holman. In his announcement for commissioner, July, 1948, he states that he had built 33 bridges and had under construction the improvements of mail and bus routes. In his July, 1950 announcement he has made the same remarks—33 bridges and mail and bus route improvements. Does he intend to improve these routes?

In the year 1949 he spent \$850.40 of county funds paid in by you and me trying to take over the duties assigned to our Sheriff, but the Supreme Court gave the decision to the Sheriff. Now why did he take this action? Was it to humiliate the Sheriff for any personal reason? I believe so. Will you ask him or the Sheriff?

You will note in election years that he begins his long stays standing on the street corners of Burk just to contact people at our expense for preparation of his campaign. Then some six weeks or two months before election he begins to cut weeds along the highways. He starts grading and dragging all the places where he thinks a vote can be had and he generally has some graded roads that he will oil down and prepare for blacktop and goes around telling the voters that he would like to stay another term to finish his projects. He started a truck with a couple of men hauling dirt and rock in the people's driveways some weeks ago. What is his idea in doing all this work at this time? I think that he is using the county funds for the purpose of getting votes while he contends that it is a big project of his.

Now can't you see that if he could get off the streets and apply himself to his job month after month that he would keep the roads in better shape and would not have to rush around like mad just a few weeks of his term? And he thinks that he has you people fooled. Here are his words: "I would not tell the people anything if I were you. They don't know anything."

I am of the opinion that you good people will go to the polls July 22 and elect a new commissioner.

I have supplied Mr. Holman with a copy of any letters that I have mailed to you and have asked him to debate his policies with me over the radio. He has not been courteous enough to reply at this date.

I want to sincerely thank every one for their respect, encouragement and promises of influence and vote. Try me for a term and if my conduct is such that must be rightfully criticized in performing my duties as your commissioner, I will not ask for more than one term.

eral medals, among them the Silver Star.

He is a member of the First Baptist Church, Masonic Lodge 1158, Eastern Star Chapter 237, The American Legion, Disabled American Veterans, and Veterans of Foreign Wars.

While serving with the 51st Legislature, he was 2nd Vice-Chairman of the Eleemosynary and Reformatory Institutions Committee, and was a member of the Public Health, Game and Fisheries, Livestock and Stock Raising, and Conservation and Reclamation committees.

His platform is as follows: "During my first campaign two years ago, I emphasized that I would do my best to fight for fair legislation for ALL. I can stand firm and proud on that same platform again this year.

Against overwhelming opposition, I succeeded in amending the Gilmer-Akin Bill 115 by requiring the members of the new elective state board of education to run for office at the same time as other state officers. This amendment will enable the people of Texas to choose their board members instead of some small minority group controlling special elections. I feel that in passing the Gilmer-Akin Bills, the 51st Legislature gave to Texas the best educational system it has ever had.

I introduced a Life Preserver Bill in the special session that I feel confident would have passed had there been ample time. It would require all rent boats on any lake in the State of Texas to be equipped with life preservers.

At present, the Game, Fish, and Oyster Commission has six members appointed at large. My bill which passed the House but was kept bottled up in the Senate, would create a nine-member commission with appointments to be made from nine geographical districts. The bill will give equal representation, particularly to North Texas where a great number of lakes are located.

I also was a co-author of a bill requiring officials holding offices with more than two-year terms to resign before running for another office. The bill passed the House, but died in the Senate, where members would have been affected by the bill. If this bill had passed, it would help to purify our elections. There would be no four- or six-year office holders taking state pay while running for another office.

Another of my bills which was killed in committee would have raised from \$250 to \$900 the amount of income each recipient of old age assistance may accept annually without becoming ineligible for state aid. I am for, and have fought for raising the ceiling on old age assistance. Along with the dire needs of our old age pensioners, let's not forget our deaf and dumb children and the blind people of our State. I intend to further my legislation that will help and protect them.

Beginning in January, 1951, the State Ad Valorem tax will be non-existent. Taxes will have to be raised by some method. I believe the two main tax issues in the coming legislative session will be a natural gas tax and a state general sales tax. I am against a state general sales tax. However, I fought all last session to pass a natural gas tax bill. Natural gas is virtually controlled by several large companies over the State. Over half of our natural gas produced is shipped out of Texas. Why can't a tax be placed upon natural gas after the company gets it and before it is used? By doing this, states outside of Texas will bring in more revenue. A small equalization tax should also be placed on timber, salt, limestone, fuller's earth, and other natural resources which are now tax free.

We must equalize our present tax structure and let each pay its prorata share. Our State Departments should be streamlined to give more efficiency and economy. Our Texas Legislature has a job of conserving and economizing that it has never faced before in order to protect our future generations.

I am proud of my record and ask that you compare it with the record of any Representative or Senator of the 51st Legislature. I, your hitch-hiking Representative, am still campaigning the "hard way" to keep myself free of all obligations. Because I am afoot, I have been unable to meet everyone. Please consider this a personal request for your support."

T. B. X-ray Unit Coming To Burk July 20th and 21st

Every person 15 years of age and older is urged to go to the free X-ray mobile unit to be stationed in Burkburnett on next Thursday and Friday, July 20 and 21. The unit will be parked in front of Helvey's Drug Store for the two-day survey.

Mrs. Daniel T. Sheriff is chairman of volunteer workers for the period. Six volunteers will be needed for each day.

This X-Ray traveling bus was presented to the Texas Tuberculosis Association by the chapters of Beta Sigma Phi Sorority of Beta Sigma. Through the facilities of this magnanimous gift, the Texas Tuberculosis Association has been able to take approximately 200,000 chest X-rays. These surveys have found many hundreds of cases of tuberculosis and other chest diseases, such as cancer and tumor of the lungs and heart conditions of which the majority of patients were wholly unaware at the time of the X-ray.

Dr. John R. Reagan, President of the Wichita County Medical Society, has made a special appeal to all parents to have chest X-rays and for all parents to see that their baby sitters take advantage of this free service. Dr. Reagan pointed out that "any person at any age can contract and spread tuberculosis."

"Another group of people in the vital public health program," Dr. Reagan continued, "are practical nurses." "Every practical nurse should have periodic chest X-rays at least once a year," he said.

Miss Margaret Hall, Executive Secretary of the Wichita County Tuberculosis Association, will accompany the mobile unit to Burkburnett and will assist Mrs. Sheriff and her workers during the two day stay in this city.

"The X-ray mobile unit," Miss Hall explained, "is capable of taking 500 X-ray pictures a day" and she expressed the hope that every person in Burkburnett would avail themselves of this service.

Miss Hall emphasized that tuberculosis has no early warning symptoms, that only an X-ray could reveal its presence in the lungs. "But," she continued, "if tuberculosis is found in its early stages it is easiest to cure."

Mrs. Sheriff, vice-president of the Wichita County Tuberculosis Association, asks that all club groups, religious, civic, cultural and other, take advantage of this public health service, so vital to our lives and happiness.

"My opponent has bought all the billboards," said Dickson, and "I can only offer my services on the basis of my qualifications. My 21 years experience as a trial lawyer, representing small, independent clients and the state in Texas civil courts, I believe have fitted me for service on the highest civil court."

Three attorneys general appointed Dickson to head departments. Jerry Mann made him chief of the land division. Grover Sellers made him head of the oil and gas division. Price Daniel made him First Assistant Attorney General.

"As first assistant, I issued more than 100 opinions to state departments, none of which has ever been overruled," said Dickson. "This is identical with the work done by judges on the Supreme Court. I urge you to compare the qualifications of all candidates, and have confidence in your judgment."

Dickson resigned as Attorney General Price Daniel's first assistant last year in order to make the race on his own time. He asked the people to get the facts about whether other candidates have been as fair with the taxpayers.

The former president of the San Antonio Bar Association is 46, a deacon in the Christian Church, is married, and has a family of three.

in Wichita County subject to the Democratic Primary. A native of Wichita Falls, McCormick was born September 5, 1921 and attended Wichita Falls public schools. He was graduated from high school and took his pre-law courses in Junior college at Wentworth Military Academy at Lexington, Mo., and received his law degree at Southern Methodist University at Dallas August 27, 1947, where he was a member of Kappa Sigma Fraternity and Delta Theta Phi, honorary legal fraternity. He was married following the completion of his education.

McCormick, son of a veteran Texas peace officer, became clerk to the County Attorney October 1, 1947, and was promoted to the post of Assistant County Attorney after he was admitted to the Bar December 16, 1947. He has taken an active part in the prosecution of cases filed in his office and a particular interest in the handling of juvenile cases. His father is the Juvenile Officer in charge of investigation and handling of juvenile matters in Wichita Falls and Wichita County.

McCormick, whose education was interrupted by the war, went from Wentworth Military Academy, where he was an honor student, to the Army Air Force in World War Two to serve as a combat pilot in B-29's in the Pacific. He is a member of the Floral Heights Methodist Church and a baritone soloist there and in other churches in Wichita Falls. A past president of the Blackstone Club, which he helped organize for young lawyers, McCormick now is president of the Wichita Falls Lions Club.

He is also a member of the Masonic Lodge, the Wichita Falls Commandry, the Maskat Shrine Temple, Knights of Pythias, Elks Club, the American Legion, and the Wichita Falls Chamber of Commerce, and as a licensed attorney is a member of the Wichita County Bar Association, the Texas State Bar Association, the American Bar Association, and the Federal Bar Association. He is a director in the Southwestern Legal Foundation of Dallas, and is a reserve legal officer for Sheppard Air Force Base.

A frequent parade marshal in Wichita Falls because of his expert horsemanship and a member of the Maskat Shrine Mounted Patrol, McCormick headed the 1949 Covered Wagon campaign for the sale of U. S. Savings Bonds in Wichita County.

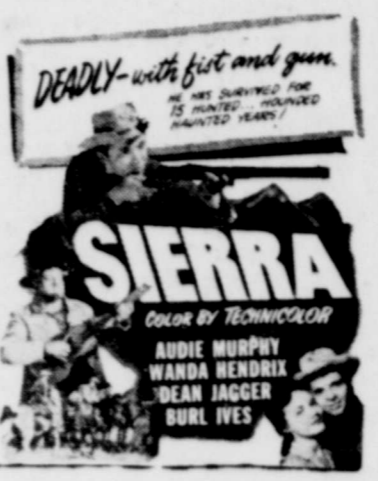

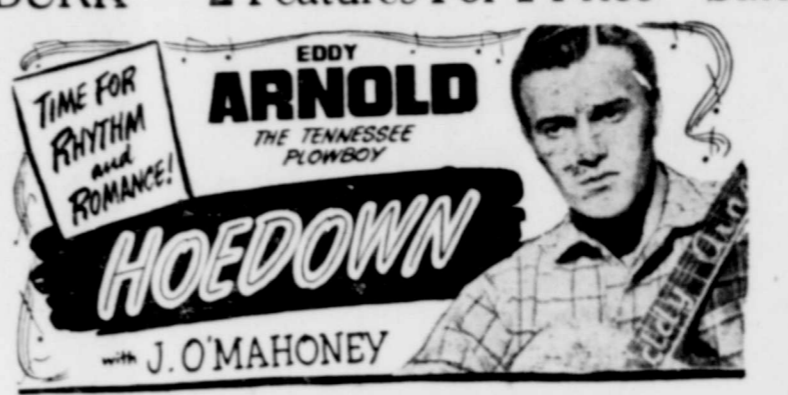

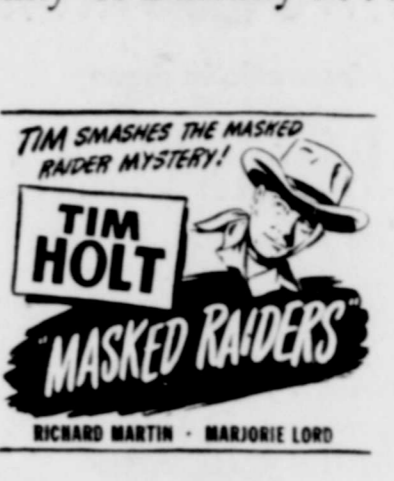

win passage of this measure at the 1951 regular session of the legislature. The act would bring a substantial amount of money to this county annually.

Hospital Program
High on the county judge's agenda has been the urgent need for additional hospital facilities and his unceasing efforts along this line have helped bring about fruition of voters' orders when they approved hospital bonds several years ago.

Judge Tipps went to Austin in June, 1947, when the question of establishing hospital project priorities was considered and since then has made many trips to Dallas and Austin as various problems arose in connection with the hospital program and he has worked out many details of the project.

Construction started last month on the project which will cost approximately \$1,800,000.00 and in which the government is paying half the expense. About two years will be required for completion of the new building and subsequent remodeling of the old hospital.

"I hope Wichita County voters will permit me to remain on my job and complete the work of pushing this project to completion," he declares.

Need for additional hospital space was pointed up a few days ago when a seriously injured woman could not be hospitalized at Wichita General because all space was in use.

Beer Taverns
Calling attention to the fact that Wichita County is the only county in the state which does not have beer taverns and dance halls along the highways, Judge Tipps recalls that this county voted wet a few weeks before he took office.

This presented an immediate problem regarding issuance of retail beer licenses, which must be approved by the county judge. He assumed a policy of limiting such licenses to the fire zones or similar sections of the county's cities, and denied them when sought for roadside locations.

Judge Tipps has been upheld by the higher courts in cases where appeals have been taken from these denials. He has nothing to do with liquor package store licenses, which are issued by the state without his approval.

His policy of seeking to keep beer establishments away from the highways and in downtown, policed areas, "tends to make this county a cleaner, safer place to live and rear your families," Judge Tipps contends.

Juvenile Program
"Wichita County's rate of juvenile delinquency at present is lowest for cities of this size in the nation," the candidate asserts.

"This is in sharp contrast to the period shortly after the war

when we ranked near the top." The county judge and the 3 district judges make up the juvenile board and they have called in various community leaders as law advisors to assist in working out a solution for juvenile problems as the cases arise.

Probate Court
Duties of the county judge include presiding over probate court, which handles estates the value of which runs into millions of dollars, Judge Tipps reminds. The probate court must watch over the interests of widows, orphans and those under other disabilities.

The county judge presides over condemnation case trials. There have been three of these during the administration of Tipps which have been appealed and in each instance his judgment was affirmed by the higher courts.

All misdemeanor cases not tried in justice court are litigated before Judge Tipps. These include drunken driving, theft and swindling under \$50, aggravated assault, morals cases, drunkenness, appeals from city court and others.

In only one criminal case has Judge Tipps been reversed — that was a case in which a Wichitan was assessed eight years in jail and a fine of \$1,000 by a jury on a charge of misdemeanor theft and repetition of offenses.

Commissioners Court
Commissioners Court, of which Judge Tipps is presiding officer, handles affairs of the county which include expenditure of some \$750,000 annually, a matter of prime importance to every citizen.

The court sets the tax rate on a valuation now standing at about \$65,000,000. Commissioners weekly must pass on requests of county officers for additional help, salary increases, new equipment and other expenditures while seeking to stay within a set income.

Besides Judge Tipps, the commissioners court is composed of commissioners from each of the county's four precincts, whose individual precinct problems must be harmonized with welfare of the county as a whole.

Population increases and re-establishment of the air force base have posed problems which the county has had to meet with what revenue was available.

It has been necessary to answer in so far as possible the needs resulting from a near-cessation of building and repair work during the war years.

Tipps was elected secretary-treasurer of West Texas County Judges and Commissioners at their last session and is to serve in that capacity when the group convenes in Wichita Falls some 300 strong next April, a convention brought here at his invitation.

Born on a Denton County farm, Judge Tipps is 39 years of age and married. He has resided in Wichita Falls since

1932 and is buying his home at 3210 Glenwood. The judge received his bachelor of laws degree from the University of Texas in 1938 and practiced law here before enlisting for service in World War Two, where he served first in the infantry and later in the air force.

"In announcing my candidacy for re-election I wish to express my deep gratitude to the people for their confidence, support and co-operation in the past," Judge Tipps concludes.

"I earnestly invite the voters of Wichita County to study my record and consider importance of this office before marking their ballots for county judge."

They spent \$100 per running front foot, while the Highway Department spent upwards of \$100,000 on the project. From the property owners standpoint, that is mighty cheap street paving. In most cases, property owners must pay for half the paving cost in front of their property.

Merchants Urged To Stamp Coupons

Every merchant in town who is participating in the "Share the Profit Rodeo Coupons" project is urged to stamp the firm name on the back of each coupon.

If you do not stamp the coupon, you are inconveniencing the customers you give them to. Coupons brought to the C. of C. office to be redeemed for rodeo tickets are not acceptable if they are not stamped. In that event, the customer must try to remember where he got the coupons and return them to the store to be stamped.

Purchasers are also requested to make sure that every coupon they receive is stamped. They are worth one cent each on the purchase of a rodeo ticket and will be redeemable at the C. of C. office up 'til five o'clock Friday night, July 21st.

Coupons are not redeemable anywhere except at the C. of C. office. They may NOT be exchanged at the rodeo ticket box office toward the purchase of tickets. Go to the C. of C. office.
