#### A DAY TO REMEMBER

"Keep the Home Fires Burning" - a poignant World War song - uplifted home front morale while the doughboys fought to make the world free.

Some returned. Others met their final appointment with destiny at Flanders Field. And when the last blows were struck and the papers signed - Armistice Day was proclaimed by President Woodrow Wilson.

The day not only honors the war dead, but also reminds us of the horrors of war. Yet, even the name of the "war to end wars" had to be changed. It became World War I to differentiate it from World War II.

The day was changed to Veterans' Day in order that a grateful nation could pay is respects to veterans of all wars. A national holiday was proclaimed.

Another November 11th approaches. On that morning some people may pause between 11:00 - 11:02 to pay respects to the men and women who paid the supreme sacrifice to keep America free. Others may just forget.

So, let us pause a few seconds to review what President Wilson said in his first Armistice Day proclamations: "To us in America the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service and with gratitude for the victory, both because of the thing from which it has freed us and because of the opportunity it has given America to show her sympathy with peace and justice in the councils of the nations."




