

The Commissioners' Court of Aransas County have a perspective plan of new courthouse and jail which will be on display in several of the business houses in Rockport. This plan shows in detail the complete outlay of the courthouse and jail. I would like to call particular attention to several additions that are compulsory, such as: Quarters for juveniles; cell for the insane; quarters for men and women who serve as jurors (which will possibly be compulsory next year). Our present courthouse does not have these facilities which now creates an emergency for something to be done immediately.

Due to the increased activity in Aransas County, through oil and real estate, your County and District Clerk's Office does not have sufficient room for storage of records or even space to accommodate abstractors. The new perspective plan shows ample room and space to take care of the present congestion as well as future expansion. As the perspective plan shows the County and District Clerk's Office will be a complete air conditioned vault, 30x60, modernized to serve the public and preserve all records in the proper manner.

Your present tax allocation has been so designed, creating enough money to pay for this bond issue without an increase in taxes. The 25c levy from permanent improvement will be used. This 25c levy is taken from the 80c operating tax that is constitutional for all counties. This means there will absolutely not be an increase in your taxes.



On January 31, 1952, near Crockett, Houston County, the Texas Game and Fish Commission released the first of one hundred wild deer in the county's piney woods.
