In the District Attorney's race Bird Old Jr. of Mt. Pleasant, with a total of 7,724 votes, defeated James R. Cornelius Jr. of Jefferson, who polled a total of 7,124 votes.

Wright Patman, holding a coun-604. y lead of 3,592 to 1,831 over Joe McCasland for Congress, pulled far away throughout the district and won by a decisive victory.

Other races of interest in the county included the contest between Hollie Banks, W. D. (Duffy) Moore and Leo Wilson for 112, Dickson 513. Commissioner, Precinct 1. Banks won a majority over both his berson 3,943, Laird 1,166. opponents.

In the sheriff's race, Lloyd Sinclair, lacked 35 votes defeating L. D. (Jabo) Landers and Motsy Gaddis.

For tax assessor-collector, Jimmie Barrett held a wide lead over Smedley 2,270, Keenan 2,300. both Lynch Harper and Charles Stephenson but failed to get a majority sufficient to close out the campaign.

Edwin White and Homer Bowden, for district clerk, won commanding leads in a field of six candidates that include Chas. W. Robinson, D. C. Morgan, J. O. Milstead and Walter G. Jackson. R. W. (Humphrey) Jones and

Harry Taylor won places in the run-off for County Judge in another six-man field that included Jack Cross, Thomas J. (Jack) Hood, R. H. (Bob) Gregory and Ad Rogers. The fight was unusually stiff between Jones, Taylor, Hood and Cross.

THE ACTION OF BAPTISM

Often today we hear religious people talk about modes of baptism, and in the religious world we find sprinkling, pouring, affusion, and immersion all recognized and accepted by different peoples as baptism. In (Eph. 4:5) Paul declares that "there is one baptism." Is it true that this baptism can be performed in any, or all, of the aforementioned four ways?

The English word "baptize" is simply the Greek word "baptizo" spelled with English letters, and any Greek scholar of renown will declare that the word "baptizo" means: to dip, to plunge, to submerge, to overwhelm, or to cover up. Baptizo cannot be properly translated to mean anything else. Hence, one cannot properly speak of modes of baptism, any more than one can properly speak of shades of white. Baptism is always a dipping, a plunging, a submerging, an overwhelming, a covering up. Anything other than this would not, and could not, be baptism. But, let us notice a few Bible examples in which the action of baptim is set forth.

When Jesus was baptized of John in the Jordan (Mt. 3:13-17) it is said that he "went up straightway out of the water." Now I raise the question: "Could one come up straightway out of something without first going down into it?" The implication of this passage, then, is that Jesus, in being baptized, went down into the water. When Philip baptzed the eunuch (Acts 8:38) "they went down both into the water BOTH Philip and the eunuch; and he baptized him." Twice in this passage it is said that both the candidate and the administrator went down into the water. Surely, the Lord wanted us to see that the eunuch did not received either sprinkling, pouring, or affusion, but that he was immersed.

By inspiration, baptism is declared to be a burial. "Therefore we are buried with Him by baptism into death . . . (Rom. 6:4). "Buried with Him in baptism, wherein also ye are risen with Him through faith of the operation of God, who hath raised Him from the dead" (Col. 2:12).

Friends, when the Bible so plainly sets baptism forth as a burial, how can honest people continue the practice of sprinkling, pouring, and affusion; and say they are just as acceptable as immersion?

Remember, it is the truth that makes men free (Jno. 8:32). This is offered that we may see the truth concerning the action of baptism.
