

## TO THE VOTERS OF THE FIRST CONGRESSIONAL **DISTRICT OF TEXAS:**

Sam B. Hall, Jr., 38 year old Marshall attorney, has announced as a candidate for Congress from the First Congressional District. Mr. Hall is making the race as a conservative Democrat, pledged to fight for the preservation of private enterprise and the destruction of the Communist conspiracy in this country.

He also is the nephew of the late Judge Reuben A. Hall, retired Chief Justice of the Court of Civil Appeals, Sixth Supreme Judicial District, Texarkana.

His wife is Madeleine Segal Hall, formerly of Jefferson, Texas. They have three daughters, aged 12, 10 and 3.





Mr. Hall is a member of the Burleson Street Church of Christ where he teaches an intermediate Sunday School class. He is a past member of the Board of Directors of the East Texas Area Council, Boy Scouts of America. He is a member of the American Legion.

At one time he served as president of the Marshall Kiwanis Club and is still an active member of that organization. He is also past Lieutenant Governor, Division Thirteen, Texas-Oklahoma District Kiwanis International.

He has held regional, state and national offices in the Junior Chamber of Commerce. He is past president of the Marshall Jaycees, past vice president of the Texas Jaycees, and past National Director of the United States Chamber of Commerce from Texas. He served three times as Emcee for the annual banquet honoring young Texans, sponsored annually by the Texas Junior Chamber of Commerce.

His legal activities include membership in the American Bar Association and the Texas Bar Association. He is past vice president of the Texas Junior Bar Association and past president of the Harrison County Bar Association.

Hall states that his opponent has held public office continuously for 41 years, the last 33 having been spent in Congress. He pointed out further that he does not believe that one man should perpetuate himself in office, thereby depriving young men of the right and opportunity of serving their country. Hall further pointed out that the present encumbent is eligible to draw approximately \$18,000 per year as a pension, which the Congressmen voted themselves several years ago.

Hall's platform reflects his grass-roots, conservative political philosophy. He has promised to lend vigorous support to "any worthwhile program, economically and materially, that has for its purpose the defeat and stamping out of Communism."

He is opposed to federal aid to education and to Socialized Medicine in any form though he favors a common sense approach to the problem of medical aid to the aged. He favors a systematic plan for reducing the national debt and believes that Treasury borrow-



ing, commonly called "Back Door Spending," should be stopped immediately.

He believes a Supreme Court Justice should have at least ten years prior judicial experience on a State Appellate Court or as a Federal Judge before he is eligible to serve on the U.S. Supreme Court. He believes, also, that a Supreme Court Justice should be required to taken an oath to support the U.S. Constitute as a pre-requisite to being allowed to sit on that court.

Other highlights of his platform call for:

A reversal of the runway trend toward centralization of power and authority in Washington which results in heavier tax burdens at all levels of government and the threat of ultimate nationalization of vital industries.

A sweeping and thorough Congressional investigation of the State Department from top to bottom along with the renovation of the program of internal security to free the government of infiltration by subversive agents.

Retention of the Connally Amendment so that the United States will never be subject to the jurisdiction of a World Court on any local or domestic matter.

Withdrawal from the United Nations if Red China is admitted or if member nations fail to pay their indebtedness and pro rata costs of U. N. operations.

A system of national defense second to none in the world.

Mr. Hall has drawn up a "Statement of Principles" which, he says, will guide him in serving the public.

According to his code the greatest of all values is the freedom of the individual to use and develop his God-given talents and free will.

He holds that "liberty and individual and economic freedom are indivisible and none can long exist without the other. The purpose of government is to protect these freedoms through the administration of justice, preserve internal law and order and provide for the national defense. When any government ventures beyond these limits it acquires power which tends to diminish our freedoms and transgresses upon our liberties. (Paid Political Adv.)
