The City of Friona is very pleased to officially announce that daycare for residents is just around the corner. We have received funding to renovate the Louise Wilson Girl Scout Hut donated to the city earlier in the year, and a local operator, Happy Tribe Academy, has applied to run the daycare. The tentative opening date will be in September 2023.

The FEDC has opened its Storefront Improvement grant program to the entire city as of April. This will allow all businesses in the city limits to apply for up to \$1,500 in matching money to upgrade your business storefront with signage or other improvements. Details and an application can be found at www.cityoffriona.com/ fedc-loan-program, or by visiting the Chamber office.

Local elections are coming up soon, on Saturday, May 6th. This year there will be no city election, but the

city is working with the school district and the hospital district to manage their respective elections. Early voting will start Monday, April 24th. Check the newspaper for local election instructions and polling locations.



Even so, two or three sizeable shocks pop up each year, which cause confined upheaval up to 5.5 on the Richter Scale.







#### Pigs in a Blanket

Kids always love pigs in a blanket, but if adults are honest, they like them, too. April 24th is the perfect day for this quick treat since it is National Pigs in a Blanket Day. This recipe takes these pigs in a blanket up a notch with garlic butter brushed on the outside. Sounds delicious.

#### Pigs in a Blanket

#### **Ingredients**

- 1 tube (8 ounces) crescent roll dough 24 links cocktail-sized sausages
- 1 large egg, beaten
- Garlic Butter (optional but recommended) 2 tablespoons unsalted butter, melted
- 1 teaspoon garlic powder
- 1 teaspoon fresh parsley, chopped
- 1/8 teaspoon ground black pepper

#### **Instructions**

Preheat oven to 375°F and line a large baking sheet with parchment paper. Unroll the crescent roll dough onto a cutting board. Using a pizza cutter, cut the rolled-out dough in half lengthwise. Then, cut each rectangle of dough into 12, 2-inch strips. You will need a total of 24 strips of dough. Place one sausage onto each strip of dough. Tightly roll the sausage link in the dough until it is completely wrapped. Place the doughwrapped sausage links onto the baking sheet, spaced about 2 inches apart. Use a pastry brush to brush the outside of each with the beaten egg. Bake for 12-15 minutes\*, or until the dough is golden brown. While the wrapped sausage links are baking, mix together the garlic butter. In a small bowl, mix together the melted butter, garlic powder, parsley, and pepper. Brush over the baked pigs in a blanket. Serve warm with ketchup and mustard for dipping.

I have a new greatnephew, born last week.


My nephew and his wife chose a blend of history and literature and faith to gift their firstborn on his birth certificate. We will call him Teddy.

### Gas prices rising


Average gasoline prices in Texas have rose 12.5 cents in the last week, averaging \$3.35 per gallon, according to GasBuddy's survey of 13,114 stations in Texas. Prices in Texas are 33.8 cents per gallon higher than a month ago and stand 33.6 cents per gallon lower than a year ago. The lowest price in Texas was \$2.78while the highest was \$4.29 per gallon.

The national average price of gasoline rose 7.6 cents in the last week, averaging \$3.65 per gallon. The national average is up 22.1 cents per gallon from a month ago and stands 41.2 cents per gallon lower than a year ago. The national average price of diesel has fallen 0.3 cents in the last week and stands at \$4.15 per gallon.

"With oil prices touching their highest level of 2023 at nearly \$83 per barrel, the national average price of gasoline has continued to inch higher, with 45 of the nation's 50 states seeing prices rise over the last week. While the rising price of oil is likely the largest factor in rising gas prices, seasonal impacts continue to also exert pressure on prices," said Patrick De Haan, head of petroleum analysis at GasBuddy.

De Haan continued, "With the Northeast making the final step in the transition to summer gasoline this week, states in that region should expect a sharp rise in gasoline prices over the next week or two. Every other region has already seen the final step in the transition occur, so while other areas will see prices continue to slowly rise, the Northeast is likely to see a pretty hefty jump of 15-40 cents per gallon soon. Oil prices remain a wildcard, but we're likely a few weeks away from seeing the national average peak. Whether it hits \$4 per gallon or not is still perhaps a 50/50 chance."

GasBuddy data is compiled from more than 11 million weekly price reports covering over 150,000 gas stations across the country.

### **Set for Success**

Being successful in life is what you want for yourself, your kids, your grandkids, family, friends, our city, our state and our nation, but the big mystery often comes back to how do you attain success, or how do you even define what success really is? If you look at the world's metric for success you will be on an ever changing bar that raises and lowers depending on the cultural and business currents of the day. On the other hand, if your idea of success is to one day hear Jesus say "Well done, good and faithful servant," then you have a mark you can aim for with your life.

Deuteronomy 1 is the beginning of Moses' second giving of the law of God before the Israelites went into the Promised Land. As the book begins recounting the nations history, one is reminded of how God had set his people up for success. God gave them abundant protection and provision for their 40 year journey in the wilderness in providing food, clothing that didn't wear out, strong leadership and much more. Beyond this, God also provided clear direction for the future in verses 6-8. ### Friona to receive \$50,013.59 tax allocation payment for April 2023

Texas Comptroller Glenn Hegar announced last week that he will send cities, coun-

ties, transit systems, and special purpose districts \$977.2 million in local sales tax allocations for

April. This amount is 12.8 percent more than the allocations sent out in April 2022. Cities will receive \$615 million, transit systems will get \$210.6 million, counties will get \$61 million, and special purpose districts will receive \$90.5 million. The allocations are based on sales made in February by businesses that report tax monthly.

The City of Friona will receive \$50,013.59 in sales tax allocation for the month of April. This payment is a 15.45% from decrease \$59,154.98 received in April of 2022. For yearto-date 2023, Friona has \$217,655.57 received

which is a 17.22% decrease from the YTD amount of \$262,962.79 received in 2022. The Friona Economic Development Corporation (FEDC) will receive \$12,503.40 of the allocation for its operating budget.

Box 579, Friona, Texas 79035, which operates Cargill Meat Solutions, a complex beef slaughterhouse, has applied to the Texas Commission on Environmental Quality (TCEQ) for a major amendment of TCEQ Permit No. WQ0001350000 to add an emergency holding lagoon. The draft permit authorizes the disposal of process wastewater, utility wastewater, domestic wastewater, and vehicle wash water not to exceed a total flow of 71,300,000 gallons for any 30day period from the facility to the playa lake and an application rate not to exceed 2.8 acre-feet per acre per year via irrigation on a combined area of 2,865 acres of various crops; and the disposal of brine and pickling wastewater at a daily average flow not to exceed 21,000 gallons per day via evaporation. This permit will not authorize a discharge of pollutants into water in the state. TCEQ received this application on September 22, 2022.

The facility is located at 1530 West U.S. Highway 60, near the City of Friona, in Parmer County, Texas 79035. The land application sites are located on various tracts of land approximately 10 miles south of the facility. The facility and land application sites are located in the drainage area of the Upper Prairie Dog Town Fork Red River, in Segment No. 0229 of the Red River Basin. ### **Sales Tax Holiday for Emergency Supplies, April 22-24**

With the severe weather season upon us, Texas Comptroller Glenn Hegar reminds Texans they can purchase certain items tax-free during the state's sales tax holiday for emergency preparation supplies, which begins at 12:01 a.m. on Saturday, April 22, and ends at midnight on Monday, April 24.

"While we can't know in advance when the next flood. tornado or hurricane may strike, we can make sure our families, homes and businesses have the supplies they need to face these and other emergencies," Hegar said. "This tax holiday can help Texans save money while stocking up for emergency situations. Don't wait for disaster to strike. Take the time now to get prepared."

The Comptroller's office estimates shoppers will save nearly \$2 million in state and local sales taxes during the tax holiday, which was approved by the Texas Legislature in 2015.

There's no limit on the number of qualifying items you can purchase. These include: (1) household batteries, fuel containers and flashlights priced less than \$75; (2) hurricane shutters and emergency ladders priced less than \$300; and, (3) portable generators priced less than \$3,000.

For purchases made online, note that delivery, shipping, handling and transportation charges are part of the sales price. Consider these charges when determining whether an emergency preparation supply can be purchased tax-free during the holiday. For example, if you purchase a rescue ladder online for \$299 with a \$10 delivery charge, the total sales price is \$309. Because the total sales price of the ladder is more than \$300, tax is due on the \$309 sales price.

Purchases that do not qualify include: batteries for automobiles, boats and other motorized vehicles; camping stoves and camping supplies; chainsaws; plywood; extension ladders and stepladders; and, tents. A list of emergency preparation supplies that may be purchased tax-free can be found on the Comptroller's website.

different locations. The meeting was adjourned. Punch and cookies were served and Connie gave tours of the book shop.


