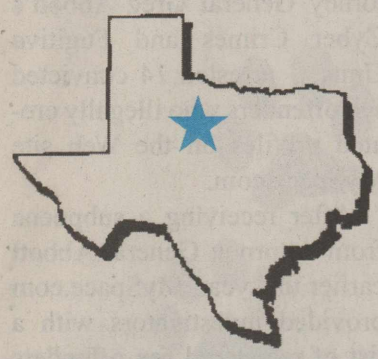

Local VFD And Law Enforcement Football Fundraiser To Be Held Oct. 18

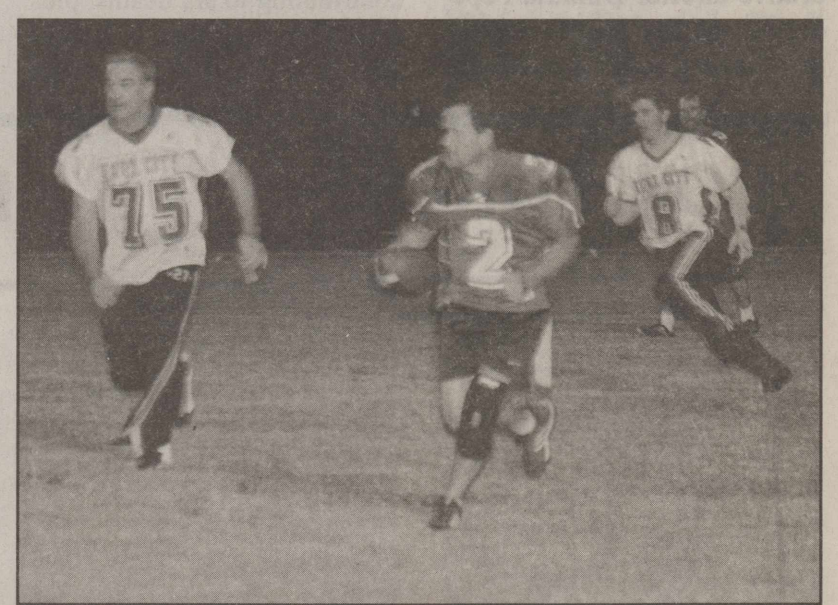
Two football teams, consisting mainly of the Knox City Volunteer Fire Department and area law enforcement officers, will go head to head on Thursday, October 18th in a benefit flag football game.

Funds raised will go toward at least one scholarship for a graduating Knox City senior, and to the Knox County Child Welfare Board. The game will take place at Greyhound Stadium and begin at 7:30 p.m. Admission price is \$2 for adults and \$1 for children.

The Knox City high school band will perform at half-time. A concession stand will be available, selling brown bag hamburger meals. Meals are \$5. Prizes will be awarded to

attendees throughout the game. The new Knox City VFD fire truck will also be on display.

This is not the first flag football fundraiser for the two teams. Last year, the teams met in their first flag football competition to benefit two local families. According to Nick Jimenez, a Texas State Trooper who works Knox County, \$1600 was raised at last year's game. Hopes are to raise at least that much this year so that two \$500 scholarships can be awarded to two 2008 Knox City high school graduates, and the remainder donated to the Knox County Child Welfare Board. Youth Commission Moves Inmates From Troubled Facility

AUSTIN - The Texas Youth Commission removed 197 male inmates confined at the Coke County Juvenile Justice Center in Bronte and transferred them to other facilities on Oct. 2.

Recent audits of the facility, near San Angelo, operated by the private firm GEO Group Inc. raised concerns about the safety and welfare of inmates.

On Oct. 1, TYC acting executive director Dimitria Pope determined the facility was in an advanced state of disrepair,

that programming and rehabilitation efforts were not being pursued, and the overall health and safety of the youth housed there were in jeopardy. She ordered the transfer of the youths.

The state canceled its \$8 million annual contract with GEO Group and an investigation has begun.

Disaster declaration is approved

President George W. Bush on Oct. 3 approved a federal disaster declaration for Bexar, Harris, Jones, Kendall, Medina and Taylor counties to help address severe flooding and wind damage caused by Tropical Storm Erin.

The declaration covers damages incurred Aug. 14-20, when a foot or more of rainfall was recorded in portions of the state, contributing to six deaths, plus road closures, flooded homes and more than 100 high-water

rescues.

Gov. Rick Perry on Oct. 3 said individuals and families who are not covered by insurance can apply for financial assistance, temporary housing, tax relief, legal services, crisis counseling and unemployment assistance.

President vetoes kids' health bill

President Bush on Oct. 3 carried through on his promise to veto legislation he said would be too costly and would have made health coverage available to families that are not needy enough.

The federal SCHIP bill was crafted to increase funding for state children's health insurance programs and expand it to cover more families that make too much money to qualify for Medicaid but still cannot afford health insurance.

Funding for SCHIP under the vetoed bill would have to

tailed \$35 billion over five years. The president has an alternative plan that would increase current funding by \$5 billion over five years.

Members of the U.S. House are counting votes to see if there are enough to override Bush's veto.

Texas ranks lowest among the 50 states in making health care available to its poorer citizens.

Texas awards first wind leases

The Texas General Land Office on Oct. 2 awarded the first four bid leases for offshore wind power in U.S. history.

"The Texas Wind Rush is on, and the pioneers are staking their claims," Land Commissioner Jerry Patterson said.

The leases, awarded to Louisiana-based Wind Energy Systems Technology, allow work to begin on the construction of meteorological testing towers

on the tracts.

Once the wind farms are operational, the lessee will pay the state's Permanent School Fund a minimum of \$132 million over the 30-year life of the leases.

Nutrition programs move to TDA

USDA nutrition programs formerly administered by the Texas Health and Human Services Commission moved to the Texas Department of Agriculture effective Oct. 1.

Now the TDA administers the School Breakfast Program and National School Lunch Program for private and faith-based schools, Summer Food Service Program, Special Milk Program, Child and Adult Care Food Program, Food Distribution Program, Commodity Supplemental Food Program and the Texas Commodity Assistance Program.

Online sex offenders are arrested

Investigators with Texas Attorney General Greg Abbott's Cyber Crimes and Fugitive Units arrested 14 convicted sex offenders who illegally created profiles on the Web site MySpace.com.

After receiving a subpoena from Attorney General Abbott earlier this year, MySpace.com provided investigators with a list of registered sex offenders who use the site.

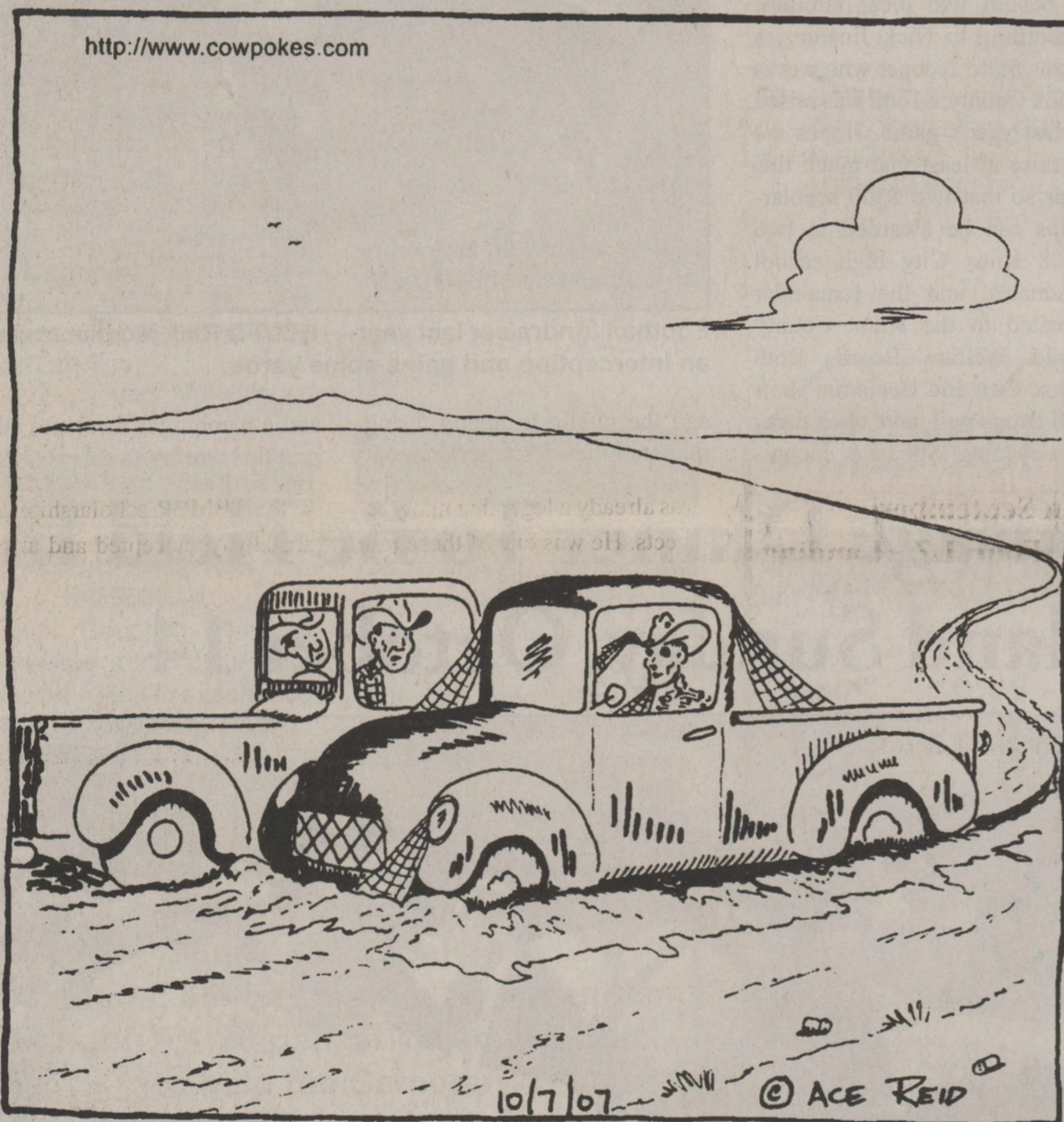

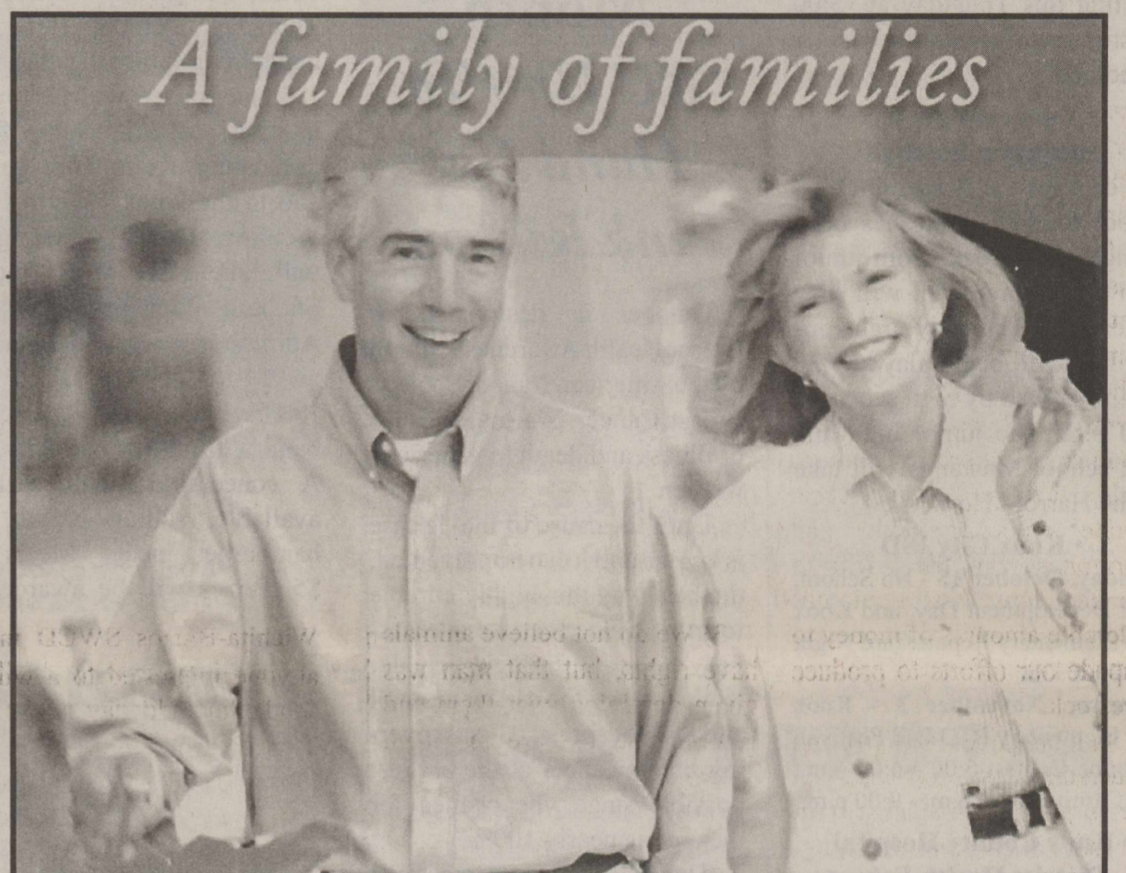
Also, voters may register at county voter registrar's offices, and most libraries, post offices and high schools.

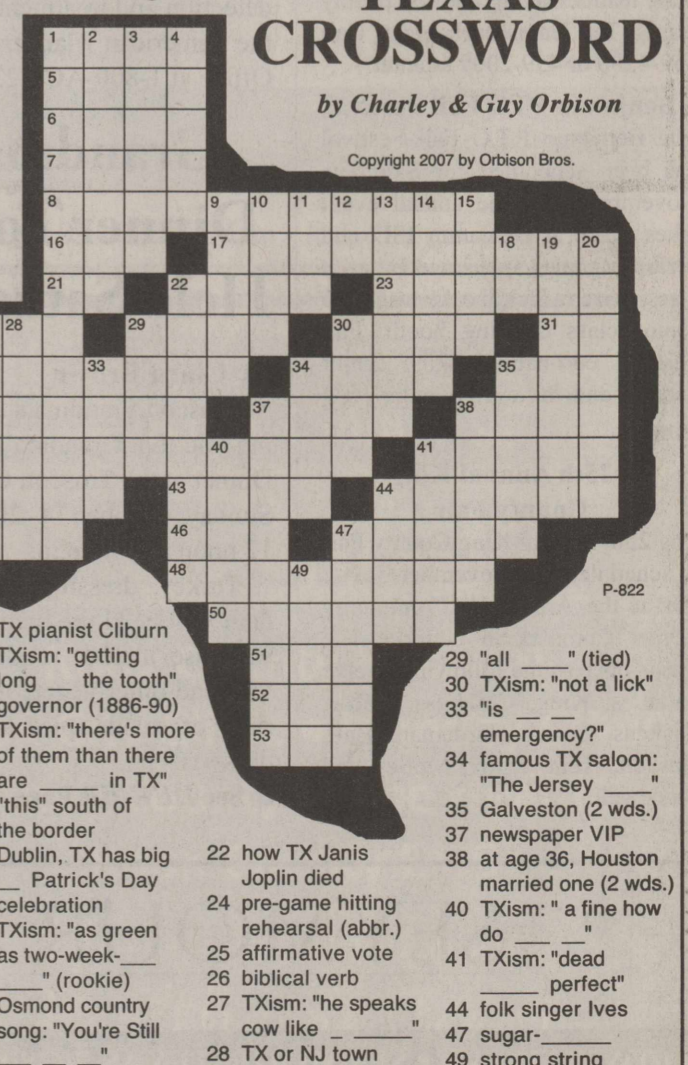

Animal Care Givers Vs. Animal Activists

To: Directors of HSUS, PETA, and the Farm Sanctuary

The first step in engaging an issue is to have the ability to understand your 'opponents' point of view. I have watched your criticisms as we in animal agriculture have become more productive.

Your criticisms range from a distaste of raising chickens in cages to promoting a vegan lifestyle and degrees in between. I have visited with each of you on the telephone and I can't paint you all with the same brush but I can include you in the same picture.

It appears to me you have a distrust for modern agricultural methods; genetically modified foods, hog confinement sheds, beef feedlots, farmed salmon and chemical fertilizer. You mourn the loss of a bucolic family farm lifestyle that no longer exists. You assume, I guess, that animals were treated more humanely 50 years ago. You abhor growth stimulants, veal barns, hog gestation crates. You use buzzwords like chemicals, factory farming, corporate farms, antibiotics and hormones with the intent to demean. And you spend considerable amounts of money to impede our efforts to produce livestock.

So it behooves me to try and understand how and why you are so prejudiced against what we think of as a noble calling. Four contributing factors:

1) You are vegetarians. In itself not a root cause but cer-

tainly a bias...you would be unable to relate to a juicy steak, spareribs, sushi or ice cream.

2) You evaluate 'animal cruelty' on your feelings of how you think a human would react to a procedure or condition, as opposed to our less subjective methods including egg production, pounds of milk, and average daily gain.

3) As best I can tell, none of you have any first-hand knowledge or experience making a living in animal agriculture.

4) You all favor more expensive, less efficient means of livestock production even though you realize they will not allow us to meet the demands of the majority of consumers.

Reciprocally, it would be nice if you understood why we work in a business that is so physically and financially risky:

1) We love it. The animals, the land, the family and the lifestyle is worth all the sacrifice.

Obviously, because it is us who are taking care of them, not you.

2) We take seriously our responsibility to meet the public's demand for the essential commodity; FOOD. Thus our continuing search for the right balance of the animal's well-being and her productivity.

3) We do not believe animals have rights, but that man was given dominion over them and is obligated to care for them properly.

In conclusion, you label us as food terrorists and we call you animal rights lunatics. But I'll concede we have a few lunatics on our side, too!

A series of turnovers at the end of the third quarter clinched the defeat of the Hounds, 66-111.

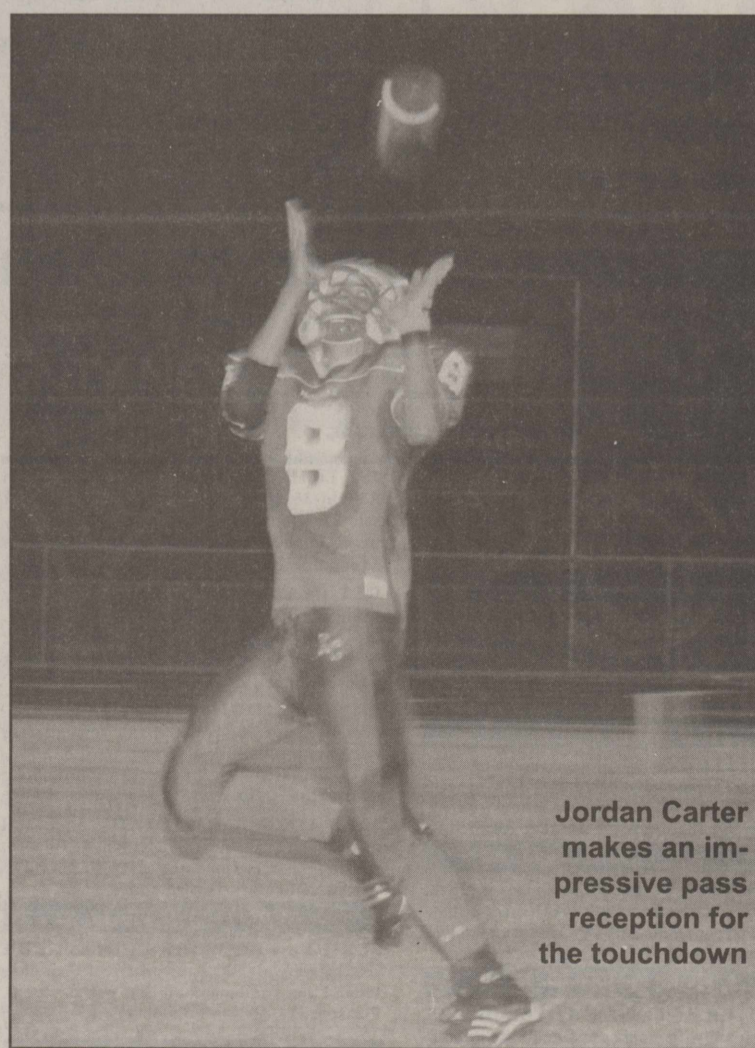
From the opening kick-off to the Bulldogs final touchdown early in the fourth quarter, it was a historic game for both teams.

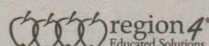

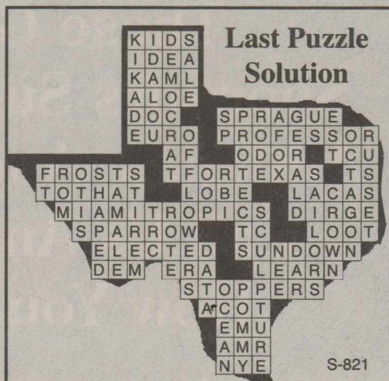
