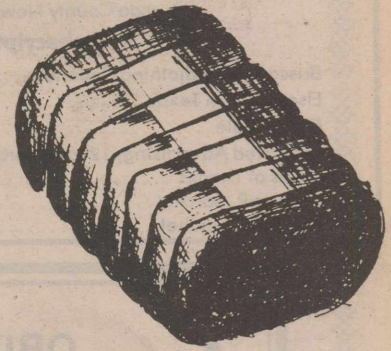
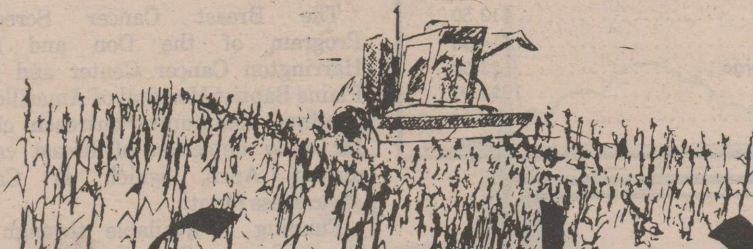

Absentee Voting in Local Elections Set to Start Monday, April 15

Absentee voting in the City of Silverton Officers' Election and the Silverton Independent School District Trustee Election begins Monday, April 15, and continues through Tuesday, April 30. Election day is Saturday, May 4.

City absentee ballots are cast at the City Hall, and school absentee ballots are cast at the Towe Office Building.

Voters in the City of Silverton will be choosing a new mayor and two councilmen. Wayne Nance is listed on the ballot as a candidate for mayor, and candidates for councilman are John Bowman, David Tipton, James Griffin and Ned V. Childress.

Two school trustees are to be elected, and those listed on the ballot are the incumbents, Terry Grimland and Perry Brunson.

farm in the county as owner, tenant or sharecropper is considered a farmer and is eligible to vote. Spouses of eligible farmers also are considered farmers for voting eligibility.

Among other duties, County Committees help determine whether an applicant is eligible for an FmHA farm loan. Two of the three members are elected by county farmers, and the third is appointed by FmHA.

Reorganization of Commodities Distribution Program Is Announced Here This Week

Cotton Farmers' Questions to Get Answers in April 11 Seminar

Questions facing Texas cotton farmers in the '90's—and answers which can add up to better yields, quality and profit—will be examined in a seminar April 11 during the annual trade show and convention of the Texas Cotton Ginners' Association.

The convention annually draws more than 6,000 ginners, producers, officials and others in the industry.

The seminar will be conducted by the Texas Agricultural Extension Service from 1:20 to 4:45 p.m. in the banquet hall of the Memorial Civic Center, in Lubbock, site of the convention. It will conclude the 34th annual meeting of the Plains Cotton Growers, being held in conjunction with the gin show.

Private, commercial and non-commercial pesticide applicators attending the seminar can obtain two of the continuing education units required by the Texas Department of Agriculture.

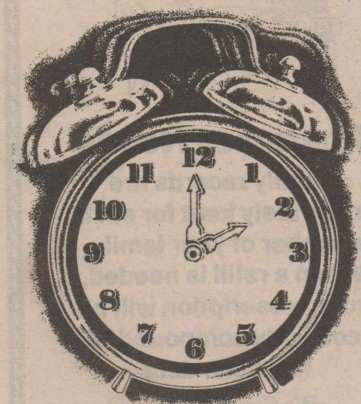
How the new federal farm bill will change the farmer's marketing strategy is one of the key questions the seminar will address. Dr. Carl Anderson, Extension Economist and Cotton Marketing Specialist from College Station, will discuss this.

Steps to prevent nematodes from robbing the farmer of yields and profits will be outlined by Dr. Jim Starr, Associate of Nematology at Texas A&M University.

Seedling diseases and ways to control them will be the topic of Dr. Harold Kaufman, Extension Plant Pathologist. Dr. Jim Leser, Extension Cotton Entomologist, will examine the latest control methods for thrips, aphids and bollworms.

The possible role of genetically engineered cotton plants in pest management will be examined by Dr. Norma Trolinder, a Plant Physiologist with the U. S. Department of Agriculture - Agriculture Research Service.

Dr. James Supak, Extension Cotton Agronomist, will summarize the discussions to conclude the seminar.

DR. CARLOS McLEOD

Funeral services for Dr. Carlos McLeod, 62, a former pastor of the First Baptist Church in Silverton, will be conducted at the First Baptist Church in Dallas at 12:00 p.m. today (Thursday). Grove Hill Funeral Home of Dallas is in charge of arrangements, and burial will be in Grove Hill Memorial Park.

Dr. McLeod, whose home was at 4603 Fallon Place, Dallas, Texas 75227, entered Baylor Hospital in Dallas with chest pains about 9:30 p.m. Monday. He died during an angiogram at 12:30 a.m. Tuesday.

He was Director of Evangelism for the Baptist General Convention of Texas at the time of his death. He was pastor of the local church from July 1961 until January 1964.

The family has requested that memorials be made to the Carlos McLeod Evangelism Fund and these may be sent to the family home in Dallas.

April is Cancer Awareness Month

The Breast Cancer Screening Program of the Don and Sybil Harrington Cancer Center and High Plains Baptist Hospital of Amarillo will continue community outreach clinics for early detection of breast cancer during April, which is Cancer Awareness Month.

Funding is available through the Texas Cancer Council for screening mammography for Texas residents qualifying for financial assistance.

Early detection of breast cancer is the major goal of cancer control for each woman seen in the clinic. The clinic provides low cost screening which includes a breast exam by a Registered Nurse trained in breast cancer detection, teaching of breast self examination, and a mammogram.

Currently, the most effective method known to win the battle against breast cancer is early detection. Early detection is best done by following the guidelines recommended by the American Cancer Society for breast cancer screening for women who have no signs or symptoms of breast cancer. The guidelines include:

1. Learn and perform breast self examination every month.
2. Have a physical examination every year.
3. Have a mammogram according to the recommendations by age.

35 to 40—One baseline mammogram
 40 to 50—A mammogram every one to two years.
 Over 50—Yearly mammograms.

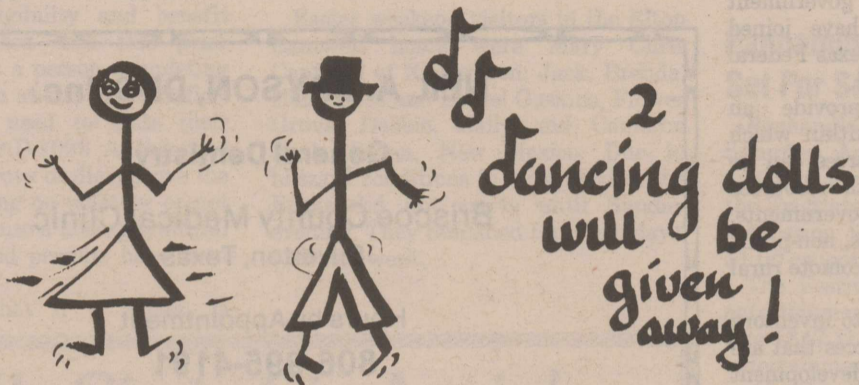

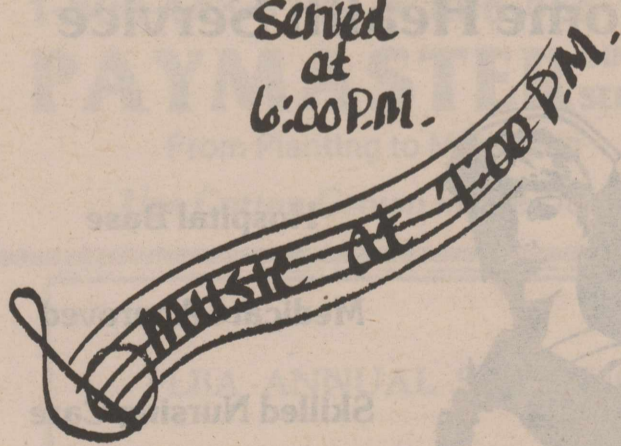

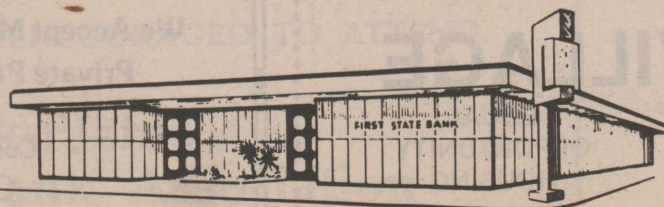

Federal Rural Development To Bring Together Resources

More than fifty representatives from Federal, state and local government and the private sector have joined together to organize the Texas Federal Rural Development Council.

Its purpose is to provide an institutional framework within which Federal government resources can be used, in combination with resources from state and local governments, private sector organizations, non-profit and charitable groups, to promote rural development in Texas.

One of its first tasks is to inventory Federal government resources that are available to address rural development needs, renew and catalogue other resources available to the public, private and non-profit sectors, and organizations involved with rural development.

The council will assess rural economic development problems in various regions of the state and develop a strategy to achieve long-term rural development throughout Texas in collaboration with state, local and private sector organizations.

The Texas Council is one of eight pilot state projects which have organized pursuant to the Presidential Initiative on Rural Development. Stressing the importance of the Initiative on Rural Development, President Bush has observed that:

"We have long recognized the needs of our cities, but now is the time to refocus our attention on the heart of America. Economic redevelopment in rural areas is not just about numbers and statistics and bushels of grain—it's about hardworking, dedicated people who simply need the benefit of sound government policies to help them to help themselves."

Thirty members of the Texas Federal Rural Development Council representing Federal, state and private sector organizations attended the National Rural Economic Development Institute in New Orleans on March 3-7, 1991. The Institute was sponsored by a Federal grant for participants from the eight pilot states.

The program, coordinated by the

University of Wisconsin—Extension Service, was constructed to provide training on the concepts and strategies that lead to successful economic development and an understanding of the diversity in economic conditions and opportunities across rural America.

Among the participants at the Institute representing the Texas Federal Rural Development Council were Conrad Alexander, director, VA Medical Center, Big Spring, Texas; John E. Kirchhoff, chair, Texas RDC, Farmers Home Administration, Temple, Texas.

Serving as officers of the Texas Federal Rural Development Council are John Kirchhoff, chairman; Wayne Thorburn, Special Assistant to the Regional Administrator, U. S. Department of Housing and Urban Development, San Antonio, vice chairman; Paulette Standefer, Regional Director, U. S. Department of Health

and Human Services, Dallas, treasurer; Henry Troell, Acting Regional Director, Economic Development Administration, Austin, secretary; Michaelyn Giebler, Office of General Counsel, U. S. Department of Agriculture, Temple, general counsel.

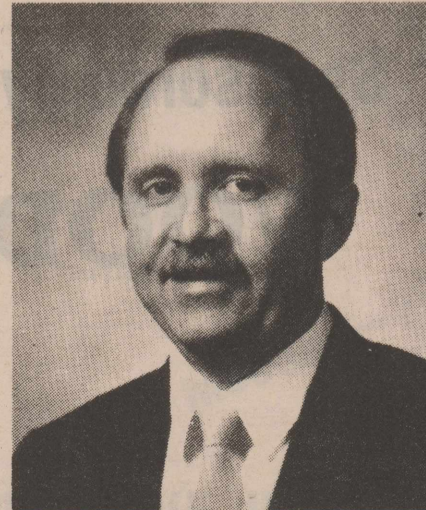

Senator Teel Bivins Reports



AUSTIN - During this session, it seems there is very little time that goes unscheduled. While it used to be common to conduct business over a meal, it now seems there are more legislative

breakfasts, luncheons and dinner meetings than ever before.

During one recent lunch meeting, Comptroller John Sharp and I discussed a program that would automate

the states's food stamp program. This system, known as electronic benefits transfer, or EBT, would not only provide savings to the state in postage and the many handling costs involved in getting benefits to the clients with the current system, it would also mean more benefit dollars going to intended recipients, instead of bureaucrats.

The concept takes advantage of current credit card and telephone technology to speed up payments while at the same time reducing opportunities for fraud in food stamps. After preliminary conversations with some people at the Department of Human Services, who advised me that they were indeed considering such a program, I introduced Senate Resolution 230. This Resolution, urging the Department of Human Services to set up

a pilot project using EBT technology, represents the Legislature's support for such a program.

The system would allow individuals participating in the food stamp program to fully automate their benefits, so that there would be no need for actual physical food stamps. Just like a credit card, each client's individual food stamp account information would be accessible at stores using a card reading terminal and an ordinary telephone line. When a food stamp recipient wishes to use his or her food stamps, they simply hand the card to the check-out clerk, who "reads" the card with the machine. The customer then types in his or her unique personal identification number, and the system automatically deducts the cost of the purchase from the account.

EBT would enable the recipient to make only one contact with the Department of Human Services when signing up for benefits. Instead of waiting to receive food stamps in the mail each month, having to keep track of loose stamps and worrying that those could be stolen or lost, the client would simply carry his or her card, which could not be accessed without the personal identification number. The system would remove many intermediaries from the benefit delivery system, reducing cost and fraud.

The card readers would be purchased by the stores which would reap the benefit of reduced turnaround time for the food stamps to be processed. Stores and banks would receive "real-time" payment from the food stamps as soon as a transaction took place, eliminating the current several day delay.

An additional benefit from such a system would be tighter controls of the food stamps dollars from the time that they leave the Department to the time they are spent in a grocery store. Since all transfers of money into recipients' accounts would be electronic, there would be no physical stamps that could be stolen in transit or from the food stamp user. Only the card could be stolen, but it would be useless without the personal identification number. Another benefit of the card would be that only the intended recipient of the food stamp dollars would be able to use them. I understand that one of the ways that fraud takes place in the food stamp program is that food stamps are traded for cash or bartered for merchandise, including drugs. If this program can accrue substantial savings to the state, and at the same time impact the illegal drug trade, then I will gladly welcome it.

The Department is now preparing to present a proposal for the pilot program to the U.S. Department of Agriculture, which administers the food stamp program. If that request is granted, and the pilot project proves workable, the Comptroller estimates that such a program when implemented state-wide, could save the state \$30 million each year in postal, handling, and fraud costs. Given the current fiscal condition of the state, I believe it is imperative we explore all creative ways to improve government efficiency.

Other states have shown that pilot programs for EBT can work. In the future, many other programs could be added to the program, increasing the savings to the State. Texas is often quoted as being at or near the bottom in social services provided. I am enthusiastic about this chance to bring Texas human services delivery into the 1990's, increasing the benefits to clients while at the same time utilizing an innovative new technology to save the state taxpayers' money.

Wetland Regulations Changed by New Bill

The Wetland regulations of the 1990 Farm Bill have changed, stated Matthew Kast, District Conservationist of the Soil Conservation Service in Silverton.

One of the most important changes involves the time frame when a person is in violation of Swampbuster. As of November 28, 1990, when a person converts a wetland for the purpose or to have the effect of making the production of an agricultural commodity possible he or she will be subject to a fine plus loss of eligibility for USDA benefits until the wetland has been restored, stated Kast.

Persons who plan to convert a wetland for other than agricultural production (this includes things such as roads or building construction) may be able to get prior approval so they will be exempt from eligibility and benefit losses. Kast stated that this prior approval involves a person completing an AD-1026 Form at the ASCS Office. He or she will need to state their intentions on the AD-1026. At this time the SCS will approve or disapprove the proposal depending on whether or not the proposal fits into a non-agricultural use and all needed permits have been obtained.

Kast stated that if a person is

planning any new construction in a wetland, he or she should contact the local ASCS or SCS Office prior to starting construction.

All programs and services of the SCS are offered on a nondiscriminatory basis without regard for race, color, marital status or handicap status.

FmHA Announces Interest Assistance Program

The Farmers Home Administration is launching a new program to help local farmers obtain credit from local lenders, according to Neal Sox Johnson, FmHA State Director for Texas. Known as the Interest Assistance Program, it provides strong incentives for commercial lenders to make loans to farmers who otherwise could not

qualify.

Under the new program, FmHA will pay up to four percentage points of interest for farmers to help them qualify for FmHA guaranteed loans. "If a creditworthy farmer can't cash flow with a guaranteed bank loan at regular interest rates, we can pay part of that interest for him until he can," Johnson said.

The percentage of interest FmHA will pay depends on the financial condition of the farmer. FmHA will pay only the number of points necessary to help the farmer cash flow with a small reserve.

An FmHA Guaranteed loan is made by a bank, PCA, or other lender with an agreement from FmHA that if the loan goes bad, FmHA will compensate the lender for up to 90 percent of its loss. "That guarantee plus the new interest assistance," Johnson said, "should greatly increase availability of farm credit through the private sector."

The program, made law in late 1990, was put on a fast track, so as to assist more farmers in time for the 1991 planting season," Johnson added.

According to Johnson, the level of interest assistance will be adjusted each year, based on a review of the borrower's need for continued assistance. In addition, a borrower must be able to project a positive cash flow, including a 10 percent debt-service reserve to qualify for assistance. This is the same rule for guaranteed farm loans not receiving interest assistance.

Money Talk

with Kay Bailey Hutchison

Editor's Note: Texas State Treasurer Kay Bailey Hutchison answers questions about personal finance and state government. These questions are compiled from timely issues of concern facing Texas and Texans. Answers, however, are not intended to replace the advice of reputable financial advisers or other professional counselors.

Q. As parents of two elementary school-age children, we are concerned about saving for their college education. We are aware of U. S. Savings Bonds, but our question is, does the State of Texas offer any similar type of college savings bonds that might help us?

A. I understand your concern and I applaud you for planning ahead for your children's college education. Yes, Texas does offer state-issued college savings bonds. As a matter of fact, several state agencies are authorized to issue college savings bonds. Before they are issued, however, these savings bonds must be approved by the College Opportunity Act Committee, of which I, as State Treasurer, am a member.

These bonds are tax-exempt, which means interest earned on them is exempt from federal income tax, regardless of their use. This allows the purchaser to retain his or her tax-exempt yield on the investment, even if the purchaser's child should decide not to attend college.

These college savings bonds are sold in denominations ranging from \$1,000 to \$5,000—with maturities ranging from five to twenty years. For information on which state agencies offer these bonds and how they can be purchased, call the Texas State Treasury's Office of Public Information at (512) 463-6000, or write P. O. DACC is an optional service that provides customers the option of having their Directory Assistance call completed to the requested number (when they call Directory Assistance for a number) by either the Directory Assistance operator or a mechanized audio response system.


The proposed rates* for fully-automated DACC calls are: \$.30 if the call is sent paid or billed to a calling card, \$1.00 if the call is collect or billed to a third number and \$.25 from a coin telephone.

The proposed rates* for semi-automated (operator assisted) DACC calls are: \$.85 for calls that are sent paid or billed to a calling card, \$1.20 if the call is collect or billed to a third number and \$2.60 for a person-to-person call.

Multiple List Directory Assistance (MLDA) allows the customer to request more than two listing requests per call to Directory Assistance. Customers can either call on "demand" and receive up to 10 listings, or schedule an "appointment" and receive the assistance of a Directory Assistance operator for as long as required. The rates for "demand" MLDA are \$.30 per listing request (after applicable allowances), with a maximum of 10 listing requests per call. The rates for "appointment" MLDA are \$1.00 per minute, with a 15-minute minimum.

The optional services DACC and MLDA are intended for use by both residence and business customers. Those persons who qualify for exemption of Directory Assistance charges because of visual or physical handicaps will be able to use DACC and "demand" MLDA free of charge. If approved by the commission, DACC and MLDA will be available beginning May 13, 1991. First-year projected revenues for DACC are approximately \$9.6 million. First-year projected revenues for MLDA are approximately \$1.7 million.

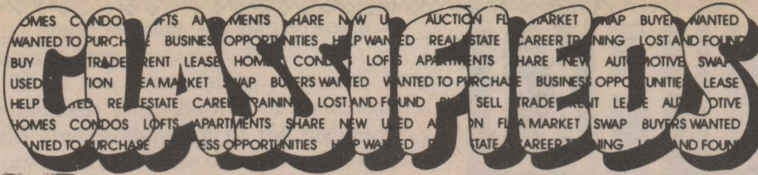
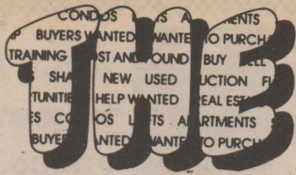
