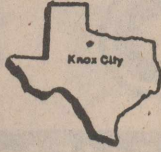

## New Chiropractor Opens Practice

Thanks to a determined effort by Stamford and Knox City Dentist L.M. Bayouth and a positive response from residents of Knox County, Dr. Steve Hambright and his wife Linda have officially opened their Chiropractic Clinic in Knox City.

Located in the same building occupied part time by Dr. Bayouth and Orthodontist Dr. Charles Taylor, the Hambright Clinic will be open two half days a week to start out. Open on Wednesday and Saturday mornings, Dr. Hambright will expand his hours in the future as his patient load expands.

Dr. Hambright has a clinic open in Stamford with Dr. Bayouth and he is a graduate of Parker College of Chiropractic in Irving, Texas. Prior to

his relocation to Stamford and Knox City, Steve practiced in Midland for one year after serving his internship in Irving. He and his wife Linda have one son, 2½ year old Bradley. The family resides in Stamford.

Linda Hambright serves as receptionist, secretary and assistant to her husband in the practice. The couple will file all paperwork necessary for insurance and Medicare. Eventually the clinic will also provide Medicaid coverage.

In a visit to Dr. Hambright's office, patients should allow a little extra time on their first visit. Along with paperwork and physical histories, patients will also receive an examination that includes listening to the heart, blood

pressure readings, nervous system test, and a brief physical. Dr. Hambright explained that as a chiropractor, he routinely refers patients to their own private physicians if their problem is not of a chiropractic nature or if medication is needed as chiropractors do not prescribe medication.

Dr. Hambright and his wife are looking forward to working in Knox City and express their appreciation for the positive response offered to them by the community. For appointments, area residents are asked to call his Stamford Clinic at (915) 773-5012. While appointments are appreciated, walk-in patients will be welcome at the clinic, they said.

## Hounds 'Pluck' Eagles

Returning to friendly home town fans, the Knox City Greyhounds put on quite a show last Friday evening when they hosted the Eagles from Chillicothe and solidly defeated the visitors by a score of 39 to 0.

Under breezy conditions with clear skies and temperatures in the lower 70's, the Greyhounds took to the field by receiving the ball on the opening kickoff after team captains Alex Flores and Monte Owen won the toss and elected to receive while defending the north goal. Bob Burkham took the kickoff and was immediately hit and flipped completely upside down. The Greyhounds picked up a 1st down in just 3 plays, then picked up another 1st down just 2 plays later. Roy Roberson and Alex Ledesma ground out short yardage plays up the middle and Quarterback Billy Large ran around the left, then faked a punt on 4th and 5 by running up the middle but the Eagle defense held and Chillicothe took over on downs.

Facing a tough Greyhound defense, the Eagles went nowhere and punted back to Knox City on 4th and 9, with KC taking over on its own 10 yard line.

## Three Men Burned In Oil Lease Fire

Two men from Haskell County and one man from Jones County were burned in a flash fire on an oil lease last Friday afternoon. Two of the men, Danny Navarrete of Rule and Catarino Macias are still in Lubbock General Hospital while the third, Larry Barbee of Rule was released from the Knox County Hospital on Saturday.

The explosion and flash fire occurred while the trio was working on an installation at a tank battery site on the Burnett Lease on the 6666 Ranch, west of Knox City in King County. A total of seven persons from various companies were at the site at the time of the fire. The three burn victims are

all employed by Raydon Construction Company of Knox City.

Removed from the scene by private vehicles and transferred to the Knox City EMS ambulance, the three men were treated initially by Dr. Terry Springer at the Knox County Hospital in Knox City. With Navarrete and Macias listed as critical, they were transferred to Lubbock General Hospital by Care Link Helicopter Service of Lubbock after arrangements were made by Dr. Springer. The helicopter landed at the Knox City Airport and the two men were taken to the medical flight by Knox City EMS after their conditions were stabilized at the Knox County Hospital.

A telephone conversation with the Media Information Office at Lubbock General Hospital late Monday afternoon provided information that both Danny Navarrete and Catarino Macias are in the Intensive Care Unit (ICU) with Navarrete having second and third degree burns on 39 percent of his body while Macias has first and second degree burns on 27 percent of his body surface. Navarrete is still listed in critical condition while Macias has been upgraded from critical to serious condition.

According to Jerry Williams,

## Council Needs Your Opinion On Depot

In a story a few weeks ago, I wrote about a proposal from Dentist Dr. L.M. Bayouth to bring some additional medical specialists to Knox City if the people here wanted them. We asked for your opinion on the issue. It was highly successful as over a hundred people responded directly and we now have a new chiropractor in Dr. Bayouth's office two days a week. In a related way, this story follows the same path; your opinion is wanted and is being asked for. The City Council of Knox City has a big issue under consideration and wants to hear from the citizens before making a decision.

The issue concerns the use of the old railroad depot building. The train station building was donated to the City by the railroad and moved to its present position on State Highway 222, just inside the west city limits. The Knox City Jaycees leased the building from the City while they were in existence and attempted to do repair work on the building. The group did manage to put a new roof on the structure before the group disbanded and the lease was cancelled. Since that time, the building has been empty except for use as a haunted house during Halloween.

Not long ago, the land the building

sits on was sold to Rolling Plains Well Service during a bidding process by the City Council. The City received needed revenue from selling the lots and Rolling Plains Well Service gained badly needed room to expand their operations. The one thing that did not sell was the railroad depot building as it was not included in the deal. It still remains the property of the City and the Council is now trying to decide what to do with it. In the terms of the sale, the building had to be moved off

### INSURANCE KEY RATES

The City and Fire Department have recently been contacted by the State Board of Insurance concerning Key Rates. The current Key Rate for the citizens of Benjamin is \$0.57. This is considered a protected Key Rate. The Key Rate is determined by many contributing factors, (fire department, water mains, fire hydrants, alarm systems, age of equipment and other items) and will apparently be raised to as high as \$0.81 due to factors we are now or shortly will be deficient in.

One item we can control without expense to the citizens is Fire Department membership. The State requires 20 members with a minimum of 17 at each meeting. The Department has had no more than 11 for the last five years. Age or physical condition is not a factor. There is a job that can be performed by everyone. Manning a pump truck or a radio requires little effort. The bottom line is we need help in maintaining a low Key Rate. If we cannot maintain the required department the protected rating will come off and insurance rate will increase.

Fire meetings are the first and third Mondays of each month. Consider becoming a member for everybody's benefit.

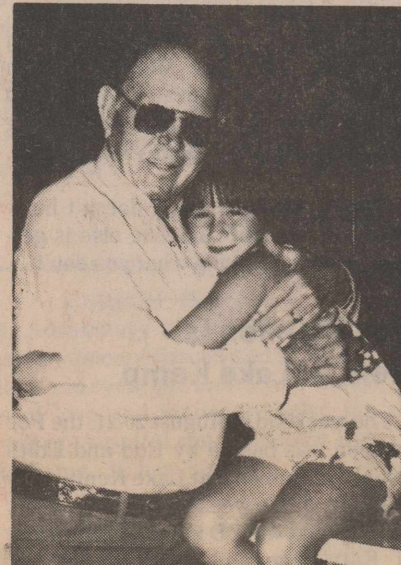

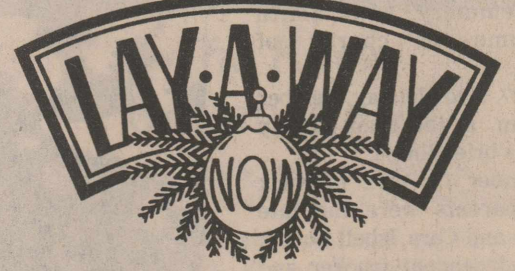

the property by February 1989 and Rolling Plains Well Service even offered help to move it.

The time has come for the City Council of Knox City to make a decision. Several ideas have surfaced on what to do with the building. They range from moving it across the highway and making a community use building out of it, to making a City Hall out of it, or moving it to Benjamin. Let me explain: One proposal is making the old railroad depot into a new City Hall. To do that, it would mean moving it across the highway to the area known as the 'triangle' and coming up with the funds to move it and completely remodel it. That idea has both support and criticism. Some feel that it would be a good idea, some feel that the location of City Hall should remain downtown where it is easily accessible to all. Another proposal up for consideration is moving the depot building to the 'triangle' and making some sort of community use building out of it as some other cities have done. A very different proposal would be to move it to Benjamin and have it used as the permanent site for the Knox County Museum by the Knox County Historical Society. While the historical society would pay the bill for moving it, that idea has also drawn some criticism because there are some who feel that the building is a part of the history of Knox City and should not be moved from the city.

In either proposal to keep the building in Knox City, the ideas are going to take money to accomplish. The basic cost of even moving it across the street is estimated at \$3,000.00. The City has received some donations to help out, but not enough to cover the entire cost. You can guess the rest: if the building is moved and turned into either a community meeting center or a new City Hall, you as taxpayers will actually be paying the bill. That is why the City Council wants to hear from citizens before they make any decision on use of the building.

Another idea making the rounds is to keep City Hall at its present location and remodel the existing building to make more room and more offices. That too will cost the taxpayers some money. One interesting note is that the council feels that it can save money on either project with the city employees accomplishing a lot of the actual work.

So, what's your opinion? What do you think should be done with the old railroad depot building? Now is your opportunity to be heard because the council members are asking for your opinion. Too often, people are good at griping at something done or action taken by our elected officials. Instead of griping later, why not let your opinion be heard now. Talk with your representatives on the council, including Derrell Marion, Barbara Barnard, Larry Staggs, Marq Brockett, Joe Barnard and Rob Harrison. Readers may also call City Hall at 658-3313. Remember, you are being asked for your opinion, so make it heard!

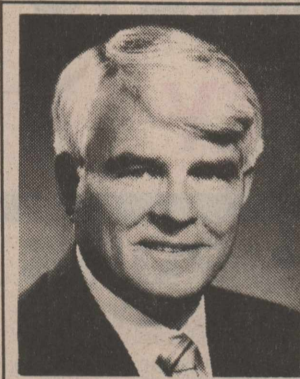

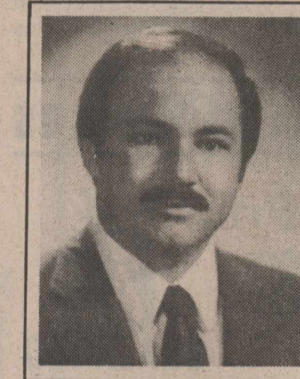

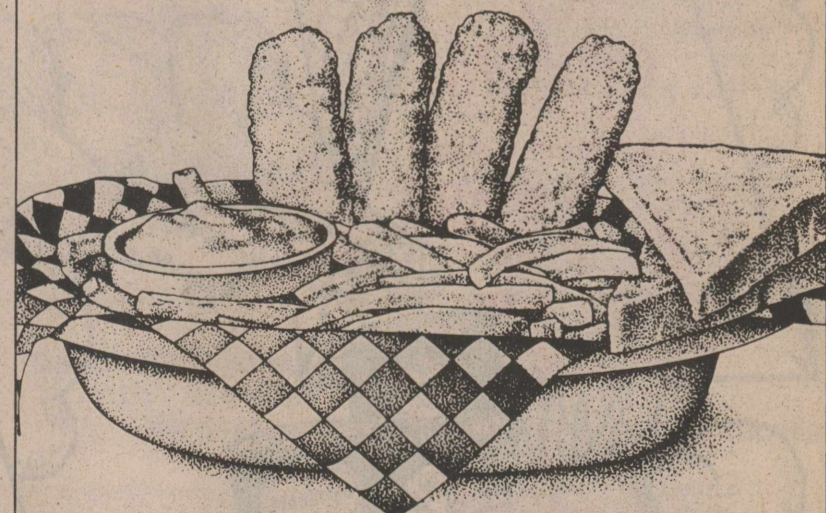

Justin and Andy brought home another first place win this weekend from Vernon! They're really doing a great job! Keep up the good work.

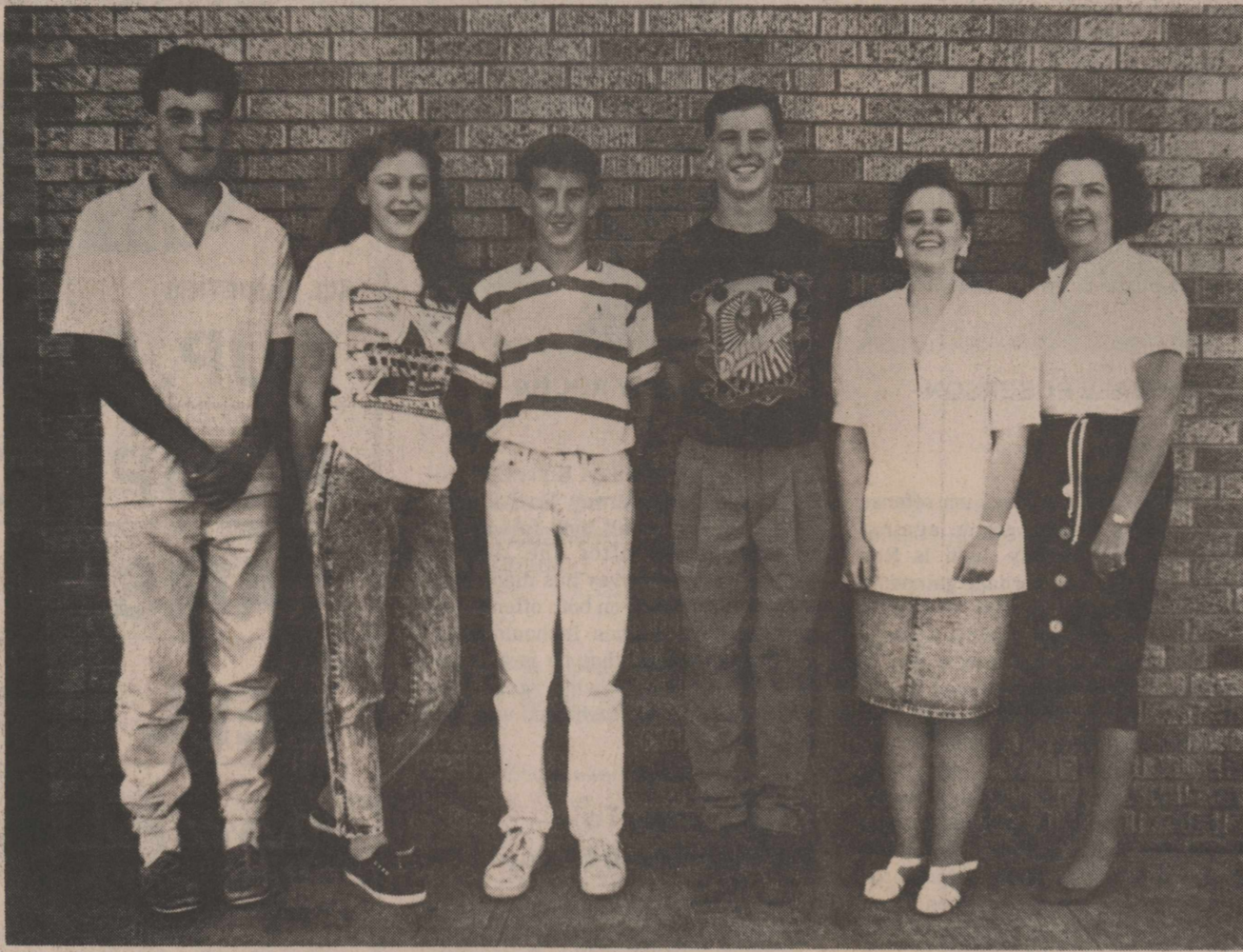
One of our good classmates, Lisa Travis moved last week. We will miss her alot and want to wish her good luck at her new home.

down in just 2 plays and set up a Roy Roberson run for 40 yards that picked up another Hound 1st down. Alex Ledesma and Billy Large ground out the yardage for another 1st down in 3 plays. After more running by both Large and Ledesma, Knox City turned the ball over on downs after a 4th and 1 yard run by Roberson did not gain the needed yard.

Chillicothe tried both runs and a long pass play but was held by the Greyhounds. On a 4th down punt, Knox City drew a penalty for roughing the kicker and started its offense from the 50 yard line. On the first play, Roy Roberson ran the 50 yards for the first Greyhound touchdown of the evening. With Knox City ahead 6-0, the extra point attempt failed as the clock wound down to :42 seconds left in the 1st quarter.

Chillicothe started out its next offensive series from the 16 yard line after a 15 yard clipping penalty. The Greyhounds drew a pass interference penalty next and the Eagles wound up with a 1st down on the 32. Monte Owen, Alex Flores, and Harvey Rocha then teamed up to sack the Eagle quarterback deep to bring up a 2nd and 18 play for Chillicothe. Harvey Rocha moved in to intercept an Eagle pass as the 1st quarter of play ended with Knox City taking over on the 9 yard line. After short runs by Ledesma and Large, Alex Ledesma ran in from the one yard line for the second Greyhound touchdown of the game. Augie Rodriguez kicked the extra point to put Knox City ahead 13-0 with 10:36 left in the first half.

With solid tackles by Harvey Rocha, Danny Grindstaff, Robbie Whitford, and a quarterback sack by Fred Ledesma, Chillicothe punted back to Knox City on 4th down.

Knox City started its next offensive drive with a 7 yard run by Billy Large. Second down brought a 5 yard penalty for illegal motion against Knox City with Roy Roberson picking up 3 on a short run and Flores picking up a 1st down. Billy Large ran down to the 4 yard line for another 1st down and two plays later Alex Ledesma ran in for another Greyhound touchdown. The extra point kick by Rodriguez was good and Knox City went ahead 20-0 with 7:05 left in the half.

During the next series for Chillicothe, Knox City Cheerleader Jennifer Grindstaff took quite a hit as she was toppled by an Eagle running back while participating in a cheer with her back to the action on the field. She did not appear to be injured and was again cheering a few plays later. The Chillicothe series failed and Knox City took over with 4:01 left on the clock.

Knox City moved downfield in a hurry with runs by Large, Ledesma and a good pass play from Large to Jim Ford. One play later Alex Ledesma again crossed into the end zone for another Knox City touchdown. The extra point kick by Augie Rodriguez failed with Knox City ahead in the game 26-0 and 1:52 left in the first half.

With tackles by Harvey Rocha and Monte Owen, Chillicothe went nowhere and punted back to Knox City with :39 left on the clock.

An incomplete pass from Large to Jim Ford was followed by a broken pass play and Large having to scramble for his life on 2nd down. Third down with :20 seconds on the clock saw another broken pass play and a scramble by Billy Large that picked up 4 yards. On 4th and 5, Ledesma picked up another 1st down for Knox City and moved the ball down to the 20 yard line. An incomplete pass attempt to Alex Flores on 1st down was followed by a field goal attempt that fell short of the goal posts and ended the first half.

Following halftime ceremonies by both schools, the Greyhounds returned to action and immediately dominated the playing action on both offense and defense. For anyone present who might have any doubts about who controlled the game in the first half, Knox City came on strong and made two touchdowns early in the 3rd quarter. The first was a run by Billy Wayne Large and the second came on a run by Alex Ledesma. Both TD's and extra points combined to put Knox City ahead 39-0 with 5:39 left in the 3rd quarter.

The Eagle defense did manage to

strengthen a little midway into the 3rd quarter, forcing Knox City to turn the ball over on the 40 yard line. On the Knox City side of the defensive story, Alex Ledesma stopped a long Eagle run and what could have been a Chillicothe touchdown. The Eagles did mount a drive and moved the ball all the way down the field. On a 4th and 7, Augie Rodriguez came in to sack the Chillicothe quarterback and end the only scoring threat in the game from Chillicothe.

The 4th quarter started with the Eagles again in possession of the ball on their own 25 yard line. Tackles by Danny Grindstaff, Harvey Rocha and a fine pass defense play by Willie Rodriguez all worked together to stop the Eagles once again.

With the Hounds taking over on the Chillicothe 32, Alex Ledesma started action in the series by picking up a hard earned 4 yards right up the middle of the line. Grindstaff picked up another 4 and Ledesma picked up a 1st down on the 3rd down play. With the Greyhounds in solid control of the game, Coach Pat Risinger began to substitute players in an effort to give as many backup players as possible the opportunity to gain actual game experience.

With the Eagles in possession and going for a long pass play from their own 20, Greyhound Danny Grindstaff stepped in and intercepted the ball to once again turn the ball over to Knox City. Grindstaff drew the next two running assignments, but his efforts were set back by penalties on both plays against the Greyhounds. On a 3rd and 26, Knox City was again moved back on a delay of game penalty for a 3rd and 31. A long pall play to Jim Ford from Willie Rodriguez was short and Knox City found itself punting off to Chillicothe with 4:39 left in the game. Another penalty against Knox City on the punt brought the play back to have the Greyhounds punt once again.

Chillicothe took possession with 4:21 left in the game and was immediately stopped by Thomas Rodriguez. The next play was stopped by Andy McCrary but another penalty against Knox City moved the Eagles downfield after the forward pass interference call that gave Chillicothe another 1st down on the KC 39 yard line. Mass confusion on the part of the officials delayed the game for several minutes, then moved the ball back to the Eagle 44 yard marker, where Chillicothe started play action. Monte Owen stopped the next play cold as he put a hard hit on the ball carrier. The Eagles did manage to pick up some yards on the following play, but Andy McCrary's tackle stopped the 1st down. Thomas Rodriguez stopped the next Eagle run, but Chillicothe still managed a 1st down on the play. A pass play that could have become an Eagle touchdown was halted with an ankle tackle by Monte Owen. With a 4th and 7 and :32 seconds on the clock, Chillicothe called a time out to confer with its coaching staff. A quarterback keeper run was cut down by several Greyhounds and Knox City took over on the 40 to run the clock out and end the game 39-0.

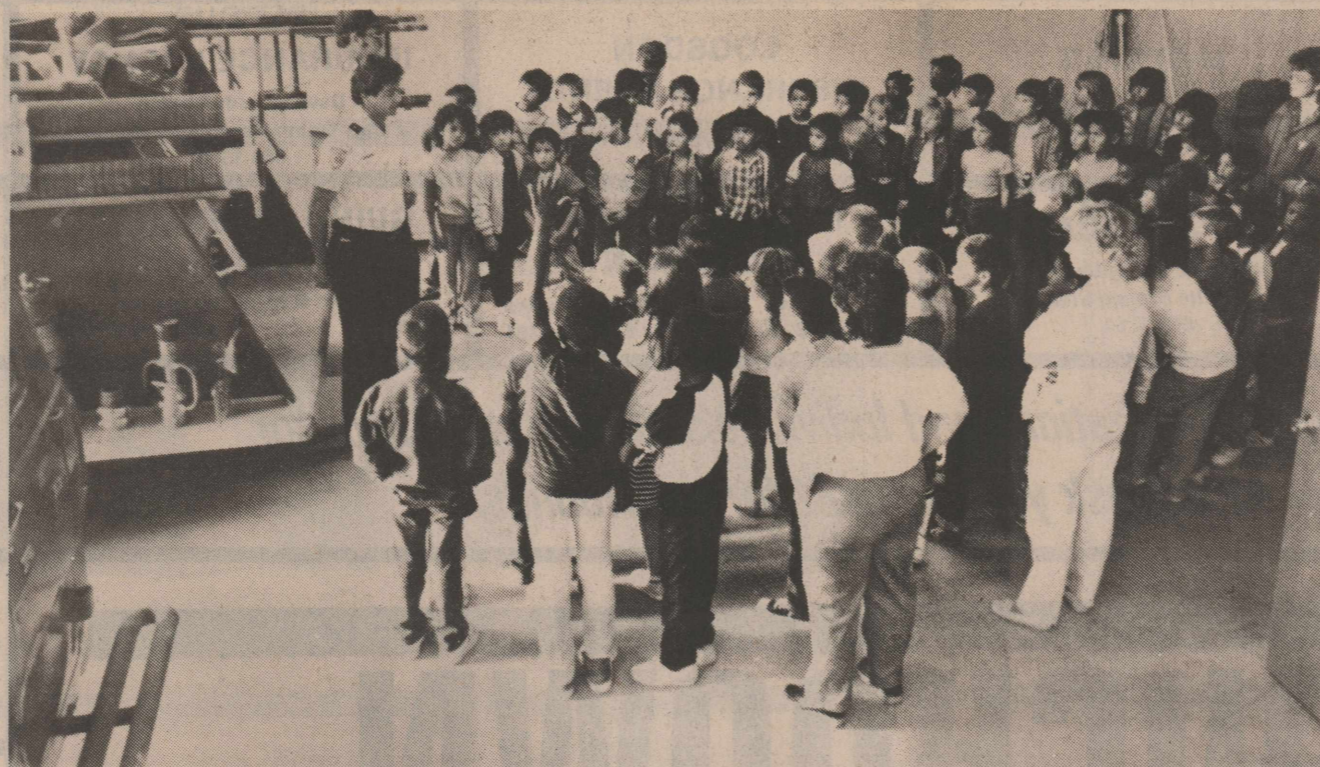
#### A TIME IN THE LIFE...
