Our home air conditioner didn't seem like it was doing all that it should and after checking the unit out, Kevin narrowed the problem down to an extremely dirty filter that I should have been cleaning on a regular basis. After getting over my acute embarrasement I listened intently to the advice passed on by Kevin. Filters in central heat and air units should be cleaned or replaced at least once a month for best performance. Standard filters can be cleaned and put back in, but the easiest way is to buy inexpensive disposable filters and put a new one in at least once a month. Crippled Children's Auction

The 21st annual Crippled Children's Livestock Auction--or, in more familiar terms, the Cattle Auction, will be held Friday and Saturday, July 21 and 22 as the North Texas Rehab Center's largest fund raising event.

Members of the Cattle Auction Committee in the 15 county area surrounding Wichita Falls have begun their work in getting livestock, merchandise and cash donations.

The two-day event is a tradition among area cattlemen, farmers and merchants, who not only donate but who come to the auction and buy.

Livestock will be sold at 11 a.m., Friday, July 21 at Arrowhead Livestock Sales Barn on the Jacksboro Highway, Wichita Falls. The big merchandise auction and barbecue will be at 5 p.m., Saturday, July 22 at Wichita

Falls Activities Center, downtown Wichita Falls.

A silent auction will be held from 10 a.m. to 4 p.m., Saturday at the Wichita Falls activities Center. Doors will reopen at 5 p.m. for the big auction and barbecue feed. The silent auction is one in which bids are written on cards for the desired items--and the highest bidder then is notified at the close of this bidding.

The barbecue will be served by Stanley's with desserts by Golden Cream Pastry.

Joe Parker, rancher and banker of Byers, will be chairman for the 18th year. Hollis Dickey, Waurika, Okla., as auctioneer, has been with the auction almost since its beginning in 1969. Bill Burgess, Graham, has assisted as auctioneer for a number of years now.

When you say "cattle auction," you're not talking of cattle only. You're talking horses, goats, mules and any animal with four legs. "Give four legs so that two can walk" has been the famed slogan all these years. The auction started out with donations of livestock only but, through the years, has increased to merchandise items of high quality, antiques and art.

Federal Funds Set To Aid Public Entities

Longview, Tex.--The Disaster Field Office has been expanded to aid local governments and non-profit organizations applying for federal funds to cover losses from spring Texas storms, according to Bob Broussard, Federal Cordinating Of-

He said public officials and officials of private non-profit organizations should contact the field office promptly to file preliminary requests for aid if they have not already done so.

A special toll-free Hot Line telephone service to take data on local damage to roads, bridges and other public properties has been opened. This number, to deal only with needs of public or

non-profit bodies, is 1-800-621-8598.

Certain non-profit private organizations are eligible for the public assistance program. Ed Laundy, State Coordinating Officer, said these may include nurisng homes, day care centers, volunteer fire departments and some types of non-profit private schools.

A futher announcement today lists ten additional counties added to those previously declared eligible for disaster assistance to individuals bringing the total to 61 counties. New counties are Archer, Clay, Hale, Knox, Marion, Rockwall, Sabine, Taylor, Titus and Trinity.

Combine, Auto Burn In Separate Fires

Two separate fires totalled a combine and an auto this past weekend.

Fire Chief Roland Marion reported that the combine was a 100% loss last Saturday afternoon on the E.L. (Jack) Tankersley farm, southeast of Knox City. It belonged to A.C. Farms Co. It was difficult to extinguish, Marion said, because during the fire, the 50gallon diesel tank began leaking over the rubber tires. Marion said 3,500 gallons of water were shuttled to the farm location.

Sunday afternoon about 3:30, a late 70 model Torino registered to Judy Tipton Gates of Knox City burned north and east of the Dairy Queen. Marion said the woman had driven her car about a block when smoke started coming out from under the hood. After she stopped the car, flames began shooting out and after she got the alarm turned in the vehicle was ablaze all over. Marion said it took about 1,000 gallons of water to extinguish the auto's blaze.

The toll-free number is 1-800-ACS-2345 and can be called from anywhere in Texas. Hours of operation are 8:30 a.m.-4:00 p.m. (CST).

"People often have a lot of questions about cancer when they find out a loved one has the disease or when they suspect they have a warning sign of cancer or when they have read an article that leaves them with a question. Now anyone in Texas can have their questions answered with just a phone call--and its free," said Myra Busby. Many people may be unaware of the variety of services provided free to cancer patients in Knox County.

Callers may ask technical questions about the disease, about cancer detection and warning signs, and about treatments. But the unique aspect of the new phone line is that callers can find out about services available to cancer patients and their families in their own city or area.

The American Cancer Society loans equipment to cancer patients and offers free classes and information to cancer patients and their families. Information about these local services, as well as education for public groups, can be obtained by calling this toll-free number.

Canner Testing Set Thursday At Benjamin

Jane Rowan, County Extension Agent, will be testing pressure canner gauges on Thursday, June 22, from 9:00 a.m. to 5:00 p.m. at the County Extension Office in Benjamin. The test will only take about five minutes and all one needs to bring is the lid to their canner and the weight for those canners that have one.

Gauges do become inaccurate with use resulting in foods that are over or under processed. This could lead to spoiled foods and food-borne illnesses.

Gardening and canning season is here. If you plan to use a pressure canner to preserve your produce you will want to have the prssure gauge checked for accuracy.

Educational programs conducted by the Texas Agricultural Extension Service are open to people of all ages, regardless of socioecoromic level, race, color, sex, handicap, religion, or national origin.



A.P. Denton Grocery and Station has been at the same location at 212 Central Avenue since 1942, and is the oldest one owner business in Knox City. The building was built in 1921 by Dr. T.S. Edwards, Roy Mullins and Mr. Banner and housed a new car agency.

A.P. bought the building from Mr. Griffith in 1942, and operated the store and station seven days a week selling 17° bread, 18° gasoline, 15° cigarettes and 33° Folgers Vacuum Packed Coffee!





GUARDING AGAINST BACTERIAL FOOD-BORNE ILLNESS

Certain pathogens (disease-causing organisms) such as Salmonella or Listeria do not signal their presence through taste or smell. To reduce risks at home, practice basic food safety principles for avoiding any food-borne illness.

1. Avoid contaminating one food with microorganisms that might be present on another.

2. Never carry raw meat, poultry and seafood--which might contain microorganisms--on the same plate you intend to use for cooked products or other foods, and do not let juices from raw products drip on other foods.

3. Remember that vegetables can carry bacteria and-once cut-support their growth. Scrub fresh produce thoroughly to remove visible dirt.

4. Cook meat, poultry and seafood sufficiently to kill harmful microorganisms. The U.S. Department of Agriculture recommends cooking meat to an internal temperature of 160 degrees F. at the thickest part and poultry to 185 degrees F. The Food and Drug Administration currently has studies underway to ensure the adequacy of cooking instructions for seafood.

5. Although bacteria can grow at low temperatures, it is still important to keep foods refrigerated so that microorganisms will not multiply as fast as they would unrefrigerated.

Disease caused by bacteria such as Listeria can be fatal for certain highrisk groups such as unborn infants, newborns, those with impaired immune systems, pregnant women and the elderly. Preventing the outbreak of this disease is of major concern. THINK TWICE

HOW YOU COMPLAIN CAN MAKE A DIFFERENCE

Got a complaint? When you complain about a product or service, be sure to do it the right way.

To register a complaint:

*Describe clearly your current problem or complaint. Use facts like dates, costs and problem.

*State exactly what you want the

company or agency to do to make things right.

*Print (don't write) your complaint

*Print (don't write) your complaint legibly. Better yet, use a typewriter if you have one.

*Use standard paper (8½x11), preferably white. Colored paper often

does not photocopy well. Since several people or departments may be involved in handling your complaint, your letter and other documents may

be photocopied several times.

* Use a pen with dark ink (blue or black) and medium point so that the letter will be legible when copied.

*Include copies (not the originals) of all related documents, purchase receipts, service receipts, past correspondence with service agencies and the manufacturer.

*Date your letters and other documents.

*Provide your daytime telephone number.

*Reread your letter several times before sending. Put yourself in the reader's shoes. Your letter is not a place to vent your anger; only state the facts and what you would like as a resolution to the problem.

*Be polite and remain calm. Customer relations personnel with a company or agency may be instructed NOT to deal with rude or offensive customers.

Once your complaint is in process:

*Don't delay providing any additional information that is requested.

*Follow the exact directions for procedures and filling out forms.

*Let the company know immediately of any new developments, such as, the product was repaired or is working, a new problem has developed.


