## 1990 Wheat Program Modified By USDA

To maintain humanitarian food aid commitments following two years of drought, and restore wheat stocks to safer levels, the U.S. Department of Agriculture will offer producers the option to modify their 1990 wheat program contracts and increase their wheat plantings if they choose to do so.

The previously-announced program includes a 5 percent acreage reduction requirement and limited cross compliance.

"Farmers will continue to have the option of signing up for and complying with the original program provisions," Glenn Brzozowski, County Executive Director of the Haskell County Agricultural Stabilization and Conservation Service, said.

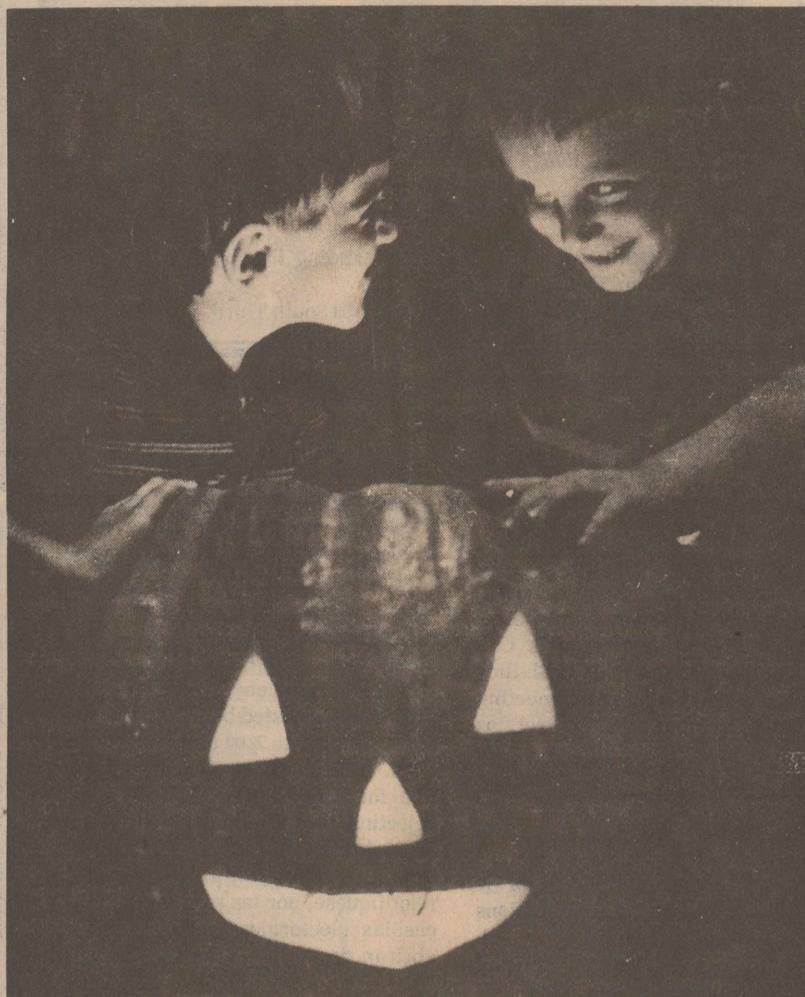
He said the change gives farmers the opportunity to modify their original contracts and plant up to the maximum 105 percent of their farm's wheat base. For each acre planted over 95 percent of the wheat base, there will be a decrease of one acre when determining the farmer's deficiency payment. "Producers may not plant more than 105 percent of their

wheat base to remain eligible for these payments."

The 1990 wheat program benefits include a \$4.00 per bushel target price, a \$1.95 per bushel price support loan and purchase rate, and advance deficiency payments at 40 percent of the estimated deficiency payment rate. "These provisions will remain applicable to all farmers who enroll in the program," ASCS official Brzozowski said.

The modified wheat program option does not contain acreage conservation reserve requirements, 0/92 provisions, soybean and sunflower options, nor the transfer of wheat bases to oat bases. Producers may not credit other non-program crop acreage as acreage considered planted to wheat and may not build future wheat base acreage on the farm. However, the increased wheat plantings may be considered as planted to other program crops for base intention purposes.

Further details on these and other wheat program requirements are available at the Haskell County ASCS office.

## Crop, Livestock Surveys To Begin Across State

AUSTIN - The Texas Agricultural Statistics Service will begin contacting farmers and ranchers across the state in late November for 1989 acreage, yield and production totals and end-of-year livestock and poultry inventories.

"Adverse weather conditions this year have certainly had an impact on Texas agriculture, and these surveys should help us summarize where the industry stands at the end of 1989," state statistician Dennis Findley explained.

"Information from these confidential surveys conducted by mail, telephone or in person will also help producers make their plans for the coming year.

"Sound production and marketing decisions require good, reliable information and some advanced planning, and our reports provide producers with solid facts and figures they can incorporate into their plans," Findley added.

As always, the Texas service will be trying to keep survey costs at a minimum, so Findley is urging producers to return their mailed questionnaires as soon as possible to avoid follow-up contacts.

"Remember, these are sample surveys, so if you are contacted it is important to provide the requested information, since one producer represents similar operations of the same type and size. Our estimates can be no better than the numbers producers provide," Findley noted.

Results of the surveys will be published in early 1990. Anyone wanting a copy of the results can write Information Section, Texas Agricultural Statistics Service, P.O. Box 70, Austin, Texas 78767.

## ASCS Reminds Farmers Of Program Provisions

The Knox County Agricultural Stabilization and Conservation Service is currently accepting applications for the 1989 Disaster Assistance Program. Farmers have until April 2, 1990, to apply for payments on their 1989 crop production losses caused by drought, excessive moisture and other perils. Knox ASCS County Executive Director, John Rector reminds farmers of a provision under the disaster program which reopened the opportunity to request advance deficiency payments for program crops. "Farmers who previously did not request advance payments on wheat, corn, grain sorghum, barley, oats, upland cotton, and rice have until November 1, 1989 to request these payments," John said.

He said it is possible that the final payment rates determined for these crops will be less than the advance rate. "If this occurs, producers who suffered a loss because of a 1989 disaster will not be required to refund the amount of advance payments

which represents loss of crop production on up to 35 percent of their normal production with crop insurance," said John. "or 40 percent of the total expected farm production with 1989 crop insurance." To be eligible for this refund forgiveness, farmers must sign up under the Disaster Assistance Program.

The 1989 crop disaster payments compensate farmers who suffered crop losses in 1989 because of damaging weather or related conditions in 1988 or 1989. Farmers who receive disaster payments for a portion of their program crop will be required to refund the advance deficiency payment for that portion of the crop, according to John.

"It is important that farmers contact our office no later than November 1, to request an advance deficiency payment. If they qualify for disaster payments they will not be required to refund the advance deficiency payments that qualify for forgiveness," the ASCS official said.

## Hounds 'On A Roll', Whop Chillicothe, 35-0

The Knox City Greyhounds continued their winning ways last Friday night when they traveled to Chillicothe and soundly defeated their hosts 35 to 0.

For the second week in a row, Knox City quarterback Billy Wayne Large put on quite a show as he led his team by example: scoring four touchdowns on runs of seven yards, eight yards and two one yard trips across the goal line. Large ran for 118 yards on 20 carries and completed three passes to Boyce Tankersley for another 50 yards offense.

Other noted areas in the game were the performance by running back Andy McCrary and the stubborn, hard hitting plays by the defense that held Chillicothe to a total of 66 yards offense

and no completed passes on seven attempts. McCrary ground up the turf as he ran for 109 yards and one touchdown in 14 carries.

Knox City compiled a total of 25 first downs for a combined offensive yardage of 340 yards while Chillicothe managed only eight first downs in their 66 yards of total offense.

Chillicothe remains winless for the season while the Greyhounds advance to 5-2 record. Knox City has an open date this week. The next game will be against Paducah on November 3, followed by a game with the Munday Moguls on November 10. Both the Paducah and Munday games will be played at Greyhound Stadium here in Knox City.

**Editorial**

Fire cost Texas 322 lives and almost \$5 hundred million in property damage in 1987 and although no firm numbers are available, everyone associated with the fire service agrees that both numbers could be substantially reduced if a combination of more training and better equipment was available to the 53,000 plus firefighters across the state.

Texas voters have a chance November 7 to take a giant step in solving the problem when they vote on Proposition No. 17. Approval of the Constitutional amendment will create a board which will oversee a special emergency fund created by the 71st Legislature to train and equip fire departments. The bill approved by the House of Representatives, Senate and signed by the Governor was the first positive step in several decades addressing a growing problem.

The legislation was passed and funding approved without any increase in taxes or fees. Now, it's up to the voters of Texas to decide the importance of the issue.

Too often as we go to the polls to vote on referendums or constitutional amendments, if we don't completely understand, we vote against the particular item. Often times that is a correct decision since the proposal may serve only a special interest group. In the case of Proposition No. 17 every man, woman and child in Texas will be served by a group of over 53,000 men and women, both paid and volunteer, from fire departments large and small whose only special interest is saving lives and property, often times at the risk of their own lives.

Certainly we own them our vote of support in their attempts to protect us. Vote FOR Proposition No. 17.

**METER TAMPERING NOW A FELONY**

The State of Texas has recently adopted an amendment to the State Penal Code making meter tampering a third degree felony. A third degree felony comes with a punishment of confinement in the Texas Department of Corrections for a term of not more than 10 or less than 2 years. In addition to imprisonment, an individual adjudged guilty of a third degree felony may be punished by a fine not to exceed \$5,000.

Before the amendment of the new law, it was a class A misdemeanor for meter tampering unless the loss of service was more than \$200. Under the new law, any meter tampering regardless of the amount of loss is now a felony of the third degree.

Meter tampering consists of, but is not limited to:

- (1) Diverting electricity from passing through a meter device.
- (2) Preventing electric service from being correctly registered by a meter device.
- (3) Unauthorized activation of electric service.

As a special note to our members, it will also be considered meter tampering if a meter is reset and electrical service is restored by anyone other than a Cooperative employee.

All Cooperative meters are sealed. This seal should not be cut or broken without special authorization. In cases where the seal must be cut for emergencies the Cooperative should be notified as soon as possible so that the meter can be resealed.

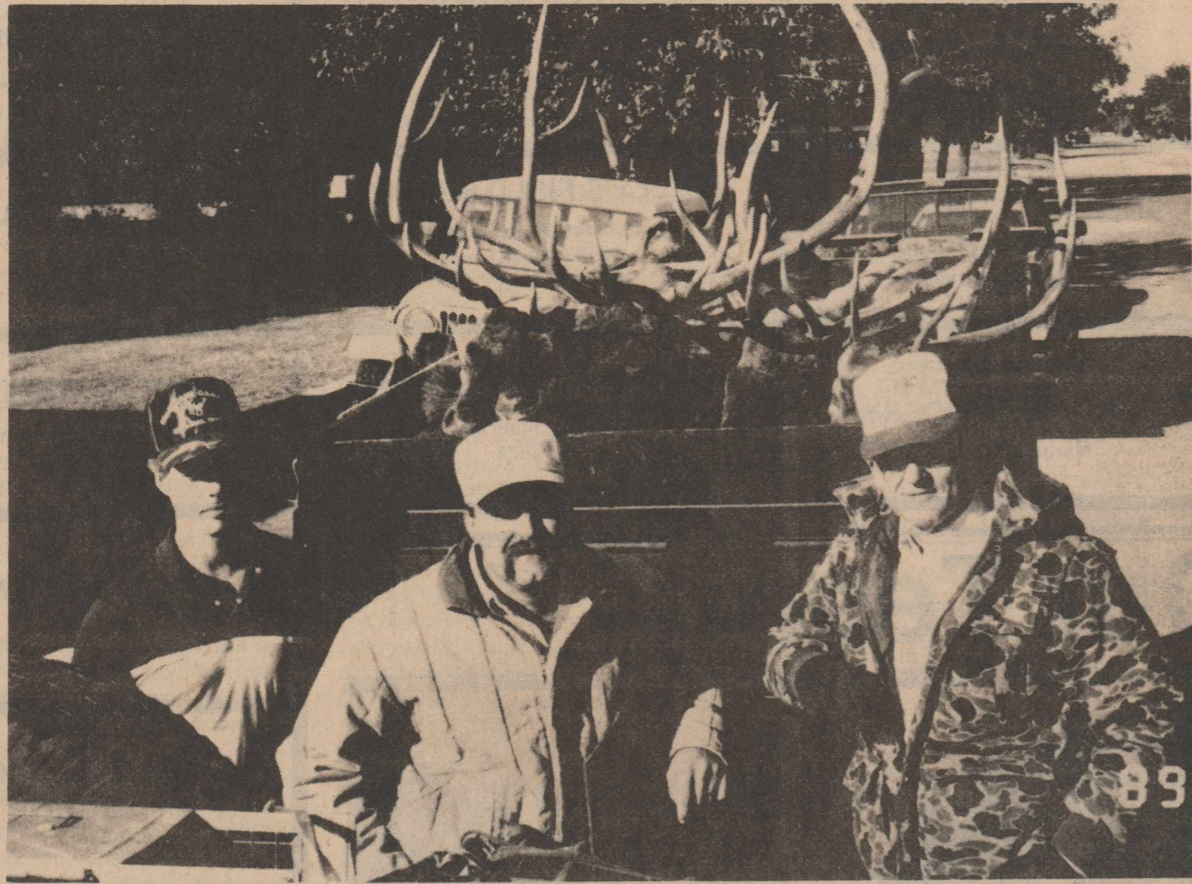
