

Repairs Being Made At Miller Creek Lake

The boat dock at Miller Creek Reservoir is receiving some much needed repairs and improvements.

The end of the boat ramp has been raised four feet, according to Dolan Moore, North Central Texas Municipal Water Authority manager. In the past when the lake was low, visitors had to find somewhere else to load their water crafts because the ramp was too steep, making it difficult to pull a boat out of the water. This improvement should solve that problem.

In order to repair the ramp, a temporary dam was built to hold back the water. The concrete was poured November 4, and after a few more minor adjustments, the ramp will be open to the public once again.

Two new fishing and boating platforms, or pontoons, have been constructed out of channel and angle iron framework "built to last," according to Moore. The former platforms were torn up by the high winds when the water level was high, and were not as sturdy as the new ones are. They are 20' x 24' and will each have a 4' x 40' walkway.

When the boat dock was built in 1989, the two platforms were placed on either side of the loading ramp, one for fishing and one for boat hookups. The fishermen complained that the boats would See Miller Creek, Page 9

KC Sales Tax Rebate Check Drops 32.32% For Month, 13.87% For Year

(Austin,, November 14, 1994) State Comptroller John Sharp today delivered \$193.5 million in monthly sales tax rebates to Texas cities and counties, including a check of \$9,449.90 to Knox City. The rebate to Knox City is down 32.32% from a big check of \$13,962.76 one year ago. Overall payments for the year to Knox City are \$81,745.22, down 13.87% from \$94,915.19 one year ago at this same time.

Texas cities received \$178.7 million, up 4.1 percent above the \$171.6 million delivered last November. Counties received a vember rebates, 1% percent less ment a year ago.

taxes collected by monthly filers on September sales and by quarterly filers for July, August and September and reported to the Comptroller in October.

For other Knox County cities, Benjamin received \$981.65, up 1.0.4% from \$892.03 last year. Gorce received \$1,042.81, down 8.44% from \$1,139.02 last year. Munday received \$10,431.10, down 5.22% from a payment of \$11,005.64 in 1993. Munday collects a 1.500% rate of sales tax, while Knox City, Benjamin and Goree only collect a 1.000% sales

FmHA Has New Name

TEMPLE - Farmers Home Administration (FmHA) has a new name under the U.S. Department of Agriculture's (USDA) reorganization; however, the same work continues, according to George Ellis, FmHA State Director. Ellis is now named the Acting State Director for Rural Economic and Community Development (RECD).

Congress passed a bill authorizing the reorganization late in September, and Secretary of Agriculture Mike Espy issued orders making the changes on October 20, 1994.

"The entire USDA was reorganized in an effort to provide better service to the public while reducing the number of agencies required to do the same work," Ellis said. "Over the next five years, savings to the taxpayers will total \$3.6 billion through the elimination of 14 separate USDA agencies and staff reductions of up to 11,000 nationwide."

Ellis said the FmHA and the Rural Development Administration (RDA) had been abolished. Most of the loan and grant programs of these two agencies are being taken over under the RECD

The farm lending, rural housing, water and waste disposal community facility, and business and industry programs formerly administered by FmHA or RDA will still be available at the newly named RECD offices. The farm loan programs will eventually become part of the new Consolidated Farm Service Agency, created under reorganization.

"For the time being, people wanting these important services should go to the local office that probably will still have a Farmers Home Administration sign out front," Ellis said. "As additional changes are made, we will let the communities know."



come in and interrupt their fishing, while the boaters would complain that the fishermen were in their way of loading or unloading. Moore will be discussing with the Board the possibility of putting one platform farther down the shoreline for fishing, and the boat dock platform in the other direction, a little ways from the ramp. This might solve the problem between the fishermen on shore and the ones trying to go out in boats.

Eventually lights will be put on the floating platforms, Moore said, but not like the ones it use to have. The new ones will probably be placed high on poles where they will be harder to destroy as the last

ones were.

The Texas Parks and Wildlife Department had a lease when the boat dock was originally built. It was their responsibility to maintain it, and make any repairs. However, after these repairs are finished, the responsibility for the upkeep will likely be turned over to the Water Authority, so Mr. Moore said they wanted to make sure it was done right this time with heavier material that will








SPOUSAL BUSINESS PARTNERS EARN SEPARATE COVERAGE

By Patty Brandt Resident Representative

If you and your spouse operate a business together, you should make sure that the earnings for each spouse are reported correctly to ensure proper crediting for Social Security coverage. Otherwise, you may lose out on potentially valuable Social Security benefits.

Disability benefits, for example, are based on recent work under Social Security. Therefore, if you have no income reported for Social Security coverage in a five-year period, or less than five years of income reported in a 10-year period, you would lose your eligiblity for Social Security disability benefits.

When spouses operate a business together, they are considered business partners and share the self-employment income if certain conditions are met:

 Both spouses contribute capital or services to the business;

2) Each has the right to participate in the management and;

3) Neither is an employee of the other.

It is important that they use the correct tax forms to report their earnings. Use of the correct tax forms will help to ensure that each

spouse receives credit for their distributive share of the partner-ship income. They should check with IRS for instructions on how to file their tax returns.
