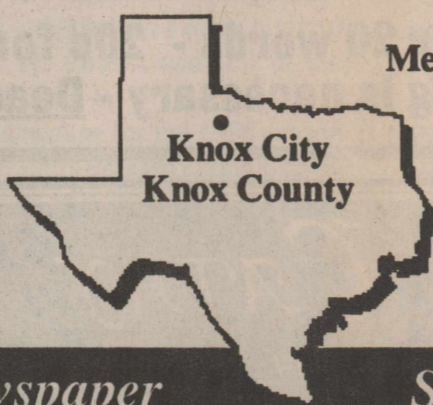

## Three Area Men Sentenced In District Court Cases

Last week was a busy week on the criminal dockets of the District Courts of Baylor and Knox counties, according to District Attorney Bill Neal.

Three area men received penitentiary sentences handed down by District Judge David Hajek.

Nathaniel Lockridge, 37, of Seymour was sentenced to five years in the penitentiary on a felony theft conviction on Tuesday, September 5, in Baylor County District Court. Lockridge had previously plead guilty to stealing from B-K Electric and was placed on probation. The State, through District Attorney Neal, filed a motion to revoke Lockridge's probation on account of Lockridge's failure to make restitution and pay costs and his failure to report to his probation officer. Kris Fouts of Stamford represented Lockridge.

Also in Baylor County District Court, William Lee Worthington, 32, of Seymour was found to have violated the terms of his probation as a felony DWI charge and was sentenced to 30 months in the penitentiary. Worthington was represented by Bret Hanes of Wichita Falls.

In Knox County last Wednesday, September 6, Michael Gene Huckabee, 24, of Haskell was sentenced to five years in the penitentiary by Judge Hajek after pleading guilty to a felony DWI indictment. The State, represented by District Attorney Neal, agreed to drop a retaliation indictment against Huckabee provided that Huckabee plead guilty to the felony DWI charge and accept a five-year sentence in the penitentiary. The evidence indicated that Huckabee had attempted to run a Highway Patrol car off the road after refusing to stop as ordered

by the Highway Patrol. Huckabee had led officers on a high-speed chase through downtown Munday after officers attempted to stop him on suspicion of DWI, according to Neal.

In other action in the Knox County District Court on Wednesday, September 6, Don Dixon, 28, and Chris Hardemon, 17, all of Goree, plead guilty to the sale of a simulated substance which they held out to be cocaine. Gary Dixon and Chris Hardemon were each given a two-year sentence by Judge Hajek, but probated for four years. Don Dixon received a two-year sentence probated for five years. In addition, each was fined \$500.00 by Judge Hajek. Don Dixon was represented by Bret Hanes of Wichita Falls; Gary Dixon was represented by Greg Merkle of Wichita Falls; and Chris Hardemon was represented by Dan Worsham of Vernon.

Kenny Hughes, 34, of Seymour plead guilty to an indictment charging him with retaliation toward a police officer in connection with an attack by Hughes on several officers who attempted to arrest him after a disturbance at a dance in Rhineland on December 10, 1994, according to District Attorney Neal. Hughes, represented by Bret Hanes of Wichita Falls, plead guilty to the charge and was given a deferred adjudication probation to extend for three years. He also was fined \$1,000.00 by Judge Hajek and ordered to make restitution to Knox County in the amount of \$438.65.

David Chavez, 17, of Knox County plead guilty to Burglary of a Building. He was given a two-year sentence but to be probated for three years and also was fined \$250.00. Chavez was represented by Bret Hanes of Wichita Falls.

In other criminal action in the Baylor County District Court last Tuesday, September 5, a new Grand Jury was empaneled by Judge Hajek with Jim Foy named as foreman.

Other members of the Grand Jury include Sharon Baldwin, Belinda Gordon, Donnie Harrington, Delbert Hayes, Dennis Kinnibrugh, Cathleen Lohman, Jerry Macha, Billie McMorris, Carolyn Moorhouse, Sammie Morris, and Judy Wheeler.

After the Grand Jury was empaneled Tuesday, District Attorney Neal presented one case to the Grand Jury, after which the Grand Jury returned an indictment against Michael Landon, 54, of Seymour, charging him with Theft of a Firearm.

The Grand Jury was instructed to return on Monday, September 11, to hear additional matters, according to Neal.

### Seymour Man Draws Five Year Sentence

Guadalupe Juarez, Jr., 25, of Seymour was sentenced to five years in the penitentiary in Baylor County District Court after pleading guilty to an indictment charging him with selling marijuana, according to District Attorney Bill Neal.

Sentence was pronounced by District Judge David Hajek.

The evidence produced by the State showed that the defendant Juarez sold marijuana to an undercover agent in Seymour on July 12, 1994. At the time the agent was working with the North Texas Regional Drug Task Force in cooperation with the Baylor and Knox County Sheriffs' Departments and the District Attorney's office, Neal said.

## Knox City Rolls By Olney, 27-14 - Ups Record To 2-0

First Home Game Is Here Friday With Haskell

Knox City's Greyhounds traveled to Olney Friday night and dampened their homecoming by coming away with a win to the tune of 27 - 14.

Leading the charge for the Greyhounds was Lance Dever who ran for 258 yards on 27 carries and scored two touchdowns on runs of 71 and 67 yards.

Teammate Duane Toliver added to the Greyhounds' cause with two field goals of 35 yards and three PAT's.

David Dudensing opened the game for the Hounds with a 70-yard kickoff return.

Olney's Andy Castro led the Cubs with scoring strikes of 34 and 64 yards to Joe Perez.

The Greyhounds racked up 296 yards in total offense with nine first downs. Olney finished the night with 213 yards with six first downs.

Knox City improved their record to 2-0 while Olney fell to 1-1.

The Hounds will host the Haskell Indians in their first home game of the season beginning Friday at 8:00 p.m. Haskell's record presently stands at 0-2 from defeats by Munday and Quanah.

## Second Annual Hospital Health Fair Planned For Saturday

From 9:30 A.M. Until Twelve Noon

Knox County Hospital is announcing the second annual Health Fair, set for Saturday, September 23, from 9:30 a.m. to noon on the hospital grounds. Administrator Stephen Kuehler said that the Health Fair is even bigger and better this year. "The community responded so well to the Health Fair last year that we were all anxious to offer the community another opportunity for free health screenings and information," he said.

Those who attend the Health Fair will have the opportunity to register for a free complete blood profile, valued at \$200.00. The winner will be drawn from the registrations.

An added benefit this year is mammograms. "Bethania Hospital in Wichita Falls is bringing their mobile mammography unit to Knox City that day," Kuehler said. "The charge for the mammogram is \$65.00. We would like for women to call the hospital at 658-3535 by Friday to schedule appointments."

Kuehler explained that patients who qualify under Medicare, Medicaid, Champus, and Blue Cross/Blue Shield will not have to pay for the mammograms. Financial assistance is also available to those who do not have insurance and cannot pay for the

exam," he said. "Breast cancer will strike one out of every ten women, so we consider this a vital service for the community."

Health care experts recommend that all women have a baseline mammogram at age 35, and then have the exam done every other year until age 50, when the procedure should become an annual test. Kuehler said that the mammogram has proved over the years to be one of the best ways to diagnose breast cancer in the very early stages of development.

Other exhibitors at the Fair will offer free health screenings, give out information, answer questions, and perform other services. For example, the Knox County Sheriff's Department will be there to do free fingerprinting of children.

Health screening available for those attending include blood pressure, height and weight, and oxygen concentration in the blood stream. "We will draw blood and do glucose and cholesterol checks, and Abilene Regional Medical Center will be on hand to do a lipid profile and percent body fat test, for those who want it," Kuehler said. "Fasting is recommended for those who wish to have blood work done."

The Texas Department of Health will give free immuniza-

tions to children. "This is a good opportunity for parents to bring in children who need their shots," Kuehler said. "Proper immunization for all children is one of the major goals in the state of Texas this year."

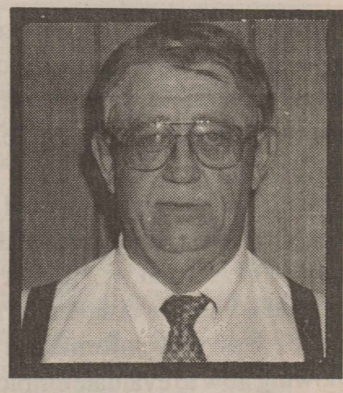


**BILL'S HINESight.....By High School Principal Bill Hines**

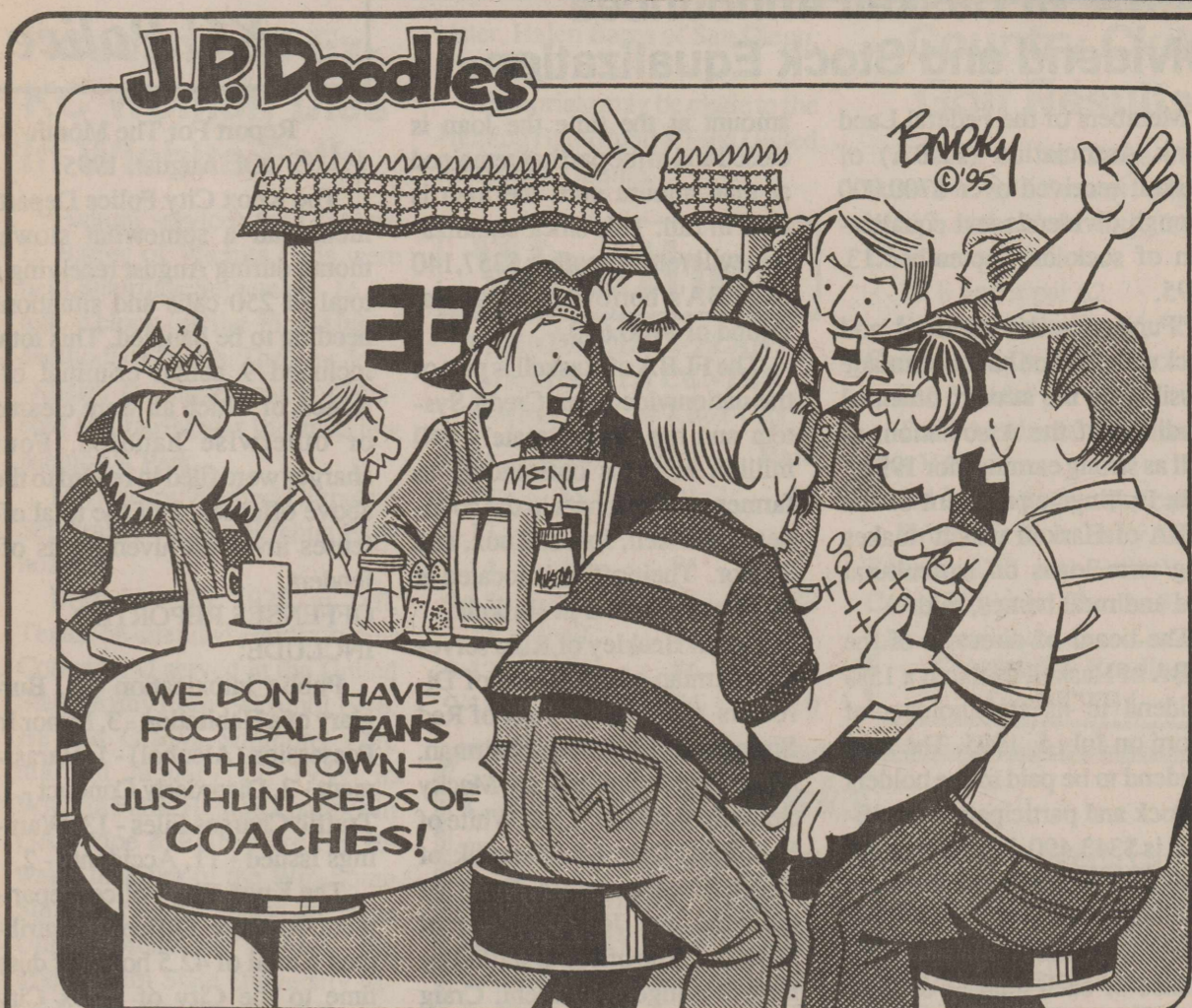

 NOVEMBER 7, 1995

**PROPOSITION NO. 1 ON THE BALLOT**

House Joint Resolution 50 proposes a constitutional amendment providing that the legislature by general law may authorize the Texas Higher Education Coordinating Board to issue general obligation bonds of the state in an amount not exceeding \$300 million to finance educational loans to students. The maximum interest rate to be borne by the bonds must be set by law. The legislature may provide for the investment of bond proceeds and may establish an interest and sinking fund to pay the bonds.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment providing for the issuance of \$300 million in general obligation bonds to finance education loans to students."

**PROPOSITION NO. 2 ON THE BALLOT**

Senate Joint Resolution 36 proposes a constitutional amendment that would authorize the legislature to exempt from ad valorem taxation the property of an organization chartered by the Congress of the Republic of Texas if the property is used primarily for the charitable, benevolent, or public service activities of the organization as defined by general law. The Comptroller's Property Tax Division has identified the Grand Lodge of Texas, also known as the Masonic Lodges, as the primary organization which would qualify for this tax exemption.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to authorize the legislature to exempt from ad valorem taxation property of an organization chartered by the Congress of the Republic of Texas that is used primarily for the charitable, benevolent, or public service activities of the organization."

**PROPOSITION NO. 3 ON THE BALLOT**

Senate Joint Resolution 51 proposes a constitutional amendment that provides that the farm and ranch finance program fund shall be administered by the Texas Agricultural Finance Authority and not by the Veterans' Land Board, as provided by current law. In addition, the proposed amendment provides that the proceeds of \$200 million of the \$500 million in bonds authorized by the Texas Constitution for the farm and ranch finance program fund may be diverted to the agricultural fund and the rural micro-enterprise development fund, also authorized by the Texas Constitution, to be used for agricultural and rural economic development programs.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment allowing the use of existing bond authority of the farm and ranch finance program to include financial assistance for the expansion, development, and diversification of production, processing, marketing, and export of Texas agricultural products."

**PROPOSITION NO. 4 ON THE BALLOT**

Senate Joint Resolution 46 proposes a constitutional amendment that would allow an encumbrance to be fixed on homestead property for an owelty of partition. In divorce and probate situations, a piece of property may be owned jointly by two

or more people, and each person owns an undivided interest in the property, as opposed to a specific portion of the property. If one owner wishes to purchase the other person's interest in the property and wishes to obtain a loan to finance the purchase, the lending institution requires all interests in the property to be used as security for the loan; this is called an owelty of partition. Senate Joint Resolution 46 would allow the lending institution to foreclose on the homestead property for an owelty of partition if the purchaser defaulted on the loan. In addition, the proposed amendment would allow the refinancing of a lien against a homestead. Finally, the proposed amendment would allow a purchaser or lender to rely on an affidavit that states that the property to be conveyed or encumbered is not the homestead of the affiant.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment permitting an encumbrance to be fixed on homestead property for an owelty of partition, including a debt of a spouse resulting from a divorce proceeding, and for the refinancing of a lien against a homestead, including a federal tax lien resulting from the tax debt of the owner."

**PROPOSITION NO. 5 ON THE BALLOT**

House Joint Resolution 34 proposes a constitutional amendment which would increase by \$500 million the constitutional authorization of the Veterans' Land Board to issue and sell general obligation bonds of the state to provide housing financing to Texas veterans. The proceeds from the bonds authorized by this amendment shall be used to augment the Veterans' Housing Assistance Fund II to be administered and invested as provided by law. The bonds authorized by this amendment shall be incontestable after execution by the Veterans' Land Board, approval by the attorney general, and delivery to the purchaser.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to increase by \$500 million the amount of general obligation bonds that may be issued to augment the veterans' housing assistance fund II."

**PROPOSITION NO. 6 ON THE BALLOT**

House Joint Resolution 64 proposes a constitutional amendment which would extend the tax exemption under article VIII, section 1-b(b) of the Texas Constitution for the residence homestead of a person age 65 or older to the surviving spouse of a person who received the exemption. The surviving spouse must be age 55 or older when the deceased spouse died, and the property must be the residence homestead of the surviving spouse when the deceased spouse died and remain the surviving spouse's residence homestead. A surviving spouse who already receives an exemption under this section of the Texas Constitution is not entitled to an additional exemption under the amendment.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment exempting from ad valorem taxation the residence homestead of the surviving spouse of an elderly person."

**PROPOSITION NO. 7 ON THE BALLOT**

House Joint Resolution 73 proposes a constitutional amendment that would reduce the amount of general obligation bonds authorized for the superconducting super collider fund from \$500 million to \$250 million.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment reducing the amount of general obligation bonds authorized for undertakings related to the superconducting super collider research facility from \$500 million to \$250 million."

**PROPOSITION NO. 8 ON THE BALLOT**

House Joint Resolution 80 proposes a constitutional amendment abolishing the office of constable in Mills, Reagan, and Roberts counties. In Mills County, the office of constable is abolished, and the powers, duties, and records of the office are transferred to the sheriff. In Reagan and Roberts counties, the office of constable is abolished and the powers, duties, and records of the office are transferred to the sheriff only if a majority of voters in each of the respective counties favors the proposed amendment.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment providing for the abolition of the office of constable in Mills, Reagan, and Roberts counties."

**PROPOSITION NO. 9 ON THE BALLOT**

Senate Joint Resolution 7 proposes a constitutional amendment that would allow investment of money from the Texas growth fund in a business without the business's disclosure of its investments in or with South Africa or Namibia. Currently, such investments are prohibited by article XVI, section 70(r) of the Texas Constitution, which would be repealed.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment allowing investment of money from the Texas growth fund in a business without the business's disclosure of its investments in or with South Africa or Namibia."

**PROPOSITION NO. 10 ON THE BALLOT**

Senate Joint Resolution 1 proposes a constitutional amendment that would abolish the constitutional office of state treasurer effective September 1, 1996. The transfer of specific constitutional powers and duties to the comptroller of public accounts takes effect on that date. The statutory powers and duties and the property and other obligations of the state treasurer are transferred to officers and agencies of state government as the legislature provides by general law.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment abolishing the office of state treasurer."

**PROPOSITION NO. 11 ON THE BALLOT**

House Joint Resolution 72 proposes a constitutional amendment requiring that land devoted to wildlife management be taxed on the basis of its productive capacity. The proposed amendment also adds a temporary provision to the Texas Constitution validating the changes to the law made by Chapter 560, Acts of the 72nd Legislature, Regular Session, 1991, which amended the Tax Code to allow land used for wildlife management to be appraised as agricultural land. The temporary provision also provides that a property owner is not authorized to claim a refund of taxes paid unless the tax payment was challenged before the effective date of the proposed amendment. The temporary provision expires on January 1, 1998.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to allow open-space land used for wildlife management to qualify for tax appraisal in the same manner as open-space agricultural land, subject to eligibility limitations provided by the legislature."

**PROPOSITION NO. 12 ON THE BALLOT**

House Joint Resolution 31 proposes a constitutional amendment providing that the legislature may exempt from ad valorem taxation income-producing personal property and mineral interests that have a taxable value which is insufficient to recover the costs of administering the tax.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the legislature to exempt from ad valorem taxation personal property and mineral interests having a value insufficient to recover the administrative costs of collecting the taxes."

**PROPOSITION NO. 13 ON THE BALLOT**

House Joint Resolution No. 35 proposes a constitutional amendment authorizing the governing body of a political subdivision to exempt from ad valorem taxation boats and other equipment used primarily in the commercial taking or production of fish, shrimp, shellfish, and other marine life.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the governing body of a political subdivision to exempt from ad valorem taxation boats and other equipment used primarily in the commercial taking or production of fish, shrimp, shellfish, and other marine life."

**PROPOSITION NO. 14 ON THE BALLOT**

House Joint Resolution 68 proposes a constitutional amendment that allows the legislature to raise the current ad valorem tax exemption for disabled veterans and their surviving spouses and minor children. The tax exemptions would be raised based on a veteran's disability rating as follows:

Disability	Maximum Tax Exemption
10%-30%	\$ 5,000
30%-50%	\$ 7,500
50%-70%	\$10,000
More than 70%	\$12,000
Age 65 and 10% or higher	\$12,000
Loss or loss of use of limb	\$12,000
Blindness or paraplegia	\$12,000

The spouse and children of any veteran who dies while on active duty may be granted an exemption of up to \$5,000. The amounts of the exemptions provided for in this proposed amendment may be repealed by the legislature by general law.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment relating to raising the limits of the exemption from ad valorem taxation of property owned by disabled veterans or by the surviving spouses or surviving minor children of disabled veterans."

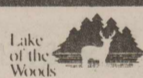

## FLBA of Haskell Announces Dividend and Stock Equalization

Members of the Federal Land Bank Association (FLBA) of Haskell received over \$700,000 through dividends and equalization of stock on September 13, 1995.

"Funds for the dividend and stock equalization have been made possible by the strong financial condition of the Association, as well as strong earnings for 1994," Dale Bullinger, president of the FLBA of Haskell which makes long term loans on agricultural land and rural homes, said.

The board of directors of the FLBA of Haskell declared a 15% dividend to its stockholders of record on July 1, 1995. The total dividend to be paid to the holders of stock and participation certificates is \$343,490. In addition, the Association has announced an equalization of stock to five per cent of the outstanding principal balance of each loan as of September 1, 1995. FLBA stock is issued at five per cent of the loan

amount at the time the loan is closed and in the past has remained at that amount until the loan is paid in full. This stock equalization will return another \$357,140 to FLBA's borrowers for a total refund of \$700,630.

The FLBA of Haskell is part of the nationwide Farm Credit System and has approximately \$40 million in loans outstanding to farmers and ranchers in the counties of Haskell, Jones, Knox, and Baylor. Their office is located at 550 South Second in Haskell.

Lavon Beakley of Rule serves as chairman of the Board of Directors with Ernest Beck of Red Springs serving as vice-chairman. Other board members are Macky Spurgin of Anson, Lynn White of Stamford, Dale Middlebrook of Paint Creek, Louis Baty of Gilliland and Jerry Kuehler of Seymour. The office is staffed by Dale Bullinger, president; Craig McCormick, vice-president; and Laquita Liles, office manager.

## KC Police Dept. Report

Report For The Month Of August, 1995

The Knox City Police Department had a somewhat slower month during August receiving a total of 250 calls and situations needing to be handled. This total included 9 actual criminal offenses, of which all were cleared or otherwise handled. Four charges were filed in regard to the above offenses, 2 of the total offenses involved juveniles as offenders.

### OFFENSES REPORTED INCLUDE:

Public Intoxication - 2, Burglary of a Habitation - 3, Minor In Possession (Alcohol) - 1, Harassment - 2, Disorderly Conduct - 1, Traffic Charges Files - 13, Warnings Issued - 11, Accidents - 2.

The Knox City Police Department Reserve Officers contributed a total of 42.5 hours of duty time to the City of Knox City during the month of August 1995.

Other items reported to the Knox City Police Department during August are classified as incidents. These incidents either did not occur in the City of Knox City or for some other reason were not able to be considered as criminal offenses.

### INCIDENTS REPORTED INCLUDE:

Domestic Disturbance - 2, Harassment - 1, Disorderly Conduct - 1, Forgery - 1, Recovered Property - 1, Lost Property - 1.

Although the incidents are either not considered as criminal offenses or were not reported as a criminal offense, they must be investigated to determine if they are to be referred to another agency or if a record is to be made for future reference. During the month of August, all incidents were settled to the satisfaction of this department.

On August 17th, Officers Walker, Curd, Steen and I attended a course in Seymour sponsored by the Texas Municipal League Insurance Company. The topic of the course was instruction in Police Emergency Vehicle Response tactics. The information presented included logical procedures when acting in an emergency situation whether it may be a pursuit or answering an emergency call.

Also presented were liability concerns if either involved in an accident or causing an accident when driving an emergency vehicle.

On August 28th-30th, I attended a Supervisory school in Abilene. The school was held at the WCTLEA and was put on by the Council of Governments. This school was very informative in showing how to evaluate employees as well as how to deal with the general public as well as the individual's supervisor.

In response to several complaints about traffic movement around the school area, a point has been made to be visible in that area. Several tickets have been written as well as a few warnings. Traffic enforcement has also been stepped up around other areas of the City of Knox City in response to the complaints about the traffic movement, as well as the obvious general disregard for traffic control signs and regulations.

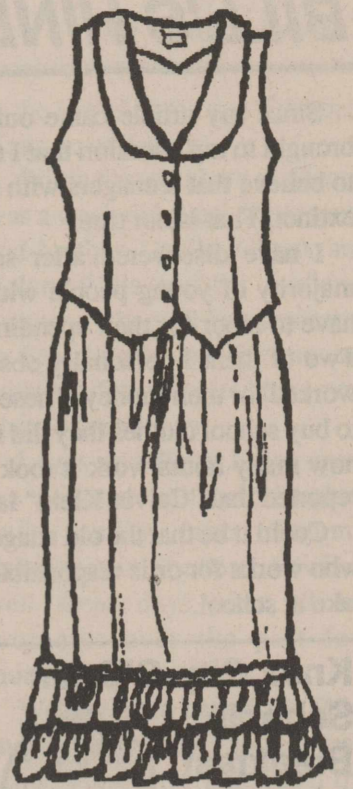

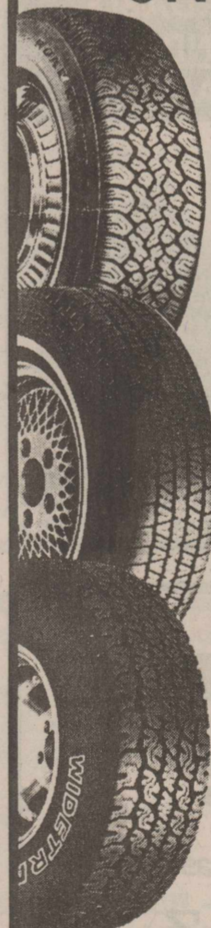

**VOTERS TO DECIDE AMENDMENTS**

Everyday I hear from folks in District 70 who want to take a more active role in their state government but do not know how to get involved. On November 7, 1995, Texans will have the opportunity to make a number of decisions affecting the operation of their state. Unfortunately, only around 20% of registered Texas voters turn out for constitutional amendment elections. In fact, in 1993, only 12.5% of Texas voters made their voices heard on a number of important issues, including their views on a state income tax.

This November, you will have the opportunity to decide on 14 statewide propositions ranging from the issuance of bonds to state policies toward South African businesses. Many of these issues can be somewhat confusing and even a little ambiguous. For that reason, over the next few weeks, I will be providing information to your local media regarding the pro's and con's of each of these proposed amendments on the ballot in the upcoming election. It is my hope that this information will provide you with the needed materials to make well informed choices in the voting booth this fall. Here is a list of the constitutional amendments that you will be seeing on the November 7th ballot.

- Proposition 1:** The amendment providing for the issuance of \$300 million in bonds to finance education loans to Texas students.
- Proposition 2:** The amendment to exempt charitable and public service organizations, chartered by the Congress of the Republic of Texas, from property taxes.
- Proposition 3:** The amendment to allow the Texas Agricultural Finance Board to use existing farm and ranch finance bonds for guaranteed loans to agricultural businesses.
- Proposition 4:** The amendment to allow Texans to refinance homes to pay off tax debts to the IRS or to purchase a divorced spouse's equity in a home.
- Proposition 5:** The amendment to allow the Veterans' Housing assistance fund to issue an additional \$500 million in bonds.
- Proposition 6:** The amendment to exempt the residence homestead of the surviving spouse of an elderly person from ad valorem taxation.
- Proposition 7:** The amendment to reduce the amount of general obligation bonds relating to the super collider by \$250 million.
- Proposition 8:** The amendment to abolish the office of constable in Mills, Reagan, and Roberts County.
- Proposition 9:** The amendment allowing investment of money from the Texas Growth Fund in businesses without their disclosure of their investments in or with South Africa or Namibia.
- Proposition 10:** The amendment abolishing the office of state treasurer.
- Proposition 11:** The amendment allowing for the appraisal of open spaced land used for wildlife management in the same manner as open spaced agricultural land.
- Proposition 12:** The amendment exempting ad valorem taxation of land and mineral interests with a value insufficient to recover the costs of administering the taxes.
- Proposition 13:** The amendment allowing municipalities to exempt boats and equipment used by commercial fisher operations from ad valorem taxes.
- Proposition 14:** The amendment raising the limits of ad valorem tax exemption of property owned by disabled veterans, their surviving spouses, or minor children.
