

Two Vehicle Accident Near Plainview Critically Injures Herbert Bellinghausen

Accident Claims The Life Of Herbert's Brother, Wilfred Bellinghausen of Munday

Knox City resident Herbert Bellinghausen is in 'very critical condition' following an accident on the South Plains Monday afternoon that claimed the life of his brother, Wilfred Bellinghausen, and injured a Plainview man.

Both Bellinghausen men were in Herbert's pickup truck, heading southbound on FM 2301 near Plainview, when they were involved in a collision with Jesse Gonzales, 30, of Plainview, who was traveling eastbound on FM 788. The Bellinghausen pickup was hit on the passenger side with enough force to nearly tear the pickup truck in half. Wilfred Bellinghausen, 71, of Munday, a passenger in Herbert's pickup, lost his life as a result of the accident.

Herbert Bellinghausen was taken by ambulance to Plainview Methodist Hospital, then later airlifted to Methodist Hospital in Lubbock. His conditioned worsened during the flight by helicopter ambulance, with Herbert's blood pressure going critically low. After arriving at Lubbock's Methodist Hospital, Herbert underwent surgery for internal bleeding. During surgery, it was discovered that a portion of his heart was bruised, but he did not suffer a heart attack, as some have reported to have heard.

Speaking with Sarah Meinzer, Herbert's daughter, at about 3:30 P.M. on Tuesday from the surgical intensive care unit waiting room at Methodist Hospital, she

advised that her father was in "very critical condition," but added that the doctors were encouraged as Herbert's vital signs were now stable. The medical team working each 24 hour period of Herbert's recovery is very important. Sarah indicated that her father had "lots of broken bones, and was swollen and discolored with a lot of bruising starting to appear.

Sarah Meinzer added that the many phone calls by friends and family are appreciated by all.



Speed Limit Goes To 70 On U.S. & State Highways

All U.S. and state highways in Texas Department of Transportation's (TxDOT) Childress District were posted at 70 mph by Friday, February 9, completing the third phase of the speed limit change.

The only remaining roadways that have not yet seen a speed limit increase are farm-to-market and ranch-to-market roads. Increased speed limit signs will be posted on those roads by May 9, 1996, completing the fourth and final phase of the speed limit increase. However, based on safety surveys done by TxDOT, some farm-to-market and ranch-to-market roads may not be posted at 70.

Signs for the first phase, which included all interstate highways and continuous four-lane divided highways, were erected on December 8, 1995.

Phase two included undivided highways of four or more lanes. Because there is a limited number of these highways in the area, they were included with phase three.

In Texas, a 1963 law set the maximum speed limit at 70 mph day / 65 night for passenger vehicles (60/55 for trucks) on the state highway system. That law was in place when the 1974 federally mandated 55 mph limit went into effect. In late November 1995.

Lawn & Garden Insect I.D. Program Slated

To help with the task of identifying lawn and garden insects, the Knox County Horticulture Committee and the Knox County Agricutural Extension Service will be sponsoring a lawn and garden insect I.D. program beginning at 7:00 p.m. Tuesday, February 20, at the TAMU Vegetable Research Station on Hwy 277 in Munday.

The program will be conducted by Emory Boring Extension entomologist in Vernon.

Many homeowners in the Rolling Plains of Texas suffer from insect damage in their lawns or gardens every year. When they inquire as to how to rid these problems, the most important step is proper identification.

Just because the lawn or garden is full of insects, it is not always necessary to begin spraying insecticides. Many insects are very beneficial, and many pest insects can be controlled quite easily by these beneficial insects. This makes identification very important.

Once an insect is identified as a pest, it is vital to understand how that pest affects the plant before applying any type of chemical. Some insecticides work well on some pests but are absolutely worthless on others.

They say the truth hurts, and the truths in that letter must have hurt from all the emotions the letter aroused in some.

But, those who read that letter carefully will see that hurting was not the sheriff's aim, that what he wanted to do was help Knox County young people and their parents by calling attention to some problems in our county, not in some distant city, but in our rural county.

One problem seems to be that some parents drop off their preteen children at night at public events. Whether the event is a basketball game at school or a parking lot gathering at an adult dance the result is that no adult really has an eye on the children for one or more hours. When children are turned loose to roam at a school gym they don't always stay inside the gym. Even if they are in the gym they are freer to do and say things they shouldn't because no adult present is directly charged with the responsibility to tell such a child "Don't do that" or "Don't

If you get "roaming rights" at age 10, then you expect to expand your control in the teen years so maybe helping teens make good choices could start with a community attitude and statement about pre-teens on the loose.

Parents have the ultimate responsibility but other citizens, churches, the schools, civic organizations, etc. can help form rules and community attitudes for parents to consider as they make parental choices.

For example should a ten year old at a basketball game without a parent be allowed to run in and out of the building? If a parent




