Work Continues On Ambulance Service Building

Work is nearing completion on the building that was purchased recently and is being converted into a permanent headquarters for the Silverton Volunteer Ambulance Service.

This work will require the expenditure of \$20,000 to complete, and this includes the purchase price. The EMS group received a grant of \$10,000 from the Amarillo Area Foundation, and this is being matched with \$10,000 from local donations, which includes money from the Martha Ann Cogdell Memorial Trust Fund.

Projected completion date is in March, and at that time all equipment and supplies will be moved into the new facility.

Work continues inside the building with partitioning of new rooms. A new roof has been installed, along with a new heating system. The ceiling is being enclosed. New plumbing is finished, and the new overhead doors are in place. The building is being prepared for painting inside and outside.

Cabinets for storing supplies have been ordered and will be installed when they arrive.

The ambulance service appreciates very much the donations and assistance of local people to this project.

The program for the evening will include a progress report of youth development, program area committee reports and an annual report from the Briscoe County Extension Agents.



Senate's Only Farmer Files For Re-Election

Thirtieth District State Senator Steven A. Carriker has filed in the Democratic Primary for re-election to the office he has served since 1988.

At the age of 43, Senator Carriker is among the youngest members of the Texas Senate and the only member of the Senate to make his living as a farmer. He is a graduate of The University of Texas and his wife, Kathy, a Texas Tech graduate, is a public school teacher. They have three children: Jake, a student at Southwest Texas University, and Karen and Stephanie, who attend elementary school in Roby.

Senator Carriker has been active in health care issues and was responsible for the 1989 law that has helped create over 170 rural health clinics in communities that had lost or were in danger of losing their health care facilities entirely. His work in health care has earned him awards from the Texas Association of Community Health Centers, the Joint Conference on Aging, and a special resolution honoring him by the Texas Silver-Haired Legislature.

Senator Carriker has passed six bills reducing taxes and protecting taxpayer rights. Among those are bills reducing the oil severance tax, abating property taxes, and protecting retirees from illegitimate income taxes levied by other states.

Senator Carriker also has just completed a four-year term on the Texas Sunset Commission where his work resulted in the abolition or consolidation of ten agencies and a savings to taxpayers of 54 million dollars.

"I am proud of the confidence the people of the Thirtieth District have placed in me and am glad to have the opportunity to continue to represent them," Senator Carriker said.





Labaume-Childre Vows Exchanged in Holiday Ceremony

In a holiday setting, wedding vows were recited by Kelli DeAun LaBaume and Charles Bellinger Childre during a 5:00 p.m. ceremony on Saturday, December 18, at the First Baptist Church in Floydada. Dr. Joe Barnett, family friend of the groom and former minister of the Broadway Church of Christ in Lubbock, performed the double-ring ceremony. The bride was escorted and given in marriage by her father. After the giving of the bride, he offered a prayer of blessing.

Parents of the couple are Jon and Elaine LaBaume of Floydada and Stewart and Judy Childre of Lubbock. Grandparents of the bride are Ashel and Mildred McDaniel of Silverton and H. S. and Emma LaBaume of Stephenville. Grandmothers of the groom are Ruth Childre and Garnett Holbrook, both of San Antonio.

The bride chose a traditional white silk satin wedding gown by Demetrios, featuring a sweetheart neckline and lego-mutton sleeves, the fitted forearm of which tapered to a point on her hand. Underneath the large pour of the sleeve was gathered Venetian lace. The gown had a fitted bodice that was embellished with appliqued lace over the entire front and back and dropped to a basque waistline. The gown was buttoned down the back with satincovered buttons. The bouffant skirt had a large applique in the front and the cathedral-length train had multiple Venetian lace inserts. A wide floral lace edged the skirt and train.

The Venetian lace and appliques were accented with luxurious beading with hand-sewn pearls and irridescent sequins. Her tulle pouf veil was attached to a luminous crown interwoven with studded pearls and irridescent sequins that matched her




