Did you know?

There are Moon Trees!



A moon tree stands tall, at NASA's Goddard Space Flight Center in Greenbelt, Maryland.

Moon trees are trees grown from 500 seeds taken into orbit around the Moon by Stuart Roosa, the Command Module Pilot on the Apollo 14 mission in 1971. Roosa, who had been a smoke jumper, was contacted by Ed Cliff, the Chief of the Forest Service at the time, with the idea of taking the seeds along.

Upon return to Earth, the seeds were germinated by the Forest Service. Known as the "Moon Trees", the resulting seedlings were planted throughout the United States (often as part of the nation's bicentennial in 1976) and the world. They stand as a tribute to astronaut Roosa and the Apollo program.

A Loblolly Pine was planted at the White House, and trees were planted in Brazil, Switzerland, and presented to the Emperor of Japan, among others. Trees have also been planted in Washington Square in Philadelphia, at Valley Forge, in the International Forest of Friendship, and at various universities and NASA centers.

17 traffic signs stolen from FM 1730 in Lynn County

The Texas Department of Transportation (TxDOT) reports that vandalism and theft of traffic signs is a big issue. In recent weeks, several signs in Lynn County have been stolen. More than 17 traffic signs on FM 1730 in Lynn County alone have been stolen over the past two weeks, according to TxDOT sources.

"We've had a variety of signs stolen in Lynn County. It ranges from stop signs to city limits signs, county line signs, advance warning signs, and roadway (FM) signs," Dianah Ascencio, TxDOT Public

Information Officer, told *The News*.

"It's no joking matter. Tampering, vandalizing or removing traffic signs is a crime—not to mention a serious safety hazard that puts lives at risk," said Steve Warren, P.E., TxDOT Lubbock District engineer. "Serious consequences can result when signs are moved, knocked down or stolen. People can be seriously injured or killed. Signs don't just provide road designations. They provide important in-



formation to travelers, especially for those who are unfamiliar with the area."

Replacing stolen or damaged signs takes limited funds for roadway maintenance away from needed projects and repairs. It costs Texas taxpayers millions of dollars annually to replace these signs. That includes knocked down signs and mailbox posts.

The cost of replacing a sign ranges from \$600 to \$1,100, depending on the type of sign.

Damaging, destroying or tampering with transportation communications devices or equipment, including signs, signals and traffic barrels and barricades is a third-degree felony if the amount of the loss is \$150,000 or less. The penalty for a third-degree felony is two to 10 years imprisonment in a state penitentiary and a \$10,000 fine.

TxDOT continues to ask the public for help by reporting missing signs and for information leading to the return of stolen signs or to the conviction of the persons responsible for sign thefts and vandalism.

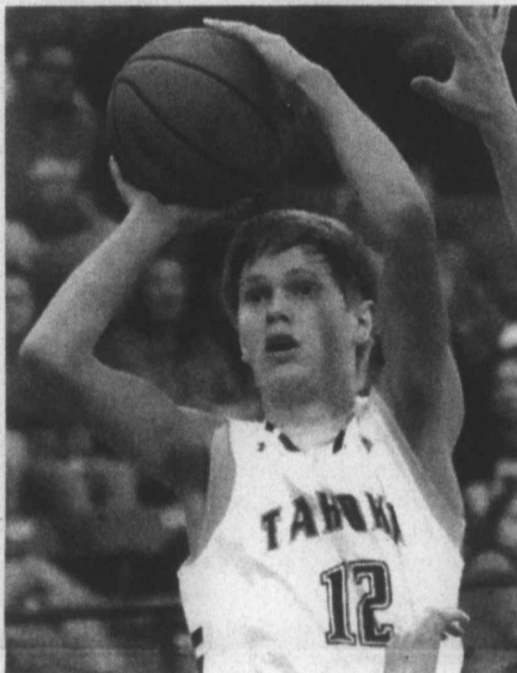
Grant funds, coronavirus topics at county session

Lynn County Commissioners met in routine session Monday morning at the county courthouse, discussing a grant funding opportunity for a new records management system at the Sheriff's Office, and getting a report from the county's emergency management coordinator on information about the coronavirus issue.

Bill Schoemann, Lynn County Emergency Management Coordinator, stated that there are currently no known coronavirus cases reported in Lynn County, but that testing supplies for the coronavirus are just now

Same song, second verse:

Nazareth powerhouse gets in way of New Home ticket to state tourney

It was the second clash between New Home and Nazareth in Class 1A regional basketball finals in a week, but this time it was the boys team that Nazareth stopped from getting a ticket to the UIL State Basketball Tournament. The Swifts crushed the Leopards' hopes for what would have been a trip back to the state UIL basketball tournament for the first time since 1988, according to a New Home sports fan.

A week ago Saturday, the Nazareth Swiftettes beat the Lady Leopards 37-30 in the regional finals.

This past Saturday, Nazareth beat the New Home Leopards 54-39 for the regional title, after Coach Koby Abney's Leopard squad beat Texline 44-42 to win the regional semifinals on Friday. Nazareth goes on to face LaRue LaPoynor in the state semifinals in San Antonio.

The Leopards finished a terrific season as undefeated District Champions, and claimed Area, Regional Quarterfinal, and Regional Semifinal titles before bowing out in the regional finals. With only two seniors coming off the squad, Kaleb LeClair and Blake Buckelew, the Leopards will be a team to watch for next year's playoffs.

In action at Levelland's SPC Texan Dome on Saturday, the Leopards stayed fairly even with the Swifts throughout the first three quarters, but in the end foul trouble and missed shots gave Nazareth a chance to pull ahead for the win.

Freshman Reagan Fiedler led scoring for the Leopards with 16 points, of which 14 were in the first half. He scored New Home's only 6 points in the first quarter, as they trailed 11-6 going into the second quarter, but the Leopards rallied back, and the lead changed hands six times in the first half. The half-time score was tied at 22-22.

Nazareth's 3-point accuracy gained 6 points right away to open

the third period, and the Swifts added 16 points in the third while holding the Leopards to 8, taking a 38-30 lead going into the final period. Heavy hitter Reagan Fiedler got into foul trouble early in the fourth, as did Ryan Weeks, both with four fouls each with another seven minutes of play left in the game. The Swifts stretched their lead by 10 points, leading 46-36 with two minutes left, and made good on several free throws on the line to gain a total of 16 points in the fourth to the Leopards' 9.

Kaleb LeClair was another leading scorer in double figures for the Leopards, with 10 points. Trevor Wilson had 8 rebounds.

Regional Semifinal match: The Fast and the Furious

The regional semifinal match on Friday was a fast and furious clash between New Home and the Texline Tornados, with Ryan Weeks tossing in a 2-point buzzer-beater to get the win for the Leopards, 44-42. Weeks was the top scorer for the game with 18 points, with Fiedler adding 14, and LeClair another 8. Wilson led in rebounds, with 7, with Weeks getting credit for 5 rebounds and LeClair 4.

New Home trailed 11-8 at the end of the first quarter, but tied it 17-17 at the half. The Tornados gained the upper hand in the third to lead by 6 going into the final period, 35-29.

The never-say-die Leopards charged back in the fourth with some crucial free throws and timely baskets, tying the score several times, but the Tornados responded immediately with their own baskets, and the final period was

a fast-paced evenly-matched eight minutes that had fans on both sides holding their breath. With only a couple of seconds left, tied 42-42, the Leopards worked the ball to Weeks, who was the hero of the hour with his basket for the win.

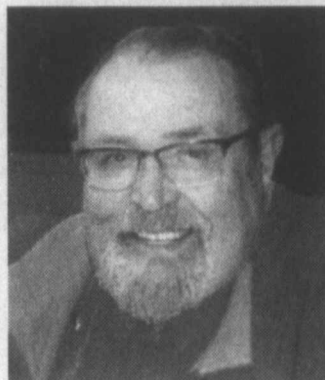
The gate operator will be handing out copies of the new changes. We will also have copies at city hall, on our web site, and our Facebook page.

Three Decades of Service:
Longtime hospital employee
Donna Raindl retiring this week

It's been 32 years since her first day as an employee at Lynn County Hospital District, but this week marks the final days of her long career for the local hospital. Donna Raindl, Controller and Compliance Officer for Lynn County Hospital District (LCHD) in Tahoka, is retiring after 32 years. She was being honored with a retirement reception on Wednesday, March 11, from 2:00-3:30 p.m. at the LCHD Meeting Room.

Succeeding Raindl at the hospital is Donna Garrett, Business Office Manager and Compliance Officer, and Marcus Bermea, Controller.

Much of Raindl's adult life has been spent at the local hospital.

"I turned 64 last month and I have been at LCHD for 32+ years. I didn't work the first 18 years of my life, so that means much of my adult life hours were spent at this hospital!" says Raindl.

"It sounds daunting, but actually it seems like only yesterday," she admits. "Tan-ya Tucker has a new song out now that says 'the days are long but the years are lightning' and it is so true. It seems like yesterday that I started here as a part-time Medicare Remittance documenter. Within two weeks I was full-time doing admissions and billing. Then the business officer director retired, and she felt I could do that, and then it seemed that every few years I added an additional title and additional responsibilities," she remembers.

Raindl says she very much appreciates the opportunities she has had with LCHD.

"I have been so privileged to learn so many different roles within the hospital, and LCHD has given me opportunities to travel for workshops. I feel LCHD has given me more than I could ever give back to it."

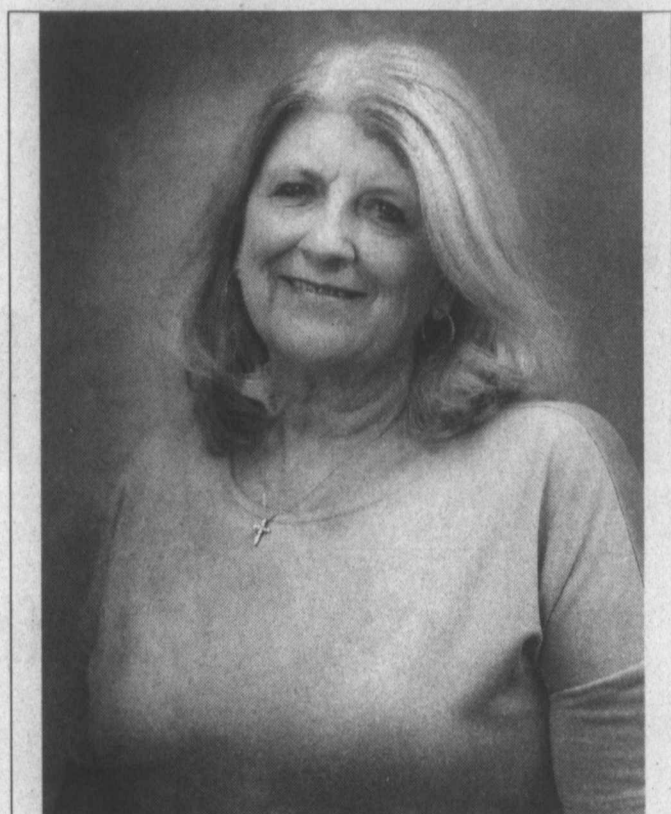
Many changes have occurred in the hospital's business office throughout the more than three decades of Raindl's tenure.

"There have been many, many changes in 32 years. We posted all our AP, Payroll, Accounts Receivable, and payments thru a massive Pitney

Bowes machine that covered a full wall of the business office. We then got our first computer system, but none of us had computer skills, so THS teacher Barbara Jaquess taught us the basics during night school. That was super fun (NOT!...sorry Barbara). We kept that system for over 20 years and I loved it and since then have had several more systems which were nightmares for the switchovers. I know we have spent some long nights at the hospital trying to learn new systems. We have also rearranged many offices and workspaces, but the business office, patient rooms and dietary have remained constant," says Raindl.

Throughout the years, however, the biggest and most obvious changes have been in the staff at LCHD.

"Although there were a few regulars that have logged many years here (Carmen Chapa, Donna Fields, and Tina Marquez for example) it seems we were always training someone. I remember once I was so excited to bring in a local lady to do commercial billing because I thought, 'she has family here so she will be a long-timer...' She came in that Monday morning and she was given an overview of her duties and the first of many trainings. She went home for

lunch, called me and said this was not her cup of tea and she would NOT be back! I had to laugh to keep from crying but it is true, the medical field is a world of its own and it takes a special person to do any and all of it ...from billing, to cleaning, to care-giving, to nursing!" Raindl recalls with a smile.

"Looking back, we have had lots of good, good moments and many laughs. But what I remember the most is the folks I have worked with have been much more than co-workers. When you spend each and every day with people, you learn to love them and care for them. We know each other's plans and dreams. They are there when you get that call that your mom has passed unexpectedly, or your EMS director (Barbara Cook) has terminal cancer, or the ambulance is on the way to get your unresponsive uncle, or I could go on and on. They

are your strength and your back up to cover you when you are out – and we feel each other's pain and sadness, as well as happiness and gladness! I am so blessed to have such wonderful friends thru LCHD.

"As I reflect on the past 32 years, it amazes me how far and how much LCHD has grown. When I came here to work, I would never imagine we would have this many doctors, nurse practitioners and certified staff employed here. We have outsourced to O'Donnell and Post, built numerous clinics, enlarged our workforce and our EMS services, added on to the hospital, opened Lynnwood... etc, etc. Who would have thought this little rural 24-bed hospital could be so thriving? I never doubted it once in my 32 years!! Rock on LCHD...I love you dearly!" concluded Raindl.

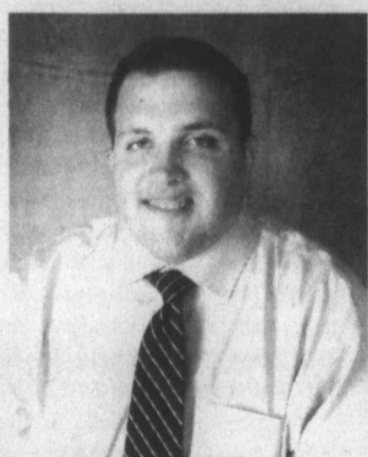

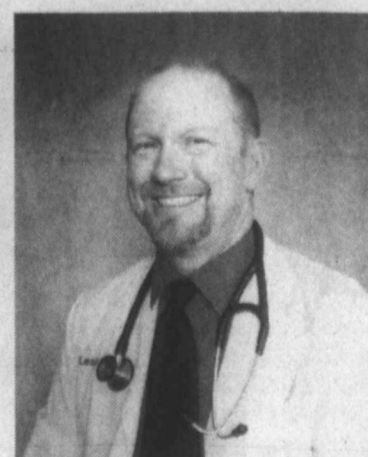

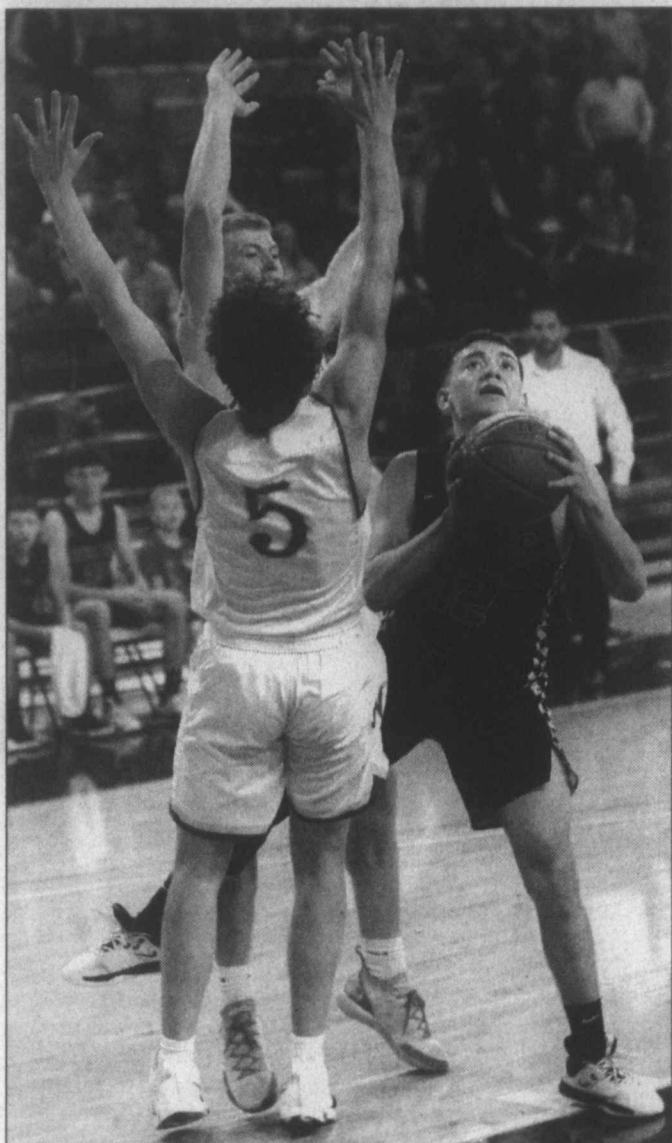

Nazareth stops O'Donnell Eagles in regional semifinal playoffs

The O'Donnell Eagles faced the Nazareth Swifts in 1A Regional Semifinal basketball playoffs at SPC's Texan Dome in Levelland on Friday. The Eagles played well against a much taller Nazareth team, missing a chance to advance in the tournament by only 5 points, as the Swifts won 48-43 to advance.

The Eagles, in the bottom of the 1A regional bracket, would have faced another Lynn County team, the New Home Leopards, from the top of the bracket if they could have pulled off the win, but it was not to be.

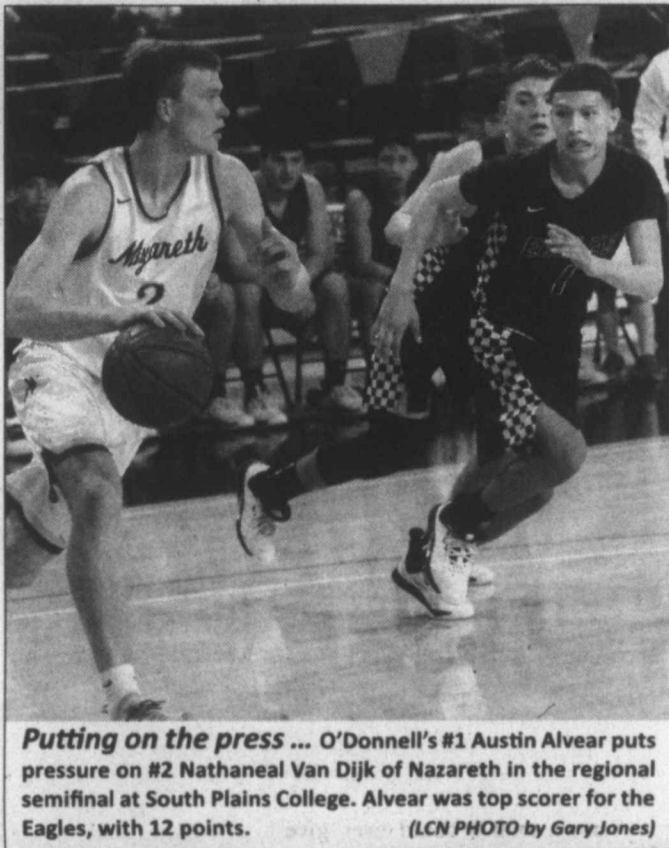
O'Donnell, under the direction of Coach Rocky Feliciano, finished at 26-7 for the season, claiming the titles of District Champions, Area Champions, and Regional Quarterfinal champs along the

way. Austin Alvear was lead scorer with 12 points for the Eagles in the semifinal match, and Elvis Garces added 11, with Jonah Vasquez 9, and Jochi Rodriguez 8.

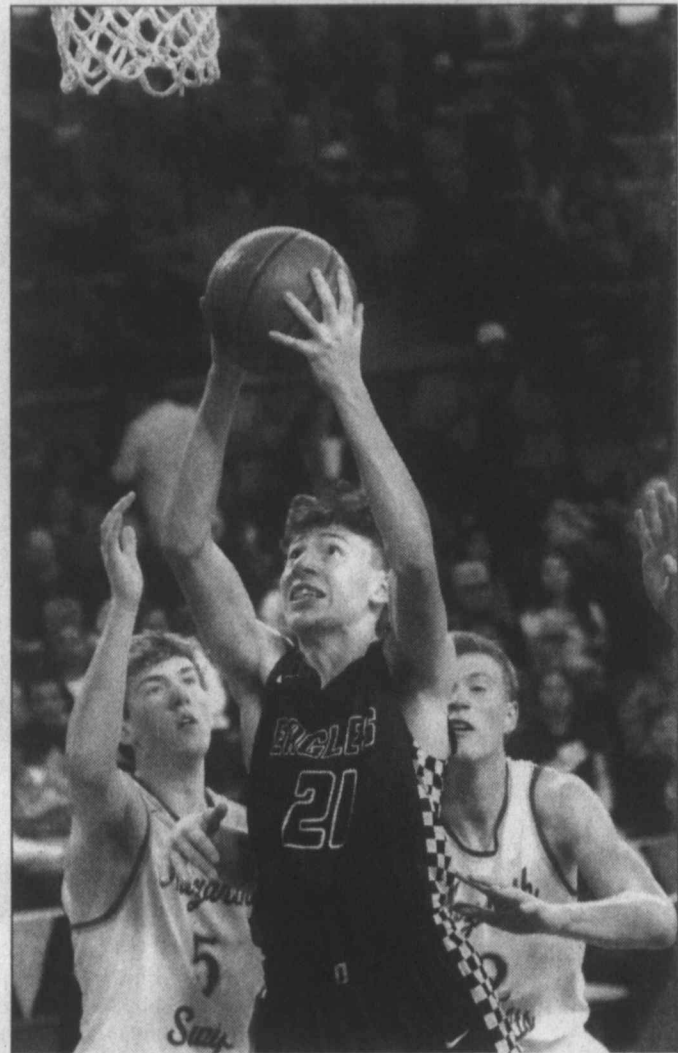
The feisty Eagles held their own with the taller Nazareth squad, trailing 8-7 by the end of the first quarter, and both teams scoring only 7 points each in the second quarter, with Nazareth leading 15-14 at the half.

In the third, the Swifts lengthened their lead by 10, at 36-26 going into the final period, but the Eagles never quit, closing the gap steadily.

A 3-point basket by Alvear put the Eagles only 1 point behind, trailing 44-43 with 1:58 left in the game. Nazareth made good on a series of free throws from the line, however, that in the end gave them the win by 5.

Man sentenced to 6-year prison term for DWI

A man was sentenced to six years in prison, in 106th District Court proceedings held Monday, March 3 in Tahoka. District Judge Reed Filley sentenced KC Castaneda, 35, to six years in the Texas Dept. of Criminal Jus-

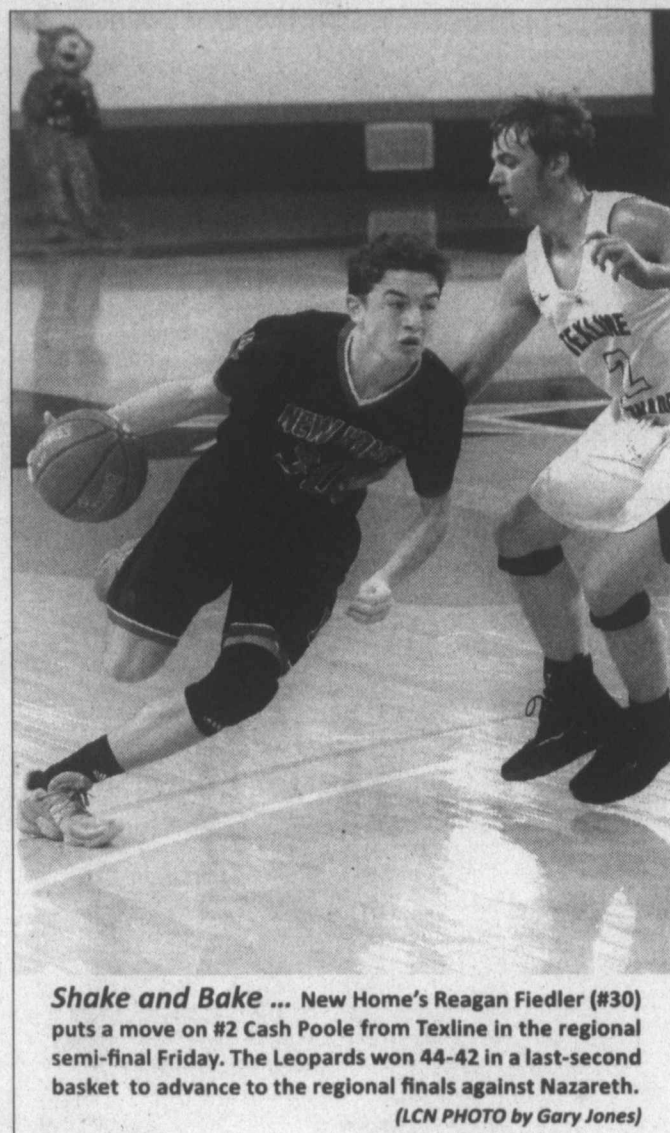
tice system in a Judgment Revoking Community Supervision for a third-degree felony of Driving While Intoxicated. The offense occurred Jan. 5, 2017, and he was originally sentenced to 10 years of Community Supervision on Jan. 16, 2018.

Tahoka Police responded to a call from a residence in the 1800 block of N. 4th Street at 7:40 a.m. March 4, regarding a burglary of two vehicles. Two Ford pickups that were parked at the residence, one owned by Robert Carl Heinrich and one owned by Davy Gene Stone, were reported burglarized sometime during the night. Among the items reported stolen was a gun taken from one of the vehicles. This investigation is ongoing.

Police responded to several 9-1-1 calls starting at 6:49 a.m. March 4 from a Tahoka man saying he was suicidal and "sees things other people do not see." According to the police report, the man voluntarily accepted help, and was transported to Lynn County Hospital for treatment.

Police assisted with tracking a reported teenage runaway from Lubbock, who was reported to have come through Tahoka last week when the teen used a credit card at a local convenience store, using a card belonging to her foster mother. The investigation is ongoing.

Police responded to several other calls during the week, including one for two youth trespassing on property, theft of tires from a backyard that were returned, domestic disturbances, and suspicious vehicles. One man was arrested for evading arrest with a vehicle, after police found him in a vehicle at a stop sign on South 1st Street, slouched over the steering wheel. When an officer tapped on the ve-

Tahoka, Wilson ISD among schools getting grant funding for CTE programs

Workforce Solutions South Plains (WSSP) announces that a total of \$792,742.65 has been awarded to 25 South Plains area school districts, including Tahoka and Wilson ISD, to purchase high demand career training equipment for Career and Technical Education (CTE) programs.

Funding sources for the project include the Texas Workforce Commission, the Lubbock Economic Development Alliance, Texas Mutual Insurance Company, Brownfield Industrial Development Corporation, Idalou Economic Development Corporation, Levelland Economic Development Corporation, Littlefield Economic Development Corporation and Plainview and Hale County Economic Development Corporation.

This project provided new career training opportunities to students across the South Plains. The goal is to provide career training to an estimated 1,890 South Plains students immediately and hundreds in the future as the as the career training equipment is a valuable investment. The participating school

districts are Abernathy, Anton, Brownfield, Denver City, Frenship, Idalou, Levelland, Littlefield, Lorenzo, Lubbock Cooper, Morton, Motley County, Olton, Patton Springs, Plains, Plainview, Shallowater, Slaton, Springlake Earth, Spur, Sudan, Tahoka, Wellman-Union, Whitharral, and Wilson.

High school CTE programs that received this funding include Construction Technology, Culinary, Welding, Health Sciences, Ag Mechanics, Automotive Technology, Business, Web Design, HVAC, and STEM programs. Tahoka ISD is using the grant funding for welding and culinary programs.

Examples of the equipment purchased for area high schools include but are not limited to: CNC Plasma Machine, welding stations, multi-purpose welders, automotive vehicle lift systems, CAD educational software, convection electric ranges, hospital beds, blood pressure machines, air compressors, heavy duty oxygen torch kits and the accessories and safety gear for each project area.

becoming available.

Some discussion was held on possible protocols for the Sheriff's Office to consider when accepting out-of-county inmates for housing here, and

that first responders should be careful when responding to calls in the county, including the wearing of gloves or masks.

"Personal safety equipment, including gloves or masks, are not being provided by the state

at this point," Schoemann added.

Commissioners approved a resolution that will allow the Lynn County Sheriff's Office to apply for a grant for the National Incident Based Management System to the Office of the Governor. If approved, the grant would provide funds, at

no matching cost to the county, for a new reporting and records management system at the Sheriff's Office.

Sheriff's Deputy Brent Meyer presented information on the grant, and told commissioners that the grant, if received, would provide all funds to implement a new records

management system for the first year, with the county responsible for a \$10,000 annual fee for subsequent years. Meyer explained that currently the Sheriff's Office pays an annual fee of \$16,000 to Justice Solutions for a similar service, and that the new system should not only work better for county purposes

but also save the county \$6,000 per year.

Chief Deputy Jason Flores presented a report on the Sheriff's Office. Donna Willis, Tax Assessor/Collector, gave a report on fees collected through her office. Monthly bills were approved as presented, and the meeting adjourned at 10:07 a.m.
