Coronavirus PANDEMIC

ours after the World Health Organization declared the Coronavirus outbreak a global pandemic last Wednesday, Americans have been flooded with announcements from throughout the country. President Donald Trump on Friday declared a national emergency over the coronavirus, freeing up additional resources and funding as federal, state and local governments attempt to combat the rapidly spreading disease. Following the national declaration, Texas Governor Greg Abbot declared a state of disaster for all counties in Texas due to COVID-19.

The virus is profoundly reshaping American life. The President instigated a sweeping ban on travel into the USA. Americans are warned not to be in crowds of more than 50 people, and many public events have been cancelled, including the NCAA's March Madness tournaments, the Houston Stock Show & Rodeo, and Austin's South by Southwest Music festival, and the NBA suspended its season altogether. Major League Baseball has cancelled the remainder of its Spring Training games, also announcing that the start of the 2020 regular season will be delayed by at least two weeks due to the national emergency created by the coronavirus pandemic. Some states have closed public schools for weeks. Universities are cancelling sports events and classes, and diverting to online classes only, and the list of closings and cancellations grows by the hour. The pandemic is an outbreak of respiratory disease caused by a novel (new) coronavirus that was first detected in China and which has now been detected in more than 100 locations internationally, including in the United States. The virus has been named "SARS-CoV-2" and the disease it causes has been named "coronavirus disease 2019" (abbreviated "COVID-19"). There is currently no vaccine to prevent COVID-19. The best way to prevent infection is to take steps to avoid exposure to this virus, which are similar to the steps taken to avoid the flu.

According to information provided by the Texas Dept. of Health and Human Services (https://dshs. texas.gov/news/updates.shtm#coronavirus), as of Tuesday, March 17, there are 64 confirmed cases of COVID-19 in Texas, and one death.

No COVID-19 cases have been confirmed in the South Plains area, including Lynn County.

That being said, however, local governments, schools and hospital facilities are prepared to take preventive measures to help prevent the spread of any infectious diseases.

LCHD sets procedures for Coronavirus measures, including specific instructions for anyone exhibiting symptoms here

(Editor's Note: The following public announcement was released Monday, March 16, by Lynn County Hospital District. It is important for ALL CITIZENS to follow the procedures set forth here.)

It's Monday March 16th and we at Lynn County Hospital District (LCHD) want to take this opportunity to update you on Covid-19 - you may also see/hear this virus referred to as SARS,CoV-2. First and most important, this is not a time to panic. It is a time to educate yourself on the virus and what you can do to prevent its spread.

What makes this virus so unique? COVID 19 has never before been known to infect humans, thus many questions remain regarding how best to understand its threat, how to treat it and how to prevent its spread at this early stage.

At this time, current data shows a person can spread the virus up to 2 days before symptoms appear and up to 14 days after symptoms start.

Symptoms: include common cold symptoms - cough, congestion, runny/stuffy nose, fever, fatigue, body aches, shortness of breath.

At this time, testing for Covid19 is very limited and restricted to the following individuals:

1. Hospitalized patients who have signs and symptoms compatible with COVID-19.

2. Those exhibiting symptoms with high risk chronic conditions, lung disease (COPD, asthma), cancer, heart failure, cerebrovascular disease, renal disease, liver disease, diabetes, immunocompromising conditions, and pregnancy.

3. Any persons including healthcare personnel, who within 14 days of symptom onset had close contact with a suspect or laboratory-confirmed COVID-19 patient, or who have a history of travel from affected geographic areas within 14 days of their symptom onset.

This means, we here at LCHD, including all our clinics, or any clinics in surrounding areas CANNOT, I repeat CANNOT at this time, test for COVID-19. We can only screen patients presenting with symptoms.

Anyone coming to the hospital or clinic with a cough/resp illness will be asked to put on a face mask - no exceptions.

Entrance into the Lynn County Hospital will also be restricted starting today. Please pay close attention to signs at this facility which will further guide you on appropriate entrance points. And stay tuned on Facebook for updates.

Also be looking for announcements in the near future on hospital/Lynnwood visitor restrictions, including closing the LCHD cafeteria to the public.

We understand the seriousness of these restrictions. However, the



In an effort to safely screen ill patients, protect the well/unsick population and protect the LCHD health care team members, we have certain procedures in place for all to follow:

1. If you or your loved one is ill with a respiratory illness, CALL THE CLINIC, DO NOT COME IN. Mildly ill patients are encouraged to stay home and contact their healthcare provider by phone for guidance about further illness management. 2. Patients who have severe symptoms, such as difficulty breathing, should seek care immediately. 3. Older patients and individuals who have underlying medical conditions or are immunocompromised should contact their medical provider early in the course of even mild illness.

We, at LCHD, have set up a Triage Isolation Clinic to better serve those suspected of having this virus, all the while protecting the well from possible exposure. It is best practice, to call ahead for pre-screening by our exceptional front-line staff. During clinic hours call the FWC at 806-998-4604. After clinic hours or on the weekends, call 806-561-2076 for direct access to nursing.

Currently the Triage Clinic will be located at the Family Wellness Clinic (across from Allsups) - access will only be granted thru the clinic's EAST doors. Signs are posted on the glass doors for help.





Governor Abbott issued a statement on initial vehicle registration, renewal of registration, and renewal of a permanent disabled parking placard. Governor Abbott also granted a temporary extension for an individual with an expired 30-day temporary permit to obtain another permit or Texas registration.

The temporary waiver applies to vehicle owners in all Texas counties as set forth in the above-referenced statement. The temporary waiver grants an extension for initial issuance of registration, renewal of registration, renewal of a permanent disabled parking placard, and issuance of a 30-day temporary permit needed to operate a vehicle on public roads. The TxDMV will provide notice when normal registration, permanent disabled parking placard re-

On March 13, 2020, Gov- newal and permit issuance ed and applies to all counties.

Also, there is a waiver of March 16, 2020, granting a the time in which to apply temporary extension to obtain for title and the associated delinquent transfer penalty. Effective immediately, there is no requirement for a title application to be submitted within a specified time. As a result, the delinquent transfer penalty does not apply to any title application submitted between March 16, 2020, and 60 days after the TxDMV provides notice normal titling services have resumed. Title applications submitted delinquently after 60 days from the TxDMV notice will not be assessed a penalty for any period associated with the waiver.

> The purpose of the waivers is to prevent customers from having to physically visit a county tax assessorcollector office to obtain these services. Customers may continue to renew their registration online at www.TxDMV. gov.

dures on campuses and district facilities, reminding staff and students of proper hand-washing and/or hand sanitizing techniques, avoiding close contact with people who are showing symptoms of illness, and asking anyone with symptoms of any illness to stay home.

"In the past, New Home ISD used the services of companies like Germ Blast to disinfect campus facilities to a higher degree, in the case of an influenza or any other virus outbreak," said Shane Fiedler, Superintendent. "Now, however, the district has purchased our own equipment for such procedures, and we can do it at a moment's notice, going through the school and coating all surfaces with disinfectant," he explained.

Dr. Cathy Palmer, OISD Superintendent, said that O'Donnell ISD has also purchased their own portable disinfectant spraying machine, which will be used daily. She sent a letter to parents and staff prior to Spring Break containing information about how the school district is carefully following preventive measures on campuses, and staying informed through updates by the Texas Dept. of State Health Services and the Center for Disease Control, as well as the Texas Education Agency.

'We're carefully monitoring all updates by state health officials, and following our normal disinfecting protocols for preventing the spread of infectious diseases, but we also have what we call our 'disinfectant bombs' that we are ready to use as needed," said Dick Van Hoose, Superintendent at Tahoka ISD. "Staff and students are reminded of personal preventive techniques that would slow the spread of any virus, such as washing hands, avoiding touching the eyes, nose or mouth, covering a cough or sneeze with a tissue, and cleaning frequently touched objects or surfaces," he added.

"As far as classes go, we are not going to change too much of what we do at Tahoka ISD - as long as there are no confirmed cases in this area," added Supt. Van Hoose. "If that happens, then more measures will of course need to be considered." At Wilson ISD, Supt. Jerry Burger said the district is also following all cautionary procedures, and added that students wipe their own desks after each class and the custodial and cafeteria follows up regularly. Regarding academic measures, Gov. Greg Abbott announced Monday that he has waived the State of Texas Assessments of Academic Readiness (STAAR) testing requirements for the 2019-2020 school year, for all school districts in Texas. STAAR tests are usually required for students in grades 3-10. At Lynn County Hospital District, Infectious Disease Control Director Nikki Donald says that all staff members are being educated on Coronavirus disease detection, treatment protocols, and infectious disease control measures. "We already have protocols in place for any infectious diseases, and of course we are getting constant updates on the COVID-19 pandemic," states Donald. "We do not currently have the testing equipment for the Coronavirus, but we do have the swabs that can be turned in for testing at Lubbock." She said that should a Coronavirus case be suspected, and the swab tests positive at a Lubbock lab, then the testing is then sent on to the CDC for confirmation. To date, no local patients have qualified for CO-VID-19 testing. As of Monday, LCHD initiated new protocols and procedures due to COVID-19, and directs any citizens exhibiting signs of illness to call a designated number.

"There are no confirmed cases in Tahoka or Lynn County, or in the South Plains area at this time," Donald reiterated. "However, Lynn County Hospital does have one room designed for holding a patient in isolation with the required separate ventilation systems, should the need arise," she added.

If a patient here is determined to need isolation for an infectious disease, the patient would mostly likely be sent on to a Lubbock facility for treatment, she said.

As a preventive measure initiated this week, visitor access will be limited at Lynn County Hospital, and no visitors are being allowed at Lynnwood Independent & Assisted Living center in Tahoka, in order to protect those most susceptible to the disease.
