Minor accident, few arrests in officer reports during week

Lynn County Sheriff's Office had numerous calls reporting reckless drivers and control burns, welfare concerns, a theft and one accident, in call sheet reports for last week.

Borden County deputies repor ed that there was a minor two-vehicle accident just inside Lynn County on FM 1054 at 3:10 p.m. Jan. 26. There were no injuries reported, and no driver information was available.

A man walking from Lubbock to O'Donnell called the LCSO for help, which he received, but it ended in an arrest due to outstanding warrants. The man called at 2:17 a.m. Jan. 26, saying that his vehicle had left him stranded and he had been walking all day from the Lubbock bus stop and was between FM 211 and the Lubbock/Lynn County line, and was trying to get to a relative's home in O'Donnell. A deputy located the man walking about a half mile north of CR 1 on US 87, but was concerned about the man's health and called Lynn County EMS, which transported him to Lynn County Hospital for

treatment. Afterwards, he was arrested on the outstanding warrants and transported to jail.

A caller on Jan. 26 reported some diesel stolen out of a cotton stripper at a barn located on CR 19, and a brush fire was reported on FM 212 between FM 2282 and CR 18 on Friday evening about 6:45 p.m. Tahoka Volunteer Fire Dept. was paged to the scene, and reported there had been several small fires on the side of the road but all

had already been put out. A 35-year-old Brownfield woman was arrested on charges of Driving While Intoxicated after Tahoka Police stopped her in the 2200 block of Lockwood at 11 p.m. Jan. 29. A caller had reported the vehicle driving erratically traveling eastbound on US 380 towards Tahoka. After stopping the vehicle, the officer conducted a field sobriety test on the driver.

Lynn County Hospital notified Tahoka Police that a woman was being treated for a dog bite, at 4 p.m. Jan. 31. The woman had reportedly been bitten on the ankle by a small dog, possibly a Chihuahua, in the 2000 block of N. 2nd. Police and Animal Control took the report and searched for the dog

Police assisted LCSO in stopping a vehicle that a caller reported was driving erratically on US 87 southbound near O'Donnell, and said that someone inside the vehicle had flashed a gun at them as they were passing in another vehicle, around 3 p.m. on Jan. 27. Officers stopped both vehicles, and a search revealed no firearm. Both vehicles were released.



City boosting gaming costs

LAMESA - Owners of game rooms are going to feel the financial pinch after Lamesa City Council members agreed last Tuesday to the first reading of an ordinance setting down heavier license and permit fees to operate such facilities.

The council discovered the city's permit and license fees were way lower than fees charged by other cities.

The city currently charges \$150 in permit fees and \$100 in license fees for game rooms. Other municipalities charge anywhere between \$5,000 and \$20,000 annually, along with setting fees for each game machine.

Under the new local guidelines, the city could require game room operators to pay a \$7,500 annual inspection fee, \$300 for background checks, and \$250 per tag for each machine.



Lake gets 2,000 rainbow trout

LAMESA - Lamesa's Boys and girls Club Lake was stocked last Thursday with 2,000 catchable-size rainbow trout for the benefit of local anglers. It was the second such stocking this winter through a cooperative effort of the local Wilton Foundation and the Texas Parks and Wildlife's Inland Fisher-

Anglers are reminded that community fishing lakes have special regulations for rainbow trout. The bag limit is 5 trout per day per person, and there is no minimum length regulation on these small lakes. A valid Texas freshwater fishing license is required for anyone who is 17 or older. Only fishing by pole and line is permitted in community fishing lakes.



Letter to the Editor

Tahoka WWII veteran shot down over Germany in 1945 was a hero

Hello. I am looking for some information on Lieutenant Andy T Wilson. Lt Wilson was killed in Germany, March 1945. He is from Tahoka and is interred in Tahoka.

I believe Lt Wilson had a son that I would like to contact if possible. My email address is jsfangda@msn.com.

I found this information on-line:

Tahoka Lynn County News, 24 June 1949, Tahoka, Texas: Wilson - Reburial services for First Lieutenant Andy T. Wilson will be held in the Methodist Church here today... Wilson is the late husband of Mrs. Betty Sue Roberts Wilson and the father of their only child, Andy T., four ... Andy T. Wilson was born at Phoenix, Arizona, April 19,1919, attended the public schools there. He was the son of Andrew Myrtle and Bessie Lillian (Thorel) Wilson.

(Editor's note: Military documentation on 31 January 1947 reported: Lt. Wilson was originally interred in Gescher, Germany, the place in which he met his death, but were later disinterred and moved to a more suitable site where constant care of the grave can be assured by our Forces in the field. The report further disclosed that his remains were then interred in the United States Military Cemetery, Neuville-en-Condroz, located 18 miles northeast of Liege, Belgium ... The Return Of World War II Dead Program provided for the return of the deceased to their next of kin, and Lt. Wilson was reburied in the Tahoka, Tx cemetery in June of 1949.)

My father, John M. Formon was a pilot, leading a B-24 Liberator 3 ship low level formation over Germany when all 3 planes were hit with FLAK. Andy's ship was on my Dad's right when it crashed. My father and Andy were both in the 491st BG, 852nd squadron.

It's important to remember that the crew loss rate in the 8th AF was the highest of any branch of the service. You had a better chance of dying, 20,000 feet over Germany, than the Marines did at Normandy or Okinawa.

Also attached is an account, from my dad's co-pilot, of exactly what happened. My thought is the family would like to know. Andy was a hero who gave his life unselfishly for his country.

From a personal perspective, I plan to visit Andy's grave and say a prayer. I (we) owe so much to the veterans who fought for our freedom. We must never forget them.

My hope in sharing this is that the ultimate outcome would be that some person or group (public school?) would "adopt" Andy's grave, learn about him and the ultimate sacrifice he and others made and maybe visit the cemetery every six months (maybe on veteran's day) to honor him and all Tahoka vets.

Andy Wilson's Last Mission

At our pre-mission briefing on March 24, 1945, we were told that the 491st Bomb Group would be part of a major 8th Air Force effort to drop supplies and ammunition to the Allied troops who were fighting their way across the Rhine. Our assignment was to supply the British forces who had established a beachhead near Wesel Germany.

Our crew, consisting of John Formon, pilot, Al Chappell, navigator, Gerson Zubkin, bombardier, Don Duke, flight engineer, Red Leavitt, radioman, Charlie Martykan, Jim Duncan, Dan Dennehy and Lou Hoffmann, gunners, and myself, co-pilot, felt that we were going to have a relatively easy mission. We would fly at low level, cross the Rhine, drop the supplies, and head back to North Pickenham, possibly without crossing enemy lines. So we optimistically boarded the "She Devil" (our old standby, "Lookin' Good" had been retired), took off, rendezvoused with the lead plane shooting the green and yellow flares, and headed across the

A short time later, we were flying over the Belgian countryside, and I recall observing that the homes, shops, and factories appeared undamaged by bombs, as if World War II were an event of the distant past.

We were to be one of the last formations (if not the last) over the target, but it didn't occur to us that we might run into difficulty. We spotted the Rhine River ahead, and prepared for the drop, focusing on our brief flight over the beachhead. After crossing the River, we encountered conditions that we hadn't anticipated, and the events of the next few minutes will never be forgotten by John Formon's crew

B-24's suddenly appeared at about 2 o'clock, coming at us on a collision course. They had just dropped their supplies and were heading home. John dropped the plan down to the treetops to avoid them, with our wing planes, piloted by Paul Fox on our left and Andy Wilson on our right, following us in close formation. We had to climb immediately to avoid high tension lines that cameinto view, and then began our run into the drop area.

As we let go of our cargo, we ran into heavy enemy fire. Before we could escape, we sustained a hit, and simultaneously Andy Wilson broke radio silence saying he was going to crash. I felt helpless watching his plane nose down a few hundred feet and explode on impact. John and I then looked to our left, and were stunned to see Fox's B-24, wings in flames, go into a vertical climb, turn over on its back, and plunge to the ground. I thought that maybe our luck had run out, but we flew through and past the enemy fire with all four Pratt & Whitneys working perfectly, and with our flight controls apparently intact. Al Chappell gave us a westerly heading, and we started to climb away from the treetops.

Duke, who had been manning the top turret, scrambled down to the bomb bay to assess the damage. Hydraulic fluid had coated the entire bomb bay, including the catwalk. The bomb bay doors were still open, and Duke was taking his life in his hands venturing into that space. He reported that a shell had opened a hole in the fuselage "that a man could walk through." The hydraulic tank was demolished by the hit, and later on, Duke counted some 86 holes in the fuselage, but fortunately, no one was injured and there was no serious structural damage.

With no hydraulic system, we knew that we couldn't close the bomb bay doors, use bur landing flaps, our brakes, and that the landing gear would have to be lowered by hand crank. While John and I were discussing our options, Al Chappell screamed into

the intercom that we were heading east into Germany. John and I realized that we had relied on the gyrocompass, which wasn't functioning property, and we made a very quick 180. We knew we would be a sitting duck if there happened to be a German fighter in the vicinity, and it seemed to take forever for us to reach the Rhine

Without flaps and brakes, we knew that North Pickenham's runways would be too short for us, so we opted for Manston Air Base in southeast England, which had a five mile long runway. Duke was able to lower the landing gear, and we brought the B-24 in at 130 knots, touching down at the beginning of the runway. We cut all four engines and shut off the electrical system to reduce the chance of fire should we crash. The plane started to veer toward the right, but we were moving fast enough that full left rudder brought us back to the center. When we reached the end of the runway, we continued on until we hit a fence at the property line, and came to a stop. "She Devil" had made her last flight, but our crew was intact, and we were ferried back to North Pick.

The next morning, Howard Kohl, a pilot in the 853rd, my boyhood chum from our hometown of New Rochelle, N.Y., came to see me because he couldn't believe what happened to our formation the day before. I described the drop zone disaster in detail, and he replied that he didn't think his formation got a single hit.

I remember his words as he looked at me and said, "and we thought it was a Milk Run."
