# LET'S BID! Annual hospital benefit starts at 5:30 here Saturday

he annual auction benefitting Lynn County Healthcare System returns to the community this week, after the Covid-19 Pandemic cancelled the 2020 event. The auction and meal will be held this Saturday, May 15, starting at 5:30 p.m. at the Lynn County Show Barn, and this year's event promises to bring lots of interesting auction items for bidders to consider. It's a fun evening where good-natured, good-hearted citizens gather to bid against each other in support of the local hospital, while enjoying the firemen's fish fry and friendly conversation with one another.

The LCHD Foundation's Billy Tomlinson Memorial Hospital Benefit Auction is uniquely smalltown, raising funds for the LCHD Foundation, which in turn directly helps make improvements at Lynn County Healthcare System. Every dollar raised benefits the local hospital and its programs.

The Hospital District serves several rural communities including Tahoka, Wilson, New Home, O'Donnell, Lamesa and Post.

This year's event will be the 40th annual benefit auction. The fun starts at 5:30 p.m. in the county show barn, located on South 9th Street near the ballpark. The event features a live auction, silent auction, door prizes, raffle prizes, and the popular all-you-can-eat fish fry prepared by members of the

Tahoka Volunteer Fire Department. "This is always a fun event, with so many good-hearted citizens attending and enjoying

the camaraderie and having such a great time bidding against each other, all in support of our local hospital and its facilities. We consider ourselves lucky to have the services of an outstanding hospital and the dedicated healthcare providers we have here, and this is our community's opportunity to show them how much they are appreciated," said Juanell Jones, publisher of The Lynn County News.

The funds raised at each event are used specifically to enhance the hospital and its services. This year, the Lynn County Hospital District's Board of Directors has selected new hospital beds for the funds to benefit. These new beds will be used in patient care. According to LCHD sources, the new hospital beds run \$11,000 each.

"Our goal this year is to raise \$55,000," said W. Calloway Huffaker, President of the LCHD (See HOSPITAL AUCTION, page 3)


# Leopard Nation doing well in post-season sports ...

# Several calls report man camping under overpass here

A suspicious person was reported to be camping out under the FM 400 overpass, and a report of a vehicle driving on the wrong side of US 87 were in law enforcement call sheets during the past week.

Tahoka Police and Lynn County Sheriff's Office received several reports of a man camping out by the FM 400 overpass, on May 6-7. The man reportedly had several blankets and supplies spread out under the overpass on the grassy area, but was far from the roadway and was not causing a traffic hazard. Police identified the man as Shannon Collins from Indiana, but said he was not violating any laws and found no warrants issued on him. The man told officers that he had plenty of water and supplies, and said that he was traveling through the area.

A white utility van was reportedly driving northbound in the southbound lanes of US 87 in Dawson County and heading into Lynn County, at 9:30 p.m. May 9. Attempts to locate the vehicle were unsuccessful, and law officers believe the vehicle may have moved into the correct lane of

Tahoka Police responded to the 2500 block of N. 4th Street at 10:17 a.m. May 7,


when the resident reported that someone had stolen his Springfield 9mm pistol from his vehicle, but did not know whether the theft occurred in Lubbock or Tahoka. The firearm was entered into the system as stolen.

A barn was reported broken into at a rural location on CR 8, at 9:53 a.m. May 4. No missing items were listed in the report.

A Dodge pickup hauling a horse trailer that was on fire was reported 12 miles west of Tahoka on US 380 at 3:19 p.m. May 7. Tahoka Volunteer Fire Dept. responded to the scene, as well as LCSO and TxDOT for traffic control. The trailer was reportedly unhooked from the pickup prior to the fire department's arrival, and was towed from the scene.

LCSO units, Tahoka and O'Donnell Police, and Lubbock County SO were all notified by Lamesa Police of a pursuit of a vehicle traveling northbound on US 87 at speeds between 110-114 mph at 4:36 a.m. May 10. The vehicle reportedly turned off into O'Donnell, where officers lost sight of the vehicle.

Other calls during the week included suspicious persons/vehicles, domestic disturbances, a child custody dispute, assisting motorists, reports of loud music, and ha-



# Seminole voters approve \$25 million bond

SEMINOLE - In the May 1 election, Seminole voters approved two bonds proposed by the Seminole Independent School District totaling \$25 million. The \$20 million bond for capital expenditures and a \$5 million technology bond proposal both passed by a large margin. The \$20 million bond passed 513 to 248. Voting results in the \$5 million technology bond election indicated 506 residents voted for it while 253 voted against it.

SISD Supt. Kyle Lynch was both please and thankful.

"We are grateful to our community for supporting the recently passed Seminole ISD Bond Election. I believe such decisions are a reflection of the values of our community," Lynch said in a statement to the Sentinel.

### Slaton mayor, commissioner elections go into runoffs SLATON - The City of Slaton will have to wait a bit

longer to see who will become the next Mayor and Ward IV Commissioner.

Both elections resulted in runoffs, as neither had a candidate receive 50 percent plus one vote to secure the win. Clif Shaw and John Gatica were the top two vote recipients

in the mayoral race, while for Commissioner Ward IV Valarie Cubit and Frank Cisneros were the top two.

In the unofficial results of the mayoral race, Shaw received 35.36 percent of the votes with 244, while Gatica received 31.8 percent with 220 votes, over candidates Jacob Parker (192) and Jessie Perez (34).

In the Ward IV candidate race, Cubit received 49.59 percent of the votes with 61, and Cisneros received 39 votes for 31.71 percent, and candidate Brad Gaydos had 23 votes for 18.70 percent of the total vote.

The runoff elections are set for June 5.




