HEEPING HAND

Tahoka Police and Lynn County Sheriff's Office (LSCO) deputies assisted a veteran who was walking through Tahoka on his way to San Marcos last week. According to information from

Police Chief Jeff Parker, police were called for a welfare concern by a caller reporting a man with a backpack, with a dog on a leash, who was sitting on the ground slumped over near the on-ramp of US 87 near the Stripes convenience store, at 1:30 p.m. last Wednesday, Nov. 10. A police officer located the man to see if he needed assistance, and a background check revealed that the man was a veteran of the U.S. Navy and a Bronze Star recipient. He had no warrants, and was not breaking any laws, and told the officer that he was traveling on foot to get to San Marcos.

"The man told the officer, 'I have money, and water for myself and my dog, and I'm not asking for anything, I'm just trying to get to San Marcos'," the chief told The News. "When we found out he was a homeless veteran who had served our country and was a Bronze Star recipient, we figured that if he fought for our country then we could at least do something to try to help him. So, we contacted the LCSO to see if they could transport him to Dawson County, and to arrange with other Sheriff's offices in other counties to kind of leapfrog him through these other counties to get him transport to San Marcos," he explained. "He didn't ask for help but it was a privilege to offer it."

EMS for medical treatment.

EMS also transported one person from another accident on Saturday, Nov. 13, that occurred just after 7 p.m. at US 380 and FM 179. According to the LCSO call sheet report, the dispatcher received a 9-1-1 call and heard a child's voice asking what had happened, and another voice responding that a car had run a light. While on the line, the 9-1-1 system plotted the caller at US 380 and FM 179, and the caller explained that another vehicle had run a stop sign and struck his vehicle. He said that everyone in his vehicle seemed okay, but that his mother was unable to get out of the vehicle. He was unaware if there were any injuries in the second vehicle. LCSO, two Lynn County EMS ambulances, Tahoka Volunteer Fire Dept., and DPS all responded to the scene. Deputies later reported that there were only minor injuries, and that one patient was transported by

EMS to a Lubbock hospital. At 6:35 a.m. Friday, Nov. 12, a caller to LCSO reported that she had run over two pitbulls with her vehicle on US 87 south of Tahoka, causing some damage to her vehicle. A deputy located the vehicle and issued an accident form, and waited with the driver until her husband arrived to help tow the vehicle



Global innovator Tahoka's Dr. Cathy Box to serve on international education committee

Tahoka woman has been invited to serve on an international education advisory committee, with the goal of identifying innovations in assessing student learning to help improve education across the world. It is an opportunity for Dr. Cathy Box to have global influence in the world of education, and she is excited about the chance to join others in a collaborative effort to inspire teachers with innovative methods of educating students.

Dr. Box is the Director for the Center for Teaching, Learning, and Scholarship (CTLS) at Lubbock Christian University. She has been invited to serve on an advisory committee for HundrED, a global education nonprofit organization that promotes innovations in education.

"HundrED is a not-for-profit organization based in Finland that seeks and shares inspiring innovations in K12 education," Dr. Box told The News. "HundrED. org's goal is to help improve education and inspire a movement by encouraging pedagogically sound, ambitious innovations to spread across the world. They are currently partnering with the Jacobs Foundation spotlight on 'Formative Assessment: Improving Learning for

Every Child' to identify 10-15 impactful and scalable education innovations that promote the systematic use of formative assessments to inform teaching and improve learning for each student. This project contributes to the strategic goals of the Jacobs Foundation's Learning Schools Portfolio and HundrED's mission of helping every child to flourish in life," she explained.

"I was asked to serve on HundrED's Advisory Board to review the leading educational practices and solutions from around the world on Formative Assessment and evaluate which ones should be included to feature in a collection of highly impactful and scalable innovations," said Dr. Box.

"According to their email, the HundrED Advisory Board is a

specialist group of stakeholders in education formed by educators, researchers, students, innovators, and experts from all over the world, so I will be one of many! Formative Assessment has been the focus of my research and writing for over 10 years, plus Palgrave Macmillan published a book I wrote a few years ago entitled Formative Assessment in United States Classrooms: Changing the Landscape of Teaching and Learning. The book and other publications are probably one of the reasons I was asked to serve on this board," she told The News.

Dr. Box said that she will work remotely with the advisory board during the month of January, but she does not know how many are on the board at this time.

"The advisory board will have a culminating event this summer in Helsinki that I would love to attend, but I don't know yet if it will work with my schedule," said Dr. Box.

Dr. Box is married to Ray Box of Tahoka, and she has been with LCU since the fall of 2008, serving as an Associate Professor in the School of Education before assuming her role as Director of the CTLS. She also serves as the Quality Enhancement Plan (QEP) Director, and formerly served as the founding Program Coordinator for the Curriculum and Instruction Master's Program in the Graduate School of Education.

She holds a Ph.D. in Curriculum and Instruction, a Master of Science in Multidisciplinary Science, and a Bachelor of Science from Texas Tech University in Lubbock, Texas. In her duties at Lubbock Christian University she provides faculty development and enrichment programs for all faculty, she leads the EquipLCU Learning Scholars as they find ways to enhance learning in their college courses, and she teaches graduate courses that focus on enhancing instruction and assessment practices in the classroom. She also serves as a consultant for schools, teachers, and faculty at the local, state, and national level.



Lynn County Republican Party Chairman, told The News that no candidates have filed as of noon Tuesday.

There are nine county positions whose terms will be up for election in the March 2022 Primary elections, including County Judge, County Sheriff, County Clerk, District Clerk, County Treasurer, Pct 2 and 4 Commissioners, and both Justice of the Peace offices (Pct. 1 and 4).

These terms of office will begin in January 2023. County officials serve fouryear terms and must file in the year before the term ends in order to be placed on the ballots for the March Primary elections. The filing period continues through Dec. 13, with filing to be conducted through the local county chairman of the Republican or Democrat parties.

To file on the Republican ticket, contact Baker at (806) 789-1257.

Currently there is no Lynn County Democrat Party Chairman. However, candidates interested in filing on the Democratic party ticket should be able to file through the State Democrat party, since there is no local county chairman.







TDCJ unit in Brownfield to close

BROWNFIELD - It was recently announced that the Jim Rudd Transfer Facility will be shutting its doors and moving inmates and staff members to other locations owned and operated by the Texas Department of Criminal Justice (TDCJ).

Brownfield Industrial Development Corporation Director Brian Brisendine spoke on the closing of the facility and how it will affect the community.

"All we got was an email. I received it from our city manager, he received it from the county judge, who received it from a TDCJ official," he said. "All it said was the number of inmates they had versus the numbers of employees they had, and the difficulty of finding employees at the moment is not economical. They are closing the facility and they even suggested it might be a temporary closure," said Brisendine.

"They will maintain the facility, keep it up and not let it fall apart, keep the utilities on, and if something changes within the TDCJ system or they have some aging facilities elsewhere, if they have a disaster in one of those and they need to put some people somewhere I can see them coming back to this one. That is a small thread of hope but it's there and maybe there is some light at the end of the tunnel. But primarily, the way they are acting, it is staffing. It is hard to find people to work right now." -- from the Lamesa Press-Reporter

The City of Tahoka will hold a Public Hearing to discuss the following proposed variance of a residential property:

City Council will hear testimony on a request for a variance to the City Code of Ordinances, Chapter 14 Zoning, Sec. 7 (10), which states on corner lots the side yard regulations shall be the same as for interior except in the case of side street or reversed frontage (where the corner lot faces an intersecting street) in which case there shall be a side vard on the street side equal to the front yard on lots in the rear. No accessory building on said corner lot shall project beyond the front yard line on the lots in the rear. This regulation shall not be so interpreted as to reduce the buildable width of a corner lot facing an intersection street, and of record at the time of passage of this ordinance to less than twenty-eight (28) feet, nor to prohibit the erection of an accessory building where the regulation cannot be reasonably be complied with. Game Wardens respond to unusual cases across Texas

The following items are compiled from recent Texas Parks and Wildlife Department (TPWD) law enforcement reports, and released by the TPWD to the media. Part Foul

A Travis County Game Warden issued multiple citations to an individual operating an illegal party boat. In an attempt to skirt party boat regulations and avoid trespassing charges, the captain of the vessel coached the attendees of a bachelorette party to announce themselves to the marina as "friends". Consequentially, the party boat was denied access to the marina. However, the marina was kind enough to provide a legal captain and lease the party another vessel to finish their celebration. Deep in the Weeds

Jackson County Game Wardens were patrolling the coastal area of Jackson County for fisheries enforcement. They observed two individuals sitting in a truck at a local boat ramp of Carancahua Bay. There were kayaks in the bed of the truck and fish in a trash bag. The individual on the driver's side appeared nervous during conversation. One of the wardens asked the subject numerous times if there was anything illegal in the vehicle. The male subject changed the topic each time. Eventually, he stated that there was a little bit of weed in the vehicle. After conducting a search of the vehicle numerous drugs were discovered and seized including: 17 grams of methamphetamine, a THC vape pen, and thirty pills of hydrocodone and amphetamine. The male subject was arrested on four narcotics charges and a parole warrant.
