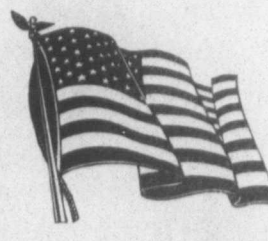

## Did you know?

### The Declaration of Independence and Constitution were hidden away during World War II.

Both documents were packed up about two weeks after the attack on Pearl Harbor, given a military escort and taken to Fort Knox in Kentucky, where they remained for several years.

### A July 4th time capsule was buried by Paul Revere and Sam Adams.

On July 4, 1795, the two men placed the capsule under the Massachusetts State House in Boston. It was discovered more than two centuries later by workers fixing a leak. When state officials opened it, they discovered a pine tree shilling coin, a copper medal engraved with an image of George Washington, several newspapers, and a silver plate thought to be engraved by Paul Revere.

## Mystery vehicle appears in owner's driveway, accidents reported here

Tahoka Police were notified on the morning of June 24, of a BMW that was parked in the driveway of a local resident with Michigan plates that appeared sometime during the night. The resident stated he did not know where it had come from and after police officers searched through the vehicle, the owner was notified and the owner advised that he had arranged for the vehicle to be towed to the nearest tire service following a blowout on US 87. Apparently whoever had towed the vehicle had simply dropped the car off at the nearest tire shop location in Tahoka but had not notified anyone at the shop or residence that they were doing so. The owner of the vehicle had the tire shop replace all of the tires.

In another incident, a FedEx truck was abandoned for several days in a driveway on US 87 on June 21. A Lynn County Sheriff's deputy checked it out and advised everything seemed to be okay and told the residents they could have the vehicle towed if they wished to do so.

Officers were notified of a one vehicle rollover on US 87 near the old Allsup's location in O'Donnell on June 24. No injuries were reported and vehicle was towed from the scene. A couple witnessed another one vehicle rollover accident on June 25 at 9 a.m., just north of the county line on US 87. The call-

er advised her husband was a member of the Lamesa Fire Department and was accessing occupants of the vehicle for injuries. They advised that Lynn County EMS might be needed for one individual with moderate injuries, however EMS obtained refusals on scene.

At 4:30 a.m. on June 26, in the vicinity of N. 2nd and Ave. O, Tahoka police were notified of a dirt bike making lots of noise in the area. Upon arrival, officers located the motorcycle and when the driver attempted to run off on the cycle, officers were able to eventually apprehend the driver who was then charged with evading arrest and also issued several citations for running stop signs during the chase.

A gas leak was reported in New Home on June 20, when a caller reported his girlfriend and other family members could smell gas and were complaining of headaches. Atmos Energy could not be reached due to an automated call line not working. New Home VFD, Lynn County EMS and Lynn County Sheriff's unit responded to the call and gas was turned off by fire department until Atmos could arrive to investigate the possible leak.

A suspicious person report was called in on June 23, a half mile north of FM 2192. Caller advised a

## Tahoka City Council approves property easement ordinance

Tahoka City Council members approved a property easement ordinance that should benefit property owners in Tahoka, at their June meeting.

The ordinance will allow the city to grant a blanket easement for access for property owners whose property structures may encroach on the city easement, due to structures being built in the past when easement considerations were not traditionally imposed. These easements are for the city to access underground and overhead utilities, including pipeline, water lines, sewer lines, gas lines, electric lines, and communication lines.

According to City Administrator Julie Arrington, property owners who may have sheds or fences or other structures in the easement area (typically within 20 feet of either side of the constructed street) are actually encroaching on city property. When these property owners are interested in selling these properties, the city was being asked to grant easements for each property.

To simplify the process, Arrington asked the council to approve a blanket easement for access, rather than having to address the issue for each property request, which is a time-consuming and potentially cost-prohibitive process requiring legal expertise.

Historically, the streets in Tahoka were platted and dedicated by its forefathers to the width of 80 feet. Thereafter, roads were constructed to a width of less than 80 feet, leaving an area of approximately 20 feet on either side of the constructed street. Since then, however, residential and commercial property owners may have added structures, improvements or other features within the 20-foot area between the platted and dedicated lines to the built curb on the adjoining streets. The property located from the existing curb to the platted lines is shown by specific subdivision plats recorded in the deed records of Lynn County for the City of Tahoka.

The blanket easement ordinance will allow city officials to expedite most easement issues with properties within the city of Tahoka.

A complaint was reported last Thursday at 7:45 p.m. in the 1600 block of Ave. J for a loud beeping noise that the caller could not locate. Upon arrival, officers could also hear the noise and located it at the Stripes parking lot. The driver of a FedEx truck could not get the brake alarm to release.

Police responded to a call in the 2000 block of N. 7th involving a deceased animal. Police advised that the dog possibly died from drinking contaminated water which was observed near the dog. A cruelty to animal citation was issued to the owner.

A LCSO deputy conducted a traffic stop on a vehicle at US 87 and CR 6 on June 27 just after midnight and after conducting a vehicle search, the driver was arrested and transported to the Lynn County Jail for possession of a controlled substance. Vehicle was towed by Lubbock wrecker service.

Other calls for LCSO and Tahoka Police during the week were for welfare concern, forgery, road assistance and threats. Arrests were made last week for domestic assault, evading arrest and possession of a controlled substance.

### Helicopter supports operation

LAMESA - A helicopter that was seen and heard flying above Lamesa at various times late last Thursday was part of a multi-agency law enforcement operation, according to Lamesa Police Chief Josh Peterson.

## July 4th Fun Facts



• **Only Two Men Signed the Declaration of Independence on July 4, 1776**  
Charles Thompson and the infamous John Hancock were the only two men who actually signed the Declaration of Independence on July 4, 1776. The other 54 delegates signed over the course of the next month.

• **The Declaration of Independence was written on a laptop ...** Okay, not a modern laptop, but still. Thomas Jefferson drafted the Declaration of Independence on a writing desk that could fit over one's lap. This device was referred to at the time as a "laptop."



• **Of the 56 signers of the Declaration of Independence**, the youngest signers, Thomas Lynch Jr. and Edward Rutledge of South Carolina, were only 26. However, Benjamin Franklin of Pennsylvania was the oldest signer at 70 years old.

**FSA accepting nominations for farmers/ranchers for local committees**

The U.S. Department of Agriculture (USDA) Farm Service Agency (FSA) is now accepting nominations for county committee members. Elections will occur in certain Local Administrative Areas (LAA) for members. LAAs are elective areas for FSA committees in a single county or multi-county jurisdiction. This may include LAAs that are focused on an urban or suburban area.

County committee members make important decisions about how Federal farm programs are administered locally. All nomination forms for the 2022 election must be postmarked or received in the local FSA office by Aug. 1, 2022.

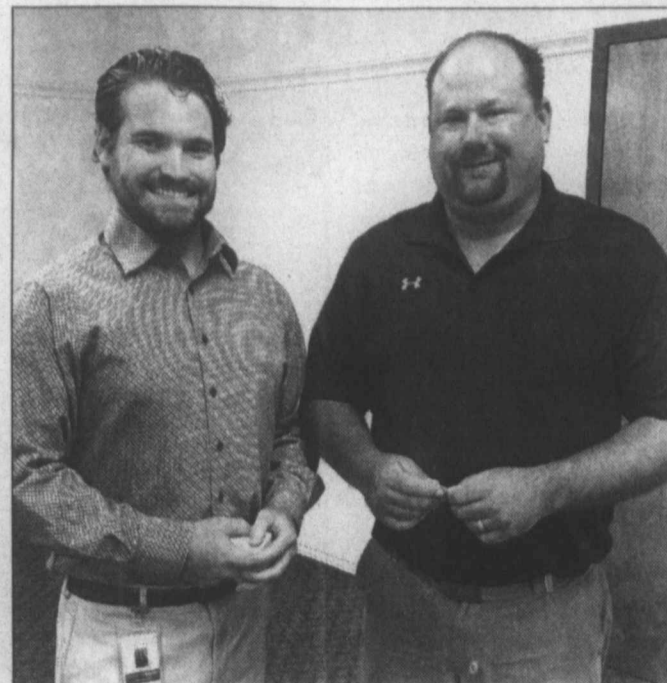
"It is a priority for USDA to integrate equity into its decision-making and policy-making, and that starts with our local FSA county committees," said Kelly Adkins State Executive Director for FSA in Texas. "We need enthusiastic, diverse leaders to serve other agricultural producers on these committees as we work to build equitable systems and programming inclusive of all employees and all of our customers. I ask that you consider making a difference in your community by nominating yourself, or another agricultural producer, to serve on your local FSA county committee."

Adkins said agricultural producers who participate or cooperate in a USDA program and reside in the LAA that is up for election this year, may be nominated for candidacy for the county committee. A cooperating producer is someone who has provided information about their farming or ranching operation to FSA, even if they have not applied

or received program benefits. Individuals may nominate themselves or others and qualifying organizations may also nominate candidates. USDA encourages minority producers, women, and beginning farmers or ranchers to nominate, vote and hold office.

Nationwide, more than 7,700 dedicated members of the agricultural community serve on FSA county committees. The committees are made up of three to 11 members who serve three-year terms. Producers serving on FSA county committees play a critical role in the day-to-day operations of the agency. Committee members are vital to how FSA carries out disaster programs, as well as conservation, commodity and price support programs, county office employment and other agricultural issues.

Producers should contact their local FSA office to register and find out how to get involved in their county's election, including if their LAA is up for election this year. To be considered, a producer must be registered and sign an FSA-669A nomination form. Election ballots will be mailed to eligible voters beginning Nov. 7, 2022.

**Water level measurements indicate declines in area**

An average decline of -0.63 feet was calculated in the groundwater levels of the Ogallala/Edwards-Trinity (High Plains) Aquifer (ETHP) from 2021 to 2022, according to water level measurements made by High Plains Water District (HPWD).

HPWD field technicians measured approximately 1,333 water wells during the first part of 2022. From these measurements, about 1,300 were also measured in 2021, allowing HPWD to calculate the average change. The publishable results of 2022 water level measurements are now available on the HPWD interactive web map.

Also of importance is the saturated thickness of the Ogallala and ETHP, which is the thickness of the water bearing formations. For 2022, the average saturated thickness of all observation wells is about 53 feet. This compares to the average of 54 feet in 2021.

More detailed statistics of the measured change include:  
16 wells with declines of 5 feet or more  
16 wells with declines of 4 to 4.99 feet  
41 wells with declines of 3 to 3.99 feet  
87 wells with declines of 2 to 2.99 feet  
201 wells with declines of 1 to 1.99 feet  
596 wells with declines of 0 to 0.99 feet  
347 wells with rises of 0.01 feet or more

The largest water level decline was -9.35 feet in a Castro County observation well. The largest water level rise was +5.25 feet in a Lubbock County observation well.

For the Dockum Aquifer, HPWD measured 30 observation wells. The average change for the Dockum Aquifer is -0.71 feet for 2022.

HPWD has updated all data on its interactive map with the 2022 measurements. This includes all of the data found using the "Aquifer Info" tool, which provides estimates of saturated thickness, 5-year change, and 10-year change.

Created in September 1951 by local residents and the Texas Legislature, the High Plains Water District works to conserve, preserve, protect, and prevent waste of underground water in aquifers within its 16-county service area. HPWD is the first groundwater conservation district created in Texas.

### Texas hay season looks bleak

The 2022 Texas hay production outlook appears in doubt due to high fertilizer prices and widespread drought, said Texas A&M AgriLife Extension Service experts.

Joe Paschal, Ph.D., AgriLife Extension livestock specialist, Corpus Christi, and Vanessa Corriher-Olson, Ph.D., AgriLife Extension forage specialist, Overton, said dry weather, high temperatures and reduced inputs like fertilizer have inhibited warm-season grass production across much of Texas. Hay quantity and quality are down, while the cost to produce bales is up, and weather forecasts do not look favorable.

Pockets of the state have received decent moisture, they said, but high fertilizer prices have discouraged hay producers from making applications. As a result, hay baled was expected to be of lower quality.

Paschal said prices for supplemental feed like range cubes and hay have continued to increase. Range cubes reached \$400 per ton, while round bales were starting to fetch \$75-\$80. For weeks, AgriLife Extension agents have reported \$80-plus bales in extremely dry areas of the state.

Some cattle producers around the state have been culling their herds deeper to reduce stocking rates and "mouths to feed," Paschal said. But many more face declining grazing, tightening hay supplies and below-average bale production this season.

"People are baling, but it looks like this hay season could be one cutting, maybe two," he said. "There is hay being fed now, so the hay situation could be tough."

Paschal said hay production and grazing conditions were spotty and mirror scattered rainfall in south Central Texas from Del Rio to Kerrville and east of Corpus Christi back to the Rio Grande River. Some pockets have reported 4-7 inches, but much of that area had not received any rainfall since last fall.

Most of East Texas is experiencing abnormally dry to moderate drought conditions, according to the drought monitor map of Texas produced by the National Drought Mitigation Center at the University of Nebraska. Areas in south Central Texas were showing mostly severe and exceptional drought conditions, which translates into major to exceptional crop and pasture loss and widespread water shortages and restrictions.

Grasses and crop growth are stunted under abnormally dry conditions, and damages begin to show as moderate drought sets in, according to the center. Extremely high temperatures are exacerbating the moisture deficit for plants, including pasture grasses.

Corriher-Olson said weather outlooks suggest Texas will slip further into the drought. Weather systems during hurricane season could change that, but producers with grazing should be implementing contingency plans if they have not already.

"I really don't have a feel for how many producers are adjusting their grazing management as a result of drought and high fertilizer prices," she said. "It gets harder to avoid overstocking when forage production is limited. But it puts a lot of producers in a really tight spot when they don't have the hay or grazing to try and maintain their herd."

Both Corriher-Olson and Paschal expect hay supplies to be tight and low quality going into winter if conditions do not reverse soon.

Paschal said producers should be planning for ways to stretch available nutrition — whether that is finding alternative feed like cotton seed, purchasing failed corn crops or using supplemental feeds with a limiter to reduce the number of trips to feed.

Hay production conditions are better in states east of Texas, he said, and bales are likely to be moved into Texas or cattle are expected to be moved to better pastures. He suggests cattle producers test bales for their nutritional value, whether purchased or produced. Tests can provide information that will better guide cattle supplementation, improving the digestibility and nutritional value of that hay.

Producers can reach out to AgriLife Extension agriculture agents in their county for assistance with hay testing, Paschal said.

"It's going to be tough," he said. "There is a lot of hay cows will eat when there is nothing else, but it doesn't mean it is good. There are ways to stretch a cow's nutritional needs, but the bottom line is getting the right amount of protein and energy in her."

In the South Plains area, AgriLife Extension district reporters compiled the following summaries:

**SOUTH PLAINS:** Subsoil and topsoil moisture levels were adequate in some areas. Producers were working to finish plantings. Cotton was struggling with the heat. Cattle were in good condition.

**PANHANDLE:** Soil moisture levels were short. Crop conditions were poor to fair. Producers were dusting in grain, hay and silage sorghum. Irrigation pivots were running steady to water corn and sorghum crops. Wheat grain harvest was expected to be very short as many fields were cut for silage and hay or damaged by May hailstorms. Some fieldwork continued. Pasture conditions recovered briefly but with very little vegetative growth due to drought. Overall, rangeland and pasture ratings were poor.
