Spring has sprung and after collecting and keeping frozen, my favorite ice cream which is not produced on a regular basis, I had one big heartbreak last night when I had to take five gallons of my favorite flavor back to the store because of a recall cream. on my ice

It seems that someone is trying desperately to cause me heartbreak by seemingly deliberately making my favorite flavor subjective to having a dangerous germ in it which can cause a very painful illness or death, depending on one's physical constitution and age. The disease is called Listeriosis.

Listeriosis is Listeria monocytogenes infection. It is cause by a gram-positive bacterium named Listeria which can penetrate human cells and replicate them. (Medicine.Net.com)


Most people who are infected with the germ may have only a few or no symptoms of the disease. When symptoms are present, they usually consist of a fever, possibly muscle aches, nausea and or diarrhea and fever.

More serious symptoms can occur in individuals whose immune systems are weak generally due to conditions such as diabetes, cancer, AIDS, pregnancy and alcoholism.

Most people who are in good health usually clear up the infection within a week and do not require any medical treatments. Those individuals at risk however should be treated as soon as possible with antibiotics administered by an IV.

It is usually following a massive recall of a food product that we turn our attention to Listeria infections.

symptoms which we might have as the infection has been around for many years, often 0with another name. It was around 1918 that the germ was first identified in a WWI soldier.

In 1979 it was found that it was food borne and could infect humans in this way. Prior to that time, it was thought that it only infected animals. It is not transferrable from one individual to another

In this new millennium we have witnessed several outbreaks of Listeriosis and people have died because of contaminated foods. In 2010, Listeria was found in celery. In 2011, cantaloupe bore Listeria. In 2012, it was found in eggs and now in 2015, it is ice cream.

So far, I do not think that I have Listeriosis, but I could have it because I have eaten one of those half gallons of my favorite ice cream with the affected UPC code.

I understand that it is only through a blood test that it can be isolated and then treated. I am keeping a positive outlook as it has been over a period of a couple of weeks in which I ate this ice cream, but if I feel the need, will seek medical help promptly as I am an at risk individual, birthdays.

Let us all get 'in cinque' and observe our wellness or lack thereof if we have eaten the recalled ice cream.

NAACP Statement on "Religious Freedom" Legislation in **Indiana** and Arkansas

BALTIMORE, Md. - After a national and state-wide uproar over bills promoted as religious freedom measures and criticized as discriminatory against lesbian, gay, bisexual and transgender (LGBT) individuals, state lawmakers in Indiana and in Arkansas approved new legislation on Thursday to remove the most contentious language. In Indiana, legislators passed a series of changes on Thursday that, while not outlawing anti-gay discrimination, clarified that the religious freedom law does not authorize such discrimination. Lawmakers in Arkansas, acting at the urging of the governor, passed a measure that is nearly identical to the federal Religious Freedom and Restoration Act.

From Cornell William Brooks, NAACP President & CEO:

"The NAACP's constitution affirmatively states that our objective is to ensure the 'political, educational, social and economic equality' of all people. Therefore, the NAACP has opposed and will continue to oppose any national, state or local policy that seeks to codify discrimination or hatred into the law or to remove the Constitutional rights of LGBT citizens. Religious freedom is a constitutional value that we both celebrate and recognize as it is woven into the fabric of who we are as a nation. Furthermore, we believe that every American deserves to live a safe and just life, free of prejudice and discrimination. The NAACP will continue to work to ensure that all Americans are protected from discrimination, regardless of their race, ethnicity, gender, point of national origin, or genuine or perceived sexual orientation."

Generation Opportunity releases monthly Millennial Jobs Report

Washington, DC - Genera-

tion Opportunity, a national, non-partisan youth advocacy organization, is announcing its Millennial Jobs Report for March 2015. The data is nonseasonally adjusted (NSA) and is specific to 18-29-year-olds: •The effective (U-6) unemployment rate for 18-29-year-olds, which adjusts for labor force participation by including those who have given up looking for work, is 13.9 percent (NSA). The (U-3) unemployment rate for 18-29 year olds is 9.1 percent (NSA).

•The declining labor force participation rate has created an additional 1.842 million young adults that are not counted as "unemployed" by the U.S. Department of Labor because they are not in the labor force, meaning that those young people have given up looking for work due to the lack of jobs.

•The effective (U-6) unemployment rate for 18-29-yearold African-Americans is 20.2 percent (NSA); the (U-3) un-

employment rate is 16 percent (NSA).

•The effective (U-6) unemployment rate for 18-29-yearold Hispanics is 14.3 percent (NSA); the (U-3) unemployment rate is 9.4 percent (NSA).

•The effective (U-6) unemployment rate for 18-29-yearold women is 11.8 percent (NSA); the (U-3) unemployment rate is 8.1 percent (NSA).

Evan Feinberg, President of Generation Opportunity, issued the following statement:

"Today's underwhelming jobs numbers and the stagnant youth unemployment rate paint a clear picture of a generation held back from realizing our full potential.


Wrongly Convicted Man Released From Jail After Spending 30 Years on Death Row



Birmingham, AL — Anthony Ray Hinton, a 58-year-old Alabama man who spent half his life on death row, walked free on Friday, April 3, 2015, after prosecutors determined he did not shoot two fast-food managers in the head during a robbery in 1985.

Hinton was quickly convicted of killing a manager at a Mrs. Winner's Chicken & Biscuits fast food restaurant, and an assistant manager at a Captain D's, and was sentenced to death in 1987.

But the charges were dropped after modern ballistics tests proved that the bullets did not come from the .38-caliber Smith & Wesson revolver found in Hinton's home or even from the same type of gun.



Hinton told reporters, "I shouldn't have sat on death row for 30 years. All they had to do was test the gun." He said the state "had every intention of executing me for something I didn't do."

He refers to his case as a "miscarriage of justice, not only to me, but the victims' family." He told the family, "I will continue to pray for you as I have for 30 years." Meanwhile, Hinton's longtime attorney, Bryan Stevenson, says that Hinton was convicted because he was poor. He added that for more than 16 years, the state refused his appeals to retest the gun.

"His case, in my judgment, is a case study in what's wrong with our system," Stevenson said. "We have a system that's compromised by racial bias, and his case proved it."

#3 – Society of Women Engineers (SWE) Scholarships: For women pursuing undergraduate or graduate degrees in the areas of engineering, engineering

technology and computer science. Female students must be attending accredited colleges or universities and preparing for careers in technical fields.

#4 – Joe Francis Haircare Scholarship: Named after Joe Francis (1933-1994), the founder of several hair care franchises, this scholarship is for women (and men) applying for entrance into Cosmetology/Barber School, OR actively enrolled in a Cosmetology/Barber program. An application must be submitted, as well as a one-page essay, and one or two letters or recommendation.

#5 – NFRW's Betty Rendel Scholarship: These awards go to three female undergraduates each year who are attending a four-year accredited college or university and majoring in political science, government or economics. It is open to women across the nation.

#6 – Women's Independence Scholarship Program: Helps women who have survived domestic violence to return to school and become self-sufficient. The primary candidates are single mothers with young children who lack the resources to attend college. It is based on financial need.

#7 – Young Women in Public Affairs Award: For young women age 16 to 19 with an interest in public affairs who plan to enroll in college. Interested students must be knowledgeable about Zonta, have experience in local or student government, and generally be active in volunteer work.

#8 – At the Well Young Women's Leadership Academy Scholarship: These scholarships are available to help students attend a summer program at Princeton University, and is geared towards building leadership skills for minority girls entering the tenth, eleventh, or twelfth grades of high school.

#9 – Miss America Scholarship Fund: Offers scholarships to over 12,000 young women who compete in the state and local competitions as well as Miss America first place winner, four runners-up, semi-finalists and non-finalists.

#10 – Go Red Multicultural Scholarship Fund For Women: This program champions greater inclusion of multicultural women in the nursing and medical industries, address important gaps in treatment, and ensure that all Americans have an opportunity to work with

their healthcare providers to make the best choices that lead to good health.

#11 – National Student Nurses' Association Scholarships: Awarded to students currently enrolled in a nursing degree program. Eligible students must be enrolled in a stateapproved nursing program that leads to a LPN or RN licensing.

12 – Women in Federal Law Enforcement (WIFLE) Scholarship Program: Open to undergraduate graduate, and post-graduate female students interested in a career in law enforcement. Eligible students may major in criminal justice, social sciences, public administration, computer science, finance, chemistry, and physics.

#13 - Sara Scholarship: Available to female high school seniors who plan to attend college and are active in golf. The renewable scholarship is awarded to 12 deserving female students each year. Students must have excellent academic skills and demonstrate financial need. #14 – Job's Daughters





Walter Scott's Family Speaks Out After Police Officer Charged With His Murder - "What If There Was No Video?"

Charleston, SC - Michael Slager, a white police officer in North Charleston, South Carolina, has been charged with murder in the shooting death of Walter Scott, who was black and apparently unarmed. Raw cellphone video taken by a bystander shows Slager firing eight times as Scott ran away from him.

Slager has been denied bond and is being held at the local Charleston County Detention Center. Reportedly, a murder conviction in the state could lead to the death penalty or up to 30 years to life in prison, according to the South Carolina Law Enforcement Division.

Meanwhile, his family has already spoken out and said that they will be filing a lawsuit against the city



Hairstyles of Black Women: Cases of Discrimination **By Sheryl Estrada**

It's 2015, yet the natural hair and hairstyles of Black women continues to be taboo in mainstream society in the U.S. and abroad. At the workplace, during travel and even at leisure, Black women face an additional layer of discrimination.

Transportation Security Administration (TSA)

When Malaika Singleton Ph.D., a neuroscientist, employed by the California State Senate at the time, began a 2013 trip to London as a U.S. delegate to the G8 Dementia Summit little did she know her "sisterlocks" hairstyle, a form of dreadlocks, would be an issue.

TSA agents at both the Los Angeles International Airport and the Minneapolis St. Paul International Airport grabbed and squeezed her natural hair from top to bottom.

She contacted the American Civil Liberties Union (ACLU) of Northern California. In 2014 the ACLU filed an administrative complaint on her behalf to challenge TSA's discriminatory hair searches. Ironically, in 2012, a similar complaint was also filed on behalf of Novella Coleman, a Black woman and Staff Attorney with the nonprofit organization; she represented Singleton.

The ACLU announced March 26 that an agreement was reached with the TSA. The agency agreed to conduct trainings for TSA agents throughout the country, with special emphasis on hair pat-downs of Black female travelers. TSA will also monitor all the airports "for consistent implementation of TSA and DHS policies and to detect the existence of a racially discriminatory impact."

"I hope that this agreement and the proposed trainings will lead to a more equitable treatment of all travelers throughout the U.S., regardless of their ethnic or cultural background or how they wear their hair," Singleton said in a statement.

tant to be aware of the fact that even with a grooming policy or even a policy about appearance, one can still discriminate against minorities or minority women if this policy has a negative effect based on their race or ethnicity," Fo Niemie of CRARR told DiversityInc.

He said CRARR looked at case precedents from the Equal Employment Opportunity Commission (EEOC) in the U.S., as this is the first case of its kind in Canada.

In a statement, Madisons New York Grill and Bar said the incident did not involve race or discrimination and apologized if the situation caused harm to Mc-Nickle or her friends and family. However, it also states, "As in any organization, there is an internal protocol to follow and a dress code to respect to guarantee that our customers' experience is ideal."

CRARR stated that they also

have yet to see a written standard grooming policy from the restaurant.

The brand vice-president for the Canadian franchises of the Madisons chain, Gilles Pépin, said because business is down McNickle has not been given any shifts, and she is not fired.

Niemie explained that if the Quebec Human Rights Commission concludes discrimination occurred the plaintiff must be compensated, including lost wages and moral damages, within 30 days. "[The fines] are meant to be remedial not punitive," he said.


In Montreal, Quebec, Canada, 19-year-old Lettia McNickle, who has worked as a hostess at a Canadian franchise of Madisons New York Grill and Bar on Drummond Street since October, said she came to work one day in March with a braided hairstyle on the side of her head, and has not received any shifts since.

According to CBCNews, Mc-Nickle said her manager reprimanded her in front of fellow employees saying her hairstyle was not acceptable.

"I obviously wanted to know what it was she didn't like specifically about the hairstyle, so the [next] day I asked her, 'What is it that's wrong with my hair?' And she said, 'We don't want that kind of look here at the restaurant," McNickle said on CBC Daybreak.

Her boss sent her home. Mc-Nickle filed a discrimination complaint against the restaurant with the Quebec Human Rights Commission, through the Centre for Research Action on Race Relations (CRARR), a nonprofit also in Quebec.

"I think it's important for businesses to know that it's impor-
