Gordon Harris told the Southwest Digest he is unhappy over the information made by the Lubbock Independent School District. He said, "On Thursday, June 18, 2015, it was published there would be citizens comments on the demonishing or sale of the empty school buildings: Arnett, Parkway and Iles Elementary School buildings. But when myself, Gordon Harris, and a couple of pastors showed up, Nancy Sharp came to me and said it would not be."

Harris said he told her it was being reported on every news channel. According to Harris, "She said they got it wrong, "He told her it had been aired for three days prior.







# In Cinque

After years of protest and sacrifice, the LGBT (Lesbian, Gay, Bisexual, Transgender) community has finally triumphed with the recent United States Supreme Court decision to legalize same sex marriage in all of the states of the United States. Thirteen states had not legalized same sex marriage, but it has now been done for them. A nursing home is by far the toughest place for me to pick up a decedent. The halls are not uncommonly narrow, neither are the doorways. The physical aspects of accomplishing my job are not what make this call the most dreaded from those that I routinely receive. The difficulty of this call is the loneliness that is unconsciously written on the resident's faces as I enter and exit the building.

As I pass groups of residents watching television or sitting in social groups, they will reach out to me. Their faces light up as they mistakenly identify me as someone they recognize and love. The disappointment that replaces their elation as they realize I am not there to visit with them is excruciating and weighs heavy on my heart.

A number of weeks ago, I was called to a local nursing home where one of my clients had passed away. As usual, multiple residents mistakenly assumed that I was there to visit them. As always, my heart began to ache as I witnessed their disappointment. I saw their spirits spiral with anguish as they realized my purpose was not to visit them but to remove one of their own as death had claimed him.

My decedent's wife visited the funeral home last week to collect her husband's death certificates. We took a moment to visit, and I asked her how she and her daughters were recovering from their recent loss. # Confederate flag taken down in South Carolina after 54 years

COLUMBIA, S.C. — For the first time since the civil rights movement, the Confederate flag was removed entirely from the South Carolina Statehouse, in a swift ceremony Friday, July 10, 2015, in front of thousands of people who cheered as the Civil War-era banner was lowered from a 30foot flagpole.

Many people believed the flag would fly indefinitely in this state, which was the first to leave Union, but the killing of nine black church members during a Bible study in Charleston last month changed that sentiment and reignited calls to bring down Confederate flags and symbols across the nation.

Dylann Roof, a white man who was photographed with the Confederate flag, is charged in the shooting deaths, and authorities have called the killings a hate crime.

The crowd, estimated at up to 10,000 people, chanted "U.S.A.! U.S.A.!" and "Hey, hey, hey, goodbye" as an honor guard of

the flag during a six-minute ceremony. Gov. Nikki Haley stood on the Statehouse steps along with family members of the victims and other dignitaries. She didn't speak, but she nodded and smiled in the direction of the crowd after someone shouted, "Thank you governor."

Haley supported the flag before the shooting, but the Republican had a change of heart in the days after the killings and led the push to get legislators to pass a bill before the end of the summer. She signed the legislation Thursday, July 9, 2015.

As she looked on, two white troopers rolled up the flag neatly and tied it with a white ribbon. They handed it to a black trooper who took it to the Statehouse

Highway Patrol Cpl. Rupert Pope downplayed the significance of their race in the cere-

"We're all gray," he said, with the other officers nodding in

was down, saying it was "a sign of good will and healing and a meaningful step towards a better

The leader of the South Carolina chapter of the Sons of Confederate Veterans refused to attend, instead recalling his seven ancestors who fought for the South in the Civil War. "I'm not going down there to watch them be dishonored and defamed," Leland Summers said.

But if South Carolina couldn't make a last stand for the Lost Cause, where else might it happen? From Alabama to Alaska, Confederate and segregationist monuments, statues, symbols and place names are being re-ex-

"They aren't going to be happy until Mississippi is just like Michigan," said Nelson Waller, who joined several dozen flag supporters in a rally at the Statehouse this week but said he was too heartbroken to see it taken

Post Traumatic Stress Disorder (PTSD) is a psychiatric disorder triggered by a life threatening experience, such as war, sexual assault, physical assaults, serious accidents or natural disasters. PTSD leaves its victims unable to function normally in life. Although black women are more likely than white women to develop PTSD, they are also much less likely to get help. Why?

Why

PTSD is a mental disorder, and among the black community, there is a stronger reluctance to seek help for any mental illness. Black women, in particular, are viewed as strong with the ability to overcome traumatic events. An article recently published in Essence Magazine also showed that treating people of color in low-income communities for PTSD is just not a high

Arthur C. Evans, Jr., Ph.D., the commissioner of Philadelphia's Department of Behavioral Health and Intellectual Disability Services, stated that "in the African-American community, people often go to their faith leaders before they will come to a treatment professional.

The invisible crisis

In the Essence Magazine study on PTSD, it is called the "invisible crises." The study revealed that about 30 percent of the African Americans who responded had symptoms of PTSD, which is shockingly higher than veterans of war. And one third of the African American women in the study had PTSD resulting from sexual assault, violence and psychological trauma.



# NAACP votes to end South Carolina boycott

Following the removal of the Confederate battle flag from the grounds of the South Carolina state capitol, the NAACP's national board of directors has voted to end its 15-year economic boycott of the state.

The national board of directors of prominent U.S. civil rights group the NAACP voted on Saturday to end its 15-year boycott of South Carolina prompted by the display of the Confederate battle flag on state capitol grounds.

"Emergency resolution passed by the NAACP National Board of Directors at #NAACP106, ending the 15 year South Carolina boycott," the National Association for the Advancement of Colored People said on its Twitter feed.

The resolution was approved during the NAACP's annual convention in Philadelphia.

South Carolina removed the flag on Friday to chants of "USA, USA!," after three weeks of emotional debate over the banner, a symbol of slavery and racism to many, but of Southern heritage and pride to others.

Numerous elected officials, including Republican Governor Nikki Haley, called for the flag's removal after the June 17 killings of nine African-American churchgoers at Emanuel African Methodist Episcopal church in Charleston. Photos of the white man charged in the slayings showed him posing with the flag on a website that also carried a racist manifesto.

The Confederate flag was raised atop the South Carolina State House dome in 1961 as part of centennial commemorations of the American Civil War. Critics said its placement was a sign of opposition by politicians to the black civil rights movement at the time.

In 2000, the NAACP announced an economic boycott of South Carolina and protesters marched on the state capital

In a separate action earlier this week, National Collegiate Athletic Association president Mark Emmert said his organization was removing all barriers to South Carolina hosting championship-level college sports events now that the Confederate flag has been removed from the state capitol grounds.


