

As the church grew, the church was moved to 2012 Fir Avenue, which was on the alley where the parking lot is now until the present edifice was built, on the corner of 2012 Fir


"Things I remember the most about Mt. Gilead Baptist Church was the late Rev. S. R. Roberts," said Ms. Bell.



91-year-old Brooklyn man dies, 100-yearold wife injured after home robbery

A 91-year-old Brooklyn man died on Wednesday after a group of robbers broke into his home and tied him up, police said.

Waldman Thompson and his 100-year-old wife, Ethline Thompson, were sitting in their home when a group of unknown intruders broke in and ransacked the place, according to police. The suspects threw a blanket over her head and then tied up both of the elderly residents, according to police.

Ethline Thompson, who managed to untie herself, ran outside and alerted authorities. Police arrived to find her husband unrespon-

Investigators believe he may have died of shock, because he had no other injuries, according to ABC's New York station WABC. The

official cause of his death has not been determined. The couple's family said it was heartbroken by the incident.

"Oh my god. It breaks my heart to see my uncle died. He was like a father to me," Karlene Grose, Waldiman Thompson's niece, told WABC Wednesday.

Investigators said they are looking for four male suspects and watching surveillance footage for clues.

Ethline Thompson was taken to a nearby hospital where she was treated for minor rope burns. According to police, she was confused and did not know her husband had died.

A neighbor said he thought he heard a "loud boom" from the couple's apartment."I thought it was a gunshot initially. But it wasn't a gunshot," the neighbor said. "From in the neighborhood, they are just saying basically, that they were robbed and the gentleman had a heart attack."

Suicide by Surgery -It Happens

This is a very sensitive subject that has been on my mind for nearly thirty years. I don't believe there can be a stronger love than that of a son for his mother. My mother died in 1988 and hardly a day goes by without me having thought or remembrance of that beautiful lady who unconditionally showed love for me every day. It is a rough and dirty world out here but mothers find ways to protect their children (nurture and protect). It was clear to anybody who knew my father that his love for her was just as strong as mine and

Mom lived a full and beautiful life. However, she was doomed by sugar diabetes (Type II). This mean and long-term disease has haunted my mother's side of our family. I have it but I am able to keep it under control through daily testing. That wasn't the case with my mother. Despite having diabetes like her siblings and mother she was a chain smoker. My father started smoking at the age of 13 through the end of his life at 76. Mom started later at the age of 30.

Her diabetes started to take a toll in 1971. It eventually caused her first amputation and that began a very sad period for everyone who loved her. She would eventually have three amputations. Twice on one leg and once on the other. She was such a strong woman who took the final years of her life in a wheel chair with a smile and strong religion. Mom was the favorite of all my cousins. We had a large family network - my father had 9 siblings and my mother had 10. With nieces and nephews all over the nation. Everyone loved "Aunt Christine". She and my father were one of the first to move out to California from Louisiana during the 1940's and

The fresh Louisiana air, spring water, home raised poultry, pork and beef, and more. Despite this, my parents would

never stop smoking. My mother was strongly independent. She did not like being cared for. In fact, she told me one day that she would never live in a nursing home. "If you and your brother put me in one of those places I will come back to haunt you." She made that clear to us. As time went on and

she and my father crossed the milestone of 70 years of age, we could see her disability was beginning to take a toll on her and my father. My brother and I would routinely make visits to them and so would other relatives. Someone would always be there to assist Dad in assisting Mom. I guess that eventually became too much of a burden on my father's physical strength

and my mother's pride.

It was during our last trip to visit my parents that it hit me. My parents always enjoyed our twin sons. This time it seemed more so. "I have the most beautiful grandsons!" She would say repeatedly. On the evening we were getting ready to return to Indianapolis, Mom broke the news to us. "I am going into the hospital to receive another amputation" (further up the leg). I shouted, "You can't survive that! No way!" My father remained silent which was extremely uncharacteristic. She retorted, "I

South Plains Food Bank Organizing Efforts to Help Victims of Hurricane Harvey: From Lubbock with Love

The South Plains Food Bank to Coordinate Disaster Relief Efforts to Assist the Thousands Affected by Hurricane Harvey

LUBBOCK, TX- The South Plains Food Bank is calling on area businesses, schools and faith based organizations who are conducting food drives for victims of Hurricane Harvey to coordinate relief efforts with South Plains Food Bank (SPFB) in a campaign called From Lubbock with Love

SPFB has been asked by Feeding Texas, a statewide network of food banks, to make food boxes for flood victims. Once the boxes are made, Feeding Texas will transport the food for distribution to areas of greatest need.

Groups and businesses in Lubbock are already conducting food drives for coastal relief efforts However, the food must be sorted and packed before it can be sent to coastal relief agencies. At this time, food banks along the coast have themselves been damaged by wind and flooding. They lack both the staff and volunteers to work donated food for

Organizations wishing to conduct food drives are being asked to register their food drive with SPFB by going to www.spfb.org/hurricaneharveyrelief. The link provides a way to register food drives or make a donation to SPFB for Hurricane Relief efforts. Organizers are asked to provide containers for the food they collect and to provide transportation to the South Plains Food Bank at 5605 ML King Blvd.

According to David Weaver, CEO of the South Plains Food Bank, "Lubbock and the South Plains is filled with generous and caring individuals who want to help. At this point, we want to coordinate food relief efforts so that no food goes to waste. That may happen when people collect food and head to the coast without a destination in mind. By working through Feeding Texas, we are insuring that donations are put to the best use."

The most needed items are:

Hand-held snack items such as granola bars

Pop-top ready-to-eat items Shelf-stable pantry items such as peanut butter, tuna and soup

Cleaning supplies (bleach, non-bleach, paper towels, etc.)

Personal hygiene items (toothbrushes, toothpaste, etc.) PLEASE NO GLASS OR CANNED ITEMS that could be damaged intransportation

Hurricane Harvey is an unfolding disaster that will require long-term recovery efforts. The best form of support right now is monetary donations that can be used to purchase the needed items and have them delivered in the most efficient manner. The SPFB can leverage donations through bulk and planned buying to avoid the cost associated with sorting and transporting.



NFLPA's Smith: 'No Player Is Disrespecting our Country or our Flag'



As thousands have shown in the past, it takes bravery and courage to speak and confront these issues as our players have, especially when it is unpopular with some," said NFL Players Association executive director DeMaurice Smith.

(Reuters) — NFL Players DeMaurice Smith released a statement Monday regarding players protesting during the national anthem, saying "no player is disrespecting our country or

our flag." Smith's statement comes following Dallas Cowboys owner Jerry Jones' comments on Sunday that his players must stand for the anthem or else they would not play.

In addition, Vice President Mike Pence left Sunday's game in Indianapolis when the visiting San Francisco 49ers knelt during the national anthem before facing the Colts.

"Last week both the Commissioner and the Chair of the NFL Management Council John Mara were clear when they assured our union leaders, in the presence of other owners, that they would respect the Constitutional rights of our members without retribution," Smith said in a statement. "I look forward to the day when everyone in Management can unite and truly embrace and article what that Flag stands for: 'Liberty and Justice for All' instead of some of them just talking about standing. We look forward to continuing our talks with them on this

"No player is disrespecting our Country or our Flag. As thousands have shown in the past, it takes bravery and courage to speak and confront these issues as our players have, especially when it is unpopular with some. There is room for Management to do the same and maybe then players do not have to risk the taunts and threats alone. This is their opportunity to lead as well and will be a true test of the motto that 'Football is

Jones' comments occurred in response to Pence abruptly leaving Sunday's game after more than 20 49ers knelt during the national anthem.

"Understand? We will not ... morning with another tweet: Association executive director if we are disrespecting the flag, then we will not play. Period, Jones said after the Cowboys' 35-31 home loss to the Green Bay Packers.

> Before the Cowboys' game at Arizona on Sept. 25, Jones and members of his family joined the players, coaches and staff on the field prior to the anthem. They kneeled and locked arms. When the anthem was performed, they stood arm-in-arm

with the players. The gesture was in response to President Donald Trump's comments that NFL owners should fire players who disrespect the flag by not standing during the national anthem.

Cowboys defensive ends Damontre Moore and David Irving raised their fists at the end of the anthem before the game against the Packers, according to the Dallas Morning News. Jones said he was unaware of their ac-

Pence, a former governor of Indiana, was on hand to celebrate former Colts quarterback Peyton Manning's induction into the franchise's Ring of Honor.

No Colts players knelt during the anthem prior to the game but the 49ers had more than 20 players kneeling with their hands over their hearts for the second straight week.

"I left today's Colts game because @POTUS and I will not dignify any event that disrespects our soldiers, our Flag, or our National Anthem," Pence

tweeted about leaving the game: About an hour later, Trump tweeted that Pence was acting in response to his instructions.

"I asked @VP Pence to leave stadium if any players kneeled, disrespecting our country. I am proud of him and @SecondLady Karen," Trump tweeted.

NBC News reported Sunday that reporters were told before the game there could be "an early departure" by Pence.

Trump followed up Monday

"The trip by @VP Pence was long planned. He is receiving great praise for leaving game after the players showed such disrespect for country!"

Trump's position unified more NFL players to protest racial injustice before or during the anthem. He said during a political rally in Huntsville, Ala., on Sept. 22 that NFL owners should fire the players who knelt during the

"We're proud of our country. We respect our flag," Trump said to loud applause at the campaign event. "Wouldn't you love to see one of these NFL owners, when somebody disrespects our flag, to say, 'Get that son of a bitch off the field right now. Out. He's fired! He's fired!"


Former San Francisco 49ers quarterback Colin Kaepernick drew national attention last season when he knelt during the national anthem as a protest against racial injustice. A number of players followed Kaepernick's lead by taking a knee during the anthem last year.

NFL players who have demonstrated during the national anthem have said they are protesting police brutality and racism, but not the flag or the anthem itself.

Why NBA Legend Bill Russell Decided to Take a Knee on Twitter

Bill Russell, a trailblazing pioneer for Black men in the NBA, had a career of historic proportions. Russell led the Boston Celtics to win 11 championships in just 13 seasons (1956 to 1969) and he was the

NBA's MVP five times. But during the time of Jim Crow laws in the United States, which supported segregation, Russell's athletic prowess didn't make him immune to rampant racism. Celtics fans didn't accept him as they did his white teammates. Russell also experienced having to sleep in a different hotel than the rest of the team when on the road.

Instead of being silent, he became an outspoken supporter of the civil rights movement. Russell was in the front row during Dr. Martin Luther King Jr.'s "I Have A Dream" speech in 1963 during the March on Washing-

And now, more than 50 years later, Russell is showing his support for NFL players who are silently taking a knee during the national anthem to protest police brutality against Blacks in the U.S., a move initiated by former 49ers quarterback Colin Kaepernick in 2016.

The 83-year-old, who became the first Black NBA coach in 1966 and the first Black NBA player inducted into the Basketball Hall of Fame in 1975, dethe end of September. And he grappled with being verified in order for people to believe it was actually his tweets. But it was worth it to Russell, who was intent on showing solidarity with NFL players.

On September 25, the legend sent his first tweet, which included a photo of him wearing the Presidential Medal of Freedom and taking a knee.

- You are a true role model sir. Thank you for all you've done for the game and for your commitment to social justice. God

For his social activism, Russell received the Presidential Medal of Freedom, the country's highest civil honor, from former President Barack Obama in

During the 1960-61 season with the Celtics, Russell linked arms with his teammates as a sign of unity

: He was a good friend of fellow civil rights activist and heavyweight boxing champion Muhammad Ali. During a press conference in Cleveland, Ohio, on June 4, 1967, Russell was among the top Black athletes who supported Ali's decision to refuse military induction to fight in the war in Vietnam. The press conference became known as

the Cleveland Summit. Many white Americans at the time considered Ali's decision unpatriotic.

cided to create a Twitter page at In a Sports Illustrated article published in 1967, Russell said he was supportive of Ali's decision to risk five years in prison for resisting the draft and was envious of his courage.

"I envy Muhammad Ali ... He has something I have never been able to attain and something very few people possess: He has absolute and sincere faith. I'm not worried about Muhammad Ali. He is better equipped than anyone I know to withstand the trials in store for him. What I'm worried about is the rest of us."

Now, in the age of social media, where President Donald Trump uses Twitter as a megaphone, including pushing for NFL team owners to fire players who protest during the national anthem, Russell has adopted a method of instantaneously supporting social activism.

And, the NBA eventually con firmed that Russell's Twitter account is legit.

On the morning of October 3, he thanked Twitter for the verification. Russell posted a photo of himself at a young age, without a beard.

Rev. Kado Lang October 4, 1922 - October 4, 1997 **MEMORIAL** -- Gone But Not Forgotten

Rev. Kado Lang was called into the ministry at the age of 30 and licensed in 1954. His first church to pastor was in McCamey, Texas in 1954.

He moved to Lubbock, Texas in 1960, and pastored Mt. Zion Baptist Church in Crosbyton, Texas, and in less than a year, he was offered to pastor the St. James Baptist Church in Lubbock, Texas, located at 2611 Cedar Avenue.

Under his leadership, a new church was built on Railroad Avenue, and the church was renamed the Greater St. James Baptist Church.

The congregation later had to relocate to 117 North Mulberry Avenue. He served for 36 years as pastor before he died.

Jemele Hill Suspended after Tweets About Cowboys Owner

ESPN has suspended one of its hosts, Jemele Hill, after she posted a series of tweets pertaining to Dallas Cowboys owner Jerry Jones, who said players who demonstrate during the national anthem will be

benched.

"If there's anything that is disrespectful to the flag, then we will not play," Jones said. "Understand? We will not ... if we are disrespecting the flag, then we will not play. Period."

Hill criticized Jones for putting some of his players in an uncomfortable spot and called on fans to take action.

"Jemele Hill has been suspended for two weeks for a second violation of our social media guidelines. She previously acknowledged letting her colleagues and company down with an impulsive tweet. In the aftermath, all employees were reminded of how individual tweets may reflect negatively on ESPN and that such

parents used willing doctors to commit suicide through surgery. I would often repeat this to my wife, Kay. One day she presented me with this document: "In 2002, the annual suicide rate for persons over the age of 65 was over 15 per 100,000 individuals; this number increases for those aged 75 to 84, with over 17 suicide deaths per every 100,000. The number rises even higher for those over age 85. Further, elder suicide may be under-reported by 40% or more. Not counted are "silent suicides," like deaths from overself-starvation or dehydration, and "accidents." The elderly has a high rate of completing suicide because they use firearms, hanging, and drowning. Double suicides involving spouses or partners occur most frequently among the aged."

Vice President Mike Pence left Sunday's game between the Indianapolis Colts and the San Francisco 49ers when the latter team knelt during the national anthem.

In a statement Monday, NFL Players Association executive director DeMaurice Smith said the players' actions are not disrespecting the flag.

"Last week both the Commissioner and the Chair of the NFL Management Council John Mara were clear when they assured our union leaders, in the presence of other owners, that they would respect the Constitutional rights of our members without retribution," he said. "I look forward to the day when everyone in Management can unite and truly embrace and article what that Flag stands for: 'Liberty and Justice for All' instead of some of them just talking about standing. We look forward to continuing our talks with them on this very issue."

Last month Hill called Trump a white supremacist on Twitter. Her words caught the attention of the White House: Trump's press secretary Sarah Huckabee Sanders called Hill's tweets "a fireable offense" at a subsequent press briefing.

Hill later said she regretted that her comments "painted ESPN in an unfair light." But she stood by her remarks as her personal beliefs.

Trump on Tuesday, October 10, 2017, attacked Hill on Twitter.

According to a new set of guidelines issued by ESPN earlier this year, "commentary related to political or social issues, candidates or office holders is appropriate on ESPN platforms."

A subsequent list of guidelines suggests that such commentary pertains to sports whenever possible and to "avoid personal attacks and inflammatory rhetoric."

"Personal attacks" and "inflammatory rhetoric" are subjective terms, Patrick Stiegman shared in an interview with ESPN analyzing the guidelines. Stiegman is ESPN's vice president of global digital content. He also serves as chairman of the company's internal Editorial Board.

"There is always a layer of subjectivity in such areas," Stiegman said.
"Editors and producers will work with those offering opinions on these topics to ensure the dialogue and debate is thoughtful, respectful and as fair as possible."

While not appearing to discipline Hill publicly after the Trump tweets, according to an exclusive from ThinkProgress, ESPN did try to keep Hill off the air after the incident. Several sources who spoke on the condition of anonymity told the outlet that Michael Smith, Hill's SportsCenter co-host, refused to do the show without Hill, and the network could not find replacement hosts in time for the broadcast.

Some of the sources said that ESPN was ideally seeking Black hosts to do the show, but others said the network asked multiple people if they were available, including white anchors. Apparently not able to find a replacement, ESPN asked Hill to come back to do the show, and she and Smith appeared on air.

ThinkProgress also reported that ESPN denies that account of the day's events .

day's events .

"Yesterday was a hard and unusual day, with a number of people interpreting the day without a full picture that happened," Rob King, Sports-Center SVP of news and information, shared with the outlet. "In the end, ultimately, Michael and Jemele appearing on the show last night and doing the show the way they did is the outcome we always desired."

ESPN reported to ThinkProgress and other media outlets that they "never asked" anyone to fill in for Hill or Smith.

Racist Dove Ad Depicts Women of Color as Unclean

An advertisement for Dove soap has drawn criticism from social media users, who called attention to its racist message .

The original ad appeared on the company's Facebook page. It depicted a Black woman wearing a brown t-shirt. She removes the top to reveal a smiling white woman wearing a white shirt who also removes her shirt, unveiling a different white woman.

By Saturday, amid growing criticism, the ad had been taken down and Dove had released apologies.

Over the weekend, social media continued questioning how Dove, which is owned by Unilever, released the advertisement in the first place. Some people also called for a boycott of the company, as well as other subsidiaries of Unilever.

Dove said on its Twitter and Facebook pages that it "missed the mark" with its ad.



"Dove is committed to representing the beauty of diversity," the company wrote on Facebook. "In an image we posted this week, we missed the mark in thoughtfully representing women of color and we deeply regret the offense that it has


