Applying each state's average yield to its 2002 projected harvest acres generates a crop of 17.1 milion bales, down from the record 20.0 million last year. Market estimates had ranged from 16.0 to 19.0 million bales.

In addition, at the council's annual meeting this week, NCC economists highlighted the bleak circumstances the cotton industry is facing. Export shipments also declined for the week. At 226,500 bales, shipments were 15 percent below the previous week and seven percent lower than the four-week average. The week's key destinations for U.S. exports were Turkey, Pakistan and Mexico.

Online sales of Texas, Oklahoma and Kansas cotton also were James Dunn, Lance Stidham lower in the week ended February 14 as producers sold 13,807 bales versus the previous week's 18,684 bale total. Prices received by growers selling their cotton online ranged from 25.16 to 28.33 cents per pound compared to a range of 26.30 to 27.89 cents per pound the previous week.
