An ordinance arreuding ordinance humber 30
and rroviding for the isswance of eity Callbons of the city of Amarillo, lexas
and providing for their payment, pria
Be it ordained by the city coundil of the city of Amarillo, Texas, as follows: section 1. That there shall be and is hereby ordered issned nine thomsand dollars, in inter. est beaning coupon bonds of the cify of Amanations of $\$ 200$. each, and tobe numbered from 1 to 18 both Section 2. Said bonds shall be fssued for the purpess of erecting a city hall in and for known and stylet" "Amarillo, eity ball bonds, Section 3. Said bonds shall be dated the first day of January 1900 and shall become due and payabin twenty fears after date; they shall bear interest at the rate of five per rent per amnne, payable semi annally, on the first, piincipal and interst payable in hawfil monbonds, or prop ? coupons at the office of the bonds, of prop coupons at the office of the
-National Park Bank, intle city and state of , New You
Sectian 4. Sxid bonds shall be signed by the Mayor, and counter signed by the dily secretary, and shall bear impress of the seal of the city of Amarillo, Texas, on each of them. The coupons altached to have the signature of the Mayor and city secretary of saia city. - Section 5. It is furtber ordaned by the said city conncit, that for the purpase of paying the annual intereat.and creating a sithing fund for the said bonds for the carrens year, there is hereby levied and appropriated a tax of twenty-five cents, or a sufficient amount of
this certain leay of twenry fise cents upon each one hundred dollat valuation of all taxable property in said sity of Amarillo, Texas, to pay interes and create a sinking find for the payment of interest, and principal of said bonds.
It is farther ordained by said eify council of suid cits, that for each succeeding year, while said bonds are out standing, a suffieient tax shall be analatly levied, assersed ands ollecty landappliolt the purposes named, above.
Section 6. That so much of ordinance No. 36 of the city of 'Amarillo, Texas, and all ordinanees or parts of ordinances in conflict with this ordinance, be and the same is Lereby re* pealed.
Section 7. That this ordinance take effect and to be in full force and operation from and after its passage approval and publication. Adopted Jannary 26, 19@0.
