Those whose names are on the list can call toll free 1-800-654-3463 for details of how to register their claims.

The phones are expected to be extra busy the first few weeks following the announcement, and callers are encouraged to continue calling.

Those who prefer to write can address their inquiry to Texas State Treasury, Unclaimed Property Division, P.O. Box 12019, Austin TX 78711-2019.

Information needed is exact spelling of your name and town where property is located, current address and addresses of past five years, including post office boxes, Social Security number of the property owner.

## Police make six arrests

Iowa Park police reported making six arrests during the past week, in addition to investigating two thefts and three acts of criminal mischief.

A 28-year-old man was arrested on a charge of carrying an unlawful weapon after a traffic stop at 12:48 a.m. Monday in the 1200 block of North Bell.

The driver, Jacob Harvey, signed a consent to search agreement, and during the search of his vehicle officers found a double-edge dagger in the vehicle.

Harvey was transported to the county jail at 3:18 a.m., according to the blotter entry.

Linda Carrol Holdbrook, 28, was taken into custody in the 500 block of

West Highway Wednesday of last week on an outstanding warrant issued locally for operating a vehicle without an inspection sticker. She paid a fine of \$104.50 and was released.

Friday morning, police took Billy Gene Morrow Jr., 21, into custody on an outstanding warrant issued by the Wichita County Sheriff's Dept. The warrant was for possession of marijuana. He was turned over to a county deputy to be transported to jail under a \$285 bond.

Friday afternoon, police arrested Michael Dean Cox, 19, on locally-issued outstanding warrants for exhibition of acceleration, violation of driver license restriction and twice for having no motor vehicle inspection, all

of which carry a fine total of \$578.50.

Cox was later released after posting \$50 bond toward his fines, according to the blotter entry.

When an officer stopped Kenneth Michael Frazier, 30, Saturday afternoon on a traffic check, it was determined by computer he had an outstanding warrant issued locally for his arrest, on an animal charge.

Frazier was later released after signing a promise to appear in municipal court.

Robert Larry Wetsel, 24, was taken into custody at 1:03 a.m. Sunday in the 500 block of South Colorado on a charge of public intoxication.

Wetsel was released some eight hours later after paying a \$280 fine.

One of the theft cases reported to police during the week was an owner of trucks who said someone was taking gasoline from them while parked in the 600 block of East Pasadena. The report was filed Friday.

An officer on patrol shortly after midnight Friday noticed a vehicle door standing open inside a fenced area in the 100 block of South Wall.

A closer investigation determined the fence had been cut. A pull-out stereo valued at \$50 was determined to have been taken.

The criminal mischief reports included: business windows in the 200 block of North Yosemite were egged sometime Thursday night; a car tire was slashed while parked Saturday night in the 1000 block of Mary Drive, and a vehicle's window broken out Sunday night in the 500 block of Rebecca.

## Council to consider changes for proposed new business building

City aldermen will consider adoption of three ordinances Monday night, all dealing with the possible relocation of a business.

The meeting is to begin at 7 p.m. in council chambers.

All three ordinances concern the undeveloped property north of Wal-Mart.

If approved, one ordinance would abandon 16 feet of alley right-of-way, one would re-zone the tract from Light Industrial to Convenience Commercial, and the third would re-zone the 2.94-acre tract from Residential to Automobile Commercial and Commercial Recreation.

The name of the business is not included on the meeting agenda.

A resolution to be considered for adoption would allow a lease agreement with Mr. and Mrs. Carlos Carrillo-Miranda, who are reportedly intending to purchase a home on East Cash where a garage is located in the dedicated alleyway.

Also on the meeting agenda is action on bids to purchase a truck, and the reappointment of Don Kirkham to the Nortex 9-1-1 Communication District board of directors.

## School board to consider '95-96 teacher contracts

Iowa Park school trustees will consider 1995-96 contracts for all teachers, during their regularly-scheduled meeting this evening.

Teacher contracts are traditionally acted on during the board's March meeting. Administration personnel contracts were acted on the past two months.

Action on those contracts, as well as the employing of a new TLC teacher, is to take place following an executive session, according to the posted agenda.

The regular business session is to begin at 7:30, in the Junior High School library.

Trustees are also to hold an informal planning meeting in the same room, beginning at 6:30, Supt. Glen Mitchell said.

Other topics on the meeting agenda include:

- \* adopt local textbook committee report for 1995;
- \* cast ballots for Region Nine

Education Service Center board of directors;

\* act on bid on property and liability insurance;

\* act on proposal to purchase a new mixer amplifier for choir;

\* act on purchasing upgraded computer equipment for administration building;

\* act on funding for Saxon Math Program at the junior high for 1995-96;

\* consider a request by Todd Hampton to use the high school auditorium for a program on Mar. 25;

\* consider ordering a new 71-passenger bus;

\* consider taking bids on a new tractor;

\* consider entering into a written agreement with the Band Boosters to purchase a new band trailer;

\* hear reports from the assistant superintendent on the status of a grant for connecting of new technology equipment, and also on Academics 2000 status;

\* hear a report from the superintendent on Senate Bill 1.

## School to get grant for new calculators

Eighth Grade students next year will be provided mathematical calculators, it was announced this week.

The Texas Education Agency no-

tified local authorities a grant application filed earlier in the school year by Robert Palmer, assistant superintendent, and Randy Lovelady, junior high principal, had been approved.

The grant will provide the district with 158 calculators, as well as training manuals for teachers and parents.

The grant program, entitled "Community Awareness, Using Technology for Access to Problem Solving," will provide the calculators for both teachers and students.

One requirement attached to the grant is that a night session must be offered to train parents on the skills they will need to help their children.

The school will announce the dates for the evening sessions later in the spring.

## All vacancies now filled for city, school elections

All three incumbents on the city council have now filed for re-election in the May 6 election, according to Janice Newman, city secretary.

Place One incumbent Virgil Woodfin filed to be returned to Place One on the council.

The other two incumbent aldermen, Mark Raby and Bob Hamilton, had filed earlier. Raby currently occupies Place Five and Hamilton Place Three.

No additional school trustee can-

didates filed during the past week, school officials report.

Incumbent Max Henderson has filed, and is being challenged for his Place Four seat by Jeff Watts.

Place Five incumbent Dennis Yeager has drawn Pat Pelz as a challenger.

The school trustee election also will be held May 6.

Candidates for either election have until Mar. 22 to file. Early voting will commence April 17 and end May 2.

Mrs. Gene Jordan

Patsy (Mrs. Gene) Jordan said her Bohemian ancestry has been a big influence on her cooking techniques.

Her grandfather, on one side of the family, and great-grandparents on the other side, were born in Czechoslovakia. She said the food is not highly seasoned, and her mother used very little spices, mostly salt and pepper, in her cooking.

Among the recipes she is sharing this week, Patsy said the "Pecan Roll" and "Meat Loaf" are her mother's, and the recipe for "Peach Pie" came from her grandmother.

Patsy grew up at Bomarton and attended schools in Seymour. She and Gene went to school together, but he was two grades ahead of her. Following high school, Gene enrolled at Texas A&M where he received a degree, and Patsy went to a business school in Abilene.

The Jordans moved into the Iowa Park school district in 1983 so their three daughters could attend the local schools.

Shonda and LeAnn are students at Iowa Park High School where Shonda was manager for the girls' basketball team this year, and LeAnn was on the freshman girls' basketball team and is on the girls' golf team. Youngest daughter, Sandi, is in the third grade at Bradford Elementary.

Patsy said she loves working with special education children, and has been an instructional aide in the Special Education Department at Bradford since 1986. Gene, who has been in banking since 1980, is president of State National Bank.

With her time pretty well taken up by family activities and work, Patsy said she doesn't have a lot of time for hobbies. But she enjoys working in the yard, and she loves to dance - especially clogging.

Patsy and Gene are involved in their girls' activities such as 4-H Club, junior stock shows, and basketball games.

Patsy is a member of Bradford PTA, Special Education Parent's Advisory Committee, Iowa Park Athletic Booster Club, and the Association for Retarded Citizens. The family are members of Our Lady Queen of Peace Catholic Church in Wichita Falls.

She said the recipes this week are all family favorites, and ones she uses often.

**Hungarian Goulash**

Brown 2 to 3 lb. roast - cut up in cubes - in 2 tablespoons oil. Add 2-3 tablespoons paprika to coat meat. Saute cut-up green pepper. Add beef bouillon and water to cover meat. Add 2 cans whole tomatoes and cook 1 1/2 to 2 hours. During final 30 minutes, add cut up potatoes with skin left on. Serve over rice or noodles.

# COOK OF THE WEEK

**Pecan Roll**

Use sweet bread dough or kolach dough and roll out in rectangular shape approximately 1/2-inch thick. Spread with melted butter. Sprinkle with brown and white sugar. Sprinkle with chopped pecans and roll up. Brush with melted butter. Bake in pre-heated 350 degree oven until golden brown on top. After you take it out of the oven, coat with melted butter.

**Fruit Cobbler**

Mix in sauce pan:  
1/2 cup sugar  
3 Tbsps. sugar  
3 Tbsps. cornstarch  
2 1/2 cups canned (#2 can) fruit - or fresh  
Bring to a boil and boil 1 minute. Sift together:  
1 cup flour  
1 Tbsp. sugar  
1 1/2 tsp. baking powder  
1/2 tsp. salt  
Make it look like meal when you add 3 tablespoons shortening. Stir in 1/2 cup milk. Roll out like pie crust. Spray bottom of dish with Pam and put a layer of fruit, then crust. Repeat one more time, ending with crust. Make slits on top and sprinkle with sugar. Bake at 350 degrees until golden brown on top.  
*I usually double the recipe.*

**Peach Pie**

2 cups fresh peaches (sprinkle fruit fresh on top)  
1 cup sugar  
2 heaping Tbsps. flour  
Dash of cinnamon  
Stir ingredients together and put in unbaked pie crust. Cover with another crust. Bake at 350 degrees until golden brown on top.

**Meat Loaf**

2 lbs. lean ground meat  
1 cup oats  
2 eggs  
1/2 cup catsup  
1 small onion  
1 tsp. salt  
1/2 tsp. pepper  
Combine ingredients and bake 1 hour and 15 minutes in 350 degree oven. Allow to set before slicing.

**Meat Roll**

1 box Pillsbury hot roll mix  
3 different meats (shaved) 2 oz. ea, turkey, chicken, beef or ham  
Mozzarella cheese, shredded  
Ranch Style dressing mix  
Pre pare hot roll mix according to directions on package. Roll out to size of cookie sheet. Butter roll and sprinkle with Ranch Style dressing mix. Then stagger the meat on the roll and sprinkle with shredded Mozzarella cheese. Roll up and pinch the ends and seams. Butter the outside of the roll before and after baking. Bake 30 minutes at 375 degrees.

**Sour Dough Biscuits**

1 cup hot water  
1 pkg. dry yeast  
1/2 cup sugar  
3/4 cup Crisco oil  
2 cups buttermilk (2 Tbsps. vinegar)  
3 tsps. baking powder  
1/2 tsp. soda  
1/2 tsp. salt  
6 or more cups flour  
Dissolve yeast in hot water. Add sugar, oil and milk. Sift flour with salt, soda, and baking powder, and add to liquid mixture. Add more flour if needed to make smooth dough. Keep in tightly covered dish in refrigerator and use as needed. The biscuits can be baked without time for rising. Bake in 425 or 450 degree oven.

**Lasagna**

1 - 8 oz. pkg. lasagna noodles  
1 lb. ground beef  
1 small jar Ragu sauce  
1/2 lb. Mozzarella  
1/2 lb. cottage cheese  
1/2 cup grated Parmesan cheese  
Brown and drain meat; add Ragu sauce. Cook noodles

In an 8x12 baking dish, layer 1/3 of the meat sauce, lasagna noodles, Mozzarella and cottage cheese. Repeat and end with meat sauce. Top with Parmesan cheese. Bake in 350 degree oven 20 minutes or until bubbly. Serves 6-8.

**Old-Fashioned Chocolate Pie**

3/4 cup sugar  
1/4 cup flour  
1 1/2 Tbsp. cocoa  
Dash of salt  
2 cups milk  
3 egg yolks (well beaten)  
1 tsp. vanilla  
1 Tbsp. margarine  
Combine sugar, flour, cocoa, salt and milk. Cook over medium heat, stirring constantly, until mixture thickens. Remove from heat and pour small amount of hot mixture into the well-beaten egg yolks. Stir well. Combine yolk mixture with the rest of chocolate mixture and cook 3 minutes. Remove from heat and add vanilla and margarine. Pour into baked pie shell and top with meringue.

**Banana Bread**

Cream:  
1 cup shortening  
2 1/2 cups sugar  
Add:  
4 eggs  
Sift together:  
4 cups flour  
1 tsp. baking powder  
1 1/2 tsp. soda  
1 tsp. salt  
Add to creamed mixture along with:  
1/2 cup sour milk  
(To make sour milk, add 1 Tbsp. vinegar for each cup of sweet milk.)  
2 cups mashed bananas  
2 tsps. vanilla  
Bake one hour in 350 degree oven.

 Mrs. McIlroy pointed out antiques are generally 100 years old or more, where as collectibles are in the 50-year range. She said some people feel the 1940s is the dividing line between antiques and collectibles.  
 Mrs. McIlroy concentrated her presentation on glassware. She told club members that Depression glass was so named due to the Depression of the 1930s. She said that glass companies decided colored glass would add cheer to people's lives.  
 The speaker related Depression glass was made in several colors, including cobalt blue, pink, amber, red and green. Cobalt blue glass is becoming scarce, she said, and added that is perhaps due to the use of cobalt in cancer treatment.  
 She explained that reproduction is common and presented examples of real vs. reproduced pieces. She added that collectors should look for trademarks, stamps or other identifying symbols, and they should study available sources regarding the antique or collectible.  
 Mrs. McIlroy pointed out differences between the "collector" and the "saver". She said collectors save items because of the value, but savers collect things because they hate to throw anything away.  
 The meditation was given by Mrs. Crumbliss, who read an article entitled "Confessions of a Collector" by Mary Ellen Shelzi. Mrs. Crumbliss also gave the Federation Counselor's report.  
 Members were reminded the 35th Annual Spring Convention, Santa Rosa District, will be held in Paducah Saturday, March 25. Members also were encouraged to attend the one day meeting by Mrs. Chambliss.  
 Members participated in the Project for the Month by bringing items needed by patients at M.D. Anderson Cancer Hospital.  
 Following a brief business session, refreshments were served by the hostesses.

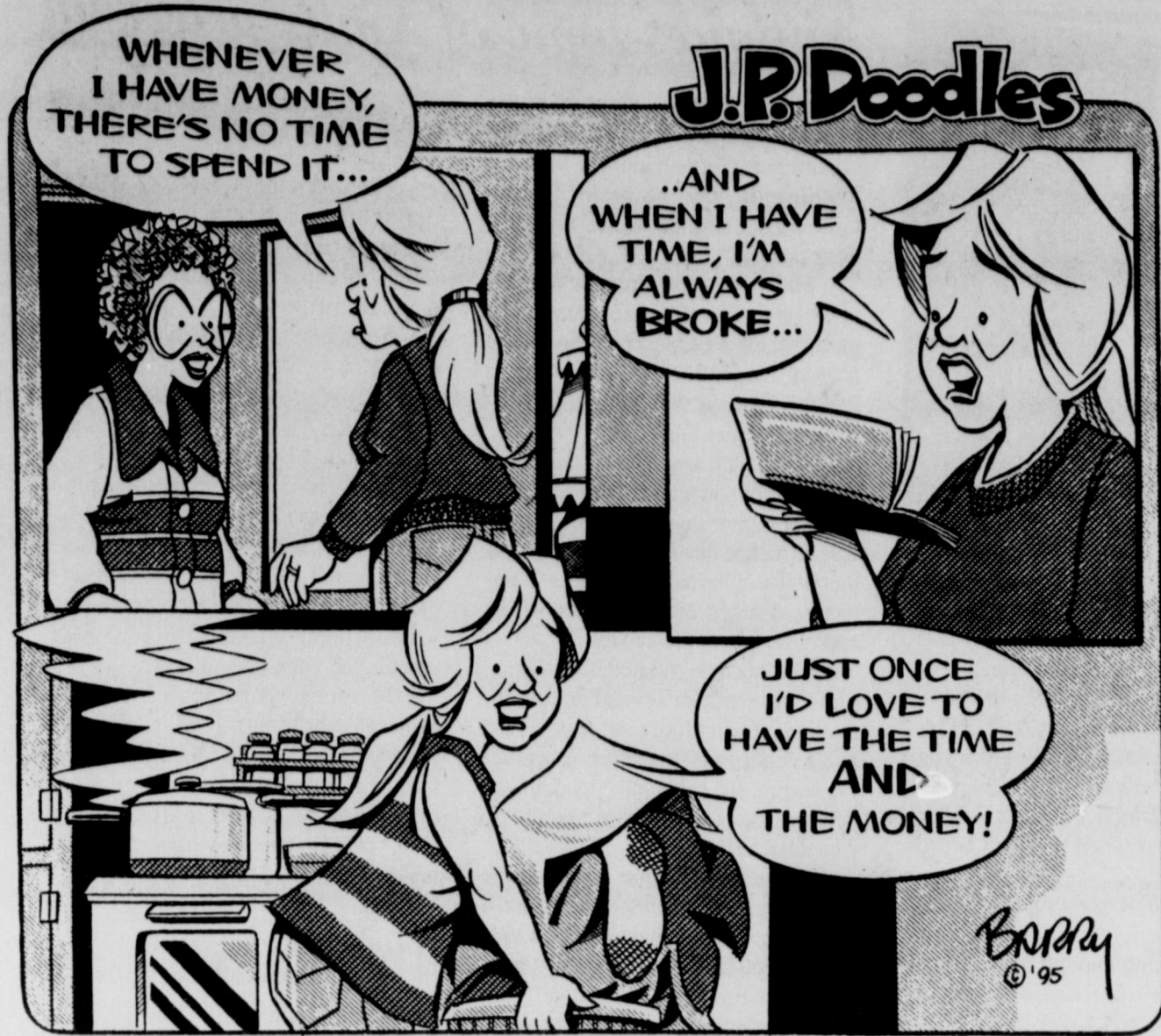

# As I See It...

I'm sorry I wasn't in the office last week to receive a call from a woman who apparently was objecting to my use of the term "equal opportunity employee" in this column.

Possibly she figured I was referring to the government hiring women. I don't know. The employee's gender had nothing to do with my use of the term.

I was referring to the federal government's use of quotas, which it has now imposed, in one way or another, on the private sector and local government levels.

With all this quota stuff in force, minorities have determined now is their time to make big changes in their local governments. They are filing law suits to force gerrymandering so their own race or color are assured to be elected.

## State Capital



### HIGHLIGHTS

**AUSTIN** — A bill that would give eligible Texans the right to obtain a permit to carry a concealed handgun moved a step closer to becoming a law last week.

Sponsored by state Sen. Jerry Patterson, R-Pasadena, Senate Bill 60 was approved 5-1 in the Senate Criminal Justice Committee.

The measure would allow owners of businesses frequented by the public, such as restaurants, movie theaters, hotels and health clinics, the right to deny entry to persons carrying concealed handguns.

Under the bill, applicants for a concealed handgun permit would be required to undergo 10 hours of handgun training and pay a fee of \$140 for a four-year permit. An amendment to the bill contains language that would cut the required number of handgun training hours to 10. The original bill specified 15 hours of training.

An opponent of the bill, Sen. Royce West, D-Dallas, said enforcing the handgun restriction at private businesses probably would require installing metal detectors.

**Lawsuit Liability Bill**  
The Texas Senate approved legislation last week aimed at limiting liability in civil lawsuits that involve more than one defendant.

Lt. Gov. Bob Bullock said the action "dispels forever this fallacy that Texas is anti-business."

But consumers said that such legislation would make it difficult for innocent victims to recover full compensation for their injuries.

The bill, which would change the rules of "joint and several liability," would require that a defendant be found at least 51 percent liable for a civil claim before being required to pay 100

percent of damages. Current law requires as little as 11 percent responsibility.

A defendant found to be 50 percent liable or less would pay only his or her share of the damages.

**Moses Is TEA Nominee**  
Gov. George W. Bush last week nominated Lubbock Independent School District Superintendent Mike Moses as Texas education commissioner.

Moses, 43, advocates a "zero tolerance" policy for violent students. He established a boot camp in Lubbock staffed by military-style drill instructors to correct disciplinary problems.

Though Moses supports the no-pass, no-play rule, he says he would prefer to reduce the period of time students with failing grades must wait before being allowed to participate in after-school extracurricular activities.

**Base Closing Hit List**  
A base-closing recommendation list released last week by the Department of Defense would close four military installations and slap Texas with the highest net loss of jobs in the nation (6,981).

Leaders of Texas communities that have long enjoyed the benefits of having nearby bases are preparing arguments to bring to the Base Realignment and Closure Commission, which must deliver a revised list to President Clinton by July 1.

Worst hit are Texarkana, which faces closure of Defense Distribution Depot Red River (820 civilian jobs), and disestablishment of Red River Army Depot (14 military and 2,887 civilian jobs); Lubbock, clo-

sure of Reese Air Force Base (900 military and 1,183 civilian jobs); and San Antonio, closure of Brooks Air Force Base (1,820 military and 1,939 civilian jobs).

Deactivation of the Bergstrom Air Force Base Reserve unit would cost Austin a total of 954 jobs, including 865 civilian and full-time reservists.

**More Probation Officers**  
Texas would add 400 juvenile probation officers under a plan approved by the House Appropriations Committee.

Officials of the Texas Juvenile Probation Commission said the \$20 million budget increase is about half of what they requested.

About \$10 million of the increase for 1996-97 would pay for 400 probation officers to expand the current staff of more than 1,450.

**Other Highlights**  
Standard premiums for homeowners' insurance in Texas would increase an estimated 2.4 percent under a rate proposal recommended by two administrative law judges. The rate plan, forwarded to state Insurance Commissioner Elton Bomer for consideration, is slightly less than what the insurance industry requested.

Allan Polunsky, a member of the Texas Board of Criminal Justice since 1987, was named chairman of the panel last week by Gov. Bush. He replaces Houston lawyer Carol Vance, who will remain on the board. Bush said Polunsky "will be an important part of the Bush administration's battle against crime."

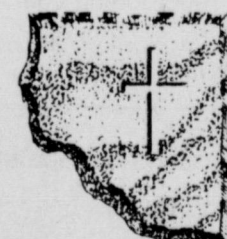

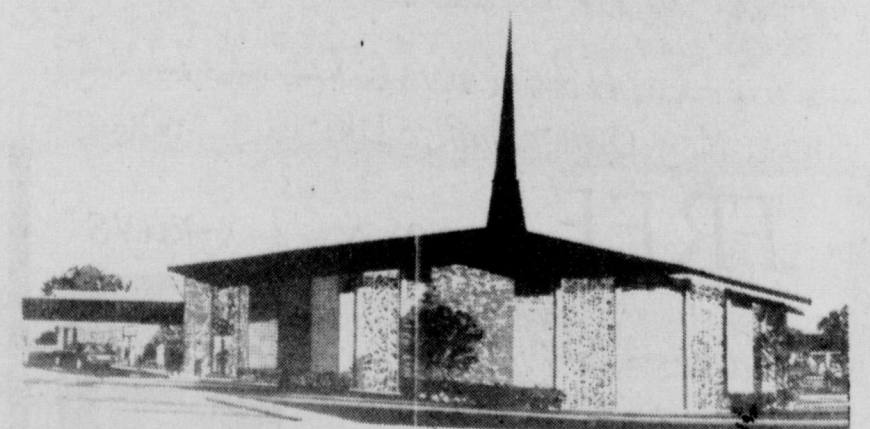

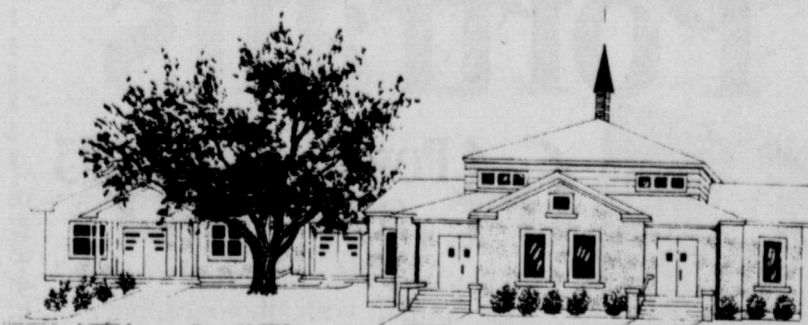

# Couple observes early anniversary on Nile

(EDITOR'S NOTE: The following article was written by Jerry McKissick, son-in-law of the subject couple)

An Iowa Park couple fulfilled a lifelong dream of touring the antiquities of ancient Egypt and sailing the Nile. Doyce and Jo Jennings returned last week from a vacation tour to Egypt and month-long visit with their daughter, grandson and son-in-law who live in Saudi Arabia.

Superstition notwithstanding, this Iowa Park couple departed on Friday, January 13th for the long flight to Cairo. Flying British Airways from DFW via London to Cairo, Doyce and Jo were pampered by ground and flight crews which had been previously informed that this was a special trip for these Iowa Park passengers. In 1997, Doyce and Jo will celebrate their 50th Wedding Anniversary and this was an early Golden Anniversary present from their daughter and son-in-law.

Arriving on a typical rainy morning at London's Gatwick Airport, they boarded a shuttle bus, complete with hostess who served tea and coffee, for the one-hour ride through the English countryside to the London-Heathrow Airport. At London-Heathrow, they were escorted to the Passenger Lounge which includes shower facilities and rest areas to await the next leg of their flight to Cairo.

Cairo is a city of 15 million people and spans both banks of the Nile, from the Pyramids at Giza, the city stretches far into the desert towards the Red Sea. The cab ride from the airport to the

hotel immediately gets the adrenaline flowing. A mixture of old and new, Doyce and Jo saw camels being herded down a main street between high rise buildings, and donkey-pull carts mixing with Mercedes in congested traffic. The Jennings spent three days in Cairo visiting the Pyramids, Egyptian Antiquities Museum where the priceless golden treasures of King Tutankhaman are on display, the alabaster Mosque, and the temples at Memphis and Sakkara.

Departing Cairo, they flew to Luxor (Thebes) to board the Sheraton Nile Riverboat "Tut" for a 5-day cruise up the Nile to the first cataracts at Aswan. In Luxor, they were taken on a guided tour of the vast Temple at Karnak where, after dark, visitors are treated to a sound and light show that retraces the building of the Temple and its symbolism.

Day two in Luxor began with a tour of the Valley of the Kings and Valley of the Queens. Doyce and Jo ventured into the tombs of several Pharaohs, including King Tutankhaman (which is historically significant, but unimpressive in comparison to the paintings and hieroglyphics of other tombs). After lunch, the riverboat set off towards Aswan.

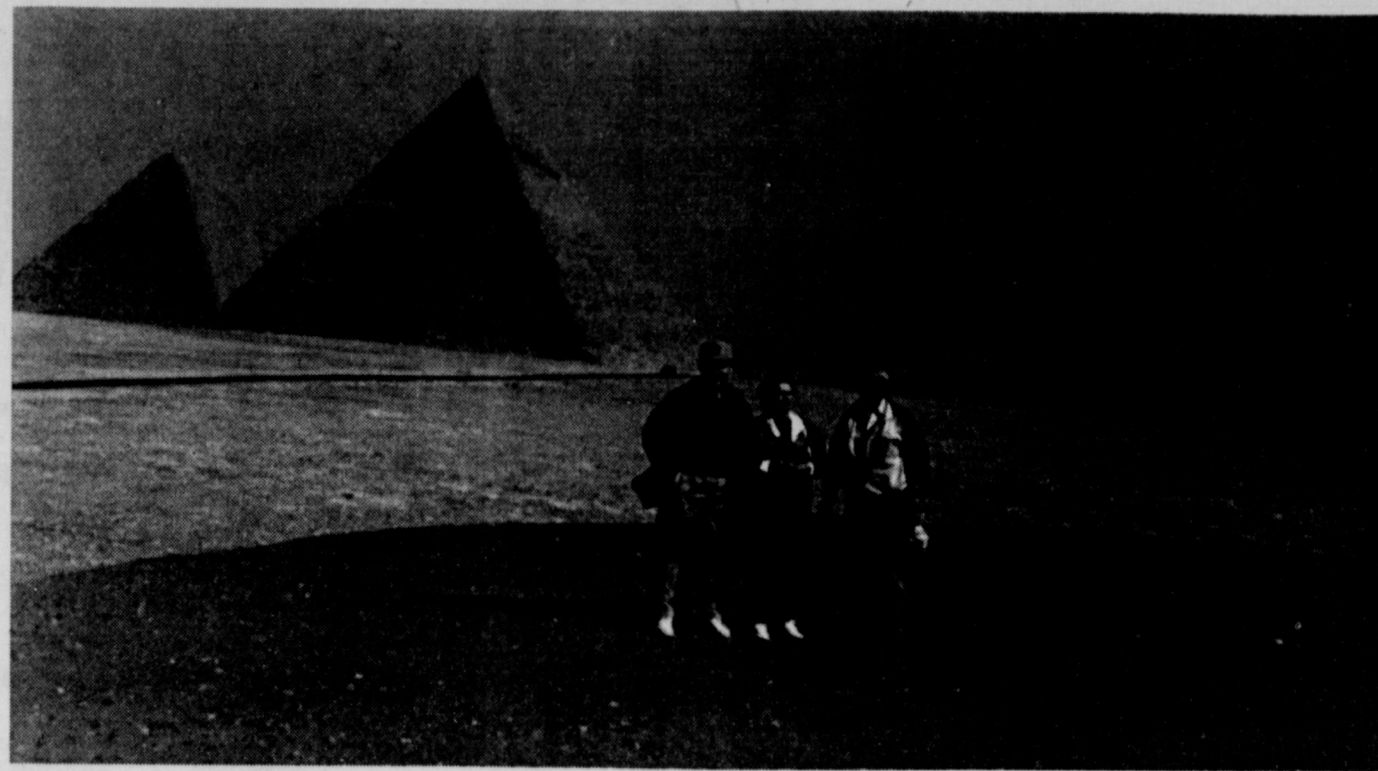
The Nile Riverboats are operated by the major hotel chains including Sheraton, Marriott and Hilton. Comfortably furnished, passengers are treated to exotic meals cooked on-board, bar service and live entertainment in the evenings. One evening, the passengers had to entertain each other

with various skits. At check-in, passengers are assigned to small tour groups. Doyce and Jo's group presented a re-enactment of the mythical Birth of Horus and the avenging of his father's murder.

The riverboats stop at the significant monuments and temples located along the banks of the Nile, the world's longest river. Between Luxor and Aswan, river traffic is light and the Nile is clean. Barges of sugar cane are occasionally seen ferrying their loads to processing plants while fishermen in their traditional felucas (fishing boats) with their large sail cast their nets for catfish and Nile perch (which can weigh several hundred pounds).

The riverboats must cautiously weave their way up the Nile river channel. The Nile is neither wide nor deep here. With the building of the Aswan High Dam, the floods that made the Nile valley one of the most fertile regions in the world are a thing of the past.

The river level is now controlled by floodgates in the High Dam and the flood waters provide year round hy-

dro-electric power and irrigation. The result is that Egypt has become industrialized and not suffered the affects of years of drought that have so badly ravaged other regions of Africa.

However, the dam and the resulting Lake Nassar submerged many monuments and completely covered the land previously inhabited by the Nubians. Several Temples were saved from the rising lake waters, including the Large Temple of Ramses II at Abu Simbal which was completely disassembled and moved to higher ground. Others now sit silently under the wa-

ter, awaiting rescue or rediscovery by future generations.

Egypt is said to be "The gift of the Nile." For without the Nile, man could not have survived or civilization advanced to build these magnificent monuments. The tour guide explained that the building in ancient Egypt was done by Egyptian farmers and not slaves.

The Nile flood would cover the farmland for almost six months every year. During this time, the farmers would bring their draft animals with them to construct the temples and

monuments. In return, they were fed from the food stores paid previously as taxes to Pharaoh. When the flood subsided, the farmers returned to their fields to plant the year's harvest.

Leaving Egypt, the Jennings flew onward to Dhahran, Saudi Arabia to spend some time with their daughter, grandson, and son-in-law who is an engineer with the Saudi Arabian Oil Company.

Doyce's only advice for future visitors to Egypt is, "Never wave at a camel rider. He won't take 'no' for an answer."

## IN THE MILITARY

### ABOARD CONSTELLATION

Seaman Cody J. Sadberry, son of Susan McBroom of Holliday, is halfway through a six-month deployment to the Western Pacific Ocean and Persian Gulf with the aircraft carrier USS Constellation.

He is among 5,500 sailors and Marines aboard the ship, who departed San Diego in November to take part in the six-month overseas assignment.

The Constellation is the lead ship of a seven-ship battle group which includes two guided missile cruisers, a destroyer, a submarine and two logistics support ships.


Since the Persian Gulf War, U.S.

navy units have continued to help enforce the UN-led international embargo against Iraq by preventing ships from transporting prohibited material to and from Iraq in violation of the agreement.


Sadberry, a graduate of Holliday High School and joining the Navy in August 1993, is expected to return to San Diego in May.



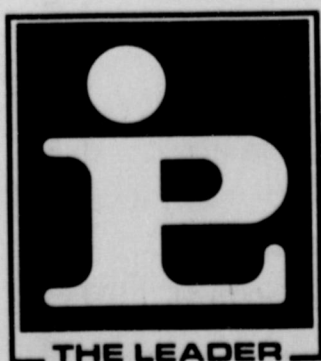

# AUSTIN NOTEBOOK

The Texas Senate is on the verge of passing another major piece of legislation which I promised to support throughout my campaign for the Senate.

The "Concealed Handgun" bill, which was passed by the Senate Criminal Justice Committee earlier this week, would allow law abiding Texans who pay a licensing fee and pass a safety course to obtain a license to carry a concealed handgun.

While I believe that the vast majority of my constituents support this legislation, I would like to take this opportunity to explain why I have consistently opposed gun control and supported the constitutional right of Texans to protect themselves by carrying a concealed handgun.

Perhaps the most powerful argument in favor of this legislation was made clear by Ms. Suzanna Gratia, who testified before the Senate Criminal Justice Committee last week.

While I usually caution against changing state law based on the emotions surrounding one event, her story is too powerful to ignore. Ms. Gratia's parents were killed by a gunman in Killeen, Texas.

You are probably familiar with the incident at Luby's Cafeteria in Killeen -- Ms. Gratia was there.

According to Ms. Gratia, who escaped being killed by running through a broken window, she carries a handgun in her purse when traveling in her car, but took the gun out of her purse before entering Luby's out of fear that she would lose her chiropractor's license if caught with an illegal handgun.

If she had kept the gun in her purse, she believes that she could have shot the gunman before her parents were killed. At the very least, it would have evened the odds.

It pains me to think that the current state law might have caused her to lose both her parents.

Ms. Gratia's testimony was being discussed throughout the Capitol Tuesday afternoon, as people realized that Texas is one of only six states in which Ms. Gratia would have had to leave her gun in the car.

In most states, such as Florida, New York and California, Ms. Gratia

or another Luby's patron might have been able to stop the killing, perhaps before it started.

I want to make sure that Texans are never helpless again in such a situation.

Another issue that I would like to address regarding the debate on concealed handguns is the question of whether or not to have a referendum on this issue.

I think that we have already had a referendum on this issue when Governor Bush defeated Ann Richards. Governor Richards vetoed such a measure after the legislative session, and I believe that she paid the price for that veto.

Those who call for an election are simply delaying the inevitable, and are willing to have the taxpayers pay for their delaying tactics through an expensive election.

I do not think that those tactics are going to fool Texans who believe in honesty and a straight forward approach in governing. I would ask those folks working to delay this issue through forcing another election to stand up and make a tough decision without dumping another expensive election on the voters.

As currently drafted, Senate Bill 60 has several safeguards against abuse, which I feel are important to ensuring that concealed handguns increase personal safety, rather than create a "wild west" mentality.

For example, only persons who have never been convicted of a felony, or who have not had a Class A or B Misdemeanor conviction in the past five years will be able to carry a concealed handgun.

In addition, persons who have been found to be mentally ill or chemically dependent will also be prevented from carrying a concealed handgun.

Persons who have defaulted on debts, such as child support or educational loans will have to become current on their payments before receiving a license.

A person who meets all these requirements will have to pay a \$140 licensing fee, as well as pass a 10-15 hour gun safety course, before receiving a license. All of these requirements should help ensure that

only qualified, law abiding persons receive a license.

Requirements have also been written into the bill which prevent a handgun from being carried into a school, a polling place, a racetrack, a government building, a liquor store, or into a private business that posts a sign saying that guns are prohibited.

These requirements should help keep guns out of places where we would all agree guns are inappropriate.

As I mentioned, S.B. 60 passed the Criminal Justice Committee on Tuesday. It will be considered by the full Senate next week, and then be sent to the House for their action over the next month or so.

Governor Bush has indicated that he will sign the bill when he receives it, so it is probably only a matter of time before Texans can have this fundamental right guaranteed by our Constitution restored.

## NEWS OF THE IOWA PARK GENEALOGICAL & HISTORICAL SOCIETY



The next meeting of the Iowa Park Genealogical and Historical Society will be March 11 at 2 p.m. at Tom Burnett Memorial Library. The program will be on Old Land Records, presented by Nikki Reed.

The National Archives in Washington D.C. has a number of field branches located throughout the United States. All of these field branches have microfilm copies relating to compiled service histories, pensions, and Revolutionary War bounty and warrant applications.

They also have naturalization records issued by federal courts for the regions they serve. Here are some of the lesser known records held by the various field branches.

The San Francisco branch has photographs, medical reports, memos and telegrams of the Army Surgeon General's office, which set up shelters and cared for thousands of residents after the 1906 earthquake and fire.

The Boston branch has New England customs records, including information on passengers, seamen, masters and owners of vessels.

The Chicago branch has a Soundex (index) to naturalizations, both local and federal, filed in specific areas of Illinois, Wisconsin, Iowa and Indiana.

The New York branch has Vice Admiralty Court records.

The Kansas City branch has navigation and marine inspection records, including licenses of pilots, mates, masters and engineers of vessels on the Mississippi River, Red River of the North, Lake Superior and Yellowstone Lake.

The Denver branch has records of the U.S. District Court of Utah, which heard 2500 polygamy cases from 1870-1890.

The Fort Worth branch has extensive records pertaining to Native Americans and the court at Fort Smith, Ark., where "Hanging Judge" Isaac Parker sentenced 96 people to the gallows.

The Seattle branch holds numerous cases relating to fishing, land title and other treaty rights of Indian tribes. The Anchorage branch has records of the surveyor general of the Alaska Territory, including applications from settlers for land or mineral surveys in Fairbanks and other areas.

A book that is an outstanding guide to the records in each branch is "The Archives: A Guide to National Archives Field Branches," by Lorretto Dennis Szucs and Sandra Hargreaves. This book also contains the address of each field branch.

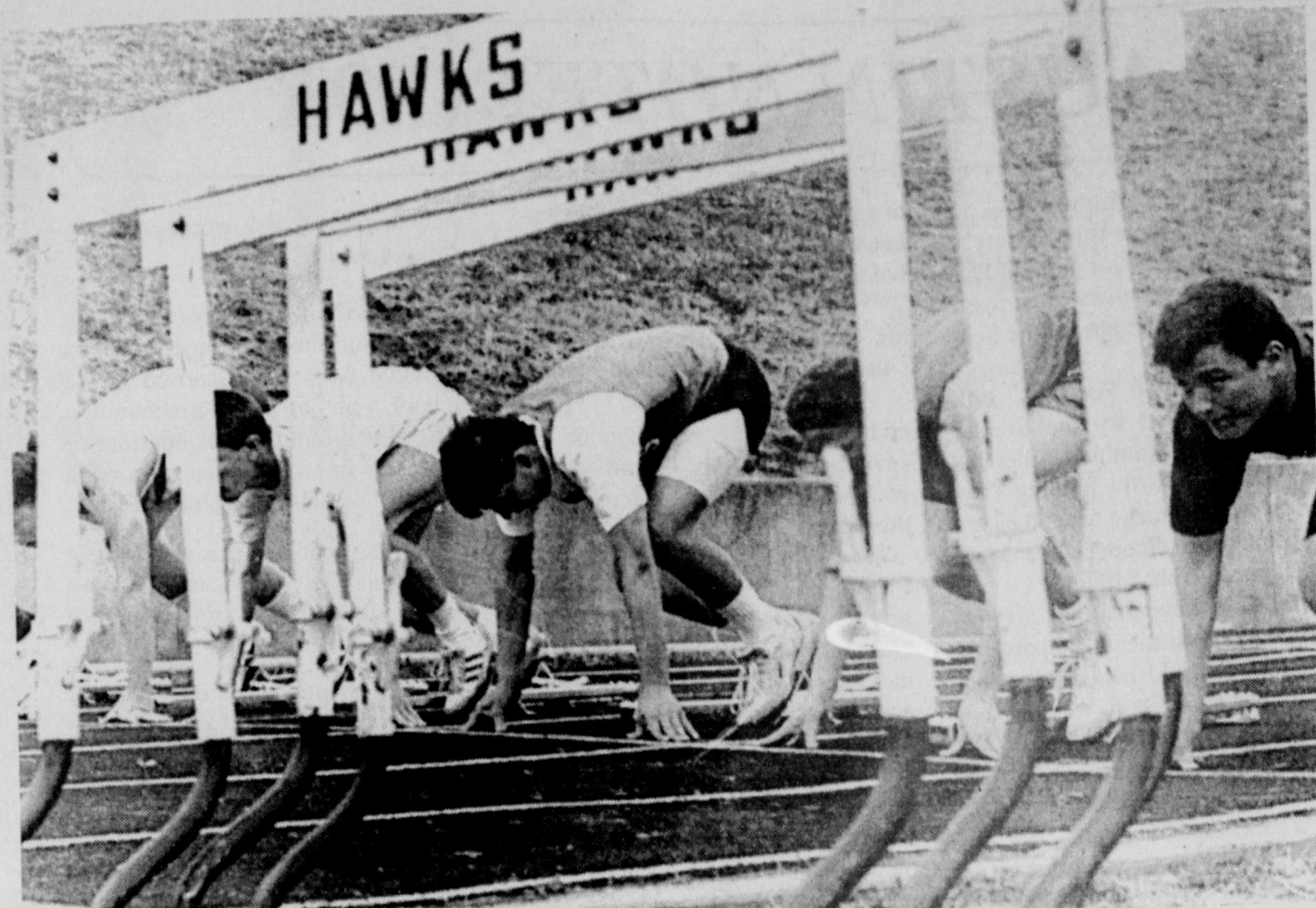

## Weather frustrating Hawks

The weather hasn't been cooperating with the Iowa Park baseball team so far this season.

So far, the Hawks have had to postpone a game against Wichita Falls High School, cancel a game with Holliday, cancel a tournament in Childress and last Monday the Hawks were forced to cancel another game with the Holliday Eagles.

But despite temperatures in the low 40's and a wind blowing over 20 mph, the Hawks were determined to get in a pair of games against Childress Saturday.

The two teams were scheduled to meet in the Childress Tournament but the field in Childress was under snow forcing the Bobcats to travel to Iowa Park to play the home team.

The Hawks lost a pair of three-run decisions to Childress who improves to 2-1 for the season.

In the first game the Hawks jumped out to an early lead when Clint Scobee singled sharply to center to score Jeff Taylor who reached base on an error. Taylor stole second to get into scoring position before Scobee's single.

The lead held up to the top of the third when Childress rallied for four runs to take a 4-1 lead. Two walks and a pair of singles led to the Bobcats runs in the inning.

Iowa Park trimmed the lead to 4-3 in the bottom half of the fourth on a pair of walks and a two-run single to

right center by shortstop Robert Klinkerman that plated Taylor and Scobee.

The Hawks tied the game at 4-4 in the fifth when Rudy Hawkins scored on an error by the Bobcat second baseman.

Childress put the game away in the top of the sixth when an error, a pair of walks and a single led to the winning runs as the Bobcats crossed the plate three times in the inning.

In the second game, the Hawks had trouble getting the ball over the plate as Iowa Park issued a total of 10 walks and gave up 7 hits while committing 4 errors as Childress prevailed 10-7.

The Bobcats scored single runs in the first and third to take a 2-0 lead before Iowa Park answered with a three-spot in the bottom of the third to take a 3-2 lead.

Hawkins was hit by a pitch to start the inning off and Taylor's double scored Hawkins. Klinkerman followed with an RBI single to score Taylor with the tying run before he came home on an RBI double by Cory Thompson to give the Hawks the lead.

It was a short-lived lead as Childress exploded for 7 runs in the

top of the fourth to put the game away.

Five walks and only three hits led to the seven runs as the Hawk hurlers struggled with their control in adverse weather conditions.

Iowa Park tried to come back in the bottom of the seventh and scored four runs but it wasn't enough to overcome the hole they had dug for themselves.

The Hawks were scheduled to play Holliday at Hawk Field Tuesday but weather conditions once again forced the game to be called off. Iowa Park will be in action tonight at 7 when they take on Lawton in the Wichita Falls Classic at Hoskins Field in Wichita Falls.

"The tournament was played on Bridgeport's home course so I expected them to play well," head coach Dick Smith said. "And as for the other teams from our district, we were within 8 shots of all of them and this was our first tournament to have a full team. I'm real pleased with the results for this early in the season."

The Hawks next action will be March 20th at Quanah and March 23rd at Sheppard before the first round of the District 3-3A Tournament on March 27th at Graham.

# Regional Powerlifting meet set here Saturday

The Region VI Powerlifting Meet will be held this Saturday beginning at 9 a.m. in the Iowa Park High School Gymnasium with 20 different schools attempting to advance its lifters to the State Meet to be held at the G. Rollie White Coliseum on the campus of Texas A&M Univ. on Saturday April 1.

The meet will be open to only the top 10 lifters in each weight class who have qualified by lifting one of the top 10 totals in the Region this season.

Iowa Park's Steve Stewart, who is the Region VI Director, will also serve as the meet director and is expecting several lifters who advanced to the state tournament last year to return to defend their titles. The defending state championship Bishop Lynch team will be back trying to win back-to-back titles this year, but according to Stewart this year's meet is wide open.

"I see it coming down to five teams with any of the five having just as good a chance as the others," Stewart added. "Bishop Lynch, Decatur, Iowa Park, Sanger and Frisco will battle it out for the top spot if things hold true to form."

The Hawks have qualified nine lifters with the top two alternates in two other weight classes.

Kevin Freeman is coming into the meet with the 10th best total in the 114-lb. weight class, Dale Lindgren is 5th in the 132's and is just 40 lbs. behind the leader in the class. Chris Norris is the first alternate in the 132's. Jose Dominguez is 3rd in the 148's and trails the leader by 60 lbs. Shane Bagley is 10th in the 148's. Troy Radford is currently in 2nd in the 181's and is only 15 lbs. behind the leader, but 60 lbs. ahead of the third place lifter.

Phillip House leads the 220's by 75 lbs. In the 242's, Iowa Park has Tyson Spruiell who is 6th and Tony Galliton who is the first alternate. Keith Hoover is 5th in the 275's and Wally Wahl is 9th in the same weight class.

The top two lifters in each weight class will advance to the state meet while the top five lifters in each class will receive medals and the top three teams will receive trophies.

"Both House and Radford stand a real good chance to move on to State," Stewart said. "And I should have 4 or

5 more lifters medal this year."

Four Lady Hawks have qualified for the Regional Meet as well.

Mandy Chastin, Misty Beavers, Jessi Boyd and Briana Stalker, and according to Stewart they all have a real good chance at picking up a medal in the meet.

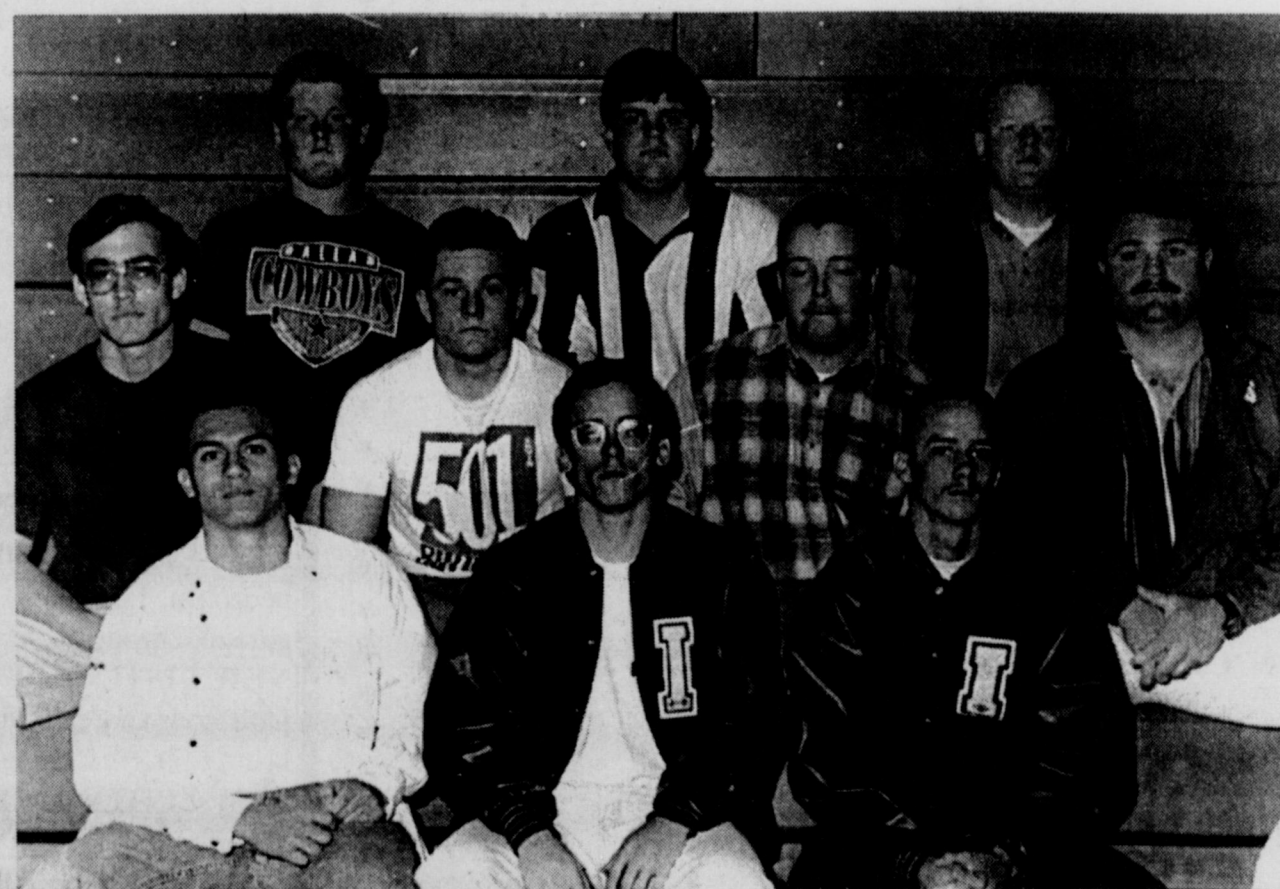
