Katt Quits as Cage Coach

Cross Plains will be in the market for a new basketball coach since Brian Katt resigned Thursday from the helm of both the girls and boys programs.

Katt said that his decision to resign after his first year with the Buffaloes resulted from a desire to coach a program that will be a state contender. His resignation is effective at the end of the school year.

Katt directed the boys team to a 25-9 record which included a bi-district and area championship. The Buffaloes were knocked out of the regional playoffs by Eula.

"They're going to have a super girls team back next year," said Katt. "The boys team needs some height. When you're (moving) up to 2A you need some tall people and we just don't have them."

The Cross Plains girls team compiled a 26-6 record and won three mid-season tournaments. They were rated No. 3 at one time by the Texas Girls Coaches Association and No. 6 at one time by the Texas Association of Basketball Coaches. The Buffaloes ended their season under Katt with a loss to Tolari in a bi-district game.

Katt's son Elgin, a sophomore, was a member of the District 29-A all-star team, averaging 23 points and 11

assists per game. Son Jerry, a freshman, also played on the varsity team.

Honored Book To Be Reviewed

On Monday evening, March 31, at 7 p.m., Dr. Lou Rodenberger will review Billy Lee Brammer's "The Gay Place," third in the series of books about Texas. Winner of the Houghton Mifflin Literary Fellowship Award, the novel has been said to portray Texas politics with the same richness that F. Scott Fitzgerald gave life on the eastern seaboard.

David Halberstam wrote in the New York Times, "There are two Classic American political novels. One is 'All the King's Men' by Robert Penn Warren. The other is 'The Gay Place,' a stunning, original, intensely human novel inspired by Lyndon Johnson." Written as three separate episodes, the novel is dominated by Governor Arthur Fenstemaker, based on Johnson, a "politician and master charmer" who manipulates and moves as an irresistible force. Brammer worked for Johnson for four years, and some say that no better portrait of a pure politician has ever been painted.

Participants are enjoying both Dr. Rodenberger's presentations and the group discussions. Again, all who enjoy discussion or listening while ideas are discussed are invited to come to the last three presentations at the Cross Plains Public Library.

2. April 7, 1986, 7:30 p.m. was set as the date to canvass results of the school board election to be held on April 5.

3. Purchase of a new school bus will be delayed until May.

4. Approval was given to participate in the Education Service Center, Region 14 school bus auction to be held the first Saturday in May. Cross Plains ISD will send the 1971 Ford Bus to be auctioned.

5. Textbook selections were approved for 1986-87.

6. Harold Schoeder was approved as Driver Education Instructor. The fee for the course was set at \$103.00. This is the same as last year. The course will be taught before and after school.

7. The compliance report from the Texas Education Agency was presented. There were no major items to be corrected and CPISD received a favorable report.

8. A temporary guardianship policy was approved pertaining to students wishing to enroll in the CPISD, but not residing with a natural parent or legal guardian.

10. A career policy was approved along with the ladder procedure to be followed for appeals.



Business Opportunities: the Old Come-On

If you're looking through the classified section of your newspaper, sooner or later you're sure to run across an ad that reads something like this:
"Business opportunity! New firm expanding into this area needs distributors for national products. No selling required. Earn \$20,000 a year working part-time! Proven investment returns. Call Mr. Wonder."

THE PITCH

If you respond to this or similar ads, there's a chance you could become the object of a misleading sales pitch for a less-than-profitable distributorship. The sales routine for such a deceptive offer generally follows this pattern:

Mr. Wonder comes to your house or sends a sales representative to explain the distributorship investment opportunity. The product to be distributed may be anything from film to children's books to vending machines that dispense freeze-dried coffee or soup.

Very likely, you will be shown lavish colored photographs and brochures of the product designed to impress you with the fact that large amounts of money can be made with little effort. The salesman of such a product as vending machines may get you to agree that such a machine will sell at least 15 units of the product a day.

"But let's be conservative," he may say. "Suppose it sells only 10 units a day. Even at that, you can make \$1400 a month if you purchase 10 machines and they earn 50 cents on each sale."

After describing the profitable machine locations provided by the company, the salesman will urge you to sign a contract immediately to take advantage of the "fantastic" offer for only \$2000.

Later, when you survey the locations, you may find that your soup dispensing machine is located in the back of a beauty salon or service station where there is little public traffic.

GUIDELINES

My consumer protection attorneys advise taking these precautions before investing any money in a distributorship:

- Find out who the principal investors are in the company.
- Ask for a list of other investors and contact them to learn what experiences they have had in dealing with the company.
- Don't rely on the representations made to you by salesmen for such companies about investment returns, product quality, or anything else—verify these things yourself or ask others.
- Don't be high-pressured into signing a contract immediately—think about the offer for a few days or even weeks, and have your lawyer look over the contract.
- Check with your local Better Business Bureau to find out if any complaints have been filed on the company.

New Rules In Food Stamp Program

AUSTIN— State Comptroller Bob Bullock Friday warned that new rules of the federal food stamp program could cost Texas government \$150 million in lost sales tax revenue on candy and soft drinks.

Bullock said reauthorization of the federal program contained new provisions that forbid states from participating if they collect taxes on food-stamp purchases.

"We don't tax meat and potatoes, but we do tax candy, soft drinks and diluted juices," Bullock said.

Bullock said the Legislature will have to look at an option of creating a two-tier system to exempt these products when they are purchased with food stamps or totally exempt taxes on candy, soft drinks and diluted juices.

He said the state has until September 30, 1987, to exempt the items or be forced out of the food stamp program.

"It's a real dilemma for the state and another financial headache that will face the Legislature when the session starts next January," Bullock said.

Bullock said that there are some 1.3 million persons in Texas eligible for federal food stamp assistance and that in 1986 an estimated \$714 million in food stamp payments will be made.

He said that unless Congress is willing to bend on the issue and make changes in the law before the deadline the state's food stamp eligibility will be threatened and another source of state tax revenue will be cut off at the knees.

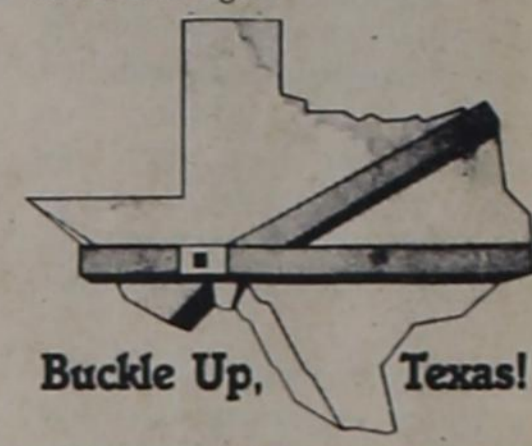

STATE CAPITAL



HIGHLIGHTS

AUSTIN—The Texas economy took two hits last week, one when the Lone Star Steel mill in Northeast Texas confirmed its layoff of 2,000 workers, and the second, when the feds took control of two state lending institutions and another six were put on watch.

Governor Mark White took the campaign trail in earnest, touring the steel mill and blaming President Reagan for allowing a "foreign invasion" of Japanese imported steel, and adding his staff is putting together a \$324,000 grant program to retrain the laid-off steel workers.

In doing so, White missed his usual weekly press conference, but he may regard that a blessing. Now that the state-wide televised debate looks hopeless, White's Democratic opponents are vowing to show up at his own press conferences in an effort to get Mark White to debate the issues.

One, Andy Briscoe, drove a tractor up the Capitol steps last week and, from the drivers seat, explained his farm platform. Briscoe, from Dallas, claims growing rural support.

Changing the Reforms

The second major contender to dump White, Don Crowder, told the Capitol press he welcomes a political fight with Dallas tycoon H. Ross Perot, who chaired the panel which created the "no-pass, no-play" school reforms.

Crowder wants to alter the reforms, and Perot vowed to beat any candidate who tried

to tinker with them.

So far, Crowder hasn't backed away from anyone this campaign, but Perot isn't exactly faint-hearted himself.

Tests, Taxes

For the first time since the education reforms were enacted, Mark White last showed signs of retreating from his hard-line stance. Speaking to a high school honors class, he expressed his fear that the recent teacher competency test would cause the loss of good teachers.

Whether that was an off-the-cuff remark or not, some Capitol watchers feel that White's only chance to stay in the Governors Mansion is to make peace next month with public schoolteachers.

So far, teachers haven't endorsed a candidate and while teacher groups protest when Mark White appears, theoretically the door is still open for a reconciliation.

Last week, Texas Education Commissioner William Kirby, a White appointee, asked parent-teacher organizations to tell the Legislature to prefer higher taxes to cuts in education.

Meanwhile, the American Federation of Teachers said a letter on their stationery endorsing White's reelection was "a fraud."

Party Chairmen

Texas GOP state chairman George Strake has all but endorsed state Sen. Buster Brown to replace him this summer and is trying to get him the votes on the party's executive committee.

Brown was prevented from running for attorney general by Strake and Texas courts on a constitutional point of order. The only announced candidate is party vice chair Diana Denman of San Antonio.

Texas Democratic chairman Bob Slagle was recently appointed by White to the Red River Compact to handle occasional problems with other states. The job brings a \$23,000 salary plus expenses.

Other Highlights

• Texas Land Commissioner Garry Mauro said a new veter-

ans loan program will be expanded to include repair or remodeling of homes, a move that will boost veterans frozen out of the conventional market. Mauro said the program is not run with one penny of tax money and will create new jobs.

• Treasurer Ann Richards drew criticism for holding a \$4,000 lakeside retreat for 29 staffers to discuss trimming the budget. She responded her agency couldn't back out of the contract signed before the executive order to cut the budget.

• Agriculture Commissioner Jim Hightower last week signed an agreement with Mexico to trade farm, ranch and other products and help the Rio Grande economy.

• A Travis County congressional hopeful was removed from the GOP ballot when many names on his petition were declared invalid.

• The son of a Texas House candidate is being investigated for impersonating an IRS agent to get information about his father's opponent.

His dad is George Lawshe, running against Al Granoff in Dallas. The son got the idea, he said, from the "Rockford Files" TV series.

• The State Commission of Judicial Conduct last week wouldn't seat a Conroe man who was first appointed, then withdrawn, by Gov. Mark White. The governor's office withdrew the appointment after it learned that Dwain Read had filed as a Republican for county judge. Instead, a Sulphur Springs man was appointed.

• Texarkana state Sen. Ed Howard will retire this spring to become a lobbying partner with former House Speaker Rayford Price.

State Rep. Sam Russell is expected to seek the seat in a summer special election.

• A former state representative, Walter Grubbs of Abilene, is expected to run as a Democrat for the seat being given up by GOP Rep. Gary Thompson. Grubbs lobbies for West Texas Utilities; Thompson will lobby for the state retirement system.
