ever before, state food and drug inspectators are being asked to check on deceptive and false labeling and advertising of food products offered for sale at grocery stores and restaurants. Such misleading advertising and food labeling is a violation of the Texas Food, Drug and Cosmetic Act of 1961. That act establishes the criteria for determining what is an adulterated or misbranded food, and any false advertising or misrepresentation that might be used to induce sale of the product. The State Health Department has received the full cooperation of the majority of establishments

There are a few items in Texas that perennially give more problems than others. The chicken fried steak is one. Occasionally, the meat is actually a breaded meat pattie. Catfish is another. The meat could actually be codfish. In some instances when a restaurant menu advertises "hamburger" 01 "hamburger steak," the meat may be ground meat pattie con-

There are four basic requirements for labeling: (1) that the true or common name of the product be listed, (2) that there be an accurate statement of the quantity of the content in terms of weight, measure, or numerical count; (3) that it list the name and place of business of the manufacturer, packer, or distributor; and (4) that it list the ingredients in descending order of amount of content.

"The problem usually arises at the retail level, rather than with wholesalers or meat packers," says James M. Doughty, director of the Food and Drug Division of the Texas State Department of Health "Products are usaully pretty well controlled up to that point through such programs as the State Health Department's Meat Inspection Program at the wholesale or meat packing plant level."

"Even so, the products on which we receive complaints are usually all good, wholesale products," says Doughty, "but with high prices the way they are, the consumer ought to know exactly what he's getting, so each person can make his own free decision and not be misled." "What we would like to see is

that the true or common name of the product be included when it's advertised either in a newspaper or on a placard in the store, as well as the requirements on the label itself."

Child Abuse Or Neglect Should Be **Reported** Promptly



The Association also suggests that parental attitudes J such as apathy toward his problems and refusal to allow him to take part in school activities. If abuse is suspected, it should be reported to the county child welfare unit or to any local or

State law enforcement agency. The report should include the names of the parents and child, their address, the child's age and the nature of the abuse. If not all these facts are known, then any information which can direct an investigator to the scene should be reported. Names of persons who report





However, since chlorine bleach can't be used on all fabrics, test it first by applying bleach to a hidden part of the garment and examine it for fiber damage and color or appearance changes. "As a rule, chlorine bleach can't be used on non-colorfast fibers, such as wool, silk, acetate, spandex (elastic) and polyester.'

For mustard in non-bleachable fabrics, the specialist recommended the same method. 'except launder in warm water and omit the chlorine bleach.' And for mustard in non-washable articles, sponge the stain with alcohol. Again, test alcohol first, as a precaution. Also, dilute the alcohol with two parts of water for use on acetate "If alcohol can't be used or if it doess't remove stain completely, follow treatment for washable articles, omitting the soaking."

If the stain seems totally impossible to remove, Miss Brown advised taking the garment to a professional drycleaner -"and be sure to tell him it's a mustrd stain."



The new law gives extra help to any consumer who complains of a fraud or misrepresentation which occurred after May 20. because: 1-It expands and clarifies the "dirty laundry list" of deceptive practices punishable by law. 2-It authorizes the trial court to order restitution to the consumer for the money he lost. 3-It allows the State to obtain penalties when a court orders an injunction against anyone found violating the consum law, instead of delaying possibility of penalties until an injunction has been violated. Obviously, that will be an added deterrant to abuse. 4-It gives the consumer not only the legal right, but the incentive, to file an individual suit, since he now will have an opportunity to recover triple damages, as well as court costs and attorney's fees, if he wins his case. 5-It gives a group of consumers who claim injury by a single deceptive practice the right to file a class action suitif each has suffered damages amounting to \$10 or more. And if they win, they can recover acual damages, plus court costs and attorneys' fees. 6-It encourages the establishment of consumer protection offices by individual cities. And 7-it gives the consumer more close-to-home help, because he can turn to his county or district attorney, who now have enforcement jurisdiction concurrent with the Attorney General's Consumer Protection Division. (Under another law, the Legislature also guaranteed the maintenance of Attorney Generals' regional offices in El Paso, Houston, San Antonio, Dal-

and several good guns. A good haul for the Indians if they had killed us. So back we came to Texas. We had traveled fast, good mules and well fed, and started back through Denver to Granada, Colorado, from there to Adobe Walls on the Canadian. I will digress a little here. When we were camped near the Adobe Walls, Jess Evans of the commission firm of Hunter Evans & Co., of St. Louis, camped near us. He was on his way to the John Chisum Ranch on the Pecos. He had been appointed receiver for the John Chisum estate of 76,000 cattle and was going to gather and drive these cattle to Wyoming. These 76,000 cattle were known as the Jingle Bob herd, the only herd of cattle in America that was known by the ear mark and not the brand - Rail on the left side. He had the biggest and best equipped cow outfit that ever crossed the Plains or was ever seen in America or any other country. He had fitted up in St. Louis. Twenty new Studebaker 2-34 and 3-inch wagons. All had new mess with full cooking outfits, bows and sheets, 100 good Missouri mules, a car load of flour, bacon, coffee and enough to last four months. He had driven on the trail before from Texas to different points in Kansas. He had 50 special coffee pots made to order with copper bottoms. He knew all about boiling coffee on a buffalo chip fire. They were the best I ever saw. Used two of them several years, not much chance to turn one over. He shipped this outfit to Do-

dge, Kansas, where he was to receive 500 cow horses contracted for to be delivered there. Most of these came from Texas the year before with trail herds. A hundred cow hands. They were the best armed bunch of men I ever saw. Most of these men had gone up the trail the year before and stayed with the cattle that were wintered on the Arkansas River. The reason for this was the Lincoln County war was just getting interesting, and Evans was fixed for anything that might happen. And it did. The worst cattle war ever wag-

# Why Not A Sorghum Plant?

The following by N. C. Martin to the Daily Panhandle is just as applicable to Clarendon as elsewhere:

"I am moved to drop your valuable paper a few lines in behalf of an enterprise (although apparently a small one) that I think would help develop an industry that would not only be a benefit to the city in a small way, at least, and of great benefit to the agricultural interests of the surrounding and tributary country. I notice that the grocery stores in Amarillo, and presumably every grocery store in the Panhandle, imports sorghum molasses from Iowa, Missouri, and other states, which is purchased by their customers. I presume thousands of dollars are sent abroad every year by grocery merchants of the Panhandle to pay for sorghum molasses that in the writer's opinion, could as well be manufactured right here on the ground that is especially adapted to the raising of sorghum. Then why not establish a sorghum molasses factory in Amarillo, thoroughly equipped with modern machinery, etc., for the making of a first-class article. Such a factory would not only supply the local demand, but would certainly stand its own in every town in the Panhandle in competition with the Iowa, Missouri, or east Texas product. Chronicle 1908



One deal at Clarendon gave the Denver orders for eightyfive cars that will be used in transporting cattle to Kansas in March.


The total orders for the week, according to careful estimates, will reach 5,000 cars. -Chronicle 1908
