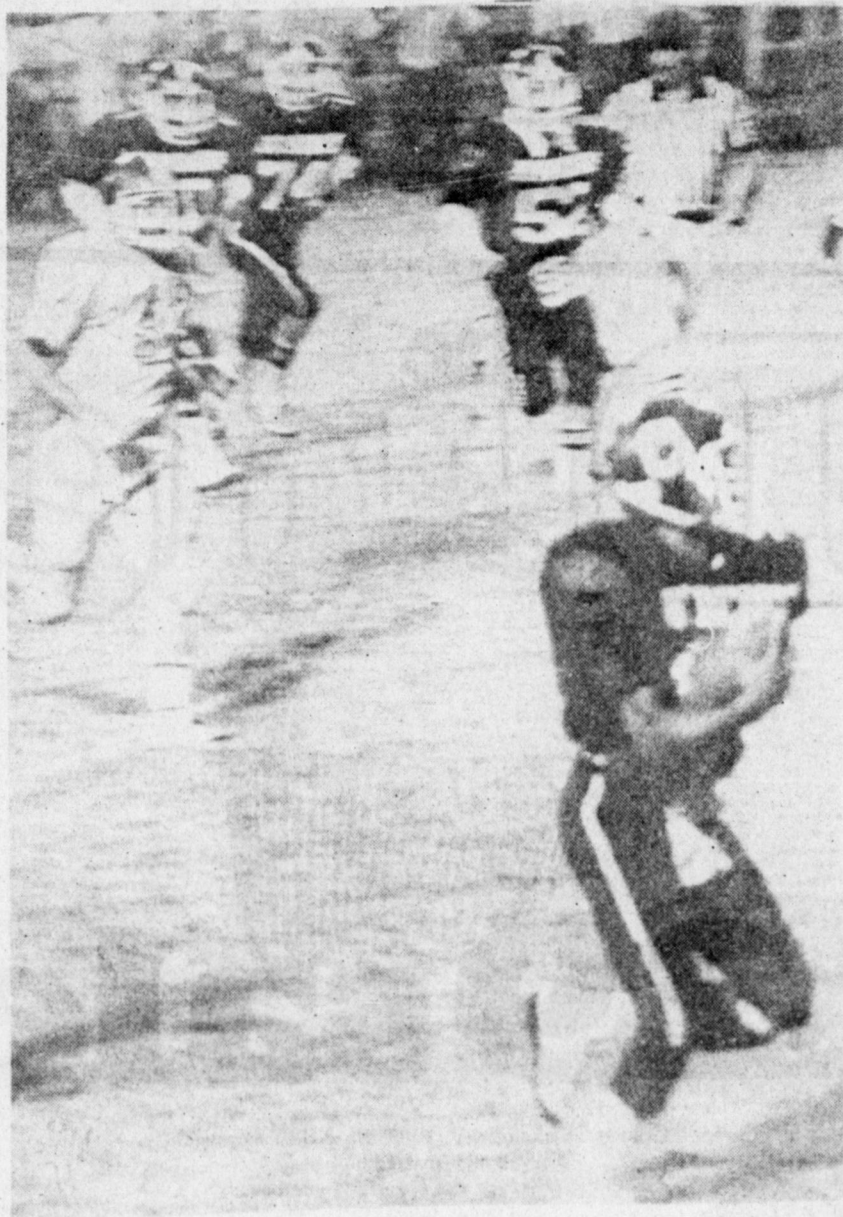

Clarendon 3-0 for season

## Bronchos down Sunray

The Clarendon Bronchos for the second week in a row shut out their opponent while the offense continued its impressive showing. The Bronchos posted a first quarter 21-0 lead and were never threatened by the Bobcats. The Bobcats were allowed only 168 yards total offense.

The Bronchos held the Bobcats on their first possession and immediately scored on their third offensive snap of the game. With the Bronchos on Sunray's 32 yard line, QB Dvron Howell ran the option to his right, pitching to Glenn Weatherton. The Bronchos continued their excellent outside blocking that is essential for the veer offense to produce and "Curly" scooted into the endzone. Arlis Thomas added the extra point and with only about 3 1/2 minutes gone in the first quarter, the Bronchos were on top 7-0.

The Bronchos again held the Bobcats on downs and took over for their second offensive showing. Dvron went to the passing game and lofted a pass to flanker Neal Johnston. The Bobcat secondary was flagged for pass interference that resulted in a 34 yard gain. With the Broncho offensive line on the left side led by tackle Dean Cearley and guard Tim Cole opening a huge hole, Glenn Weatherton quickly made 26 yards to the Bobcat 4 yard line. With first and goal, Dvron ran straight for the corner flag of the end zone and went in for the score. Arlis kicked the extra point to make it 14-0.

Sunray again could not put together a drive against the swarming Broncho defense. The third play of the Bronchos third offensive possession again produced a TD. This time to the excitement of the home crowd, Dvron hit flanker Richard Gaines with a perfect pass at the Broncho 32 yard line and Richard won the foot race to the goal line to complete a 68 yard scoring play. Arlis added his third straight extra point to pull the Bronchos further ahead 21-0.

The Bronchos' first possession of the second quarter resulted in a fumble but Sunray could not capitalize. The Bobcats seemed to have the Bronchos in a hole as their punt went out on the Bronchos 7 yard line. But Sunray's excitement soon turned to disappointment as Rodney Smith took the pitch from Dvron and fought his way down the sideline for a thrilling 93 yard run. The Bronchos pass attempt for the extra point fell short leaving the score 27-0. The Bronchos were to score four more times in the second quarter to completely dominate the game. These came on a 36 yard run by Stanley Gardner with Arlis adding another PAT, a 44 yard scoring pass from Dvron to Doug Walker. The pass failed for the extra point. The seventh score for the Bronchos came on a Rodney Smith 34 yard run with Johnny Gaines making the extra point kick.

## Bronchos play Roughriders in homecoming game

After a 46-0 slaughter of Kress, and a 59-0 rout of Sunray, the Bronchos are meeting a team that has size and speed never before seen this year - Boys Ranch.

The Bronchos are 3-0; Boys Ranch is 2-1, with a win over Sunray 34-6. This is going to give the Bronchos a tuff challenge. In addition to Boys Ranch being a very good team, the Bronchos are going to have the homecoming events on the week before the game.

Homecoming is an exciting week. The school halls are decorated as never before and never again. Each class is trying to "out-spirit" the others and all the talk is about the dance and after the game.

But, the game is the most important part of the week as Boys Ranch will be in town to get after the undefeated and the most explosive offensive unit in the Panhandle as the Bronchos have outscored opposing teams by 125 to 7 points.

The "easy" game have all been played, beginning with the "Ranch" all of the Clarendon foes are extremely strong teams. The Roughriders are not overly big but are above average size with an offensive unit averaging 190 pounds as a team and defensively about 188 pound average.

"The Ranch" is led by a pair of extremely fast, big backs, Ed Ransom, a 205 lb. fullback and John McClain, a 190 lb. halfback, Tony Hellicotes, a 215 lb. tackle, Kerry Mills, a 185 lb. guard-linebacker, Benji Adams, a 155 lb. 3 year starter at QB.

This team is a very aggressive, hard hitting unit. They are out to get another victory and want it to be a top-ranked team such as the Bronchos.

The Bronchos are well and plan to continue their romp and stomp type play as far as they can. It is a good point to remember that a great many teams have had a hard time getting ready to play a homecoming game and at the same time a great many teams have been mentally prepared for the old exes.

## National Farm Safety Week

Protecting rural children and teaching them safety measures is the emphasis of National Farm Safety Week September 18-24, according to George R. Gustafson, Executive Vice President of the Texas Safety Association. The 40th annual observance of rural safety has been proclaimed by President Ronald Reagan and is being sponsored by the National Safety Council and the U.S. Department of Agriculture.

Farm safety is a particular concern in Texas, where 100 persons lost their lives in

farm accidents last year, according to Gustafson. The statistics are tabulated by the Texas Farm Bureau, based on data furnished by the Texas State Health Department. These records show that of the 100 deaths, most were related to tractors, firearms, drowning, electric current, and machinery, he said.

Safety leaders estimate that the incidence of these rural-type accidents is actually much greater than those numbers reported, he said.

Although farm fatalities

are a major concern, farmers and ranchers should also be aware that up to 20,000 disabling injuries and up to 250,000 serious injuries requiring medical attention occur to Texas farmers and ranchers each year, according to Dr. Gary S. Nelson, Extension Specialist Safety Engineering, Texas A&M University and Texas Safety Association Vice President for Agriculture.

According to Nelson, "If you are a farmer or rancher, the probability of experiencing a serious injury this year is 1 in 5."

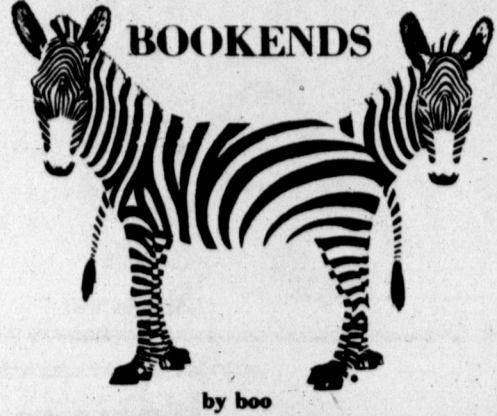

His brothers are Fred and Dr. Jimmy Bourland and his sisters are Lotta Bourland Davis and Neva Bourland Baldwin. Mrs. Don Hillis offered to buy the book for the library, but Bourland insisted that he donate a copy.

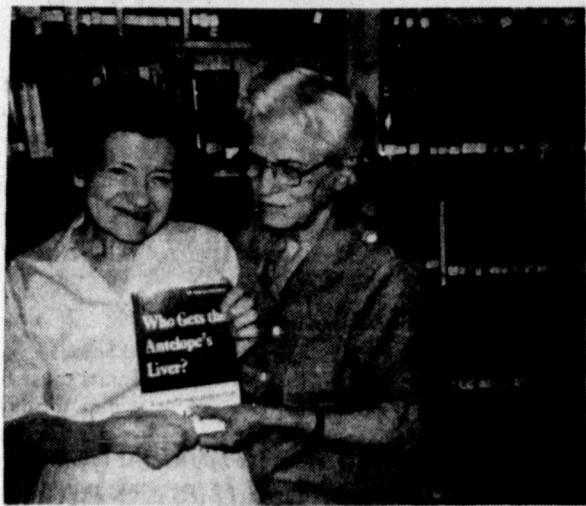
The title of the book is unique and makes one wonder if it is about the early pioneer days here or perhaps a family joke among the Bourlands. It is neither. It is a "How-to-Handbook for People Power". It is a clearly written and concise concept about what can be done to make government better serve the average citizen instead of helping politicians and special interest groups get rich at taxpayer's expense. He reviews a broad range of governments from ancient Egypt up to the present United States Government. He suggests following the example of modern Switzerland where power is in the hands of the hunters not the tribal chiefs.

Whether one agrees with Bourland's solution or not, it is one of those books which should be read by students of government and anyone who is interested in our own form of government with all its shortcomings and strong points.

This book is of gem quality and one seldom finds a diamond between the bookends.

**Mrs. Lella Eula Beville**  
Mrs. Lella Eula Beville, age 96, a long time resident of Clarendon and Amarillo died Thursday, September 15, 1983 at Palo Duro Convalescent Center in Claude.

Mrs. Beville was born on October 3, 1886 in Rosston, Texas and moved with her parents, Mr. and Mrs. D.P. Ross, to Clarendon in 1901. D.P. Ross, her father, was an early day Clarendon merchant, operating a general mercantile store from 1901 until 1922 when he retired. Mrs. Beville was married to R. Harwood Beville in 1909 in Clarendon. Her husband maintained his law practice in Clarendon until 1928 when they moved to Amarillo. He died in 1947.

**THE OTHER HERPES**

Much has recently been said and written about genital herpes - a venereal disease occurring in epidemic proportions. There is another herpes infection called **herpes zoster** which is not a venereal disease. Better known as **shingles**, this viral infection afflicts many persons - particularly the elderly.

Shingles is caused by the same virus that produces chicken pox - **varicella virus**. Yet shingles and chicken pox have little in common. Chicken pox tends to occur once in one's lifetime and is of relatively short duration. Shingles can reoccur and may last for months or even years.

There is no cure for shingles, and available drugs have provided only minimal relief of pain and discomfort for most individuals. The prescription drug **carbamazepine** is considered by many authorities to be the best drug for use in shingles. Other physicians have used injectable local anesthetics to produce nerve block and thereby relieve pain. **Vidarabine**, which is injected intravenously in treatment of shingles, has recently been approved by the U.S. Food and Drug Administration for use in persons having depressed immune systems.

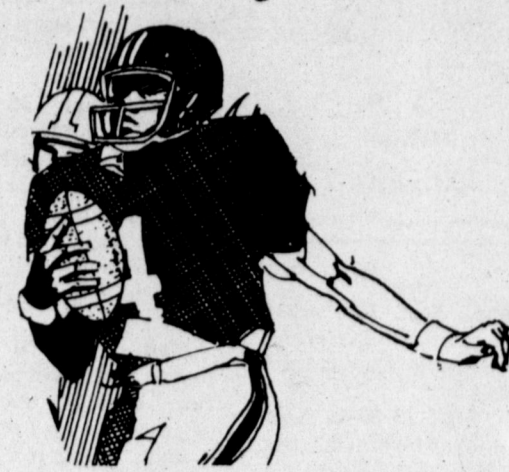

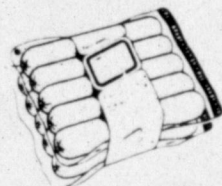

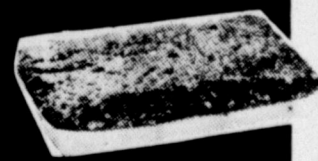

BRIEF EXPLANATORY STATEMENTS OF PROPOSED  
**CONSTITUTIONAL AMENDMENTS**  
SPECIAL ELECTION  
NOVEMBER 8, 1983

**PROPOSITION NO. 1 ON THE BALLOT**

House Joint Resolution 91 proposes a constitutional amendment which requires a county with a population of 30,000 or more to be divided into not less than four nor more than eight justice of the peace precincts. A county with a population of 18,000 or more but less than 30,000 shall be divided into not less than two nor more than five justice of the peace precincts. A county with a population of less than 18,000 shall be designated as a single justice of the peace precinct or, upon a finding of necessity by the commissioners court, shall be divided into more than one justice of the peace precinct but not more than four. The amendment provides further, that in any precinct in which there is a city with a population of 18,000 or more, two justices of the peace shall be elected. The amendment allows a justice of the peace, constable or commissioner to continue in office until the expiration of his term, although a change in precinct boundaries results in the officer no longer being a resident of the precinct for which he was elected or appointed and allows a justice of the peace or constable to continue in office until the expiration of his term even though a change in precinct boundaries results in the abolition of the precinct or more than one justice of the peace or constable serving the precinct. Vacancies in the office of justice of the peace or constable that result from a precinct boundary change shall be filled by the commissioners court until the next general election. The amendment would take effect on January 1, 1984, and counties with populations of less than 30,000 and with more than four justice of the peace and constable precincts would have until January 1, 1987 to comply with the amendment.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing fewer justice of the peace and constable precincts in counties with a population of less than 30,000 and providing for continuous service by justices of the peace, constables, and county commissioners when precinct boundaries are changed."

**PROPOSITION NO. 2 ON THE BALLOT**

House Joint Resolution 105 proposes a constitutional amendment which would limit a homestead in a city, town or village to a lot or lots amounting to not more than one acre of land, together with any improvements on the land. The constitutional requirement that, at the time of

designation, an urban homestead not exceed ten thousand dollars in value without reference to the value of any improvements on the land would be eliminated.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment replacing the limitation on the value of an urban homestead with a limitation based on size."

**PROPOSITION NO. 3 ON THE BALLOT**

Senate Joint Resolution 1 proposes a constitutional amendment that authorizes the Legislature to enact legislation that permits representative associations of agricultural producers to collect refundable assessments on their product sales to be used solely to finance programs of marketing, promotion, research to those products. It provides, further, that adoption of the proposed constitutional amendment will bring into effect Senate Bill 607, Acts of the 68th Legislature, Regular Session, 1983, with rejection of the amendment resulting in Senate Bill 607 having no effect.

The proposed constitutional amendment will appear on the ballot as follows: "The constitutional amendment providing for the advancement of food and fiber production and marketing in this state through research, education, and promotion financed by the producers of agricultural products."

**PROPOSITION NO. 4 ON THE BALLOT**

House Joint Resolution 30 proposes a constitutional amendment which authorizes the Legislature to enact laws to provide for the succession of members of the Legislature in the event of enemy attack and allows the suspension of procedural rules imposed by the Constitution in the event of, or immediate threat of, enemy attack. The amendment empowers the Governor, after consultation with the Speaker of the House and the Lieutenant Governor, to suspend the constitutional requirement that the Legislature hold its sessions in Austin and allows the suspension of procedural rules by the Governor issuing a proclamation in which the House of Representatives and Senate concur by resolution approved by a majority of the members present. Suspension of the constitutional rules may not exceed a period of two years under a single proclamation; however, the Governor may renew the suspension by issuing a new proclamation concurred in by the House of Representatives and the Senate through a resolution approved by a major-

ity of the members present.

The amendment will appear on the ballot as follows: "The constitutional amendment authorizing statutory provisions for succession of public office during disasters caused by enemy attack, and authorizing the suspension of certain constitutional rules relating to legislative procedure during those disasters or during immediate threat of enemy attack."

**PROPOSITION NO. 5 ON THE BALLOT**

Senate Joint Resolution 12 proposes a constitutional amendment that authorizes the Legislature to enact legislation providing for the use of the permanent school fund and income from the permanent school fund to guarantee bonds issued by school districts. The amendment provides, further, that the Legislature may appropriate part of the available school fund for administration of the permanent school fund or of a bond guarantee program established pursuant to the amendment.

The constitutional amendment will appear on the ballot as follows: "The constitutional amendment authorizing use of the permanent school fund to guarantee bonds issued by school districts."

**PROPOSITION NO. 6 ON THE BALLOT**

House Joint Resolution 1 proposes a constitutional amendment which would permit the Legislature to provide for the garnishment of wages to enforce court-ordered child support payments. The garnishment remedy would not be available for other purposes.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment allowing the Legislature to provide for additional remedies to enforce court-ordered child support payments."

**PROPOSITION NO. 7 ON THE BALLOT**

Senate Joint Resolution 14 proposes a constitutional amendment that authorizes the Veterans' Land Board to provide for, issue, and sell general obligation bonds of the State of Texas in an amount not to exceed \$800 million to provide financing to veterans of the state. The amendment requires that three hundred million dollars of the state bonds be dedicated to the Veterans' Land Fund. The Fund is to be used to purchase land to be sold to veterans under such terms, rules and regulations as may be authorized by law. The amendment creates the Veterans' Housing Assistance Fund and requires that \$500 million of the state bonds authorized by the amendment be dedicated to the Fund. The Veterans' Housing Assistance Fund will be utilized by the Veterans' Land Board for the purpose of making home mortgage loans to veterans for housing within the state and for the administrative

costs of administering the fund and issuing the bonds. The amendment provides, further, that if there is not money in either the Veterans' Land Fund or the Veterans' Housing Assistance Fund available for payment of principal and interest on the general obligation bonds issued pursuant to the amendment, then money coming into the Treasury in each fiscal year is appropriated in an amount sufficient for payment of principal and interest due in that fiscal year.

The proposed constitutional amendment will appear on the ballot as follows: "The constitutional amendment for financial assistance to veterans and to authorize the issuance of \$800 million in bonds of the state to finance the Veterans' Land Program and the Veterans' Housing Assistance Program."

**PROPOSITION NO. 8 ON THE BALLOT**

Senate Joint Resolution 1 proposes a constitutional amendment that authorizes political subdivisions to exempt veterans' organizations from ad valorem taxation on their property. The amendment requires that the veterans' organizations be chartered by the United States Congress, be composed of members or former members of the United States Armed Forces, and be organized for patriotic and public service purposes. The amendment provides, further, that political subdivisions may exempt fraternal organizations from ad valorem taxation on their property. The amendment requires that the fraternal organizations be organized to perform and be primarily engaged in charitable or benevolent functions. The Legislature would be authorized to enact laws that prescribe eligibility requirements for fraternal organizations to benefit from the exemption and to pass legislation limiting the types or amount of property owned by a fraternal organization which may be exempted from ad valorem taxation.

**PROPOSITION NO. 9 ON THE BALLOT**

House Joint Resolution 70 proposes a constitutional amendment to authorize the Legislature to provide, by local or general law, a method by which judges of statutory courts with probate jurisdiction may be assigned to any other statutory court with probate jurisdiction and to any constitutional county court in any county in the state.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for assignment of judges of statutory probate courts to other statutory county courts with probate

jurisdiction and to county courts."

**PROPOSITION NO. 10 ON THE BALLOT**

Senate Joint Resolution 17 proposes a constitutional amendment that authorizes the Legislature to enact laws which would allow a city or town to expand public funds to relocate or replace sanitation sewerage laterals on private property if done in conjunction with the replacement or relocation of sanitation sewer mains serving the property. The amendment requires that the law authorize the city or town to affix a lien on the private property, with the consent of the owner, to cover the costs of the replacement or relocation of the sewer laterals on the property. The lien may not be enforced until five years have expired since the date the lien was affixed. The amendment provides, further, that the law require that the costs of the replacement or relocation of the sewer laterals on the private property be assessed against the property with repayment to be amortized over a period not to exceed five years and at an interest rate provided by law.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to permit a city or town to expend public funds and levy assessments for the relocation or replacement of sanitation sewer laterals on private property."

**PROPOSITION NO. 11 ON THE BALLOT**

Senate Joint Resolution 13 proposes a constitutional amendment that would change the Board of Pardons and Paroles from a constitutional agency to a statutory agency and would eliminate the Governor's power to revoke paroles. The Legislature would be authorized to establish the Board of Pardons and Paroles and to require it to maintain records of its actions and the reasons for its actions. The amendment would empower the Legislature to enact parole laws. Constitutional language specifying the qualifications and terms of office for members of the Board of Pardons and Paroles is eliminated. The constitutional language governing the composition of the Board of Pardons and Paroles and the manner of filling vacancies on the Board is eliminated.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to change the Board of Pardons and Paroles from a constitutional agency to a statutory agency and to give the board power to revoke paroles."

**PROPOSITION NO. 9 ON THE BALLOT**

House Joint Resolution 70 proposes a constitutional amendment to authorize the Legislature to provide, by local or general law, a method by which judges of statutory courts with probate jurisdiction may be assigned to any other statutory court with probate jurisdiction and to any constitutional county court in any county in the state.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for assignment of judges of statutory probate courts to other statutory county courts with probate

# Announcement of Director election DCSWCD

An election for a director to serve in Zone 5 on the Donley County Soil and Water Conservation District Board is scheduled for October 3, 1983 at the Soil Conservation Service Office in Clarendon announced Bud Hermesmeyer, chairman of the board. The election will be held at 8 p.m.

State law decrees that to be eligible to vote in a soil and water conservation district director's election, a person must own agricultural land within the subdivision where the election is being held. The person must also live in a county all or part of which is in the district and the voter must be 18 years old.

Legal qualifications state that a candidate for the office of a soil and water conservation district director must own land in the zone he represents, be 18 years of age and be actively engaged in farming or ranching. He must also live in a county all or part of which is in the district.

Zone 5 of the district includes an area from 287 South and the west line in FM 1260.

Current members of the board of directors of the Donley County SWCD are Bud Hermesmeyer, Chairman, Clarendon; Dick Bode, Vice Chairman, Alanreed; Ted Shaller, Secretary, Clarendon; Jack Moreman,

member and Henry Hasty, member.

The purpose of the Donley County SWCD, with headquarters in Clarendon is to promote sound soil and water conservation programs on farm and ranch lands within the district and to serve as a voice for farmers and

ranchers on conservation matters and other issues affecting private property rights of landowners.

The district board of directors coordinates the conservation efforts of various local, state and federal agencies and other organiza-

tions and has authority to enter into working agreements with these governmental agencies and private concerns to carry out its purposes.

All conservation programs managed by the district are of a voluntary nature to the landowner or operator.

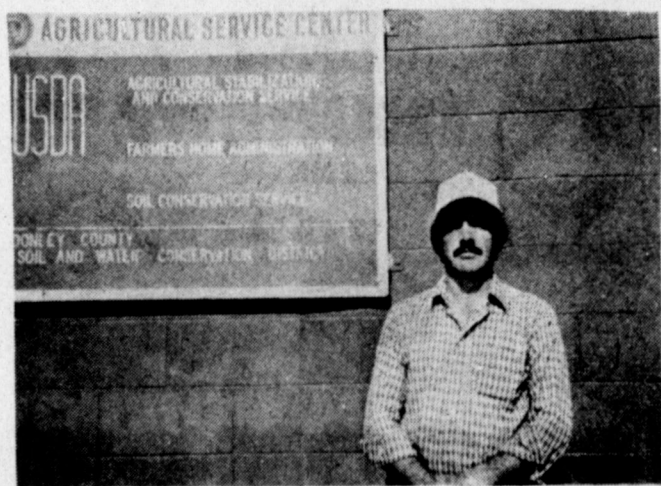

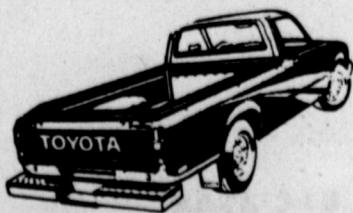

## Hedley Board of Trustees meets

At the September meeting of the Hedley Board of Trustees, a contract was approved by the Board for the leasing of newly constructed trailer house parking spaces. This contract is the final step in a cooperative plan by Hedley Schools, the City of Hedley, and the Hedley Lion's Club.

The idea was formulated with one major goal in mind: To provide more places to live in the Hedley area. If

more living or renting space is available, people may be attracted to live in Hedley. This will improve the economy and provide an increased enrollment for Hedley Schools if families with children choose to reside here. To enhance this idea, the Board decided to allow a family with children attending Hedley Schools to park permanent trailers at no charge for the space.

The plumbing and construction of the park were completed by Loyd Riddle-spurger. At the present time, four 50'X100' lots have been surveyed, plumbed, and wired. West Texas Utilities set the poles for the electricity and Lone Star Gas

will set the gas meters upon notification of an intent to park a trailer. The City of Hedley provided the water service for the lots.

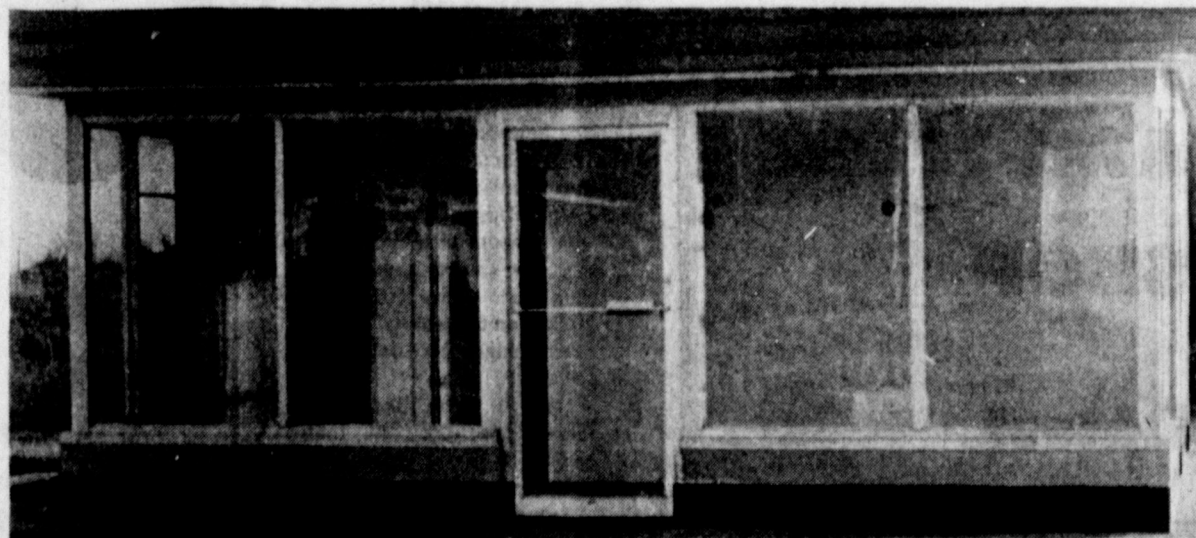
