
## Devin, Chamberlain are honor students for 2000

## It's morning in Amerika

Cuban-Americans in Little Havana are calling it Black Saturday, and it was truly a dark day in the life of this nation

In the wee hours of Saturday morning, federal stormtroopers broke through the door of a Miami home and snatched a little boy from the clutches of his family.

The boy in question, of course, was Elian Gonzalez - the six-year-old who was rescued from the sea after his mother died fleeing Cuba for a new life in America.

America - a land of freedom, opportunity, and equal justice under the law, where the People are sovereign and the Constitution protects them from government abuses.

But that was not the America that the world saw on Saturday morning. What the world saw instead was an INS agent pointing an automatic weapon in the direction of a little boy who was scared to death. A boy who witnesses say was screaming "Help me! Help me!" and "¿Qué pasa, qué pasa?" as the government stole him away from the family who has cared for him since his mother gave her life for his freedom.

Those images, captured forever on film and video tape, ought to be burned into the hearts and minds of Americans, for it shows the heavy-handed tactics the federal government is willing to use today.

According to General Reno, negotiations had "broken down" with the Miami family. But witnesses, who were in the Miami home at the time, have said they were still on the phone with the justice department when the agents came barreling through the front door.

I suppose the Gonzalez family should consider itself lucky. Other people who exhaust the patience of Reno's justice department have found themselves dead. Remember Waco?

In fairness, government supporters say the stormtroopers did not point their guns directly at the little boy and that in the infamous picture of Elian being held at gunpoint, the man's finger is not on the trigger and that the safety is on. But in all honesty, ask yourself this question. If federal agents broke down your door at 5:00 a.m. with machine guns drawn and pointed in your general direction, would you: A.) Notice the safety is on and the finger is away from the trigger, or B.) Wet your pants?

A lot has been made about the rule of law in this case. Let's look at that for a moment.

## Clinton, Reno were right to retrieve Elian


Elian Gonzalez is finally reunited with his father. An early morning raid Saturday by the US Marshals and INS officers removed the little boy from his distant relatives' home in Miami and placed Elian back in his father's arms.

Attorney General Janet Reno and President Clinton were right in retrieving this child refugee and in using force as required. ABC News reports stated the agents knocked on the rear door three times with pauses in between, and the family failed to acknowledge the knocks.

This is the same family which has refused to ignore lawful orders and requests. Instead, they have paraded Elian around for the media and rallied the already emotional Miami Cuban population. With these actions, the Gonzalez family has demonstrated they are more interested in defying Fidel Castro than serving this child's welfare.

For all of the fathers out there who have been shafted in custody disputes, this is not an analogy of your own personal cases. Ask yourself, if it were your child and he were living with your relatives in America - not your exwife's relatives, but your relatives - and you were living in Cuba - under what most sources say is one of the most oppressive governments on Earth, what would you do? Would you really want your son to live under tyranny?

I know what I would do. I'd let my son stay with my brother or other family members so that he might enjoy the blessings of Liberty, and I would hope that one day I too could join him in America.

In January, I wrote that what becomes of Elian will say a lot about the character of our nation. Indeed, what happened this past weekend speaks volumes about a federal government that is out of control.

## Fed's seizure of Elian denigrates rule of law

The horrifying seizure of Elian Gonza-And while we're on the subject of the law, the presi- lez is one more reflection of the depths of moral depravity to which the U.S. government has plunged in our lifetime. The episode also reflects the extent to which all too many Americans continue to deny the reality that beneath the velvet glove of the benign welfare state lies the iron fist of a brutal, terrifying government.

President Clinton and Attorney General Reno said that they had no choice -that the military-style raid on the home of the Miami relatives of Elian Gonzalez was necessary to enforce "the rule of law."

They are wrong. The raid was instead a denigration of the rule of law and an elevation of the rule of terror -- the same type of terror that reigns in the nation from which the boy was taken by his mother.

What does the term "rule of law" actually mean? It means that in a free society, people are able to govern their conduct according to well-defined laws that have been duly enacted and to judicial judgments interpreting the laws.

On the other hand, in societies governed by the "rule of men," people must govern their conduct through obedience to the arbitrary, constantly shifting dictates of government bureaucrats.

Reno and the INS claim that their terroristic, predawn raid was justified because the INS had revoked the "parole" under which it had given custody of Elian to the Miami relatives. Thus, in the classic bureaucratic style that has come to characterize such agencies as the IRS and the ATF, they commanded the Miami relatives to turn over the boy to his father and threatened the use of force in the event of recal-

But the government had another remedy when its orders were not immediately and unconditionally obeyed -- the same remedy that every citizen of the United States follows when an agreement is purportedly breached. The government could have gone to court to enforce the parole agreement and secure the necessary judicial orders for the change in custody, pending the outcome of the boy's asylum

claim in the federal Court of Appeals. Why would this have produced a different result?

One reason is that a judicial proceeding, unlike a predawn raid, allows both sides to be heard before a fair and impartial judge, and that's important, especially to the losing side.

Another reason is that Cuban-Americans, like most other Americans, have a deep and abiding respect for America's judicial system. If either a state or federal court had issued a final order commanding the Miami relatives to surrender the boy forthwith, on pain of contempt for failing to do so, there is little doubt that they would have complied, especially because their attorneys would undoubtedly have advised them to comply.

The difference between a bureaucratic edict and a judicial order is the difference between night and day, especially for people who have fled a society whose very existence is based on the rule of men and the rule of terror rather than the rule of law.

Clinton, Reno, and INS Commissioner Doris Meissner justified the raid by their purported concern for the welfare of the child. But how can that "concern" be reconciled with the forcible extraction of the child at the point of an assault rifle from

the arms of the fisherman who had saved the boy's life at sea? More important, their own justification for the military-style assault belies their claim that they had the welfare of the boy at heart. For if there was any chance whatsoever that a shootout would occur, morality and the welfare of the child dictated that the raid not take place at all. After all, wasn't it Clinton's and Reno's concern for the children that cost the children their lives in the Waco inferno?

Clinton's and Reno's claim that they simply wish to reunite a father with his son is also overshadowed by the official longstanding policy of the Clinton-Gore administration to repatriate Cuban refugees back into communist tyranny. Let's not forget that only recently, in a desperate attempt to capture defenseless Cuban refugees before they reached American shores and to repatriate them into communist tyranny, U.S. Coast Guard officials attacked them with water cannons and pepper spray in the middle of Miami harbor.

Make no mistake about it: Father or no father, forcible repatriation to Cuba is what would have happened to Elian if U.S. government officials, rather than Donato Dalrymple, had found him clinging to that inner tube

The winner in all this, of course, is Fidel Castro, who has every reason in the world to be celebrating. Not only has he converted a sitting U.S. president, attorney general, and INS commissioner into his emigration agents, he also has displayed to the world that the U.S. government behaves just like his.

The reason for such a decision not to prepare such a statement is based upon the fact that all environmental concerns could either be minimized or mitigated.

An Environmental Review Record for the proposed project has been made by City of Clarendon which documents the environmental review of the project and more fully sets forth the reasons why such a statement is not required. The Environmental Review Record is on file at the Office of Community Development, City of Clarendon, 119 S. Sully, Texas 79226 and is available for public examination and copying, upon request between the hours of 9:00 a.m. and 5:00 p.m., Monday through Friday.

#### Public Comments of Finding

All interested agencies, groups, and persons disagreeing with this decision are invited to submit written comments for consideration by the City to the address as set forth above. Such written comments must be received at the address specified within sixteen (16) days after this publication. All such comments so received will be considered and the City will not request the release of funds or take any administrative action on the project prior to date specified in the preceding sentence.

#### Release of Funds

The City of Clarendon will undertake the activities described above with the Community Development Block Grant funds under Title I from its Program Year 2000 under grant for 2000 funding cycle from the Housing and Community Development Act of 1974. The City of Clarendon is certifying to TDHCA that Mr. Tex Selvidge, in his official capacity as Mayor, consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to environmental reviews, decision-making, and action and that these responsibilities have been satisfied. The legal effect of the certification is that upon its approval, City of Clarendon may use the Block Grant funds, and it will have satisfied its responsibilities under the National Environmental Policy Act of 1969. TDHCA will accept an objection to its approval only on one or more of the bases and the procedures described in 24 CFR Part 58.75. Objections are to be addressed to the Texas Department of Housing and Community Affairs, PO Box 13941, Austin, Texas 78711-3941.

Objections to the release of funds on bases other than those stated above will not be considered by the TDHCA. No objection received later than thirty-three (33) days after this publication will be considered by the TDHCA.


