## 4-H's Fair Well At Houston

Sixteen 4-H members and thirteen parents just returned from the Houston Livestock Show, having one of the best years competing at Houston in quite some time. Donley County 4-H's managed to place four pigs and two steers in the sale.

Placing at the top of the class in the light weight Hampshire barrow class was James Lee Potts of Hedley. With over 3,300 barrows at Houston and approximately four hundred in the Hampshire class, winning one of the classes is very tough to do. James Lee received \$7,500 at the barrow sale for his first place barrow. Also placing in the Hampshire barrow class at Houston was Missie Butts with an eighth place middle weight, and D. J. Edwards with a seventeenth place light weight. Jana Hill from Hedley placed 35th in the heavy weight Duroc class. Only six hundred and forty-five pigs out of the 3,300 made it to Houston to be placed and sold. According to Houston officials, the minimum that lower placing pigs will bring is \$600.

In the steer division Melisse Campbell placed seventh in the middle weight Angus class. This is the third year in a row that the Campbells have placed a steer at Houston. Also, Buddy Howard exhibited the ninth place heavy weight Shorthorn steer.

In the heifer division, Brad Williams placed eleventh in the Angus scramble division and tenth in the Junior Angus division. Phillip Williams placed third in the Junior Hereford division. Other Donley County exhibitors at Houston included: Chad Campbell, Karli Hill, Matt Hill, Kevin McAnear, Darcy McAnear, Ty Lewis, Jennifer Carson, Clint Green, Lindsay Green, Matt Talley, Josh Talley, Donny Howard, Mark Howard, James Turner, Troy Turner, and Wesley Smith.

## Disaster Deadline Is Close

Farmers who suffered losses in 1990 or 1991 because of drought, excessive moisture and other natural disasters, may apply for disaster payments through March 13 at the Donley County Agricultural Stabilization and Conservation Service. Before applying for the program, farmers should organize their production records to assure they have adequate documentation according to ASCS official Drew Thornberry.

To qualify for the program, producers with crop insurance must have had losses greater than 35 percent. Producers without crop insurance must have had losses greater than 40 percent. Eligible farmers will receive payment for production losses on participating program crops of wheat, feed grains, upland cotton; nonparticipating program crops: peanuts and all nonprogram commercial crops. Remember, March 13 is the deadline for all signatures and production evidence.

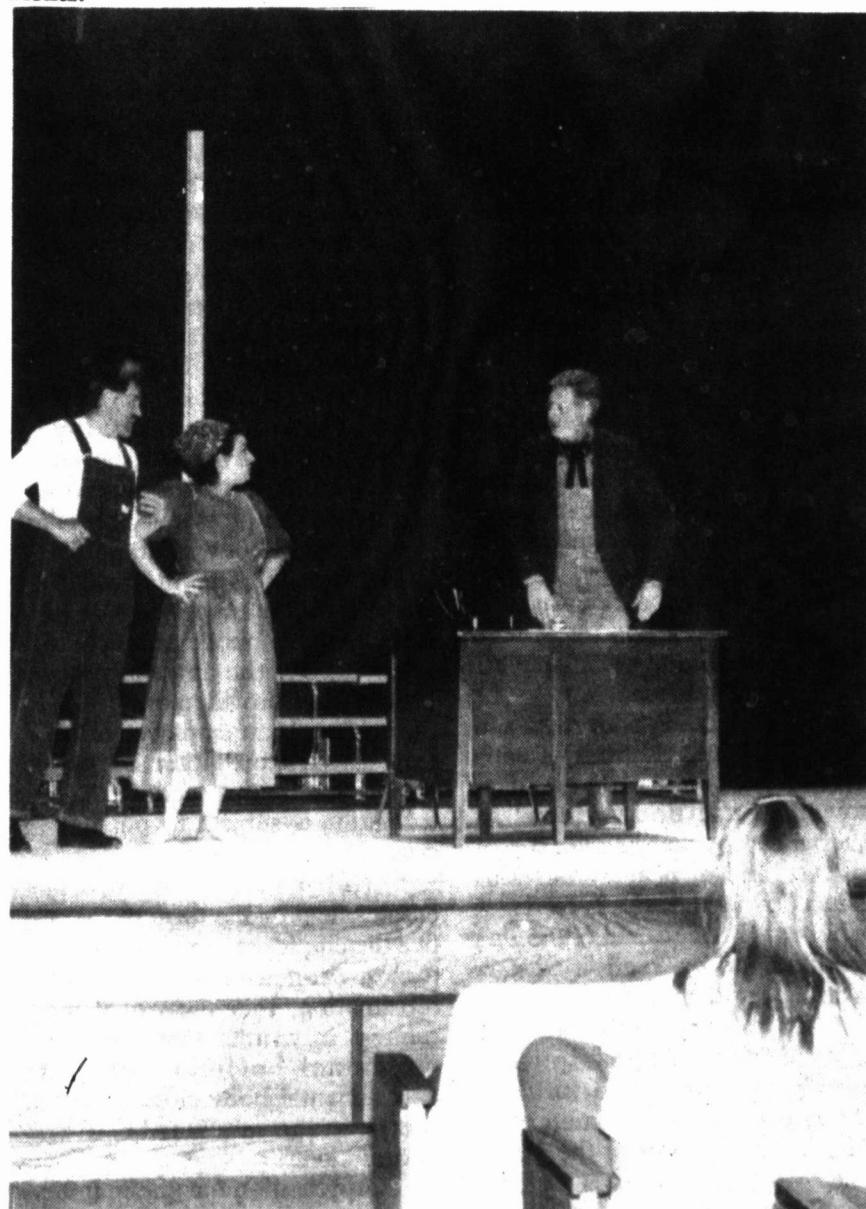

## Law Enforcement Report Released

Donley County Sheriff Jimmy Thompson reported 21 arrests in February. There were four counts of aggravated assault on a police officer from the "The Great Chase" between Clarendon and Hedley. Three were charged with sale of a controlled substance, as a result of the drug bust.

Two young white males and a young white female were charged with criminal mischief. Two scored charges of aggravated assault, two put charges of burglary of a building on their record, and two individuals had DPS warrants served.

One person was cited for disorderly conduct, one got his probation revoked and one managed to get charged with "aggravated assault on a police officer". One young white male was allegedly caught with a controlled substance, and one gentleman failed to appear before the county docket. There were no bodies found, no rapes reported, no muggings or armed robberies.

Officers investigated one accident, firemen rushed to seven fires, and the ambulance took 29 trips. The city/county enforcement officers issued seven traffic tickets. Deputies served 15 pay-as-you-go tickets. The jail provided room and board for 209 inmate days and 627 meals.

# Texas Open Records Law Reprinted

**Editor's Note: The Texas Legislature has guarded the citizen's right-to-know with several major laws. One of the most important is the Texas Open Records Act. This law applies to every public board or body in Texas. That includes: the commissioners and officers of Donley County, the aldermen and employees of the City of Clarendon, The City of Hedley and its officials, The City of Howardwick with its elected leaders and employees, The Clarendon Consolidated Independent School District including trustees and administrators, the Donley County Hospital Board and The Clarendon College Board. Every citizen should be aware of the contents of this law.**

## Open Records Law

Art. 6252-17a. Access by public to information in custody of governmental agencies and bodies.

### Declaration of policy

Section 1. Pursuant to the fundamental philosophy of the American constitutional form of representative government which holds to the principle that government is the servant of the people, and not the master of them, it is hereby declared to be the public policy of the State of Texas that all persons are, unless otherwise expressly provided by law, at all times entitled to full and complete information regarding the affairs of government and the official acts of those who represent them as public officials and employees. The people insist on remaining informed so that they may retain control over the instruments they have created. To that end, the provisions of the Act shall be liberally construed with the view of carrying out the above declaration of public policy.

### Definitions

Sec. 2 In this Act:

(1) "Governmental body" means:

(A) any board, commission, department, committee, institution, agency, or office within the executive or legislative branch of the state government, or which is created by either the executive or legislative branch of the state government, and which is under the direction of one or more elected or appointed members;

(B) the commissioners court of each county and the city council or governing body of each city in the state;

every deliberative body having rulemaking or quasi-judicial power and classified as a department, agency, or political subdivision of a county or city;

(D) the board of trustees of every school district, and every county board of school trustees and county board of education;

(E) the governing board of every special district;

(F) the part, section, or portion of every organization, corporation, commission, committee, institution, or agency which is supported in whole or in part by public funds, or which expends public funds. Public funds as used herein shall mean funds of the State of Texas or any governmental subdivision thereof;

(G) the Judiciary is not included within this definition.

(2) "Public records" means the portion of all documents, writings, letters, memoranda, or other written, printed, typed, copied, or developed materials which contain public information.

### Public information

Sec. 3. (a) All information collected, assembled, or maintained by governmental bodies pursuant to law or ordinance or in connection with the transaction of official business is public information and available to the public during normal business hours of any governmental body, with the following exceptions only:

(1) information deemed confidential by law, either Constitutional, statutory, or by judicial decision;

(2) information in personnel files, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy;

provided, however, that all information in personnel files of an individual employee within a governmental body is to be made available to that individual employee or his designated representative as is public information under this Act;

(3) information relating to litigation of a criminal or civil nature and settlement negotiations, to which the state or political subdivision is, or may be, a party, or to which an officer or employee of the state or political subdivision, as a consequence of his office or employment, is, or may be, a party, that the attorney general or the respective attorneys of the various political subdivisions has determined should be withheld from public inspection;

(4) information which, if released, would give advantage to competitors or bidders;

(5) information pertaining to the location of real or personal property for public purposes prior to public announcement of the project, and information pertaining to appraisals or purchase price of real or personal property for public purposes prior to the formal award of contracts therefor;

(6) drafts and working papers involved in the preparation of proposed legislation;

(7) matters in which the duty of the Attorney General of Texas or an attorney of a political subdivision, to his client, pursuant to the Rules and Canons of Ethics of the State Bar of Texas are prohibited from disclosure, or which by order of a court are prohibited from disclosure;

(8) records of law enforcement agencies and prosecutors that deal with the detection, investigation, and prosecution of crime and the internal records and notations of such law enforcement agencies and prosecutors which are maintained for internal use in matters relating to law enforcement and prosecution;

(10) trade secrets and commercial or financial information obtained from a person and privileged or confidential by statute or judicial decision;

(11) inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than one in litigation with the agency;

(12) information contained in or related to examination, operating, or condition reports prepared by, on behalf of, or for the use of an agency responsible for the regulation or supervision of financial institutions, and/or securities, as that term is defined in the Texas Securities Act;

(13) geological and geophysical information and data including maps concerning wells, except information filed in connection with an application or proceeding before any agency or an electric log confidential under Subchapter M, Natural Resources Code;

(14) student records at educational institutions funded wholly, or in part, by state revenue; but such records shall be made available upon request of educational institution personnel, the student involved, that student's parent, legal guardian, or spouse or a person conducting a child abuse investigation required by section 34.05, Family Code;

(15) birth and death records maintained by the Bureau of vital Statistics of the Texas Department of Health or by a local registration official;

(16) the audit working papers of the State Auditor;

(17) the home addresses and home telephone numbers of each official and employee of a governmental body except as otherwise provided Section 3A of this Act, and of peace officers as defined by Article 2.12, Code of Criminal Procedure, 1965, as amended, or by Section 51.212, Texas Education Code;

(18) information contained on or derived from triplicate prescription forms filed with the Department of Public Safety pursuant to Section 3.09 of the Texas Controlled Substances Act, as amended (Article 4476-15, Vernon's Texas Civil Statutes).

(19) photographs that depict a peace officer as defined by Article 2.12, Code of Criminal Procedure, or a security officer commissioned under Section 51.212, Education Code, the release of which would endanger the life or physical safety of the officer unless:

(A) the officer is under indictment or charged with an offense by information; or

(B) the officer is a party in a fire or police civil service hearing or

a case in arbitration; or

(C) the photograph is introduced as evidence in a judicial proceeding; (as added by Acts 1987, 70th Leg., ch. 341, &1, at 3487)

(19) rare books and original manuscripts which were not created or maintained in the conduct of official business of a governmental body and which are held by any private or public archival and manuscript repository for the purpose of historical research; (as added by Acts 1987, 70th Leg., ch. 1053, &1, at 7201)

(20) oral history interviews, personal papers, unpublished letters, and organizational records of nongovernmental entities, which were not created or maintained in the conduct of official business of a governmental body and which are held by any private or public archival and manuscript repository for the purposes of historical research, to the extent that the archival and manuscript repository and the donor of the interviews, papers, letter, and records may agree to limit disclosure of the item; and

(21) curriculum objectives and test items developed by educational institutions that are funded wholly or in part by state revenue.

(b) This section does not authorize withholding of information or limit the availability of records to the public, except as specifically stated in this section. This section is not authority to withhold information from individual members or committees of the legislature to use for legislative purposes.

(c) The custodian of the records may in any instance within his discretion make public any information contained within Section 3, Subsection (a) 6, 9, 11, and 15. The custodian of a photograph exempt from disclosure under Section 3(a)(19) may make the photograph public, but only if the officer gives written consent to the disclosure.

(d) It is not intended that the custodian of public record may be called upon to perform general research within the reference and research archives and holdings of state libraries.

(e) For purposes of Subsection (a)(3) of this section, the state or a political subdivision is considered to be a party to litigation of a criminal nature until the applicable statute of limitations has expired or until the defendant has exhausted all appellate and postconviction remedies in state and federal court.

### Election on disclosure

Sec. 3A. (a) An employee hired by a governmental body, and each official of the governmental body, shall choose whether or not to allow public access to the information in the custody of the governmental body relating to the official's or employee's home address and home telephone number. Each official and employee shall state that person's choice to the main personnel officer of the governmental body in a signed writing not later than the 14th day after the date on which the employee begins the employment with the governmental body, or the official is elected or appointed. If the official's or the employee's choice is to not allow public access to the information, the information is protected as provided by Section 3 of this Act. If an employee or official fails to report within the period established by this section, the information is subject to public access.

(b) If, during the course of the employment or the term of the office the employee or official wishes to close or open public access to the information, that individual may request in writing that the main personnel officer of the governmental body close or open access, as the case may be, to the information.

### Application for public information

Sec. 4. On application for public information to the custodian of information in a governmental body by any person, the custodian shall promptly produce such information for inspection or duplication, or both, in the offices of the governmental body. If the information is in active use or in storage and, therefore, not available at the time a person asks to examine it, the custodian shall certify this fact in writing to the applicant and set a date and hour within a reasonable

time when the record will be available for the exercise of the right given by this Act. Nothing in this Act shall authorize any person to remove original copies of public records from the offices of any governmental body without the written permission of the custodian of the records.

### Examination of Public Information

Sec. 4A. (a) A person requesting information must complete the examination of the information within 10 days after the date of the custodian of the information makes it available to the person.

(b) The custodian shall extend the initial examination period by an additional 10 days if, within the initial period, the person requesting the information files with the custodian a written request for additional time. The custodian shall extend an additional examination period by another 10 days if, within the additional period, the person requesting the information files with the custodian a written request for more additional time.

(c) The time during which a person may examine information may be interrupted by the custodian if the information is needed for use by the governmental body. The period of interruption is not considered to be a part of the time during which the person may examine the information.

### Custodian of public records described

Sec. 5. (a) The chief administrative officer of the governmental body shall be the custodian of public records, and the custodian shall be responsible for the preservation and care of the public records of the governmental body. It shall be the duty of the custodian of public records, subject to penalties provided in this Act, to see that the public records are made available for public inspection and copying; that the records are carefully protected and preserved from deterioration, alteration, mutilation, loss, removal, or destruction; and that public records are repaired, renovate, or rebound when necessary to preserve them properly. When records are no longer currently in use, it shall be within the discretion of the agency to determine a period of time for which said records will be preserved.

(b) Neither the custodian nor his agent who controls the use of public records shall make any inquiry of any person who applies for inspection or copying of public records beyond the purpose of establishing proper identification and the public records being requested or establishing whether the custodian is authorized under Subsection (c) [sic] of Section 4A of this Act to refuse to honor the request for the records. The custodian or his agent shall give, grant, and extend to the person requesting public records all reasonable comfort and facility for the full exercise of the right granted by this Act.

### Specific information which is public

Sec. 6. Without limiting the meaning of other sections of this Act, the following categories of information are specifically made public information.

(1) reports, audits, evaluations, and investigations made of, or by, governmental bodies upon completion;

(2) the names, sex, ethnicity, salaries, title, and dates of employment of all employees and officers of governmental bodies;

(3) information in any account, voucher, or contract dealing with the receipt or expenditure of public or other funds by governmental bodies, not otherwise made confidential by law;

(4) the names of every official and the final record of voting on all proceedings in governmental bodies;

(5) all working papers, research material, and information used to make estimates of the need for, or expenditure of, public funds or taxes by any governmental body, upon completion of such estimates.

(6) the name, place of business, and the name of the city to which local sales and use taxes are credited, if any, for the named person, of persons reporting or paying sales and use taxes under the Limited Sales, Excise and Use Tax Act;

(7) descriptions of an agency's central and field organization and the established places at which the employees (and in the case of a uniformed service, the members) from whom, and the methods whereby, the public may obtain information, make submissions or requests, or obtain

decisions;

(8) statements of the general course and method by which an agency's functions are channeled and determined, including the nature and requirements of all formal and informal procedures available;

(9) rules of procedure, descriptions of forms available or the places at which forms may be obtained, and instructions as to the scope and contents of all papers, reports, or examinations;

(10) substantive rules of general applicability adopted as authorized by law, and statements of general policy or interpretations of general applicability formulated and adopted by the agency;

(11) each amendment, revisions, or repeal of 7, 8, 9 and 10 above;

(12) final opinions, including concurring and dissenting opinions, as well as orders, made in the adjudication of cases;

(13) statements of policy and interpretations which have been adopted by the agency;

(14) administrative staff manuals and instructions to staff that affect a member of the public;

(15) information currently regarded by agency policy as open to the public.

V.T.C.A. Tax Code &151.001 et seq.

### Attorney General Opinions

Section 7. (a) If a governmental body receives a written request for information which it considers within one of the exceptions stated in Section 3 of this Act, but there has been no previous determination that it falls within one of the exceptions, the governmental body within a reasonable time, no later than ten days, after receiving a written request must request a decision from the attorney general to determine whether the information is within that exception. If a decision is not so requested, the information shall be presumed to be public information.

(b) The Attorney General shall forthwith render a decision, consistent with standards of due process, to determine whether the requested information is a public record or within one of the above stated exceptions. The specific information requested shall be supplied to the Attorney General but shall not be disclosed until a final determination has been made. The Attorney General shall issue a written opinion based upon the determination made on the request.

### Writ of mandamus

Sec. 8. If a governmental body refuses to request an Attorney General's decision as provided in this Act, or to supply public information or information which the attorney general has determined to be a public record, the person requesting the information or the attorney general may seek a writ of mandamus compelling the governmental body to make the information available for public inspection.

### Cost of copies of public records

Sec. 9. (a) The cost to any person requesting noncertified photographic reproductions of public records comprised of pages up to legal size shall not be excessive. The State Board of Control shall from time to time determine the actual cost of standard size reproductions and shall periodically publish these cost figures for use by agencies in determining charges to be made pursuant to this Act. The cost of obtaining a standard or legal size photographic reproduction shall be in an amount that reasonably includes all costs related to reproducing the record, including costs of materials, labor, and overhead unless the request is for 50 pages or less of readily available information.

(b) Charges made from access to public records comprised in any form other than up to standard sized pages or in computer record banks, microfilm records, or other similar record keeping systems, shall be set upon consultation between the custodian of the records and the State Board of Control, giving due consideration to the expenses involved in providing the record shall be in an amount that reasonably includes all costs related to providing the record, including costs of materials, labor, and overhead.

(c) It shall be the policy of all governmental bodies to provide suitable copies of all public records within a reasonable period of time after the date copies were requested. Every governmental body is hereby instructed to make reasonably efficient use of each page of public records so as not to cause excessive costs for the

reproduction of public records.

(d) The charges for copies made in the district clerk's office and the county clerk's office shall be as otherwise provided by law.

(f) The charges of copies made by the various municipal court clerks of the various cities and towns of this state shall be as otherwise provided by ordinance.

### Distribution of confidential information prohibited

Sec. 10. (a) Information deemed confidential under the terms of this Act shall not be distributed.

(b) A custodian of public records, or his agent, commits an offense if, with criminal negligence, he or his agent fails or refuses to give access to, or to permit or provide copying of, public records to any person upon request as provided in the Act.

(c) It is an affirmative defense to prosecution under Subsection (b) of this section that the custodian of public records reasonably believed that the public records sought were not required to be made available to the public and that he;

(1) acted in reasonable reliance upon a court order or a written interpretation of this Act contained in an opinion of a court of record or of the attorney general issued under Section 7 of this Act;

(2) requested a decision from the attorney general in accordance with Section 7 of this Act, and that such decision is pending; or

(3) within three working days of the receipt of a decision by the attorney general that the information is public, filed a cause of action seeking relief from compliance with such decision of attorney general, and that such cause is pending.

(d) It is an affirmative defense to prosecution under Subsection (b) of this section that the defendant is the agent of a custodian of public records and that the agent reasonably relied on the written instruction of the custodian of public records not to disclose the public records requested.

(e) Any person who violates Section 10(a) or 10(b) of this Act shall be deemed guilty of a misdemeanor and upon conviction shall be punished by confinement in the county jail not to exceed six (6) months or fined in an amount not to exceed \$1,000, or by both such fine and confinement. A violation under this section constitutes official misconduct.

### Bond for payment of costs of preparation of public records or cash prepayment

Sec. 11. A bond for payment of costs for the preparation of such public records, or prepayment in cash of the anticipated costs for the preparation of such records, may be required by the head of the department or agency as a condition precedent to the preparation of such record where the record is unduly costly and its reproduction would cause undue hardship to the department or agency if the costs were not paid.

### Penalties

Sec. 12. Any person who willfully destroys, mutilates, removes, without permission as provided herein, or alters public records shall be guilty of a misdemeanor and upon conviction shall be fined not less than \$25 nor more than \$4,000, or confined in the county jail not less than three days nor more than three months, or both such fine and confinement.

### Procedures for inspection of public records

Sec. 13. Each governmental body may promulgate reasonable rules of procedure by which public records may be inspected efficiently, safely, and without delay.

### Interpretation of this Act

Sec. 14. (a) This Act does not prohibit any governmental body from voluntarily making part or all of its records available to the public, unless expressly prohibited by law; provided that such records shall then be available to any person.

(b) This Act does not authorize the withholding of information or limit the availability of public records to the public, except as expressly so provided.

(c) This Act does not give authority to withhold information from individual members or committees of the Legislature of the State of Texas to use for legislative purposes.

(d) This Act shall be liberally construed in favor of the granting of any request for information.

(e) Nothing in this Act shall be construed to require the release

of information contained in educational records of any educational agency or institution except in conformity with the provisions of the Family Educational Rights and Privacy Act of 1974, as enacted by Section 513 of Public Law 93-380, codified as Title 20 U.S.C.A. Section 122g, as amended.

**Severability**

Sec. 15. If any provision of this Act or the application thereof to any person or circumstances is held invalid, such invalidity shall not affect other provisions or applications of the Act which can be given effect without the invalid provision or application, and to this end the provisions of this Act are declared to be severable.

**PROPERTY TAX RENDITIONS**

Almost everyone with personal property in the Donley Appraisal District has now been mailed rendition forms. Additional forms are available at the appraisal district office. Please complete the listing of your taxable personal property and return the forms by the end of March. All personal property must be rendered each year even if there has been no change from the prior year. You should include cars, pickups, trucks, RV's, travel trailers, and airplanes.

If you own a business, you should also render your business inventory held for resale and other business related equipment.

January 1 of each year is the assessment date in Texas; render only that property which you owned on January 1, but make your rendition before April 1. File your completed rendition with the Donley Appraisal District office in the Courthouse Annex. The rendition must be signed, and you may, although it is not required, list an opinion of market value.

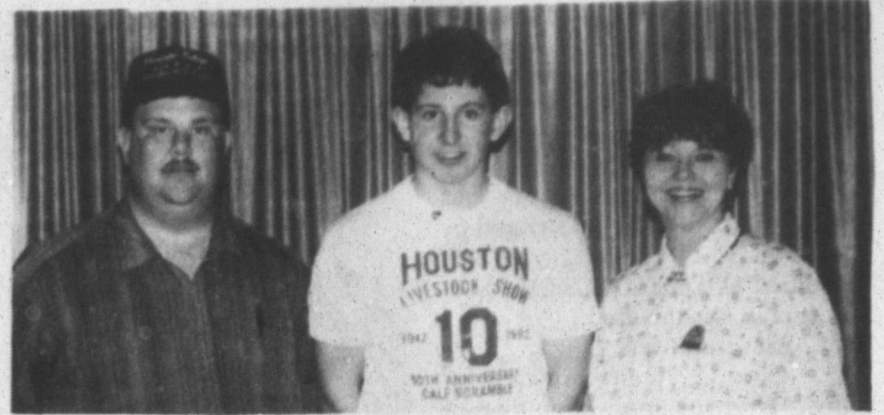

**What to Do About Excess Ear Wax**

Ear wax (cerumen) helps lubricate the lining of the exterior ear canal. It also protects the ear by trapping and removing foreign substances such as dirt and other debris that routinely enters the ear canal. Ear wax is expelled automatically from the ears in the form of tiny spheres. Jaw movement from chewing and talking aids wax removal. Contrary to popular belief, it normally is not necessary for wax in the ears to be removed with hairpins, cotton tips, or similar objects. The ear canal can be damaged from such objects.

Some persons accumulate excess ear wax. There are several reasons why this occurs, including an abnormal secretion of wax by the ceruminous glands and an abnormally shaped exterior ear canal. Excess hair in the ear canal also may impede wax removal.

Excessive wax can be safely removed from the ears through the use of wax softening agents. The U.S. Food and Drug Administration through an advisory panel recognizes over-the-counter products containing carbamide peroxide as safe and effective. This compound releases oxygen which helps loosen and soften debris and wax, making removal with warm water and an ear syringe easier. If wax remains after 4 days, contact a physician.

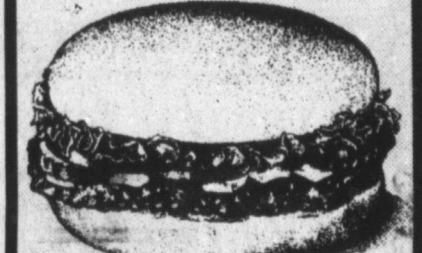

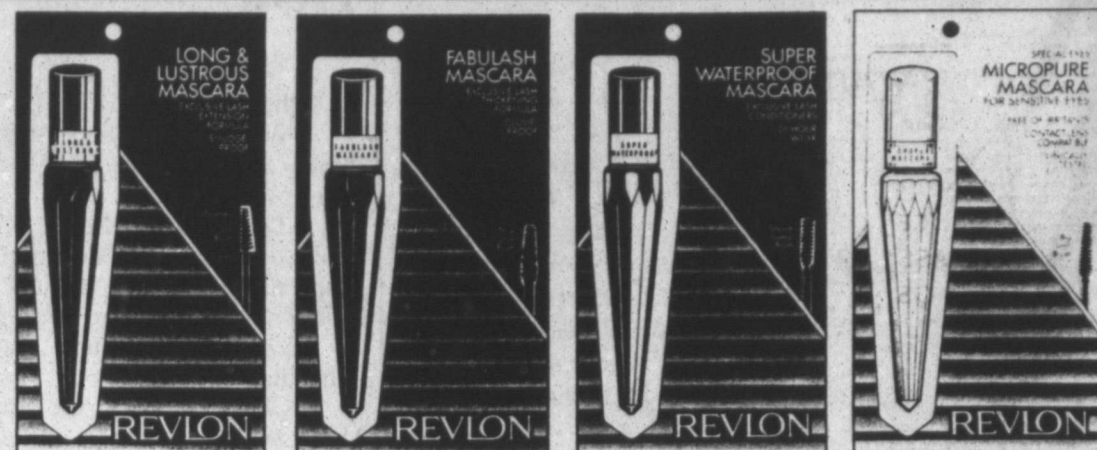



Representatives from Yesterday's Children and the Thunder Junction park project have returned from a trip to Washington, D.C.

Pat Kaiser, Yesterday's Children president, Mr. and Mrs. Stan McClendon of Greenbelt Electric Cooperative, and State Rep. Warren Chisum visited the capitol February 18 - March 3 to explore potential funding possibilities for the park to be built near Clarendon.

## Severe Weather Awareness Week March 8 - 14

Governor Ann W. Richards has designated the week of March 8-14, 1992, as Severe Weather Awareness Week in Texas. The National Weather Service and the Texas Insurance Advisory Association have joined with DEM to promote severe weather awareness to the citizens of the state.

**Tornado PSA -15 Seconds Watch/Warning**  
Knowing the difference between a Tornado Watch and a Tornado Warning could save your life. A Watch means conditions are right for Tornadoes to form. A warning means a Tornado has been sighted in your area, and you should take cover quickly.

*This message from the Texas Division of Emergency Management and the Texas Department of Public Safety.*

**Tornado PSA -30 Seconds Take Action**  
Tornadoes can strike at any time, any place, in Texas. Listen to National Weather Service Bulletins for weather information. If a warning is issued or you see a Tornado, immediately take shelter below ground or in an interior hallway or bathroom on the ground floor. Stay away from windows.

If you're outside, lie flat in a ditch or ravine and cover your head with your arms. Do not stay in or under your car or mobile home, since both are easily moved by Tornadoes. Do not try to outrun a Tornado or drive away from it in your car.

## Plan Now For Severe Weather

Although tornadoes, severe thunderstorms and floods can strike virtually any part of Texas at any time, spring seems to bring an increase in violent weather.

You can take precautions to assist yourself and your family in the event of a tornado.

Periodically hold a tornado drill so that family members know what to do and where to go if the national weather service issues a tornado warning. The safest part of a house during a tornado traditionally is the basement, but be aware of the potential for flooding if there is heavy rain in the area. Interior bathrooms, hallways and closets on the ground floor also offer protection from tornadic winds. Avoid windows and outside walls. Take along blankets or sleeping bags to protect yourself from falling debris and shattering glass, which are frequently cause of death and injury during a tornado.

Make certain you have a portable radio and several flashlights (and fresh batteries for both) as well as bottled water, extra prescription medications and a first aid kit in your shelter area.

Remember, if a tornado strikes, electricity, gas, water and sewer service may be disrupted for several days.

Mobil homes and automobiles are dangerous places to be during a tornado. If you live in a mobile home, make sure all family members know where the nearest substantial shelter is. If you are in your mobil home or car and can't get to a better shelter: go outside, lie down in the nearest ravine, ditch or culvert and cover your head with your hands. Be aware of the possibilities of flooding in low-lying areas. Do not hide under your mobile home or car because both can easily be picked up and carried away by a tornado.

Preparedness information is available from libraries, weather service offices, and state and local emergency management offices. The state, as well as many local governments, offers help in developing emergency management plans and exercises to test those plans.

No part of Texas is immune to the vagaries of spring weather, and all citizens and visitors should know how to properly protect themselves, their families, and their property.

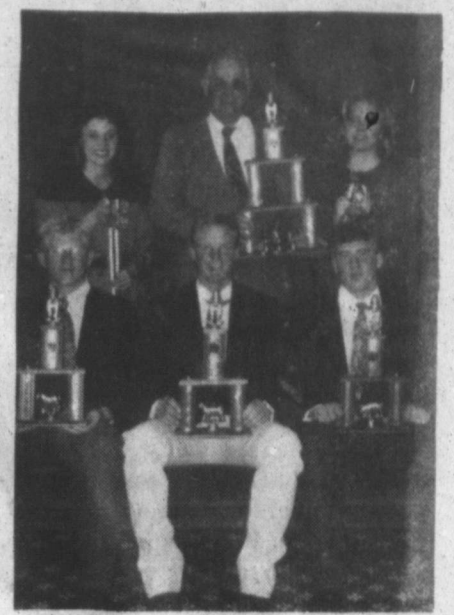
The Fourth and Fifth Grades heard the story of *Don Pasquale*, the upcoming opera, told by storyteller Jerry Williams.
