US should work with the people of Venezuela

Contrary to what Americans hear constantly from the media, Venezuelans have a poor opinion of their president, Hugo Chavez, and a positive opinion of Americans and the United States

As a senior Venezuelan currently living in the U.S. while keeping up-to-date with Venezuelan affairs (I am also a former member of the Venezuelan congress), I have come to accept that Venezuela generally merits little attention from U.S. society, except in three or four areas: baseball players, beautiful women, oil and the antics of Hugo Chavez.

Hugo Chavez' September 2006 UN speech in which he called President Bush a "devil" and spoke aggressively against the United States, helped to push Chavez and Venezuela, even if negatively, onto the American consciousness. Due to this speech, millions of U.S. citizens felt curious enough to do some research on Chavez and learned, for example, that Citgo, the chain of corner gas stations, is really a major oil company owned by the Venezuelan government and being used by Chavez to make inroads into American domestic politics. Americans also learned that Chavez loved Saddam Hussein and now calls Iranian President Ahmadinejad and Zimbabwean dictator Robert Mugabe "brothers." However, few still know that his buddies in the U.S. include: Actor Danny Glover, who received \$18 million from Chavez to make a movie. Glover has been known to compare Chavez to Dr. Martin Luther King, Jr.; Joseph Kennedy Jr., who runs Citgo's distribution of "cheap" Venezuelan fuel oil for Chavez in the northeast; and Jesse Jackson, who was decorated by Chavez in Venezuela; and many others.

The intense propaganda machine installed by Chavez in the U.S. (that costs the Venezuelan Embassy well over a million dollars per year) is trying to sell U.S. public opinion on the idea that Hugo Chavez is universally loved by Venezuelans while the United States is bitterly hated.

In fact, neither of these two claims is correct, judging by all credible polls, both in Venezuela and outside the country. In Venezuela the most professional and respected polling company, Hinterlaces, produced its poll for the month of June, with a 95 percent reliability. Some of the results are quite interesting:

Hugo Chavez is rejected by 43 percent of those polled and approved of by 39 percent;

Attacks against the U.S. by Chavez are rejected by 75 percent of participants and approved of by 14 percent;

To give money away to other countries, as Chavez is doing from the Venezuelan oil largess, received the support of only 9 percent of those polled, while 87 percent rejected it;

The pretense of Chavez to re-elect himself indefinitely by modifying the existing constitution is rejected by 63 percent of those asked and approved of by 19 percent. 81 percent of Venezuelans would generally like to see new political leadership in the country. According to the survey by Hinterlaces, the political style of Hugo Chavez is starting to rub Venezuelans the wrong way, since he is increasingly being perceived as a dictator. A poll conducted by a reputed Chilean company, Latinobarometro, in January 2007, indicated that Venezuelans clearly prefer democracy to any other political system. This poll also revealed that Hugo Chavez had a very low approval rating in Latin America, only better than Cuba's Fidel Castro and Peru's Alan Garcia. The highest ranked Latin American leader in this poll was Brazil's Lula da Silva, followed by Chile's Michelle Bachelet, Colombia's Alvaro Uribe and Argentina's Nestor Kirchner, while Hugo Chavez, Alan Garcia and Fidel Castro were at the very bottom of the ladder. Pew Global Attitudes Poll, issued in June 2007, surveyed the views on the U.S. in 47 countries, including Venezuela. While it is true that the U.S. image in Latin America has deteriorated, the clear majority of respondents in countries such as Mexico, Peru and, yes, Venezuela, expressed a positive opinion about their northern neighbor. In fact, it might come as a surprise to many Americans that more Venezuelans (56 percent) thought favorably about the U.S. than did the British (52 percent), the Swedes (46 percent) and the French (39 percent). While 71 percent of Venezuelans enjoyed U.S. music and movies, only 63 percent of the British shared their enthusiasm. At the same time, 76 percent of Venezuelans professed admiration for U.S. science and education, while 74 percent of the British did. Venezuelan opinion of the U.S. was much more favorable than that of most European countries. The picture Venezuelans have formed of Hugo Chavez and of the U.S, according to these polls, is not the picture Hugo Chavez's propaganda machine in Washington is trying to sell to American public opinion. The positive sentiment that Venezuelans have about the United States appears to be culturally driven, not political. The U.S. should consider taking the initiative towork with the Venezuelan people, through organizations of civil society, to promote the conversion of more Venezuelans into productive citizens. The Venezuelan population is highly dependent on a paternalistic, authoritarian state and cannot prosper without a critical mass of self-starting citizens. Such an initiative could create new good will for the U.S. in my country.

First responders show volunteer spirit

Texas's earliest settlers appreciated the wide open spaces of our vast landscape, but they were quick to band together for the common good when an emergency arose. Nothing brought out that cooperative spirit more rapidly than the specter of fire.

In the smallest communities, citizens organized bucket brigades on a moment's notice. In those days, firefighting equipment might consist only of shovels, water containers and anything handy to smother the flames.

In 1845, a fire in San Augustine enveloped several buildings, but the hotel "was saved by the indefatigable exertions of the citizens who covered the roof with carpets and blankets and kept the front deluged with water thrown from windows."

In Houston, during the same era, authorities organized a paid company of firemen. But any major fire brought out an eager corps of civilian volunteers nonetheless.

Today, that spirit of volunteerism still thrives across Texas. Of 1,800 fire departments in the state, some 1,450 are all-volunteer, and another 250 combine paid and volunteer staff. These citizen-run operations cover the vast majority of Texas's 261,797 square miles.

Put another way, two-thirds of the 60.000 firefighters in Texas are men and women willing to volunteer their time and

risk the dangers of emergency service to help their neighbors.

Recently, rural firefighters have been busy fighting fast-moving grassfires. Texas State Forester James Hull believes we have just passed the midpoint of a 30-year dry or drought cycle, vastly increasing fire risk across the state, especially in rural areas, where the dry conditions of 2006 were particularly perilous.

With a few other central U.S. states, Texas has had above-average rainfall so far in 2007 - reducing fire risk in many areas. But, as residents of East Texas were reminded again this summer, danger is a constant companion for firefighters at all times

Earlier this month, two volunteer firemen from Noonday, Texas - Captain Kevin Williams and Austin Cheek - made the ultimate sacrifice while battling a house fire in Flint, Texas. Two other volunteers were injured while trying to save their lives

In June, Nacogdoches Fire Captain Joe Ed Ivy, a career fireman, died in Houston during a high-rise training exercise. Capt. Ivy's brother and cousin also work for the Nacogdoches Fire Department.

While their communities were shocked by these losses, it should be some small comfort to their families that these men died serving others.

In recent years, and especially since

Sept. 11, 2001, the federal government has assumed a greater role in local emergency preparedness. Although the danger of terrorism is likely greater in urban areas, we have learned from Katrina and other disasters that after-effects often spill over into suburban and rural areas. Emergency personnel in all regions must be prepared and up to date.

In 2001, Congress created the Assistance to Firefighters Grant (AFG) program aimed at assisting rural emergency organizations to maintain readiness. These grants help firefighters and other first responders obtain equipment, protective gear, emergency vehicles, training, and other resources needed for fires and related hazards

Over the past six years, the program has made 1,437 grants to Texas, totaling \$123.6 million. These funds have helped most state fire departments keep up with potential problems that seem to multiply with increased population, weather cycles, human mistakes, and both domestic and international threats.

A byproduct of 9-11 has been increased appreciation for the role that first responders - police, fire and emergency personnel - take on the front lines. They are often the pillars of our communities, and they earn our respect and gratitude every day. It is well deserved.

Texas so special is the greatest privilege of serving as your Senator. I particularly treasure the opportunities I have to speak with our veterans and active duty personnel and thank them personally for their tremendous service to our country. This month, I've traveled all across Texas and met some of the brave men and women who answered the call to defend our freedom and way of life.

In San Antonio, I had the honor to present Private First Class Sonny Weldon with a Purple Heart for wounds he sustained in Iraq when a roadside bomb exploded near his unit. The occasion was especially meaningful because PFC Weldon received his medal on the anniversary of the day George Washington created the Purple Heart decoration in 1782. I am inspired by PFC Weldon's strong convictions and dedication to his mission.

Then, in Houston, I met Marine Corporal Paul Gardner and his wife Ashley. Corporal Gardner was shot and paralyzed during a firefight with insurgents in the opening weeks of Operation Iraqi Freedom. I was deeply moved by his courage and determination both on and off the battlefield. He once wrote, "I can do anything if I want it bad enough. It just takes a little more effort sometimes." That day I participated in a ceremony to give the Gardners the keys to a brand new home, custom built by the Wounded Hero Home Program to fit Paul's special needs.

The Wounded Hero Home Program

is a compassionate partnership of 57 Houston-area Rotary Clubs, the Coalition to Salute America's Heroes, and corporate capitol donors such as Gal-

In addition, Perry Homes and the Riverstone Development Company each gave about \$50,000 to the project. The Gardners' home is the first of 14 that this ambitious venture aims to provide for wounded veterans of Iraq and Afghanistan by the end of this year.

Later that week, I welcomed the crowd at the Freedom Concert held in Grand Prairie. Featuring country music stars Montgomery Gentry, Lee Greenwood, and Colin Raye, the benefit concert was organized by the Freedom Alliance and radio and television commentator Sean Hannity to provide college scholarships for the children of soldiers slain in combat. This month I also received the results of a study I requested to assess the heath care needs of our veterans living in the Rio Grande Valley. Currently South Texas veterans are forced to endure 500 mile, ten-hour roundtrip treks to the San Antonio VA hospital for even basic procedures and routine check-ups. This is simply unac-

ceptable. The study calls for an expanded, 158,000-square foot VA facility specializing in services like cancer treatment and outpatient surgery that will eliminate 95 percent of the arduous trips to San Antonio. Last week, local leaders joined me in Harlingen to welcome the results of this study, and I will continue to work with my colleagues in Congress to secure funding to build this vital center.

Throughout my travels, I was proud to see Texans supporting the troops. Our current conflict in the Middle East has challenged our nation's fortitude, but I am always touched by your pride and patriotism. While some of my colleagues in Congress would like to ignore the threat of radical Islam, Texans know the high stakes of the Global War on Terror. If we walk away from our commitments in Iraq and Afghanistan, the terrorists will not be appeased-they will follow us home. Many of our friends and loved ones are serving bravely in our armed forces, and some have made the ultimate sacrifice in the defense of liberty. As I have said on their efforts to have been in vain.

I am always inspired to meet the service members and veterans who give of themselves to preserve our nation's bedrock principles and most cherished ideals. When given the chance, I urge you to give these brave Americans your deepest thanks. They are true heroes, deserving of our highest respect and steadfast support.





Keeping cool is a priority, especially for the elderly among us. We are to remember our pets and to check on our neighbors when the heat climbs. There is something else that needs to be checked, and that is our apparel. What olothing do we wear (or not wear) during this hot time of the year? Does heat or any reason allow us, in God's eyes, to go about partially unclad or almost naked?

It's Getting Hot

This time of the year in the Panhandle, the heat is legendary.

In Gen. 3:7. Adam and Eve realize they are naked after eating the forbidden fruit. They sew fig leaves together and made themselves coverings or "loincloths." Verse 8, they hear God walking in the Garden and hide themselves. Why? Verse 9 tells us that God calls out to them and in verse 10, Adam answers God by saying, "I heard they sound of you in the garden, and I was afraid, because I was naked and I hid myself." Wait a minute! thought they had made some clothing, not much but some. Many places in the Bible, the word "naked" can mean: totally nude, poorly clad, or without an outer garment (Gen. 3:7, 3:10; Job 22:16; 1 Cor. 4:11; John 21:7).

We understand a few things from our passages from Gen. 3: 1. They were at one point completely nude. 2. They made coverings for their loins from fig leaves, yet, still referred to themselves as being naked. 3. God, from animal skins, made them coverings. Some translations say coats or tunics. The point is, just covering one's bottom is not to be considered properly clothed. Obviously God's new clothes also covered one's breast also. Logic dictates that God doesn't approve of the public wearing of clothing that just covers our bottoms and breasts, such as bikinis, plunging necklines on upper garments that expose the breast, slits on garments that expose flesh up to the rear, short shorts, etc. If God saw fit to dress Adam and Eve appropriately, shouldn't we dress the same? Survival Has Increased with Better Breast Cancer Drugs According to the American Cancer Society, breast cancer is the second most common cancer among women. More than 175,000 new cases of invasive breast cancer are predicted to occur in 2007. The good news, however, is that the Society now reports that the death rate from breast cancer continues to decline. Health experts believe this decline can be attributed to earlier detection through screening and increased awareness, as well as the use of better drugs to treat this type of cancer.

A recent study of breast cancer treatment conducted by cancer specialists at the University of British Columbia in Vancouver evaluated women in 4 different groups. Survival was significantly longer in women who were treated either from 1997 to 1998 or from 1999 to 2001. The research group reported that the improvement in survival appeared to be caused by newer, more effective drugs. Some of the newest cancer drugs include Abraxane, Arimidex, Faslodex, Femara, Herceptin, Nolvadex, Tykerb, Xeloda, and Zoladex.
