has just received word from Dr. Darby of the Bureau of Animal Industry that the testing of TB in cattle in Donley County will start in early August. The county is tested every three years to be declared a free county of TB. Tht dairymen of Donley County are especially interested in this type of testing and there is no charge for this service.
