To get the most out of Trick or Treating, be safe and use good common sense.

#### Homeowners

Make sure your yard is clear of such things as ladders, hoses, dog leashes and flower pots that can trip the young ones. Battery powered jack o'lantern candles are preferable to a real flame. If you do use candles, place the pumpkin well away from where trickor-treaters will be walking or standing. Make sure paper or cloth yard decorations won't be blown into a flaming candle. Healthy food alternatives for trickor-treaters include packages of low-fat crackers with cheese or peanut butter filling, single-serve boxes of cereal, packaged fruit rolls, mini boxes of raisins and single-serve packets of low-fat popcorn that can we microwaved later. If a sidewalk is not available, walk on the left side of the road facing traffic.


Cross busy streets at a intersection or cross walk. Be sure to look both ways (2 times) before crossing the street.

· Quality is its own salesman. I once asked a very successful professional speaker how he marketed his speaking business. He said, "Every speech sells the next on.


• All buyers aren't quality buyers. Some people buy junk. Research tells us that 20% of all buyers are more concerned about price than any other factor. They aren't quality



Lake Depth--October 23, 2000--48.73 feet

The Lake level was down slightly over 1.5 inch this week. Monday morning Jim's rain gauge at the office had shown .72 inch for one rain and .09 inch for the second.

There were 5 RVs in the North Park this weekend--none on the office side. Jim is seeing more deer in groups now. The bucks have come out of hiding, as their horns have gone beyond the velvet stage. Watch for the wild turkeys in the parks on the north side, so far they don't frequent the office side.

The Panhandle Bird Club birders sent Jim a copy of the birds they found on their trip to Hansford County and Palo Duro Park, and Joan copied it for me. They saw 72 different species, 16 in the county and 56 at the Lake. The same morning's mail, I received an updated copy of Birds of Palo Duro Lake compiled by Kenneth Seyffert of Amarillo. His year around list had 161 species listed. I will copy it for the office, so if any one is interested in a copy or copies of the lists, see Jim or Joan or let me know.

Kenneth Seyffert has his list broken into the four seasons. Jim and Mandy have recently seen a Blue Grosbeak at their feeder. It is listed only for spring and summer.

Two of our unusual birds found on both lists are the Sora and Virginia Rail. These birds should be found around the edges of the Lake, feeding on the mud flats. Both birds, members of the rail family, are rarely found in the Panhandle. The Virginia Rail is the more color-

The shy Sora is a small, brownish chicken-like bird with a yellow beak and a ridiculously short, stubby tail.

After writing about the Littlefield cattle herd being driven down the Dodge City-Tascosa Trail, I found that the LX herd of Bates and Beal had come first, as they left Dodge City area July 6, 1877, and it was September when the LIT Ranch was started. Charles A. Siringo wrote in A Texas Cowboy "...We struck out on the 'Old Fort Bascom' Trail in a southwesterly direction."

After telling of the trip to the new ranch on the Canadian River, he wrote, "After arriving on our newly located ranch we counted the cattle and found the herd three hundred

Bill Allan, the boss, struck back to try and find their trail. He found it leading south from the 'rifle pits.' The cattle had stolen out of the herd without anyone finding out; and of course finding themselves free, they having come from southern Texas, they headed south across the

Bill came back to the ranch, picked up Charley and two horses apiece. They were able to get about two hundred of the cows back.







# Lynx Blank Broncos

Two plays later, Eduard Vasquez ran up the middle from 10 yards out for the touchdown with 11:55 left in the game. Lopez' PAT kick failed and Spearman led 15-0.

Clarendon went three and out on their next possession and had to punt back to the Lynx. Miller ran the punt back, but Tanner Beedy made a huge block on a Clarendon defender that sprung Miller in for the TD. Lopez' kick was good and Spearman's lead

increased 22-0. The Lynx defense continued to play tough defense and would not let Clarendon gain many yards. Clarendon started their next drive on their own 21 yard line. After making one first down, they went for the first down on 4th and 10, called for holding, which was a but came up short and Spearman

After getting a touchdown called back on the first play from scrimmage for blocking in the back, Miller ran up the middle on the next play down to the Clarendon 9 yard line. 


