Miss Della Palmer Entertains.





CASTRO COUNTY OFFICIALS.

Designate The Brand as Official Organ.

Last Monday, in company with Judge Jno. P. Slaton, ye editor made a visit to the hustling Castro County seat + Dimmitt.

The weather was all that could be desired for a 20-mile drive and, seated \in the Judge's fine new rubber-tired turnout (which, by the way, is the swellest that ever struck Hereford) we enjoyed immensely the two days' outing.

Upon coming to a ranch house we invariably stopped and inquired how crops were progressing, the condition of cattle (though the latter question was unnecessary as a glance would show that they were fat and in fine condition—that is, the most of them) and how things were generally. In each instance the reply was about the same—all having had plenty of rain and that an excellent season was in the ground.

On arriving at the O. Y. O. ranch we found the manager, D. C. Laird, absent, being on a visit among East Texas friends. However, we found the same hospitality existed among those in charge as would have been extended had Mr. Laird been present. Mr. Bernard, who was in charge, invited us to come in and get dinner -though it was past the dinner hour-but we declined, having brought a lunch with us. However, Gus, the cook, seemed determined that we should partake of the O. Y. O.'s hospitality and tendered us a large pitcher of rich Jersey, milk to drink with our lunch, which we accepted and enjoyed to 'the utmost. Mr. Bernard informed us that they had lost but few cattle this winter. This may be accounted for by reason of the fact that they have a large amount of feed on hand yet from the last year's growing. The O. Y. O. people seem to go on the theory that it is better to have too much feed than too little-a very good and practical theory and one which the rest of the Panhandle stockmen could put into practice with profit to themselves.

On arriving at Dimmitt we found the Commissioners Court in session and working assiduously in the interests of their constituents. The commissioners had for some time been studying over the proposition of having for their official organ a paper that was largely read by the residents of Castro county (there being no paper published in the county) and upon motion it was unanimously carried to designate THE BRAND as their official organ and henceforth all proceedings of the county officers of interest to the residents of the county will be published in their organ, including the treasurer's quarterly report.

It also gives us pleasure to state that THE BRAND now has a representative in Dimmitt, Dr. Charles E. Donnell, who will keep THE BRAND readers posted on what is going on in our neighboring county. Dr. Donnell is authorized to accept and collect subscriptions and take orders for advertising and job work for THE BRAND. This will be a great convenience to the residents of Castro county, as heretofore they have had to wait until they could make the trip to Hereford to have their wants supplied. Payments for this class of work are also payable to the doctor. .

County Judge C. F. Kerr informs us that Castro county is now in as good shape financially as any of the counties of the Panhandle. Four years ago the indebtedness of the county was \$17,000. Today the county is but \$6,000 in debt, that sum being still due on the court house, which, by the way, is considered the finest on the plains. This showing speaks very well for the able manner in which the county's business has been conducted, and shows that Castro county is coming out of the kinks in fine shape. Four years ago Castro county's scrip was worth only about 30 cents on the dollar. Today the only scrip being issued is scrip having Uncle Sam's official stamp and is consequently worth 100 cents on the dollar.

Castro county is being rapidly settled with a thrifty class of stock farmers-men who are scrupulously honest, loyal to their county, state and country, and not afraid of a little hard work if the occasion requires, and withal the most hospitable people on earth. They are proud of their county and its resources, and well they may be. They have plenty of fine grass for their cattle, a splendid season in the ground, a happy, contented class of citizenship, and bright prospects for the future.

Their county seat, Dimmitt, seems to have taken on new life and many fine new houses have been built within the past few months and many more are in contemplation. Many prospectors are visiting the town and county and a large per cent of them are investing their money therein. Certainly the Panhandle of Texas is a paradise on earth and Castro county has nothing to lose by a comparison with her sister counties.

Castro county now has four postoffices within her borders-Dimmitt the first one, being established soon after the organization of the county, Miss Lalla Hill now being the popular postmistress. Rawl was the next postoffice established by the government, but was later discontinued. Hart, a community in the southeast part of the county, was the next to be established, T. W. Hart being appointed as postmaster, which position he still holds. This community has gradually grown in population as the rest of the county developed, so that now about thirtyfive families patronize the office. The citizens of a settlement in the northeast part of the county, next petitioned for a postoffice, which was granted and bears the name of Arney, the postmaster being George Arney. The last postoffice acquisition to the county is called Nazereth and was established quite recently

with Mrs. T. P. McCormick as postmistress. This postoffice is situated in the heart of the German colony, in the eastern part of the county, the neighborhood being composed of about thirty families. That this is a progressive and thrifty settlement will be testified to by anyone acquainted with the German citizenship of the United States. It is also stated that many more German families will soon join this colony and it may be confidently expected that in the near future Nazereth will be one of the most prosperous communities in this section of the country. At this session of the commissioners court a local option election was ordered to be held Tuesday, June 2, 1903, the entire county to be embraced in the prohibition territory, providing the prohibition movement is victorious. It might be stated that there are no intoxicating liquors now being sold in the county, but with the rapid growth of the county it is feared that a saloon will be opened and it is to guard against this that the election is ordered, as it is believed that it would be easier to keep whiskey out now than to get rid of it after it has gained a foothold.

A peculiar case came up before Judge Kerr in Tuesday's session. The matter of the county judge's salary was under discussion and upon a vote it was found that two of the commissioners were in favor of paying him \$60 per month salary and \$50 per year as school superintendent, while the other two were in favor of a \$50 per month salary and \$100 per year for the latter office. It was thus up to Judge Kerr to decide whether to allow himself \$770 per year or \$700. Inasmuch as the county officers are straining every point to free the county from debt Judge Kerr generously voted for the lower salary, He thus saves the county \$126 per year as his salary for superintendent of schools is paid

by the state.

At the afternoon session the much talked of road proposition came up. This road, as laid out by the jurors of view, runs from Dimmitt to the southeastern part of the county, and passes through the ranches of C. E. McLean, G. D. Sikes, J. E. Turner, Mr. Gollehon and others, separating their holdings and causing them much damage thereby. These gentlemen had employed Judge Slaton to appear before the commissioners court and endeavor to have the route changed. In this he was successful by showing the commissioners a more feasible and less expensive route.

This matter being disposed of upon motion it was decided to employ Judge Slaton as legal adviser to the county commissioners.

PROGRESS OR RETROGRESS?

It is with regret and humility that we have to publish to the world that a few of Hereford's citizens have placed her in a position where she MAY change from better to worse in the matter of organization, though we doubt if their efforts in this direction will be successful. On Wednesday last C. G. Witherspoon presented a properly signed petition to County Judge Boyd, requesting that that official order an election to determine whether or not the incorporation shall be annulled.

We have talked to several signers of this petition and find that they themselves are not dissatisfied with the incorporation proposition, and are indifferent as to the success or failure of the movement now on foot, but, like all people of this class, will sign any petition that is presented to them, many of them having signed the previous petition calling for a corporation election. Others signed this latest petition while favoring incorporation and voting for it at the incorporation election. Others signed it because so-and-so wanted them to. One man informed us, in the presence of witnesses, that upon refusing to sign it (although being an anti-corporationist) the carrier of the petition tried to induce him to sign it by misrepresenting the facts of the case. A few signed it because they honestly believe that the town would be better off without corporation than with it, and voted against the movement at the last election.

We believe we are aware of the source from which this latest movement emanated, but will discuss that phase of the question when occasion requires.

Some people maintain that they have had enough of incorporation and complain of the ordinances and laws, either as a whole or in part, yet we have failed to find one of these who could point to an unjust or obnoxious law passed by the City Council, and when closely questioned fail to give one reason as to why they are opposed to incorporation. That they have reasons, however, we have no doubt, but their reasons are better left unsaid. Some of them are in the employ of wealthy foreign incorporations, who, notwithstanding the fact that they have

derived large revenues from their investments in this city, object to the paltry taxes to which they would be subjected through incorporation, and thereby donate their just share toward the city's improvement. Possibly some of them object to a prohibitive tax being placed on pool halls, bowling alleys and other like iniquities, which entice our growing youth into practices and habits which will be a source of pain to loving and indulgent fathers and mothers. To abolish incorporation would be to invite operators of such games as these to open their dens in the now CLEAN CITY OF HEREFORD. It would say to these operators: "Hereford is a city of nearly 2500 inhabitants, without a "den" of any kind-made so by a prohibitive incorporation tax-but her citizens have abolished that and now offer special inducements for a pool room, bowling alley or any other device which is not contrary to the laws of the state, and the only tax the operator will be subjected to is the state tax-a mere nothing." And the good people of Hereford can rest assured that these operators will not be slow in recognizing the invitation. We did not have any such institution IMMEDI-ATELY before Hereford was incorporated, you may say. No! But we know of two different parties who were contemplating coming here and asked us what the chances were of being allowed to operate. They were told that the citizens of the town did not want any such institutions and that when the town was incorporated, which we had reason to believe would occur soon, a prohibitive tax would be placed on these "industries (?)." And what we said was true; a prohibitive tax was made.

It's up to you, gentlemen; an incorporated city free from dens of vice, or a wide place in the road with no legal status and abounding with character destroyers, breaking the hearts of loving fathers and mothers. Which will it be?

INCORPORATED Hereford means a clean city from a sanitary standpoint, free from dens of vice, free from the disgusting spectacle of hogs running at large, and as soon as possible free from disastrous fires (as we have reason to belive that an adequate waterworks system for fire protection will be soon established:) No incorporation means the reverse. Which shall it be?

IN a recent issue of THE BRAND appeared an article headed "Coming to the Front," which we clipped from the Higgins News and unintentionally failed to give proper credit. Several of our exchanges copied the article, which was a good one, and gave us the credit therefor. We try to be careful in these matters, but mistakes will happen occasionally, so please excuse us for this one, Bro. Mitchell.

ONE of the signers of "that petition" and a loud howler against incorporation has never paid a cent in taxes, never donated a nickel to any public enterprise, bought his goods as far as possible from outside parties, and never missed an opportunity to run down the town and country. On second thought, we don't blame him. If we were as non-progressive as that we would want to bring everyone else to our level.

WE wish to draw a little comparison with the incorporation abolishment movement and a prohibition abolishment movement. How many are there who would vote for a saloon in this town IF it could be operated in the same law-abiding manner as it was before the local option election. held nearly two years ago? There are many. How many of these same men would vote against prohibition if they could not have that assurance (and of course they could not)? Not one. How many would vote for no corporation IF they were assured that no dens of vice would come into Hereford? Probably a large number. How many will vote for no incorporation, knowing that the way will be open to these institutions of vice if it is abolished? None, we

WITH the abolishment of incorporation a "blind tiger" would have one less enemy to fight. By all means let's abolish incorporation and give the poor, down-trodden animal a

THE Snyder Coming West last week issued a very creditable 16page special edition, profusely illustrated with half-tone cuts. It should be a good advertisement for the town and county.

SOME of the opposers of incorporation do so on the ground that the City Council made the occupation tax to high. That may be true in some instances, though we cannot say. If this be true, however, would it not be better to appear before the City Council, state your position clearly and ask for a reduction, than to try to abolish the best movement ever made by the citizens of Hereford? The City Council is composed of fair minded, honorable men, and who would be glad to right any wrong that they have unintentionally done anyone. We say again, would it not have been better, gentlemen? However, these are not the people who are responsible for the abolishing movement, though that is one of the pretenses by which they were brought into line. Right your own wrongs, brother, do not ask or even allow someone else to attempt to do it for you. A personal talk with the members of the City Council would have been all that was necessary.



FAT CATTLE SHIPPED.

Charles Hannaford, Proprietor of Green Valley Ranch, Makes Experiment.

On Saturday last ye editor accompanied Judge Jno. E. Ferguson to the stock pens to look at a bunch of fat cattle which were to be shipped to the Kansas City market. These cattle, numbering 88 head, were put on corn feed on the 18th of last December at the Green Valley ranch, owned by Charles Hannaford, as an experiment, Mr. Hannaford wishing to ascertain if it was practicable to finish cattle in this country for the market. Notwithstanding the unusually severe winter these cattle were in excellent shape for shipment and will no doubt bring a good price in the market, thus bringing to their owner a nice little sum of money to repay him for his trouble and experiment. He also shipped 45 fat hogs to the same market, which averaged 285 pounds in weight.

Mr. Hannaford is a firm beliver in this country as a finishing country as well as a breeding country and his latest experiment only goes to prove the soundness of his judgment in the former case. There is another item which has also been proven beyond doubt, and that is that as much and as good corn can be raised in the Panhandle as in any other section of the country. It is now up to the farmers of our country to make themselves independent of the northern buyer by fattening their own cattle and thereby make the profits that have heretofore been made by the feeders of Kansas, Missouri and other states.

New Hunting Law.

Following is the text of the act relating to hunting on private grounds which was passed by the legislature at its regular session, and which will go into effect on June 30:

Section 1. That article 804, chapter III, of the Revised Statutes of 1895, shall be amended so as to read as follows, to-wit:

Sec. 2. Any person who shall enter upon the inclosed land of another without the consent of the owner, proprietor or agent in charge, and therein hunt with firearms, or therein hunt or take any fish from any pond, tank or stream, or in any other manner depredate upon same, shall be punished by fine not less than \$10, nor more than \$100; provided, further, that this act shall not apply to inclosures including 2,000 acres or more in the inclosure.
