In all it gave cause for concern among lawmen and officials, realizing that the Rising Star job could have been a "draw" to attract officers there and leave other banks vulnerable.

Sheriff's deputies, Texas Rangers and other officers left a murder trial in progress in 91st district court to help investigate the Rising Star robbery and join the chase.






