### "How Do You Feel About African Americans Receiving Reparations?"

The NAACP has strongly endorsed H.R. 40, legislation in the U.S. House of Representatives to study reparations for America's enslavement of blacks. The NAACP has placed it at the top of its 1999-2000 legislative agenda. "We need to be pushing the issue, starting a grassroots movement, leading an education and information campaign, and it will happen," says NAACP spokesperson Marie Davis. H.R. 40 would establish a commission to review the institution of slavery and the resulting racial and economic discrimination against African Americans. "The bill would also acknowledge the fundamental injustice, cruelty, brutality and inhumanity of slavery," said NAACP President Kwame Mfume. A lobbying effort and class-action suit is being organized by the Washington, D.C.-based Committee to Support the Reparations Study Bill. ### Civil Rights Community Unites Behind Saving Community Reinvestment Act

Civil Rights groups, led by The Leadership Conference on Civil Rights, are supporting the Community Reinvestment Act (CRA) the U.S. Senate seeks to weaken. The law currently encourages financial institutions to lend money in communities where they are located. CRA laws have been instrumental in stimulating economic development and makes it possible for residents in underserved areas to obtain mortgage, small business and other loans. In 1977, Congress enacted CRA to ensure that banks invest in the communities where they collect deposits. CRA-related investments have helped to revitalize distressed communities, increased rates of black and urban homeownership and grew small businesses.

### Low Down Payments Make Homeownership Easier To Achieve

More first-time buyers are achieving the dream of homeownership than ever before. More than 66.9 percent of American families own homes, as do a record 5.9 million (46.9 percent) African Americans. Much of this advancement toward the American Dream is a result of flexible financing that allows lower down payments. The average first-time homebuyer puts less than 5 percent down at closing. Anyone with an interest in buying a first home whether they have considerable savings or not, should explore the possibilities of qualifying for a loan. The initial investment is often much less than people expect. For many first-time buyers, the key to an affordable home-buying experience is an FHA (Federal Housing Administration) or VA (Veterans Administration) loan. Both types of mortgages require from zero to 3 percent to qualify. Many lenders also offer conventional loans which require as little as 3 percent down. ### A Memorable Kodak Moment

Two thousand Eastman Kodak minority and female workers will receive \$13 million in retroactive and current pay raises after the company settled out of court for past discrimination. In addition to the settlement, Kodak fired a number of supervisors who were connected with the discriminatory and prejudicial treatment that caused the workers harm and Rochester NAACP Chapter involvement after the case was brought to them by workers.

### Talkin' Trash

America produces more garbage than any other nation. The Environmental Protection Agency estimates that, on average, we produce 4.4 pounds of garbage a day for a total of 237 million tons in 1997. The cost of handling garbage is the fourth largest item in many cities' budgets - close behind education, police and fire protection.

### News From Washington: Many Black GOPers Go With Money Man

The wealthiest of the Republican presidential candidates, Malcolm S. "Steve" Forbes, recently named an African American, Ohio Secretary of State J. Kenneth Blackwell, as his National Campaign Chairman. Now, Forbes has named black Omaha businessman Herman Cain as one of his campaign co-chairs. Cain, president of the National Restaurant Association and chairman of Godfather Pizza Inc., has long been active in GOP circles.

## Reverend Al Sharpton One Of 200 Arrested in St. Louis Protest

New York, NY (July '99) - Reverend Al Sharpton, President of the National Action Network (NAN), and one of America's foremost civil rights and political leaders was among 200 demonstrators who shut down Interstate 70 in St. Louis, Missouri, on Monday, July 12, 1999, to protest the Missouri Highway Department's contracting practices.

According to Sharpton and other St. Louis demonstrators, minority-owned companies are being excluded from highway contracts across the country and people of color aren't being hired for construction jobs. Approximately \$130 million is being spent to refurbish Interstate 70, and the state department's 14% goal for minority contracting is not enough for projects in St. Louis, where census figures show the city's population is almost evenly split between Black and white residents. The protest in St. Louis was the largest act of civil disobedience in recent history and will have national ramifications for employment discrimination across the country.

The St. Louis demonstration was part of a series of ongoing rallies that Rev. Sharpton has initiated to protest police racial profiling, corporate racial profiling, police brutality, banking discrimination, and labor

and employment discrimination. Earlier this week, Sharpton and the Mayor of Boston, Thomas Menino, took part in a public hearing to oppose discrimination against minority bankers in the city of Boston where a pending merger between Fleet Financial Group and Bank Boston threatens to isolate minority bankers and customers.

Sharpton has emerged as one of the major political spokespeople for the Black leadership in the country and is an advocate for virtually every significant cause for civil liberty, community empowerment and economic equality. Some of his recent speaking engagements include the keynote address at the NAACP's "Youth Freedom Fund Dinner" on July 14th; an appearance at The Indiana Black Expo on Friday, July 16th; and he addressed the National Bar Association in Philadelphia at the end of the month.

According to Edward Lewis, the CEO and Publisher of Essence Magazine, the nation's pre-eminent magazine for Black women, "Sharpton is the renaissance man and torchbearer for civil rights who will lead us into the next century. He is a man who has evolved from Brooklyn preacher to viable candidate for the U.S. Senate. From local action campaigns against drug



dealers to national projects such as "Second Chance," a program for non-violent felony offenders who have served their prison sentences. People call Rev. Sharpton, because they know he'll listen, and they know he'll act."

Sharpton's National Action Network fights for progressive social policies, economic support for small businesses, and seeks to eliminate economic injustice, political inequity and corporate racism. His efforts with NAN include the first-ever Invitational Summit on Multicultural Markets and Media - held in January 1999 in New York - which brought together more than 200 advertising, marketing and media leaders. The event provided a unique learning opportunity for executives to grow brands and profits in a dramatically changing demographic environment.



This is a photo of Frankie Wise. Frankie is almost 11 years old and has a devastating disease called: Ataxia Telangiectasia (or A-T for short)

This disease is unrelenting. There is no cure and the only treatment is exercise, both physical and mental. A-T has already taken Frankie's ability to walk or stand without assistance. It will soon take his ability to speak clearly, to focus his eyes and read, and will eventually cause him to lose control of his muscles. A-T will render his immune system unable to protect him from the slightest illness. A cold will become life threatening for Frankie.

Frankie comes from a traditional home with a modest income. But A-T has had its impact on that, too. Frankie's family has exhausted their personal funds. They had borrowed to their limits to provide their son with health care needs and treatments before getting a final diagnosis of this devastating illness. Since then, each new stage of this progressive disease has brought additional needs with additional expenses.

From small repairs to large projects, the Wise family worries about his safety in their home as well as his therapy and sanitary needs. Frankie's newly installed handicap accessible bathroom toilet is loosening from the floor and with his increasing need for support must have a permanent and stable handrail. The front door to the home is the only entrance Frankie can use from the driveway where the wheelchair lift van is parked and that door must be widened for his wheelchair. Because his wheelchair gets stuck in the lawn at the bottom of the front door ramp, the concrete driveway must be widened and extended to meet the front porch. Closing in an old patio off the family living room would provide a 6' X 10' computer room to house the computer equipment which is increasingly important to Frankie's education and communication.

His family usually sets up an inexpensive, K-Mart model, 3' deep, straight-sided swimming pool in the back yard for Frankie's water therapy which has always helped him to stretch and exercise muscles that have tightened as the disease has progressed. This summer, the aging pool has deteriorated and this beneficial form of exercise will be unavailable to him.

Frankie has always been an important part of his family. He loves to play games and work puzzles with his brothers. Their home has already undergone simple but expensive modifications just to make Frankie's living environment safer and more accessible for him. But still, doors, rooms and halls have to be widened, weatherized, or converted and special equipment installed for his benefit. The Wise family can't even begin to afford these construction projects. They can only ask others to help with donations, materials, labor and needed equipment to help adapt their home for their youngest son.

## Ask the AG: Y2K Ready

**Q: I read a newspaper article about Y2K issues in the Child Support Division and am now a little concerned. What are you doing to make sure that child support checks are not delayed by the Y2K problem?**

**A:** I am very aware of the concerns that custodial and non-custodial parents have about the Y2K bug and its possible effect on their child support payments. My administration has taken extraordinary steps since January to ensure the child support computer system will be Y2K compliant.

The Texas Department of Information Resources recently announced that the Attorney General's office had been removed from the Y2K "At Risk" list. As of May 1, 1999, the Child Support Division was 96 percent ready. We are estimating that the system will be fully compliant by mid-summer.

We will contract with an independent verification and validation service to test our system over the summer. Through this process, we hope to find and repair any remaining problems with the child support computer system.

In addition to readying the child support computers for the year 2000, we are completing contingency plans for handling any potential Y2K problems with outside organizations linked to our system.

Please be assured that my staff and our consultants will work through the course of the year to ensure that no child support checks are delayed or lost as a result of Y2K.

**Q: My checks are frequently "hung up" in the child support computer system. Why does this keep happening and what are you doing, if anything, to fix the problem?**

**A:** I understand your frustration with the system and the delay you have experienced in receiving your checks. We have already begun to identify and address the problems in the system that cause delays in payment to occur.

The computer programs handling the finances for the child support system are needlessly complicated. The Child Support Division is working on a



plan to revise the system. Our goal is to minimize both the number of checks that get held and the length of time they are held.

We will also change the policies causing payments to be held unnecessarily. Currently, if the computer system shows that no payments are due, the system will either hold any extra money that has been received until the next month or return the payment to the non-custodial parent. This does not allow non-custodial parents to make early or extra payments to their children.

However, the problems with the payment system are not rooted solely in the computer system. In many cases, the Office of the Attorney General is unable to distribute money because we cannot locate the custodial parent or the non-custodial parent in the case of a refund.

Members of my staff have been working to locate parents who have checks waiting for them. When I assumed office on January 1, 1999, the Child Support Division had \$16.3 million in held funds. Since then, we have disbursed \$10.4 million.

Custodial and non-custodial parents should always report address, telephone number and employment changes to the Child Support field office handling their case. This will facilitate the appropriate disbursement of payments.

## 34 Korean Students Visit LCU

LUBBOCK, TX—July 27, 1999—This afternoon 34 students, two sponsors and three radio reporters from the Christian Broadcasting Service—all from Korea—arrived for a two week stay in Lubbock as guests of Lubbock Christian University. The students are all from Korea Christian University a school of about 1500 students located in Seoul. They are here as a part of a program called The American Democracy Bell Program. The aim of the program is to introduce the students to American culture, democracy, and values. The students are housed in Christian homes throughout Lubbock.

## Rep. Jackson Offers Prayers For JFK, Jr.

With a heavy heart, Rep. Jesse Jackson, Jr. today acknowledged the worst — that John F. Kennedy, Jr., his wife Carolyn Bessette-Kennedy and sister-in-

law Lauren Bessette have apparently perished in an airplane accident near Martha's Vineyard on their way to a happy occasion, the wedding of his cousin.

Rep. Jackson said, "It is just beyond belief that tragedy has again struck the Kennedy family. My heart is broken and my prayers go out to both the Kennedy and Bessette families. At this time, I have a special place in my heart for my recent colleague in the House, former Rep. Joe Kennedy and my current colleague in the House, Rep. Patrick Kennedy, and in the Senate, Senator Edward Kennedy.

"We are reminded that the Bible says that 'God will not give you more than we can bear.' Clearly, the Kennedy family has had to endure great pain and suffering. While the weight is often heavy, the burden is made lighter when we can lean on God for strength and guidance, rely on our spiritual strength and call on our faith to sustain us in such trying times. My prayers and the prayers of my family are lifted up for the Kennedy and Bessette families.

"I first met JFK, Jr. at the Democratic National Convention in Atlanta in 1988 when he introduced his uncle, Senator Ted Kennedy, and I introduced my father, the Reverend Jesse Jackson. Most recently, I was with JFK, Jr. about a month ago at the US-Air Arena. We both participated in a BMW-George Magazine co-sponsored fund-raiser — Pils vs. Pundits — during which they faced BMWs on behalf of women's breast cancer research. Even though he had a cast on his leg, we had a great time. We laughed, we talked, we took pictures together, and we talked about serving together for a term on a 9-member advisory policy committee — he was to have been the chairman — at the Kennedy School of Government at Harvard. Senator Kennedy had invited me to serve on the committee and I had agreed to do so.

Jackson concluded, "None of us know what tomorrow holds, but through our faith we can know who holds tomorrow."

### Jackson Introduces "World Tibet Day"

Congressman Jesse L. Jackson, Jr. today introduced H. Con. Res. 136 supporting July 10th as World Tibet Day (WTD). He was joined by a bipartisan group of 24 cosponsors. First organized in 1998, this year's WTD was celebrated in fifty-one cities in ten countries, including thirty-one cities in twenty-one states in the U.S. Last year only five cities participated. Well over a thousand houses of worship of many faith traditions joined the Interfaith Call for Freedom of Worship in Tibet and for Universal Religious Freedom.

Rep. Jackson said, "I hope this Concurrent Resolution will help to stimulate an even broader celebration of WTD in the U.S. and beyond so that many more people will become aware of the plight of Tibetans. Coming from a deeply religious home that placed a high value on human rights, I know that the denial of religious, cultural and political freedom anywhere is a threat to religious, cultural and political freedom everywhere.

"In the 1950s and 60s, when our country was preoccupied with a struggle over civil rights at home, on the other side of the globe the Tibetan people were being invaded, annexed and repressed by the Chinese during this same period. July 10th is linked to the birthday of His Holiness, the Dalai Lama. The spirit and purpose of WTD is to celebrate the unique beauty of Tibetan culture, honoring His Holiness, and making a strong statement for the restoration of religious, cultural and political freedom to the Tibetan people. This is a just cause that the American people must join."

"Since 1950, over one-sixth of the Tibetan population has died — 1.2 million people — and over 6,000 monasteries have been destroyed. In 1960, Nobel Laureate, the Dalai Lama, established the 'Department of Religion and Culture' as part of the Tibetan government-in-exile, to preserve and promote the religious and cultural heritage of the Tibetan people. Tibetans are in danger of having their unique culture, religion and even their lives completely extinguished. The human rights violations committed by the Chinese towards the Tibetan people include torture, arbitrary arrest, and denial of freedom of religion and speech, and Tibetan lands are quickly being overrun by the migration of ethnic Chinese.

"I hope that this resolution will serve to encourage all Americans to remember the Tibetan people who have spent almost 50 years struggling against oppression and trying to spread their message of peace. We should join with them and recognize World Tibet Day through this concurrent resolution as a humble measure of support for their ongoing struggle.

## IN CINQUE

Once again the subject of federal surplus monies has become a topic of discussion. Our Congressmen and women, as well as our executive branch of the government want us to think that there is a surplus of money in the treasury, of which they are willing to set aside a large amount for future Social Security benefits, while at the same time, Medicare funds and benefits have been cut back.

The cutbacks have hurt our senior citizens very much. Social Security and Medicare benefits were designed to help the elderly and the disabled who had worked on a job where they paid into these funds through salary deductions. In many instances, depending on where one worked, the employer paid a portion of the Social Security funds. THESE ARE THE FUNDS WHICH ARE BEING CALLED SURPLUSES!

Treasury surplus is what Congress and the President call the moneys collected from the workers of America through Social Security and Medicare channels. These funds are used in every department of the government where funds are needed. Listen carefully to the media

when there is a discussion of a deficit in the federal government. The first thing one will hear is the need to cut the Medicare and Social Security programs. When the funds have been used for everything else, it is logical to cut the program where the money came from in the first place. So, who suffers? The very people who the fund was intended for, suffer, senior citizens and the disabled, along with children who have lost a parent.

Senior citizens who do not have medical insurance really suffer even when they get the maximum benefits from Medicare, because it does not pay for one of their most expensive needs; prescriptions. A national health insurance for all people, not just the indigent who receive Medicaid would make better use of Medicare money. It would appear that it pays to be poor in some instances. Choices are limited, but the necessity is covered.

The Medicaid recipient can receive physicians' care, hospital care, nursing care and prescriptions, free, but the Medicare recipient, (Social Security recipient) needs a supplemental insurance coverage which at best will pay eighty percent (80%) of some needs and none of others, to survive. It is time that we get 'in cinque' and let our Congressmen KNOW what we need.

## THIS WAY FOR BLACK EMPOWERMENT

### Abolish The FEC!

With all the public furor over campaign finance reform and political corruption, it would also make sense to focus on the regulatory body which is in charge of the entire election process. That body is the Federal Election Commission. And, in a word, this Commission has got to go.

The Federal Election Commission was created in 1974. Its structure and design was controversial, and in many respects, tainted from the very start. It was originally to be a six-member body, with Congress appointing four of the six commissioners, but the Supreme Court invalidated the structure of the Commission on the grounds that it violated the doctrine of separation of powers. Since the FEC is a federal agency, the Executive Branch is supposed to control appointments to it. But when the FEC was set up by Congress to oversee Congressional elections, Congress wanted to choose the people who would be checking up on them. That would have been nice for Congress. But the Supreme Court didn't buy it.

In 1975, the FEC was restructured to have commissioners appointed by the President and confirmed by the Senate. In addition, two non-voting members -- the clerk of the House and the secretary of the Senate -- were added. Obviously, the Democrats and Republicans wanted to hold on to as much control as possible over the FEC.

However, in 1993, the courts struck down the "non-voting member provision" as violating the separation of powers doctrine once again. The FEC had to reconstruct itself for a second time in less than 20 years. By then, it should have been apparent that this was one of the most highly politicized bodies in the history of American government. The folks who make the laws -- all Republicans and Democrats -- are committed to making sure that whatever regulatory body is installed, it will take care of

them, no matter the toll it takes on democracy and the American people.

Today the Commission is a six-member body, made up of three Democratic and three Republican appointees. Any enforcement action undertaken by the Commission requires the vote of a majority of Commissioners -- which means four. Consequently, any time one party or the other wants to block an enforcement action, an investigation, a penalty or a fine, it can do so simply by having the Commissioners vote along partisan lines.

Right now, some Congressional eyes are turning toward the FEC looking for ways to reform it, to make it ever so slightly more balanced and inclusionary. Some of the smarter guys on Capitol Hill have figured out that the contours of American politics are changing and it would be best to be responsive to that. They are feeling the heat from the independent movement. Senator Max Cleland of Georgia has a new bill -- at would give one seat on the FEC to an independent from among the independent parties that garner over 3% of the vote in national elections. Two would go to Democrats. Two to Republicans. Two to non-partisans appointed by the Supreme Court.

The truth about the Federal Election Commission is that it is a complete corruption, and putting independents on it won't cure that problem. We need a regulatory body that is completely independent of government and of the parties. It has to be an independent, non-governmental apparatus, since it supervises the process by which governmental officials are elected. Making it multi-partisan creates the appearance of fairness. But the body which regulates elections shouldn't be partisan at all.

We have to totally abolish the FEC, create a completely independent and non-governmental alternative and turn over any and all investigations it is currently conducting for



review by the equivalent of an independent counsel. I know what it is to be an independent candidate thrust into the investigative net of the anti-independent bipartisan Federal Election Commission. I've been under investigation by the FEC since my 1992 presidential campaign. I have been accused -- and then exonerated -- of being part of a criminal conspiracy to commit fraud and embezzlement of government funds. I've had to supply thousands of pages of documents; contributors to my campaign have been questioned by FEC investigators; vendors whom my campaign hired were subpoenaed for documents pertaining to their private business interests and not the campaign. There have been five years and hundreds of thousands of taxpayer dollars spent on investigating the crime of being an independent.

And I am not the only target. As Reform Party leader Pat Choate said on his radio show, the FEC sends its "auditor dogs" to harass and investigate independents. Ross Perot and Pat Choate have had their share of trouble from the FEC, most notably the FEC's failure to insist that Ross and Pat be included in the 1996 debates.

The FEC has taken a hard line about independents. And frankly, I think the time has come to take a hard line about them. I say this, not in retribution for their bias and harassment, but because the American people need and deserve something far better than the FEC to regulate something as precious to democracy as the process of elections.

**Ask the AG:**  
**Charitable Raffles**

**Q:** My church group wants to hold a raffle as a fund raiser for our youth group's summer trip. I want to make sure that we do not break any laws when we do this. What are the rules for raffles?

**A:** The Charitable Raffle Enabling Act sets out all of the guidelines for raffles in the state of Texas. The Act allows qualified organizations to hold up to two raffles per calendar year. Qualified organizations include religious organizations, volunteer fire departments or volunteer emergency medical services and nonprofit membership organizations that meet certain criteria.

An organization holding a raffle can offer any prize except money. If the organizers are offering a prize which they have purchased, the value of the prize may not exceed \$50,000. If the prize has been donated to the organization, there is no limit on the value.

Prior to conducting the raffle, the organization must have the prize in its possession or it must post a bond for the full value of the prize with the county clerk.

There are certain restrictions on how a raffle may be conducted. A qualified organization may hold only two raffle per calendar year and only one raffle at a time. Raffle tickets may not be advertised statewide or through paid advertisements. Each ticket must state the name and address of the organization, the price of the ticket and a description of the prize offered.

Only members of the organization may sell tickets. The organization may not pay anyone to conduct the raffle or sell tickets. Proceeds from the raffle must be used only for the charitable purposes of the organization.

The language of the raffle enabling act is very technical. If you are considering holding a raffle, you should contact an attorney or check the statute, Article 179f Texas Revised Civil Statutes Annotated, to be sure that you qualify. To request a copy of the statute, contact the State Law Library at (512) 463-1722 or go to their Web site at [www.sll.courts.state.tx.us](http://www.sll.courts.state.tx.us). In addition, my office has published a Charitable Raffle Brochure. Call us at (512) 4754413 to request a copy.

**Q:** I am so confused. I have heard that "8-liners" are illegal. I even heard the Governor talk about how they should be illegal. yet the gas station down the road has several of them that people play all the time. Are they allowed or not?

**A:** Eight-liners, or video slot machines, as they are generally operated in Texas are illegal under the laws prohibiting gambling. Each case requires an investigation to determine how the machines are

being operated at a particular location.

Under Texas law, a machine that requires the player to pay money for the chance to win a prize of value is a gambling device. The value of the prize does not affect the legality of the machine. Because most 8-liner machines pay out coupons or vouchers redeemable at local stores or for more games, they are considered gambling devices.

By contrast, a pin-ball machine is not considered a gambling device because all it pays out is credits for

more chances to play, and these credits must be used at the time of play or else be forfeited. Texas law provides for the appropriate County or District Attorney to have original jurisdiction to pursue possible violations of the law, including violations involving 8-liners. Many times, local prosecutors are not aware of the existence of 8-liners and rely on citizens to bring the machines to their attention. If you have concerns about the illegal operation of 8-liners in your area, contact your local prosecutor for assistance.

**1999 ELIGIBILITY REQUIREMENTS FOR DESIGNATED MINORITY REPRESENTATIVES ON THE SPAG BOARD OF DIRECTORS**

- Must be a member of a racial minority and a resident of the geographic area he/she is elected to represent
- Must be eligible to hold a public office established by the constitution of the State of Texas (citizenship, age, criminal record, etc.)
- May not be an employee of any private organization which receives funds from SPAG
- Must be able to attend regular monthly meetings of the Board of Directors on the morning of the second Tuesday each month

There are 38 seats on the SPAG Board of Directors. At least 25% (10 members) of the Board must represent racial minorities of the region. There are currently four minority elected officials on the Board who are not holding designated minority slots. There are 6 designated minority seats on the board to be selected for two year terms beginning on October 1, 1999.

Representatives to be selected are as follows:

- Bailey, Cochran, Lamb, and Yoakum counties - currently represented by Van Ashley of Littlefield
- Hale County - currently represented by Mei Gomez and Daniel Rascon of Plainview
- Hockley and Terry counties - currently represented by Rudy Dominguez of Sundown
- Lubbock County - currently represented by Virginia Alamanza and Charles Planks

## from the Desk of Parson D.A. Smith

"Facing Our Fears" cont.

"When Jesus heard it, he answered him, saying, Fear not: believe only, and she shall be made whole."—Luke 8:50

Everyone experiences problems in his or her life. Jairus was no different. When he found the Lord, a great number of people were around him. In desperation Jairus humbly called out to Jesus, "My little daughter lieth at the point of death: I pray thee, come and lay thy hands on her, that she may be healed; and she shall live."

Jesus responded to the father's cry for help, and together they began to walk to the home of Jairus. However, a woman needing a touch from the Lord interrupted their journey. Jairus must have been growing impatient as hope slipped away with every passing second.

While Jesus spoke with the woman, a messenger arrived from the house of Jairus. He brought the sad news that Jairus daughter was dead.

Jairus's faith now was put to a crucial test. He had approached Jesus publicly; believing that Jesus could help him in his need. Instead of finding his predicament resolved, however, Jairus saw it take a cruel turn for the worse and end in the very thing he had tried to stop from happening—death. With his hope apparently smacked, would Jairus give up in despair; or would he maintain his faith?

Jesus spoke, "Fear not: believe only." Christ understood that Jairus was in danger of falling prey to his fear. He also knew that when fear dominates a person, trust in God becomes impossible. When Jesus directed Jairus to believe, He was indicating that He was to be the object of trust. Christ was saying that if Jairus could trust Him, all fear would be removed. Jesus promised that if Jairus would place his trust in Him, He would alter the circumstances.

Jairus evidently held on to the hope that the Lord held out to him. We read that Jesus continued on to the home of the ruler of the synagogue. He entered the house and proceeded to bring

the girl back to life. He presented her to her parents and "charged them that they should tell no man what was done."

Jairus learned that when difficult situations arose, he needed to maintain trust in the Lord. When major problems confronted him, he needed to believe in the Lord. Jesus was there when Jairus was facing his terrible crisis. Jesus remained with Jairus and provided comfort for the duration of the crisis.

The words that Jesus spoke to Jairus centuries ago are still beneficial when we go through the trial: "Fear not: believe only." The world may be skeptical, but believe. When our circumstances causes us to be fearful and dismayed, believe. When hope seems shattered and human encouragement is not there, trust in the Lord. He is always there to uphold us and to give us the courage we need to face our greatest fears.

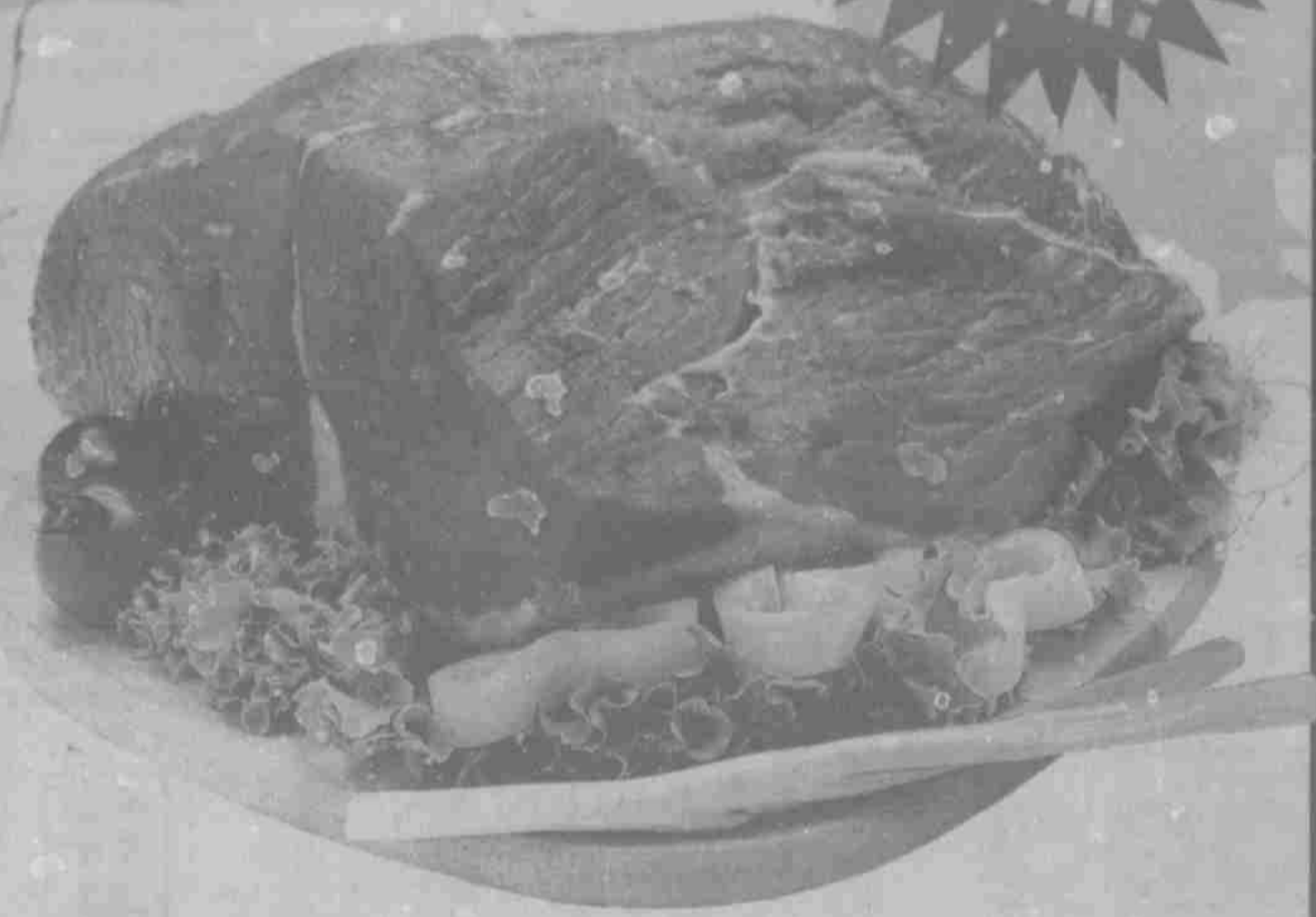

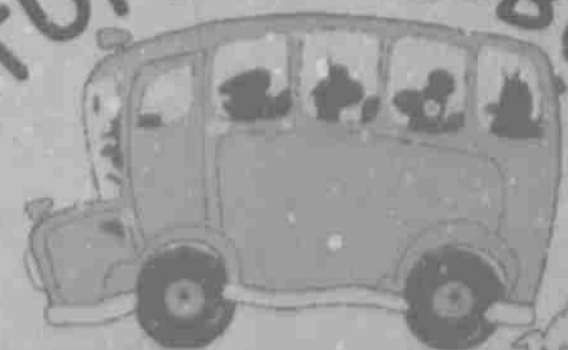
