FIGHT IN MAJOR LEAGUES TIGHT AS YANKS LEAD

RACE IN JUNIOR LOOP SEEMINGLY FOR 2ND PLACE

Seldom in the history of major league baseball have the races in both American and National leagues been so close as they are today. In the American, however, the race appears to be for second place.

Cincinnati leads the National, four and one-half games ahead of New York. But the Giants are in sixth place and in between are Pittsburgh, St. Louis, Chicago and Brooklyn. In the American, New York has a margin of nine and one-half contests over second place team, Cleveland. The Indians are only three games ahead of Detroit in sixth place.

Yesterday the Giants, who once again have become threatening and have traded Billy Southworth, outfielder, to St. Louis for Helme Mueller, also a fly chaser, lifted Cincinnati again, this time by four to three. Paul Florence sent forth a triple in the final inning to break a deadlock. Ed Foush leaped for the ball, touched it and then ran to the clubhouse. Pete Donohue was the loser. Hoagy hitting by the Brooklyn outfit gave the St. Louis Cardinals, 8 to 5. Babe Herman, turned back by Minneapolis this season because there was no room for him, inserted a valuable double and later a home run.

Pittsburgh, with Emil Yde left-handed, ran into trouble at Boston, three singles and a triple giving the Braves three runs in the fifth while the Pirates could score only twice.

Four homers by the Chicago Cubs, two by Stephenson, formerly of Cleveland, and one each by Wilson and Hartnett, accounted for a victory over Philadelphia, 9 to 7. Wright came out of the Philadelphia pen to hit the circuit.

Babe Ruth hit his twenty-second homer at St. Louis and now is one behind his record of 1921. But the Yanks lost, 7 to 3, and the late injured one of his knees in pursuing a fly ball.

Cleveland gained second place in the league by taking the third in a row from the Athletics and the seventh out of nine from Eastern teams, 6 to 5.

SECRETS OF STARS ON INSIDE BASEBALL

as told to BILLY EVANS

The most difficult play a third baseman must make? Well, that is merely a matter of opinion.

To my way of thinking, it is the handling of a swinging bunt down the third-base line. Now to illustrate: Let us suppose the batsman is a slugger, fond of pulling the ball down the third-base line with great speed. Such a type hitter is Harry Heilmann, champion batsman of the American League.

When batters of the Heilmann type are up, it is customary for the third-baseman to play deep, largely as a matter of self-preservation.

We will assume that Heilmann, after taking a healthy swing at the ball, merely tops it. The result is usually a slow bouncer in the direction of third. The fact that the third baseman is playing so deep is what makes the handling of such a ball so difficult.

In making this play, the moment the ball has been topped I rush in with all speed, keeping my eye on the ball. When I believe the proper time has arrived to execute the play, I make a sweeping downward motion with my right hand.

If I have properly judged the bunt and am favored with good luck, I come up with the ball, which, however, is merely the beginning of the play. The more difficult part is just ahead.

To get your man at first it is necessary that you make a speedy and accurate throw to that base. This must be done while on the run and without straightening up to get set for the throw. Such a delay would invariably result in the loss of the play.

The fact that such a play is the exception rather than the rule adds to the difficulty of successfully executing it. To overcome this, I make it a point to try to handle a dozen such batted balls in practice every day.

There are women players who go up to the ball and putt without any hesitancy. The results are so good at times that it makes the ordinary mortal wonder—whether she ought to adopt a similar casual manner, but in the long run a constant combination of determination and concentration on the green will reap its reward. Speaking of my own experiences I am convinced that my mind is not on the task in hand half the time. I am endowed with a particularly keen sense of hearing and, when playing before a crowd, I constantly find myself listening to whispered remarks when I should be concentrating to an extent which would make this eavesdropping impossible.

I am constantly asked why I do not learn to putt, but few people realize how difficult it is to practice this part of the game. To my mind there is nothing simpler than to put approach putts stone dead and hole out with regularity from a reasonable distance when nothing is dependent upon the result.

It is a very difficult story in an important event, for then the yard putt is doubly difficult and the long approach putts become terrifying.

They abruptly refused to renew his contract and foreclosed. Magee was compelled to sell.

Started Weekly Paper

But a few weeks later he had built, editing a weekly paper called the Independent which he published daily under the name of The New Mexico State Tribune. He sold stock in the hands of the state and got an instantaneous response.

Just at this time Magee took over the reins of the Independent. He was a critic of Justice Parker of the state supreme court. A criminal trial was brought against him—but lost by Parker, who later said he did not believe the essential facts of Magee's libelous. And Magee was tried not in the home county, but in the distant county of San Miguel, before his bitter enemy, Judge Leahy.

The jury was composed of 12 Mexicans who could not find the sentences they were expected to pass on Magee. In fact, in Magee's favor, the jury returned a verdict that each man was to give the time to get new ones. Naturally, he was convicted.

Magee expressed his mind about Judge Leahy; expressed it so vehemently that Leahy cited him for contempt of court, on five counts. He ordered Magee to \$100 for 10 months. The state, who wanted to keep Magee in prison, ordered a writ of habeas corpus. The writ was granted, and Magee was released. It was then that Magee struck at Leahy's liberal administration, but it was a momentary discovery.

When Magee bought the Albuquerque Journal, Fall told him he was broke. Now, four years later, Magee found that ten years' back taxes on the paper were paid up, that extensive improvements had been made and that a general air of great prosperity had developed on the place. He gathered evidence, documentary and verbal, and in a short time went to Washington, where he told the Senate investigating committee enough to

Former Arkansas Official Is Taken Back To His State Penitentiary As Extradition Fight Lost At El Paso

(By the Associated Press)

EL PASO, June 15.—W. H. Hall, former chairman of the Arkansas State Board of Control, left here for the Arkansas State penitentiary this afternoon in custody of J. R. Henson, Arkansas state penitentiary. Sat. following his three and a half months fight against extradition proceedings.

Henson took Hall into custody this morning after Judge P. R. Price, of the Forty-First District Court, refused Hall's application for a writ of habeas corpus.

Convicted in Arkansas

Hall was convicted in Arkansas on a charge of embezzlement and sentenced to three years in the penitentiary. He was pardoned by Acting Governor S. B. McCall during the absence of Governor Terrell from the State, but must return and serve the remainder of his sentence, the Supreme Court holding that the pardon granted by McCall was invalid.

Hall was first arrested in El Paso February 23, as a fugitive from justice. The same day, he was released under \$1,000 bond to appear for hearing March 3.

March 4, on learning that Captain D. Horton, of the Arkansas State penitentiary and Henson were in El Paso trying to locate him, Hall surrendered to the sheriff. Immediately following his surrender, Hall filed a petition for a writ of habeas corpus before Judge W. D. Howe, of the Thirty-Fourth District Court. Judge Howe took the petition under advisement, pending action of the Governor on the deposition of testimony by authorities, and released Hall under \$1,000 bond.

Bond Is Withdrawn

Hall's bond was withdrawn March 4, when he was lodged in jail where he remained until yesterday, when he made his final attempt to obtain liberty on a writ of habeas corpus.

Hall made every effort to block extradition. When Arkansas authorities asked Governor Ferguson for extradition papers in his case, Hall and his attorney spent several days in Austin in a fruitless attempt to prevent the Governor from signing the papers.

While at liberty in El Paso, Hall was in hiding and refused to divulge where he lived. All officers of the Arkansas and El Paso detectives to find him were futile.

Watson-Parker Group Is Appointed Monday

WASHINGTON, June 15. (AP)—Four of the five members of the Board of Moderation under the new Watson-Parker railway labor act were nominated today by President Coolidge.

Those whose names were sent to the Senate were former Representative W. S. Winslow, of Massachusetts, for a term of five years; former Governor Edwin P. Morrow, of Kentucky, for four years; S. G. Hanger, of the District of Columbia, for two years, and Hywel Davies, of California, for one year.

Morrow and Hanger were members of the railroad labor board, abolished by the act which created the mediation board. Davies is a consultant in the Department of Labor. Winslow is a former chairman of the House Interstate Commerce Commission.

O'Connor Approved For Shipping Board

WASHINGTON, June 15. (AP)—Renomination of T. V. O'Connor, and the nomination of Jefferson Myers of Portland, Ore., to membership on the Shipping Board were approved today by the Senate Commerce committee. O'Connor is now chairman of the board.

Chairman O'Connor, whose term has expired, was re-nominated last week. Myers had succeeded Hart E. Halsey, Democrat, also of Oregon, who resigned.
