Pioneer Printer Appears In City

Three decades and more ago a country lad from Fisher county, with a little experience in the printing trade as it was in that day, landed in Abilene, set up a small foot-pressed press with a "shirt-tail" full of type in a space 14 feet square.

A man was operating a weekly newspaper in Abilene, the Reporter. His business was going to pieces. Presently he found the boy printer was cutting into his job printing business. So he hired the boy at \$40 per month.

Soon the proprietor of the newspaper had to make an assignment to his creditors. The creditors hired the Fisher county boy to operate the paper for the remainder of the year.

At the year's end \$400 profit was reported to the creditors.

They sold the paper to him at a high rate of interest. It took him years to pay it out completely but in doing so he laid firmly the foundation of what today is one of the strongest newspapers in Texas, as well as one of the largest commercial printing and office supply businesses.

The Fisher county boy has taken on a few gray hairs. He no longer actively edits the newspaper—the Abilene Reporter—and its companion paper in the morning field, the Morning News, but he still is active head of the Abilene Printing and Stationery company.

George S. Anderson has through the years established a dramatic and praiseworthy record in business—a business which has been always securely entwined in West Texas development, and has also been a leader as a civic worker, a churchman, a philanthropist. As a regent of Simmons university, and, even more successfully, as the leading figure in establishment and operation of the West Texas Baptist Sanitarium he has left his mark indelibly upon West Texas.

Mr. Anderson was one of the speakers at Friday afternoon's session of the West Texas Press Association here.

Chairman W. A. Paddock of the Harris County Red Cross appealed for immediate fulfillment of the \$10,000 relief fund quota. Less than \$5,000 had been subscribed.

Meantime, improved conditions were noted in the stricken coastal area encircled by the Brazos river, which the early Spaniards called El Brazos Del Dios—"The Arms of God."

There were no additions to the death list of 41 persons. The emergency crops of physicians and nurses had adequate supplies at hand with which to treat the injured.

By order of Governor Sterling, the national guard division camped at Palacios sent teams to shelter the homeless. Other army teams were sent from Fort Crockett at Galveston.

Bandit Gasps Name, Dies Of Gun Wounds

Slain Fugitive Identified As W. T. Prater Of Dallas

MARSHALL, (AP)—A bandit who gasped his name to officers died here as police and deputy sheriffs from two East Texas towns and from Shreveport, La., surrounded his companion in a thick and captured him.

The slain fugitive was identified as W. T. Prater, Dallas police officer, and officers said his brother was his aide in the robbery of the W. T. Peyton Drug Store of Shreveport. The captured man insisted his name was H. T. Taylor and maintained his home was in Iowa.

Prater died in a hospital late yesterday after being wounded in the head during a gun battle with two deputy sheriffs. The fugitive pair opened fire on the officers, Chief Deputy Sheriff John Henderson and Ellis Johnson, when they were approached at a West Marshall gasoline filling station for questioning.

The marksmanship of the bandits was ineffective. Henderson's first shot punctured a tire on the bandit car and in the rain of bullets that followed the car was struck three times. Prater crumpled over the wheel when struck in the head. His companion took the wheel from him and attempted an escape.

Later the blood-stained automobile was discovered and in it the dying fugitive was intensified when George Chastain returned here and told officers of having taken a man four miles out of town in his automobile. He said the man pleaded his mother-in-law was injured in an automobile accident, but later became suspicious of his passenger and forced him from the automobile.

The fugitive escaped capture but four hours. He came from the thicket, his hands above his head and pleaded he was not harmed.

The Peyton Drug Store was robbed early yesterday of \$25 and quantities of morphine. Nearby towns were advised of the theft and descriptions of the bandits were flashed to city and county officers in East Texas and counties nearby to Shreveport. Longview officers assisted in the manhunt when it was determined the fugitive was surrounded.

Henderson and Johnson had been furnished this information and were in search for the fugitives when they came upon the two men.

Shreveport officers and Peyton identified the men as the robbers. Marshall police said. The captured bandit was returned to Shreveport today for questioning in connection with the robbery.

Olton Jury Gives 5-Year Suspended Term For Murder

OLTON, (AP)—A five year suspended sentence was given Friday to Ivan Inklebarger by a jury which convicted him of murder in the shooting of John Lee near Littlefield last October.

Inklebarger claimed that Lee, who at one time was employed on his farm, had alienated Mrs. Inklebarger's affections.

Flyer Stays 24 Hours In Small Plane

Good Landing Made At Saint John, New Brunswick; Fuel To Spare

ST. JOHN, New Brunswick, (AP)—Captain J. A. Mollison completed the first westward solo flight across the Atlantic Friday, bringing down his small sports plane in a perfect landing at Penfield ridge, forty miles from here.

He said he had plenty of gasoline and might have gone to New York but he was too tired to do more flying. He had been at the controls more than twenty-four hours, sitting in an uncushioned seat, pushing the flying gasoline tank across more than two thousand miles.

He said he intended to stop at Harbor Grace but got better mileage than expected and passed on. Mollison was well over Halifax airport at 5:05 a. m. Friday, a hundred miles east of here. He was lost sight of for a time in a fog blanketing the Bay Fundy region.

Frank Kelly, of the Magnolia Petroleum company land department, an old friend of Mr. Mooney, led in the funeral arrangements. With other oil field men who were here for the funeral he paid tribute to Mr. Mooney as "a real old-timer who could go through the toughest fishing job, the coldest night with a smile. He had been in the oil game forty years and you'd have to hunt forty years to find a man who was ever greeted by him without a smile. He was a good citizen, a lover of children. Men in every part of the world, wherever bit dig for petroleum will be saddened by his death."

Thompson For Retention Of Per Well Plan

Candidate At Tyler Indicates Allowable Ought To Be Raised

TYLER, (UP)—Strict adherence to the per well basis of oil production and indication the allowable should be raised was made here in a campaign address by Col. Ernest O. Thompson, former mayor of Amarillo, and candidate for the railroad commission.

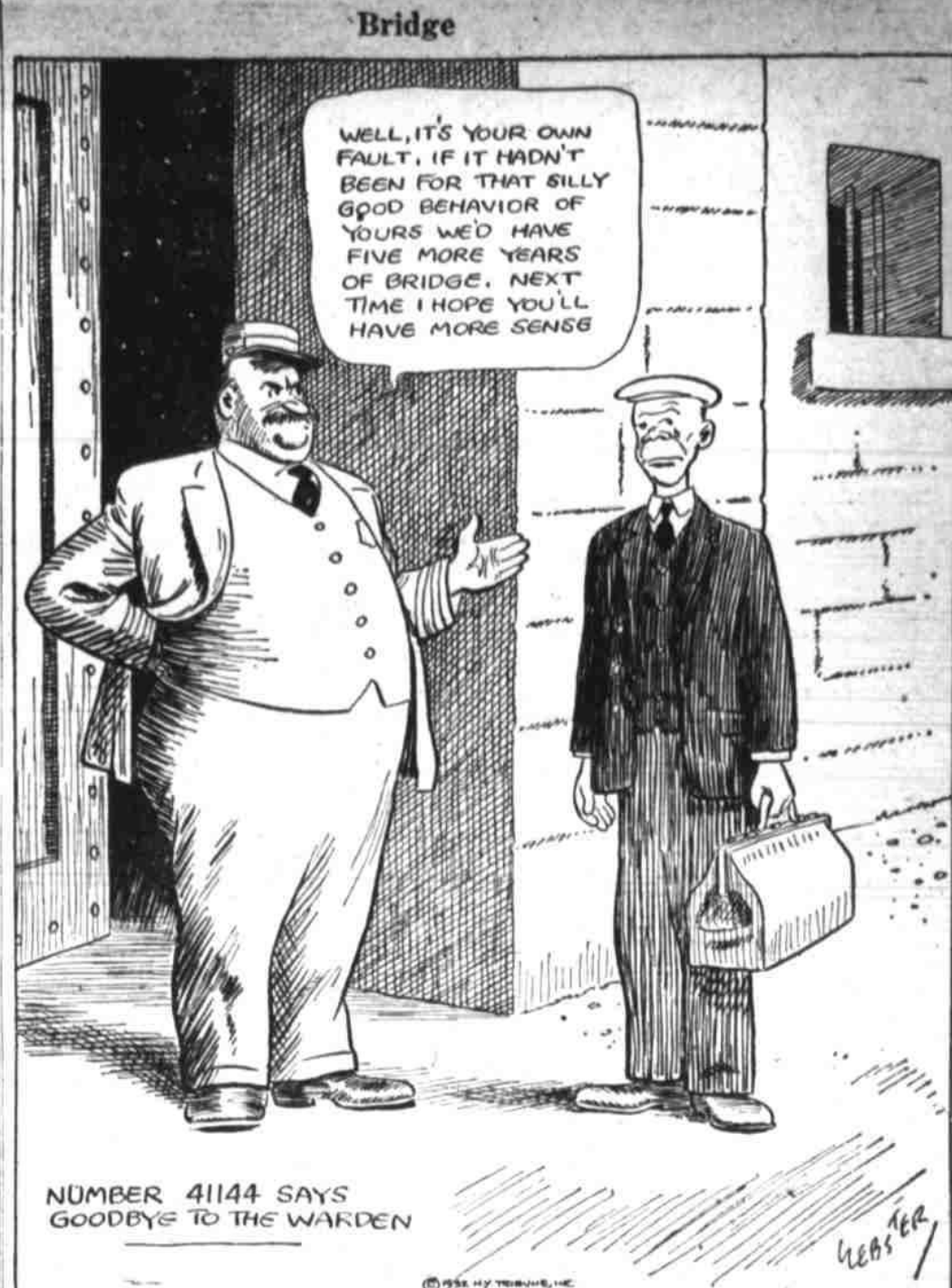

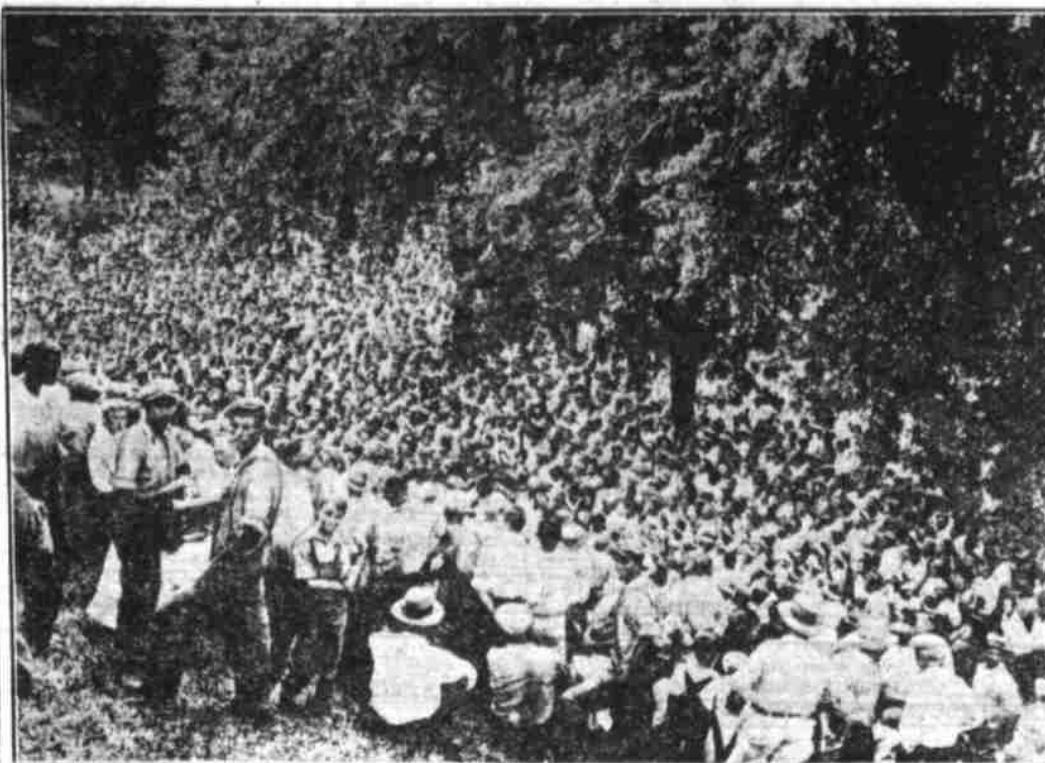
Allison Defeats One, Erstwhile Low Ranker Handles Another

Salvaging Of 200,000 Child Nomads Urged

Social Welfare Agencies Being Marshaled At Washington

WASHINGTON (UP)—The federal government is in the midst of a vigorous campaign to rally all social welfare agencies to the task of salvaging the 200,000 members of America's army of nomad children. The factor of time is all-important in this struggle, officials say, because if the wanderers are allowed to remain too long on the road they will become confirmed in the ways of the hobo and are likely to form a permanent army of social parasites. Using the double-edged sword of research and publicity, the children's bureau of the department of labor hopes to arouse cities and states to the gravity of the plight of 200,000 minors driven from their homes by the business depression.

"A campaign of publicity is needed," said Dr. A. W. McMillen of the University of Chicago, who did field work for the children's bureau. "We must impress parents and teachers with the suffering and hazards the boys face. We also must have a national remedy. There should be a national transient service fund to be allotted to towns and cities which can prove that they have a transient problem they cannot meet unaided."

Circular
McMillen approved of a circular sent by Postmaster General Brown to be placed in all post offices, warning minors of the dangers of leaving home with no job or set destination in view.

"In Colton, Cal.," he continued, "a citizen impressed by the plight of the boy wanderers set aside a field for a 'jungle.' Neither local nor railroad police are allowed to enter it."

The children's bureau makes these suggestions:
"Additional research would be of relatively little value. The need is for action. The situation calls for two types of community activity—one preventive, one protective. The object of the preventive campaign is to induce boys to remain at home. Every boy persuaded to stay at home is a clear gain from his own and from the public welfare point of view. All social workers may help by bringing personal influence to bear upon boys who show signs of restlessness. In all publicity on this subject great care must be taken to hob the 'open road' of the glamor which it naturally holds for the venturesome lad."
