## Styles Of Paris Are Denounced

SHORT SKIRTS WIN IN VOTE TAKEN BY NEW YORK CLUB WOMEN

(By Associated Press)  
NEW YORK, Dec. 12.—Foreign entanglements in the form of the long skirts decreed by Paris style dictators have been denounced by New York club women.  
After hearing the skirt debated at length yesterday at a meeting sponsored by the New York State Federation of club women, the 600 delegates indicated by applause their approval of a statement that "American women cannot be dictated to by a small coterie of meal ticket seeking Frenchmen in Paris."  
Six models, three dressed in the short skirts of last year and three in the new longer style, were called to the platform. The short skirts won a popularity vote from the audience.  
Gertrude Lawrence, English actress, wearing a skirt 12 inches from the floor, defended long skirts. She said:  
"The new styles with their long graceful lines are more aesthetic, they are easier to look at, and that should be a determining reason for us."  
Rita Weisman, short story writer, arrayed in a frock which was 17 inches from the floor, voiced the declaration of American independence of Paris style-tyranny in a speech championing the short skirt. She said:  
"My task is almost hopeless. I am pitted against the entire world of fashion and commerce. But we must fight. After years of comfort we find ourselves trying to manipulate dresses that drag on the dance floor."

# WARRANT ISSUED FOR CALLES

## VALLS PLANS TO CARRY OUT MURDER COUNT

LAREDO LAWYER SAYS JUSTICE MUST BE SERVED IN CASE

(By Associated Press)  
LAREDO, Dec. 13.—Sheriff A. J. Condon of Webb county today had a warrant for the arrest of Plutarco Elias Calles, former president of Mexico, charged here with conspiracy in the murder of General Lucio Blanco and Col. Aurelio Martinez seven years ago.  
Calles is expected to pass through Laredo en route to Mexico after a tour of Europe and the United States.  
District Attorney John A. Valls has written a letter reviving to one from American Consul Richard F. Boyce in which Boyce requested immunity from arrest for Calles on diplomatic grounds.  
Consul Boyce, at Nuevo Laredo, Mexico, had informed Valls at the request of the state department that Calles had been issued a diplomatic passport by the Mexican government, that the passport had been used by the American government and that the president of the United States recognized the diplomatic status of General Calles.  
Valls, in his reply to Boyce, declared that the passport was a false one and indefinite to form the basis for a definite answer.  
"When the president of the United States called upon the American people to stand by constituted authorities in the enforcement of laws, he penned no idle platitudes. Surely the president of my country

# SLAYER FOUND DEAD IN CELL

After expressing disgust with a jury for not condemning him to the electric chair Tuesday, Clay Lester, 36, committed suicide by hanging himself this afternoon, shortly before 2 o'clock, in the Lubbock County jail.

The self-inflicted death was affected by tying his belt to a water pipe near the ceiling of his cell and falling down, knees bent, until the leather thong had choked him to death. He did not have room for his feet to fall unsupported between the pipe and the floor.  
He died with his face to the wall, and was found by Will Ernest, deputy sheriff and jailer.  
A note addressed to R. B. "Blackie" Lester of Lubbock, a brother, read: "Please take charge of all I have."  
Mr. Ernest called Dr. J. W. Rolfe but the convicted prisoner died before the physician arrived.

## PROBE MADE OF ATTEMPT TO ASSAULT

LUBBOCK YOUTH BEING INTERROGATED ON CASE HERE

District Attorney Durwood Bradley is making an investigation today into an alleged attempt of a Lubbock youth to commit an assault upon a 10-year-old girl, a pupil of the Central Ward school.  
The prosecuting attorney announced this afternoon that he was yet to have sufficient information upon which to base a charge, following an interrogation of two youths arraigned in City corporation court last night about 12 o'clock.  
Case Is Probed  
City police started a probe of the case late yesterday, after the child's mother had reported that her daughter had been enticed by the youth man. The child stated that the youth had pleaded with her to enter the house where he rooms, while she was returning from school. She later located the house for officers and accused one of two roomers who were arraigned in city court.

## BRIEF FACTS ON LESTER'S CASE

It was at 10:30 o'clock on the morning of Thursday, October 24, that Clay Lester shot his estranged wife, Mrs. Virgie Lester, 36, only a few hours after she had filed a complaint against him for aggravated assault. The shooting occurred at her residence, 413 Avenue H.  
Following the shooting Lester surrendered to Sheriff Wade Hardy.  
District Attorney Durwood A. Bradley, on Friday, Oct. 25, announced that he would fight any effort for Lester to get out on bail.  
The Lubbock county grand jury was empaneled on Monday, Oct. 28, and immediately began an investigation of the shooting. An indictment was returned late Monday afternoon charging Lester with murder.  
Date for Lester's trial was set for Monday, Nov. 4.  
Attorneys for Lester entered plea for Habeas Corpus hearing in an effort to get him released on bail. This hearing was held on Friday, Nov. 1.  
Judge Clark M. Mullican refused Lester freedom on bail at the close of this hearing.  
A plea for continuance until the next term of court was granted on Thursday, Nov. 7. Date for trial was set for Monday, Dec. 2.  
Lester went to trial December 2 after another continuance plea was denied.  
Was convicted and given life sentence, December 10.

# COWBOYS TO LAY PIONEER IN HIS TOMB

COL. GOODNIGHT TO BE BURIED SATURDAY; MANY TO ATTEND

AMARILLO, Dec. 13.—Cowboys four of whom worked for Col. Charles Goodnight more than 30 years ago, and all of whom have worked on the famous JA ranch here founded in 1876, will be pallbearers when the frontiersman is buried at his old home in Goodnight, 45 miles southeast of Amarillo, Saturday afternoon.  
The body of the 83-year-old pioneer, called "The Father of the Panhandle," will arrive in Clarendon early Saturday from Tucson, Ariz., where he died yesterday. There it will lie in state at the residence of J. W. Martin during the morning, and then it will be taken overland to Goodnight.  
The Pallbearers  
The pallbearers will be Joe Horn, M. E. Bell, Wint Bartfield, Jim Wilson, Lou McClelland and S. E. Johnson.  
Funeral services for the pioneer were expected to bring about the greatest gathering of "old timers" ever seen in the Panhandle, as many planned to come from all sections of the southwest to pay tribute to the man who was their leader for more than half a century.

## MINE STRIKE IS SPREADING TODAY

SPRINGFIELD, Ill., Dec. 13 (AP)—Mining coal in Illinois today was a mixture of strikes, legal maneuvers aimed at President John L. Lewis of the United Mine Workers of America and measures by enforcement officers to arrest strike leaders on charges of inciting to riot.  
Since the beginning of the strike Monday, the National Miners Union, which called it, has been successful chiefly in Christian county, where picketing has been concentrated. Its announced plan to picket the Panther Creek mine at Auburn yesterday was abandoned when policemen kept the highway clear. The union transferred its campaign to two mines at Pana with the result that miners there endorsed the strike.  
The Belleville district, employing between 8,000 and 9,000 men, was marked for picketing today.

The Ganns were estranged, police said, and Gann had threatened the life of his wife and their two children.

## Western States Have Weather Variation

DENVER, Colo., Dec. 13 (AP)—The weather gods of the Rocky Mountain region today gave full vent to their chameleon tendencies, afflicting Montana with 6 below zero temperatures while favoring Colorado and New Mexico with spring-like balminess.  
After Montana had experienced a brief visit from spring, winter rushed back and covered the country with ice and snow. In the vicinity of Great Falls the mercury hovered near or below the zero mark.  
Indications the Montana storm was moving south were seen, with snow predicted for northern Wyoming today.

## Non-Stop Hop Over Pacific Is Planned

SEATTLE, Wash., Dec. 13 (AP)—The Pacific and Aeronautics research foundation, recently organized, will sponsor a non-stop flight across the Pacific from Tokyo to Seattle next May, Dr. Alexander Grinstein, head of the organization, announced today. The foundation has signed Pilot Bob Wark to attempt the 4,800 mile hop in competition for a \$25,000 prize raised several years ago. A specially built cabin type monoplane has been ordered, members of the organization said, for delivery about February 1.

## GOOSE CREEK YOUTH KILLED IN ARGUMENT

JACK BRASHEAR NAMED IN DEATH OF CARL RAYNER, 15

(By Associated Press)  
GOOSE CREEK, Dec. 15.—Jack Brashear, 14-year-old school boy, was free today on \$500 bond, under orders to report for a preliminary hearing in connection with the death of his school mate, Carl Rayner, 15, who died last night of concussion of the brain.  
Rayner was killed, witnesses said, when he was knocked to the ground during an argument over a basketball game. Physicians said his head apparently hit some hard object. Justice of the Peace Flowers, who held the inquest into the death of Rayner returned a verdict of "death due to a blow on the head inflicted by Jack Brashear."

## Doheny's Trial Is Set For March 10th

WASHINGTON, Dec. 13 (AP)—Date for the trial of Edward L. Doheny, oil magnate, on a charge of bribery was set for March 10 today by Justice Hitz in District of Columbia Supreme Court.  
The indictment against the oil man is one of the series growing out of oil leases made during the Harding administration. The charge is that Doheny gave Albert B. Fall, former secretary of the interior, a bribe of \$100,000 in connection with the lease to Doheny's company of the Elk Hills Naval oil reserve in California.  
Fall was recently convicted on the charge of receiving the \$100,000 from Doheny and was fined \$100,000 and given a suspended sentence of a year in jail.

## MEXICAN BOY FATALLY HURT

LAMESA MAN'S CAR STRIKES TRUCK NEAR CITY

One Mexican was killed and another painfully injured when a car, driven by R. B. White of Lamesa, struck the victim and crashed into the rear end of a parked truck 13 miles northwest of Lubbock on the highway near Shallowater last night at 7 o'clock.  
Isabel Garcia, 6-year-old son of Tancito Garcia, of San Antonio, died at the Lubbock sanitarium before emergency treatment could be rendered, while Mrs. Frank E. Garcia, 21, a sister-in-law of the child, is recovering today from injuries sustained in the mishap.  
Mother Hurt  
J. E. Hill and A. D. Pace, of Lubbock, picked up the two and rushed them to the sanitarium, where he died a few minutes later. Mrs. Garcia sustained fractured ribs.  
Mr. White, who was accompanied by Larry Hill and H. S. Fair, also of Lamesa, told officers here last night that they were blinded by the lights of another car when the accident occurred.

## THIRTY-YEAR-OLD SCIENTIST CLAIMS ISOLATION OF GERM CAUSING INFLUENZA; VACCINE DEVELOPMENT MAY RESULT

CHICAGO, Dec. 13.—A 30-year-old scientist, Dr. Isadore S. Falk of the University of Chicago, has announced the successful isolation of the germ that causes influenza.  
Dr. Falk, professor of hygiene and bacteriology, began his search for the influenza germ a year ago and succeeded in isolating it September 30. During experiments, it was learned, the 13 co-workers, as well as Dr. Falk himself, were victims of the disease.  
Hope was expressed that vaccine or anti-toxin might be developed that would bring influenza and certain types of common colds and bronchitis under control.  
The influenza germ, Dr. Falk said, is of the pleomorphic streptococcus type, resembling a string of pearls not well matched. The germs colonize in clumps rough and smooth. The rough clumps are the more virulent. The smooth ones produce common colds of the sore throat type.  
Samples of the blood and string of pearls were matched with patients, Miss Ruth A. Kinney, were used at the start of the experiments these revealed many varieties of germs. After continued investigation suspicion centered upon one, and experiments were conducted with it, convincing Dr. Falk this was the germ responsible for the disease.  
The germ, Dr. Falk said, will not prove fatal in itself, but the disease for which it is responsible weakens the patient in many cases so that he falls victim to other, deadlier, germs. Zavisfilone isolated germ Dr. Falk and his associated conducted experiments on small animals, producing

### NEW AIR MAIL NET PLANNED

#### VAST SYSTEM OF LINES OVER NATION ASKED BY DEPARTMENT

(By Associated Press) WASHINGTON, Dec. 13.—A vast work of new air mail lines, including a new trans-continental route, was recommended today to the post office department by the interdepartmental committee on airways.

The new lines will not be placed in operation for some time, however, as the routes will have to be lighted for night flying. Bids will be asked for the routes as soon as practicable.

**Stops Not Chosen**  
The new transcontinental line will run from Atlanta to Los Angeles with stops at Birmingham, Ala., Jackson, Miss., Shreveport, La., Dallas, Fort Worth, and El Paso, Texas and San Diego. A stop will be made either at Midland, Sweetwater or Big Spring, Texas, but it has not been decided which.

**Another Recommended**  
Another line which eventually may connect with the Southern Transcontinental at Fort Worth has been recommended to run from New York to St. Louis by way of Pittsburgh, Columbus, Ohio, and Indianapolis, Ind. It is the plan of the department eventually to extend this route to Fort Worth by way of Springfield, Mo., Tulsa, and Oklahoma City, Okla. This probably will not be done until legislation has been passed.

**When the line from Atlanta to Birmingham and thence to Fort Worth is begun, the line which now connects Atlanta, Mobile, and New Orleans will be routed through Montgomery, Ala.**

It was understood that there is little chance of the routes being placed in operation until about July 1, when the new fiscal year begins. At present, the funds for lighting airways have been about exhausted and the air mail service is facing a \$3,000,000 deficit for this fiscal year.

#### Third Victim Of Burns Succumbs

SAN ANTONIO, Dec. 13 (AP)—Mrs. A. Hahn, 72, of Fredericksburg, died here Wednesday as a result of burns received last week when a bus in which she was riding burned on the Fredericksburg road.

Mrs. Toss Forrester of Nixon, Texas, and B. J. Morgan of San Angelo already had succumbed to burns received in the same accident. Bob Downs, driver of the bus, is recovering from burns received when he rescued his passengers.

The fire was believed to have been caused by the explosion of moving picture films carried in the bus.

#### TO AVOID TAXES

FORT WORTH, Dec. 13 (AP)—In an effort to avoid payment of the state gasoline tax of four cents, the city of Fort Worth has contracted with the Texas Pacific Coal and Oil company for gasoline to be used in municipally operated vehicles to be brought here from Oklahoma City, Manager O. ### COMMITTEE FOR CARRYING OUT STUDY OF THE STABILIZATION OF BUSINESS IN AMERICA NAMED; LEADERS EXECUTIVES

BY CLINTON COFFIN Associated Press Staff Writer WASHINGTON, Dec. 13 (AP)—Twenty men, notable in American financial and commercial fields, were named today to constitute an executive committee for carrying out business stabilization projects authorized by the national business survey conference called in Washington last week by President Hoover.

Julius H. Barnes, chairman of the conference and of the committee, in announcing the selection, said "nothing of an emergency character exists in the present business situation to require undue haste" in further procedure. He added that the committee would meet soon and that it would probably be assisted by a larger committee, with 50 or 60 members representing an even larger sector of the American business field.

### GREATER GAS SUPPLY ADDED

#### NEW LINE TO BE BUILT TO SOUTH PLAINS COMPANY

(Special to The Journal) BIG SPRING, Dec. 13.—The Big Spring Public Service company has signed a contract with the South Plains Pipe Line company for an additional supply of gas which will raise the open flow supply for Big Spring from five million cubic feet to one billion five hundred million cubic feet daily available supply. The construction of a new gas line will be laid from Big Spring to the South Plains Pipe Line company lines which will be about 37 miles in length. A survey will be made immediately and since the company has on hand enough 8-inch pipe for 20 miles the work will not be held up. The supply will be raised from five million cubic feet per day coming from the local field which has been adequate for domestic use, the new supply will enable the company to meet rates of other cheap fuels. The domestic rate of Big Spring will remain unchanged according to officials of the Big Spring Public Service company.

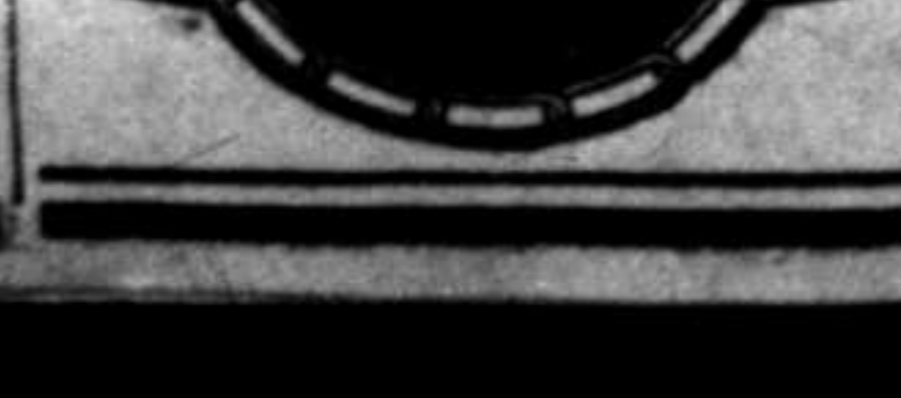

### SHORTER SEASON SEEN AS CERTAIN IN 1930 SCHEDULE

NEW YORK, Dec. 12.—The annual meetings of the two major leagues and their joint session have come to a close with a minimum of action in the matter of business transacted.

The question of a September opening failed to come up for official consideration after the managers discussed the league presidents and not the club owners had jurisdiction in the situation. Since both John Heydler and E. S. Bernard favor a season running from April 15 to September 25, it is safe to assume such will be the schedule.

Trade talk was rife in every quarter, but actual deals were scarce. Grover Cleveland Alexander, hero of the 1926 world series, did return to the scene. . . . The league contract—Philadelphia—in a deal more important from a sentimental angle than from any other. . . . Harry McQuay, former University of Illinois star, also became a Philly with Old Aler, the Great, and Young Homer Piel became a Cardinal again in the same transaction. The only other swap returned Wally Schang to the Athletics in exchange for Sammy Haas, who became a Bronco.

At the joint meeting yesterday the chain-store system of baseball ownership was discussed at length. Sam Breadon, most extensive dealer in live and dressed ivory, produced telegrams from presidents of a wide range of minor leagues endorsing major league ownership of the smaller clubs. These messages included word from the heads of such circuits as the Western, Texas, Central, I. I. L. Piedmont, Blue Ridge and Eastern Carolina Leagues and the South Atlantic and Western Associations.

Influenced Action  
President Breadon's action in speaking frankly regarding the chain-store system doubtless had much to do with failure of the joint session to adopt the regulation. Commissioner Landis suggested one requiring clubs to make known officially to the various baseball headquarters any transaction by which they gained control of a smaller franchise. All hands, including Commissioner Landis, seemed satisfied to let the matter rest.

While no general gathering of the baseball rules committee will be held this winter, the joint session did authorize clarification of certain points in the scoring rules and unification of the scoring instructions which the two leagues issue to their official scorers. These instructions now vary in several items, notably the one which requires a starting pitcher to gain a victory when an American Leagueer need go but four.

### CONSPIRACY INVOLVED IN DIVORCE OF COL. ROGERS, DAMAGE SUIT ALLEGES

NEW YORK, Dec. 13 (AP)—Charges there was a conspiracy involving the divorce of Col. Henry H. Rogers, a standard oil magnate, and his subsequent marriage are made in a suit filed by Edward E. Kern, who was dismissed as the colonel's secretary. He seeks \$750,000 from the colonel's bride and two of her relatives.

The colonel's first wife, Mrs. Mary Benjamin Rogers, obtained a divorce in Holland last summer. Colonel Rogers soon after was married in Paris to Margit Barbola Braun Miles, widow of Basil Miles, former American commissioner to the International Chamber of Commerce.

Count Andre and Countess Marie Zichy, cousins of the present Mrs. Rogers, are defendants with her in the suit.

Declaring his dismissal was "malicious," Kern said in his petition "it was done among other reasons to obtain revenge upon the plaintiff because the plaintiff in the course of his employment with Henry H. Rogers, and under specific orders of Mr. Rogers, had investigated and obtained information concerning the defendant's (Margit Barbola Van Braun Rogers) birth, family, social standing, previous history and mode of living and had communicated to Henry H. Rogers the result of the investigation."

Kern gave notice he would ask for examination of Mrs. Rogers and the Zichys before trial. One of the questions on which the examination is based is:

"Whether or not, from December, 1928, until June, 1929, the defendant and each of them represented to Henry H. Rogers that the defendant Rogers (then known as Daisy Von Braun Miles) was a member of the Hapsburg family, to wit, an illegitimate daughter of Franz Josef, emperor of Austria, and represented to Henry H. Rogers that the defendant Rogers received an income

Says

That Girl on Broadway says when a boy finds the girl of his dreams he usually loses sleep over her. Now that the first annual Community Chest drive is all "washed up and done", The Plainsman wants to make a few remarks concerning it—remarks that he withheld before and during the campaign because he felt to make them then might in a small measure, affect the final result. This column recognized from the start that the most important thing about the drive was the collection of money to carry on the city's donatory organizations through the coming year. Any other facts surrounding it could be nothing more than sidelights.

There was a certain amount of dissatisfaction with the agencies included in the chest, with the budget set and the various divisions, and with the fact that an outside organization was employed to manage the collection of funds. The Plainsman can see reasons for all these dissatisfactions, yet at the same time can over-look them because the Community Chest plan here is brand, spanking new and, like everything else, will be improved with time as the citizenship as a whole becomes more acquainted with it.

This column suggests that by the time another chest drive rolls around more study be given the division of the funds and the amount for each agency set in direct ratio with the good done by the individual organization. It also suggests that we profit from the experience of the city gained this year by watching professionals direct the drive and head our own campaign in 1930 and thereafter.

Getting down to facts and figures, the American City Bureau, through its representative, contacted to head Lubbock's Community Chest for the sum of \$2,575. That sum was "flat", to be paid whether the \$30,000 budget was reached or not. Present indications are that approximately \$25,000 has been pledged to the chest, according to the neighborhood of \$23,325 for donatory organizations in Lubbock in 1930, payment to the bureau deducted. This amount, The Plainsman believes, will be sufficient to carry on the work with accuracy and dispatch.

Considering that this year marked this city's first venture in the Community Chest plan, The Plainsman thinks the employing of the America City Bureau might possibly be a good investment. More than 100 Lubbock people actively engaged in the drive saw how the work was done and, in our opinion, we will be able to carry on our own drive next year. While the city might approve the employing of a small force of office workers, at a nominal sum, for other Community Chest drives, it will not favor contracting next year's campaign at a figure as top-heavy as the one contracted this year. The first place we don't believe it will be necessary. In the second place we believe the figure spent this year will be much too high for another.

Starting out on a Community Chest is just like starting out on any other innovation. The program with which the people are unacquainted. It takes time and experience to learn how to handle it efficiently and Lubbock should be able to profit financially from its experience this year.

Here's Some Interesting Facts About The Pantry—Cost Of Living Nearer 1913 Level, Rodney Dutcher Insists

BY RODNEY DUTCHER, NEA Service Writer WASHINGTON, Dec. 13.— Frequently one hears the householder or housewife muttering about the good old days when eggs were only 10 cents a dozen, talking as if eggs were a horrible example of the way the cost of living has gone up since the war.

Fact is, eggs are about the cheapest thing anyone can buy for a meal, if you compare present prices with pre-war prices. Eggs last year cost less than 25 per cent more than the eggs of 1913 cost in 1913, whereas nearly all the other commoner articles of food showed an increase of from more than 50 per cent up to nearly 100 per cent. The only foods of importance which haven't gone up higher in proportion than eggs are sugar, lard and rice.

Thus, anyone who lives on a diet of eggs can make his money go further as compared with pre-war prices than by any other method, insofar as food is concerned— unless, of course, one cares to live on rice, which is a much better bargain. Here is a list showing the percentage of increases of 1928 food prices over 1913 prices: Ham 98 per cent, round steak 88, sirloin steak 88, rib roast 77, corn meal 77, hens 76, chuck roast 74, chops 74, pork chops 66, coffee 65, flour 64, bacon 63, bread 62.5, milk 60, potatoes 59, plate beef 57, butter 47.5, tea 42, eggs 34.5, sugar 29, lard 18 and rice 15—omitting most of the decimal points.

If anyone doesn't believe these figures he can ask the U. S. Bureau of Labor statistics, which went to a great deal of trouble in compiling them. This bureau has figured it out that food was a little cheaper in 1900 than in 1890, but that after that it went up gradually from year to year until in 1913 it was nearly 50 per cent higher than at the dawn of the century. If one's memory is any good there was a lot of talk in the 1912 presidential campaign about the "high cost of living", but the election of a Democrat didn't do any good because food prices went right on rising. In 1920 retail food prices were twice the prices of 1915, almost exactly. No doubt many persons still blame the Democrats for that, but as a matter of fact it was the war.

By gextious work with index numbers the bureau statisticians now decide that food in 1928 cost only 75 or 80 per cent as much as it did in 1920. It will be recalled that prices dropped wildly in 1921 and 1922, so that whereas food prices of 1922 were less than 42 per cent in advance of the pre-war prices of 1913 they are now more than 94 per cent higher—using the 43 most common articles of food as priced in 51 scattered cities.

A check on the average annual family consumption of the 43 articles by geographical section shows an interesting variance of food habits in different parts of the country. The average family in the North Atlantic states eats but 27 pounds of sirloin steak a year, compared with 94 pounds in the South Atlantic states, 34 in the North Central, 38 in the South Central and 39 in the Western. But the same family consumes more chicken, more lamb, more canned salmon, more fresh milk and more bread than the average family elsewhere.

The average family in the South Atlantic states eats more bacon and ham and almost more pork chops than the family elsewhere, with a high record for chicken and the lowest sectional consumption of milk. South Atlantic and South Central families are far ahead of everyone in consuming flour, corn meal and rice, while the South Central family holds the undisputed record for onions, consuming 23 pounds a year.

The North Atlantic family eats seven times the amount of lamb consumed by the South Atlantic and North Central families and 14 pounds to the South Central family's one. North Central families are the biggest eaters of potatoes and of pork chops.

Diet and Health

"DEAR DR. LULU: What are the dangers of eating very little bread and cereal? My family prefers the starch of potatoes. I have just about concluded that there is no substitute for cereal because even though my children eat all the other foods, I find it necessary to give laxatives often. Is it possible to eat too much fruit?" "MRS. B."

Give your family cereals in the morning, Mrs. B. Get the whole-grain types for steady use. They are not only good energy foods, but they have a high-grade protein, and vitamins. (So do potatoes.) The whole-grain products are high in vitamin B, which is necessary for the integrity of the intestinal tract, and therefore peristalsis, and this is one of the reasons for its helpful effect in constipation. And the bran furnishes necessary bulk.

Potatoes are an exceedingly wholesome food, having an alkaline ash, and there are many who can with profit, eat more of them and proportionately less cereal products. Those who should do this are those who have been having too many of the cereal products (this includes bread and cakes) and other acid-ash foods, and are suffering from a dietary acidosis from this excess. (Norman Stanley Case was born at Providence, R. I., Oct. 11, 1888. He is a graduate of Brown university later studying law at Harvard and Boston universities. He was admitted to the bar in 1911. From 1914 to 1918 he was a member of the city council of Providence. He was elected lieutenant governor of Rhode Island in 1927 and succeeded Governor Fenner in office when the latter died in 1928. In 1916 he served on the Mexican border and later in France during the World War.)

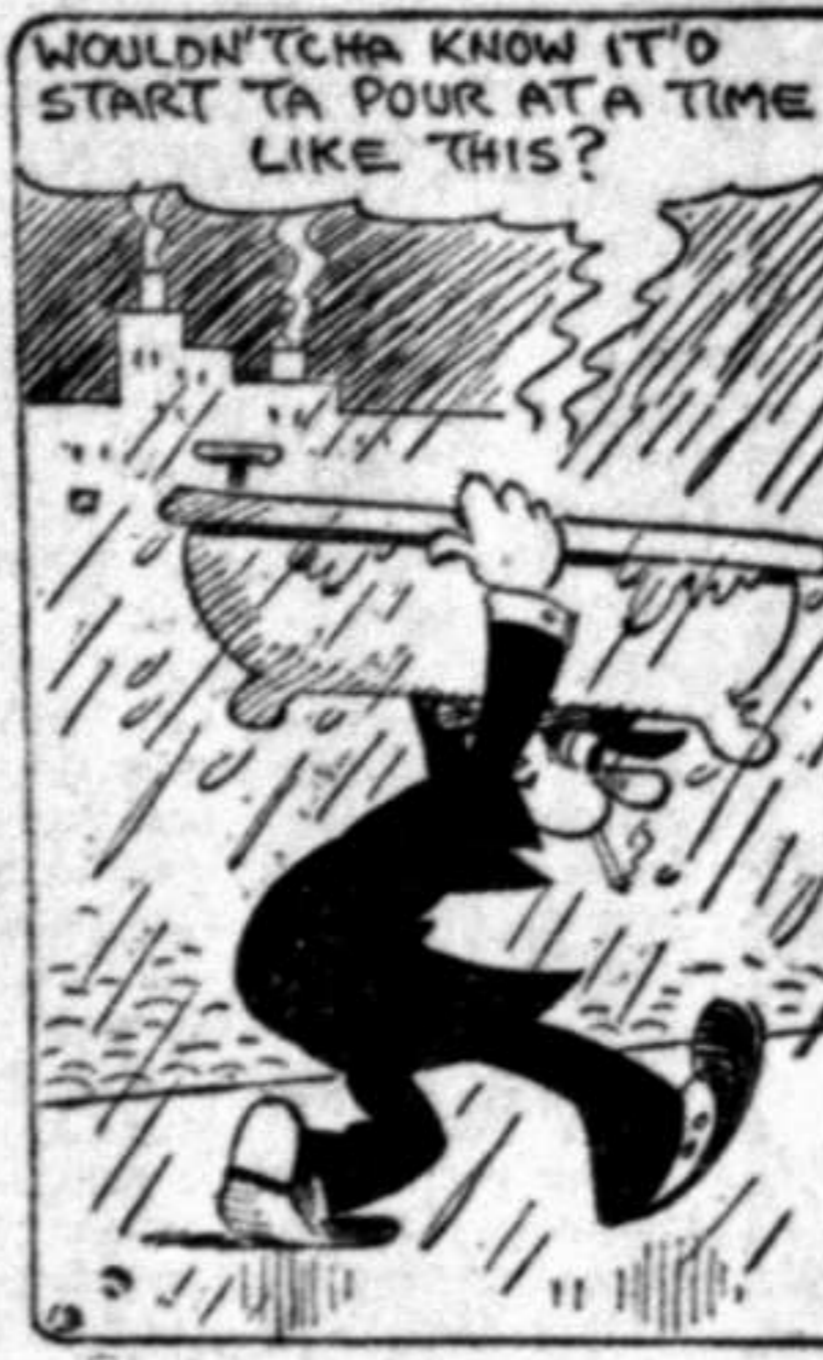

# PRISON SITE BOARD SPLIT

## CENTRALIZATION BODY TO RECOMMEND THREE DIFFERENT SITES

(By Associated Press) AUSTIN, Dec. 12 — The prison centralization commission will recommend three sites to the legislature for construction of the proposed new central penitentiary plant.

There will be two minority recommendations, one proposing rehabilitation of the walls at Huntsville and the second supporting the Imperial farm, twenty miles south of Houston, for the new prison.

The four members not coinciding with the majority, which favors a site within twenty miles of Austin the state capital, were divided two and two.

**Suggest Imperial Farm**

Representatives A. H. King of Throckmorton and E. T. Murphy of Livingston have filed a report suggesting Imperial farm as the most feasible for concentration, and Senator Nat Patton of Crockett and Representative Harry N. Graves of Georgetown want to rehabilitate the walls at Huntsville, where the main penitentiary has been for 80 years.

The Huntsville site is the second choice of King and Murphy, however, for they urge in their report that "in case the legislature concludes that the Imperial farm is not the proper place to build a new prison, the enlargement and modernization of the plant at Huntsville be undertaken," expressing the opinion this could be accomplished with the expenditure of less than \$1,000,000.

**Expenditures Shown**

Senator Edgar Witt of Waco, who drafted the majority report, added an exhibit showing that during the past twenty years the system cost approximately \$10,000,000 in excess of the revenues derived therefrom and quoting B. F. Williams, state reclamation engineer, to the effect cost of reclaiming the overflow lands of the present-owned properties would be approximately \$2,000,000. Williams said this expenditure would not protect the repressive farm of 1,425 acres, giving it as his opinion it is not feasible to attempt to reclaim this acreage.

The commission has been called to meet here Friday to take final action with reference to its recommendations to the legislature.

The commission is composed of the nine members of the state prison board and nine legislators. The prison board members are unanimously behind the majority recommendation that the prison be built near Austin. Four of the nine legislators are opposed to centralization near Austin, and the attitude of one, Representative Coke R. Stevenson of Junction, is not definitely known. Stephenson had not attended a meeting of the commission recently.

California, with an estimated population of 6,900,000, has a prison population of 7,378.

# FIGHTING IN CHINA RAGES

## WOUNDED BEGIN TO ARRIVE FROM BIG BATTLE SCENE

(By Associated Press) SHANGHAI, Dec. 13—Wounded began to arrive in Nanking today from a battle in progress 50 miles north of Pukow between loyalist soldiers and the revolting Pukow garrison. Fighting was described as intense.

British and Japanese warships were on their way up the Yangtze river to aid in evacuating their nationals in case events forced that move. An American flotilla was expected here tomorrow with like intent.

**Nanking May Fall**

A rebel victory, it was thought, might initiate a train of events ending in the fall of Nanking and the nationalist government. Serious disorders affecting foreigners in the central capital in event of its fall were feared here.

The Pukow mutineers began the offensive near Chuchoo with severe fighting developing along the Tientsin-Pukow railway. The nationalist troops were said to consist of three divisions and one regiment with additional forces en route from Nanking.

Five hundred nationalist troops at Nanking were disarmed by government officials because their loyalty was questioned. They did not resist. Additional foreigners left Nanking for Shanghai.

A strict censorship was believed to be preventing stories of important happenings in Central China from permeating to the coast and the outside world.

# HEFLIN CHARGES COTTON COMPANY

WASHINGTON, Dec. 13 (AP)—A charge that the firm of Anderson, Clayton & Company, Houston, Texas, cotton brokers, was exerting an "over shadowing influence" on the cotton exchanges of the country was made before the senate agriculture sub-committee today by Senator Hefflin, democrat, Alabama, during an investigation into the causes of depressed cotton prices.

Will Clayton, member of the Texas firm, is to appear before the sub-committee tomorrow.

Hefflin asserted the Houston company's influence "swings over the exchanges like the wind of democracy."

The first mass started shortly after midnight and one celebration of the rite followed another for many hours. Scores of police were on duty at the church and at frequent intervals they had to close the doors in order to prevent a catastrophic crush within the structure.

Several hundred other officers were on duty along the four mile route from the National cathedral to Mexico City to handle the emergency traffic. Many of the devout made the pilgrimage on their hands and knees.

Mex., Dec. 13 (AP)—Tom toms beat in the shadows of the radio broadcasting towers at the Mexico State A. and M. college Thursday as Aztec and Pueblo Indians, grotesquely painted and masqueraded, celebrated "the return of the Virgin of Guadalupe." Patron saint of Mexico and the Indians.

Immediately after the native rite, the Indians went to a Catholic church, to be blessed in the Catholic ritual.

Similar services were held in Cuernavaca, Mexico, and Fabens, Texas.

### FLIGHT PLANS BEING MADE

#### EASTERWOOD ON WAY TO HONOLULU TO SEE DOLE

(By Associated Press)  
LOS ANGELES, Dec. 13 (AP)—Colonel W. E. Easterwood, Jr., millionaire of Dallas, Tex., announced here today he had reopened his offer of a \$25,000 prize to the first aviator to fly from Hong-Kong, China, to Dallas. The offer was made in 1927, but was withdrawn after lives of several contestants in the Dole race from Oakland to Honolulu had been lost.

Colonel Easterwood said he was on his way to Hawaii to confer with James Dole, pineapple grower who posted the prize money in the Dole race, and expected the Honolulu millionaire to post another \$25,000 in prizes for the Hong Kong-Dallas flight.

Effective in Summer

"The prize offer will be effective this coming summer. The route includes stops at Tokyo, Japan, Honolulu and one on the Pacific coast," Colonel Easterwood said. "This is not going to be a race, but will be more of an endurance test. The first pilot ready will get the first chance, and if he succeeds none others need to start."

"Major Ting Ling Haung, Chinese aviator, already has a plane half completed for the flight. There is no restriction placed on the type of plane used, nor on the number

of persons who may fly in each entry. It will be necessary only for the pilots and crews to finish in the planes used at the start."

### IOWA'S ACTION IS NOTED WITH FAVOR

CHICAGO, Dec. 13 (AP)—The University of Iowa's action in declaring ineligible athletes who benefited by the athletic fund has brightened its prospect of early readmission to athletic competition in the western conference.

Frederic Woodward, vice president of the University of Chicago, and its representative on the faculty committee, said Iowa should be given an early hearing if it files notice of another appeal.

Prof. O. F. Long, Northwestern's representative, said the action had placed Iowa in "a favorable light," and he indicated he anticipated the committee would visit Iowa City soon to review the situation.

Prof. Ralph Aigler of Michigan would not comment directly, but indicated a renewal of Iowa's plea would be favorably received by the committee. Mr. Aigler mentioned the possibility of a special meeting to hear Iowa, if the school decided to petition again.

SAN ANTONIO, Dec. 13 (AP)—Belief that Rafael Arellano, 25, had "hexed" him and his sweetheart by spells and by placing funny things in tea led Jose Morales to kill Arellano, Morales maintained today. Arellano's skull was crushed and pierced by a pair of scissors. Morales was charged with murder.

### Mixed Bouts Rule May Be Cancelled

CHICAGO, Dec. 13 (AP)—A rule prohibition boxing matches between whites and negroes, passed by the old Illinois State Athletic commission because of a riot during the Jackie Fields-Young Jack Thompson bout at the Coliseum last March, must be rescinded before the pair will be permitted to engage in a title bout in the same arena for promoter Jack Dempsey, January 17.

Dempsey has Fields, welterweight titleholder, and Thompson, San Francisco negro, lined up for a championship bout, and it is expected the new commission will repeal the ruling made by the commission headed by Paul Prehn. Prehn's committee made the regulation after one man was killed and several were injured during the last meeting of the pair. The trouble started when a white man and a negro came to blows.

"I do this in justice to the family of the principal keeper, who was killed, to the guards who were wounded, and to the other guards, who with the state troopers and militia acted with such conspicuous bravery in Wednesday's riot," the governor said.


"Furthermore it is time that the handful of incorrigible criminals in the state prison should realize that continuation of acts of violence against the state will be met with immediate and drastic severity."

### FRENCH DEBT BILL PASSES

#### HOUSE RATIFIES DEBT PLAN FOR NATION; TO SENATE NEXT

(By Associated Press)

WASHINGTON, Dec. 13.—Settlement of France's war time indebtedness to the United States was brought nearer consummation Thursday by the House, which voted 239 to 100 to ratify the Mellon-Berenger agreement.

The bill now goes to the Senate, where the finance committee already has voted a favorable report on the companion measure introduced by Chairman Smoot.

Representative Crisp, democrat, Georgia, a member of the American Debt commission and leading advocate of the settlement, argued at length that the \$4,925,000,000 payment, which would be made over 62 years, was the most that France was willing to make.

That or nothing he said, pointing out that the French chamber of Deputies ratified the plan after a bitter contest with a majority of but eight votes.

Chairman Hawley of the Ways and Means committee, and Representatives Frear, Wisconsin, and La Guardia, New York, republicans, also spoke for the measure, while opposition was voiced by Representatives Rainey, Illinois; Hastings, Oklahoma; Howard, Nebraska; and Green, Florida, democrats, and Schafer, Wisconsin, republican.

Hastings said the bill call for cancellation of "more than 52 per cent of France's obligation to the United States," and that "not more than one in ten thousand taxpayers would approve it if they knew the facts."

It is Dr. Falk's opinion that a vaccine may be developed which sprayed in the throat will cure influenza. Development of anti-toxin also is to be sought.

try did not mean his memorable appeal to stem the ever-increasing crime wave here should apply only to the mean and defenseless violators of the law," he said.

**Went Hide Him**

"No amount of evidence will convince me that my government would deliberately invest with diplomatic immunity a fugitive from justice for the foul purpose of enabling him to evade arrest and punishment.

"Calles himself publicly asserts the purpose of his present trip is to regain his health which was impaired by recent military campaigns in Mexico, and his presence in this country is certainly not embraced in the expression: 'ambassadors and other ministers.'

"The laws of Texas have been violated. The majesty of the law must be vindicated, and the statutes of my state will be enforced no matter how high the station or how contemptible the character of the defendant.

"I therefore advise you that if Calles should unfortunately be able to produce a certificate from the secretary of state under the great seal of that office, attesting diplomatic immunity, he will be allowed to proceed unmolested." Otherwise, the law will take its course as in ordinary cases.

Obedient to demands of the letter writer, who asked immunity from arrest and \$100 expense money, residents stayed inside their homes for the most part to avoid any appearance of interference.

There was more excitement in this town than since the population turned out to search for the boy when he disappeared last December 27.

### BRITISH TROOPS LEAVE RHINELAND; TERRITORY TO BE PUT UNDER FRENCH

(By Associated Press) WIESBADEN, Germany, Dec. 13.—Some reminiscence of the first Armistice Day celebration were enacted here tonight after the Union Jack had been hauled down from British headquarters and the last soldiers of Great Britain left the Rhineland.

The Union Jack came down from its staff over the hotel Hohenzollern at two o'clock this afternoon. At the same hour another small British detachment was leaving Bingen on the Rhine.

Pass In Review The company of British fusiliers mounted guard at the approach of the color bearers and the detachment then passed in review before General Thwaites, British commander, for the last time on German soil.

There was a long roll from the drums and the military band struck up "God Save The King" as the British flag fluttered over the staff. Then the troops wheeled into column and marched to the station where they entrained.

With the departure of the last English garrisons, the number of allied troops in the Rhineland had been decreased within a few months by 25,000.

### SHOOTS PARENTS OF SWEETHEART

CARROLLTON, Mo., Dec. 13 (AP)—Enraged because he was forbidden to enter the home of Otis Cothran and call on a 16-year-old girl, Fred Eisenhour, 20, last night shot and dangerously wounded Mrs. Cothran, slightly wounded Mr. Cothran and fled from the house. Today his body was found at Carrollton Junction, 2 miles west of town where he apparently had fallen under a freight train while attempting to steal a ride.

### Aircraft Carriers Values Advanced

WASHINGTON, Dec. 13 (AP)—The military value of aircraft carriers was advanced today by the navy's bureau of aeronautics as the basis for a recommendation that the full carrier strength of 135,000 tons permitted under the Washington arms treaty be reached as soon as possible.

This recommendation, seconded by Secretary Adams in his report to President Hoover, would involve the construction of four aircraft carriers of the size of the one authorized in the 15-cruiser bill, 13,000 tons. The navy is ready to call for bids on this ship.
