Yancey Story Case Arguments Started

DALLAS, Jan. 27. (AP)—Taking of testimony in the trial of Yancey Story, Denton county ranchman, charged with the robbery by firearms for the holdup of the Krum bank last summer, began here this morning. Introduction of evidence followed Story's plea of not guilty and Judge Pippen's overruling of a defense motion for dismissal.

Dr. A. H. Knox, cashier of the Farmers and Merchants Bank at Krum testified that Story, whom he knew well, warned him the morning of the robbery that "the bunch" had decided to hold up the institution. Story asked him what he intended to do about it and he answered he wanted to prevent it, Knox testified.

The witness testified that after warning him, Story said he did not want to see him hurt and then left the bank, where the conversation occurred. Dr. Knox described how two masked men held up himself and the bookkeeper and escaped in a large automobile that day.

JIM FERGUSON ATTACKS MOODY

MITCHELL RESIGNS AS ARMY OFFICER

COOLIDGE MIGHT RETURN REQUEST WITHOUT ACTING

MITCHELL WILL NOT SAY HE IS LEAVING FOR ARMY'S GOOD

(By Associated Press.)
WASHINGTON, Jan. 27.—Colonel William Mitchell resigned today from the army.

The final decision will rest with President Coolidge, who two days ago approved with modifications the sentence of the court martial. He sustained the court in sentencing the colonel to five years suspension, but reduced somewhat the court's finding that he should be without pay or allowance during the period.

To Make Lecture Tour. It is the belief of Colonel Mitchell's friends that if he is permitted to step out of the army he will accept an offer to continue the lecture platform his crusade for a reorganization of the national defense to give a more prominent place to the development of air power.

Should the President return the letter of resignation because of Colonel Mitchell's failure to say he is leaving for the good of the service, there is considerable doubt where the succeeding developments might lead.

Won't Say Army Bettered. It is the impression of the colonel's intimates that he would stubbornly resist any effort to put him in a position of saying that the armed services would be improved by his withdrawal from them.

The convicted air officer, under sentence of five years suspension from the army, because of his criticism of government aviation policies, put his resignation in this single sentence:

"I hereby tender my resignation as an officer of the United States Army to take effect February 1, 1926."

The letter was dated today and addressed to the Adjutant General of the army through the commanding general of the district of Washington.

May Not Let Him Quit. Whether the resignation will be accepted had not fully developed. Some army precedents indicate that in such cases withdrawals should state directly that the resignation is submitted "for the good of the service."

LUBBOCK SCHOOL'S PLANS NEARING COMPLETION

Plans and specifications for the additional housing facilities that will be added to the Lubbock Independent School district by authority of an election held recently, are now in the last stages of preparation, and will be ready for distribution to contractors for bids the latter part of this week or the first of next. It was announced here Wednesday from the office of Peters and Haynes, who are preparing the plans.

The school board plans to meet some time the latter part of this week, Supt. M. H. Dunean, of the public school system said, when final authority for the reception of bids on four projects is expected to be given. Present plans of the board provide that bids will be received February 12, and that work will get under way immediately following.

Two buildings are provided under the program, one in the north part of the city, which probably will be a sixteen room structure; one in the southwest portion that will be somewhat smaller, but erected on the site plan so that it may be added to if the need arises, and for the addition of two rooms to the present high school building to be used as assembly and study halls.

A bond issue of \$170,000 was voted recently to finance the program, and it is expected by school authorities that the new buildings will be ready for occupancy for the next term.

Great Storm Moves From North Pacific

VICTORIA, B. C., Jan. 27. (AP)—A great storm, one of the largest in area ever recorded on the North Pacific, is moving toward this coast. The storm Napier Denison, observatory superintendent, estimates from radio reports received from ships in the last 24 hours, has a diameter of nearly 3,000 miles. Its center lies about due west of Prince Rupert, and at 10 o'clock last night its outer edge was about a thousand miles off the British Columbia coast.

HOFFMAN TRIAL NEARING CLOSE

Instructed Verdict Expected As Result Of Moody's Request Of Moody's Assistant

(By Associated Press.)
AUSTIN, Jan. 27.—If the court permits defendants to offer rebuttal testimony on issues of fraud in the state's road suit against the Hoffman Construction company, the state will ask an instructed verdict. Ernest May, assistant attorney general, made this declaration and Judge George Calhoun recessed court at 11:45, promising his decision on the legal angle at 2 o'clock.

The facts in the case not only do not admit of fraud, but absolutely exclude its possibility, John D. McKee, defense attorney, told the jury today. "We want you to know the truth, for the truth will make them free," he said.

Defendants readily state they were and are friendly with Joe Burkett and were gratified at his appointment. However, they expected no favors from him.

We expect to show that G. A. Davison, president of the defendant company, refused to lend money to Burkett, though money was lent to Frank Kirk, because of his undoubted solvency. Kirk lent the money to Burkett. This transaction transpired several months after the Hoffman contracts had been awarded. I don't think it amiss to state Mr. Davison has been a sick man since last August.

This accounts for his absence from the court.

The Hoffman Construction company was organized in February, 1924. In F. G. Hoffman it has as good an engineer as there is in the state. Hoffman took specifications drawn by the highway department and upon those made a bid which he believed would yield a fair profit.

Lubbock merchants who are cooperating with railroad and steamship company officials in connection with the California Tours campaign that was launched here recently, are planning in the near future to offer a banquet to all contestants in the campaign when a general discussion of details will be engaged in. It was announced at campaign headquarters here Wednesday.

Fourteen Lubbock business firms are cooperating in the movement by which two ladies will be given a trip to the Golden West with all expenses paid in a tour that will be personally conducted and well chaperoned, through various places of national interest, including Catalina Island, the Yellowstone National park and other national preserves that are visited annually by thousands of sightseers.

Reservations Made. Reservations on the special train that will go from this part of the state have already been made by the merchants for the two that will go from here.

New contestants are entering the campaign daily and enthusiasm is reaching higher with each passing day. There are no restrictions on entry, and no restrictions on the manner of procedure after entry, except that the contestants must work in cooperation with the merchants who are behind the proposition. There has been no minimum or maximum set on the number of votes that various workers must secure, but the two ladies, irrespective of person, who receive the highest number of votes will be awarded the trip. DOORN, Holland, Jan. 27.—The black and white Hohenzollern banner floated the torches of the former Kaiser's residence here today in honor of his sixty-seventh birthday, and a constant stream of messengers entered, bearing huge baskets of flowers tied with the Dutch and German colors.

A number of visitors arrived in automobiles, to be received by the court marshal, who wore a gala uniform in honor of the occasion, and entered their names in the congratulatory register kept at the entrance of the lodge.

At 11 o'clock the ex-Kaiser, with his wife, the Princess Hermine, and her daughter emerged from the lodge for a walk through the village, where they were snapped by a half dozen photographers.

Patrick Goes Before House With Air Plan

WASHINGTON, Jan. 27. (AP)—Major General Mason M. Patrick, chief of the army air service, outlined before the house military committee today the legislation for aviation, which he requested him to prepare for consideration along with other proposals.

Repeating his plan for a separate air corps, to be directly under the secretary of war, he said that within five years this branch of the service should be expanded to include 3,000 officers, 15,000 men and 1,800 planes.

The corps would have a separate promotion list and would be charged with defense of the coast lines, which, he said, at present "are much in disrepute between the army and navy aviation."

It would be logical, he added, to have a similar air corps for the navy.

FIVE DEAD AFTER FLAMES SWEEP TENEMENTS

NEW YORK, Jan. 27. (AP)—Five persons lost their lives in two early morning tenement house fires today. A mother and her three young children were burned in one fire, and a man died from shock and suffocation in a blaze in the other.

Mrs. Anna Pals and three of her seven children were the victims of the first fire. They were entrapped in a blazing bedroom and were dead when firemen succeeded in entering the room. Her husband, William, in an adjoining room, was awakened by his wife's screams. He tried to fight his way through the flames, but was driven back with serious burns. Leading four other children, the eldest 13, he fled to the street. George Klissen, the fifth victim was suffering from a wound in the head, inflicted by robbers several nights ago, and was unable to leave his bed. His wife, a paralytic, was rescued.

PHENOMENA CAUSE OF TROUBLE IN RADIO WAVES

NEW YORK, Jan. 27. (AP)—Aurora borealis phenomena, which handicapped the international radio tests on Sunday night, reported today throughout the country, causing havoc with wire communications. The first manifestation of this nemesis of telegraph companies and news associations in 1919 a. m. in New York and one minute later made itself felt in Chicago. While manifestations were intermittent they were sufficient to disrupt wire communications for short periods virtually in all parts of the country. Currents were felt on both overhead and underground circuits. On its first appearance the disturbance lasted only a few minutes, but it cleared out when it returned at 11:03 a. m. New York time and continued until 11:38 a. m.

Wires Affected During these periods wires of the Associated Press were affected in New York City and in the state north of Albany, and west to Toledo. A curious coincidence was that there was no effect upon the wires east of New York and in New Jersey. At 11:45 o'clock wire communication centering about Chicago and Columbus, Ohio, was seriously affected, spasmodically. The American Telephone and Telegraph company reported that its wires had been affected all the way from New York to San Francisco and from Winnipeg, Canada, to New Orleans. The Western Union Telegraph company also reported trouble in all districts. That company's wire chief stated that wires running north and south, which parallel the magnetic field, felt the disturbance more than those running east and west, which cross the magnetic field. The Postal Telegraph company's wires also were affected, as were those of the brokerage houses.

Thompson, of Amarillo, for the construction of a modern five story hotel in Vernon at a cost of approximately \$240,000. Vernon will contribute the building site, which will cost \$21,000. Construction will be started as soon as a deed of the lot is given Mr. Thompson.

(Sled) Allen, of the Lubbock Hubbers, is thinking about the kind of baseball Lubbock is going to have this year and about the aggregation which will bear the Hubber heavy through the coming diamond campaign.

Thoughts Turn to Baseball While in the spring most young men's fancies are said to turn to thoughts of love and other things, Manager Allen's thoughts are mostly turned toward baseball and while he is still slow to be seen in the fence corners Manager Allen can forget it and put his mind on fast infields and away hitting outer gardeners.

TECH MATADORS AGAIN GO DOWN TO DEFEAT AT HANDS OF HILL BILLIES BUT SHOW GAIN OVER FIRST NIGHT

Once again the Daniel Baker Hill team from down Brownwood way went into action on the basketball court here, and once again the Tech matadors have been made the victim. This time it was by a much narrower margin than on the night before. Only four points margin was won by the visitors when the final whistle ended one of the most brilliant displays ever exhibited on a basketball court. The final count was 22 to 25.

Billy Evans Says

CLARK GRIFFITH'S PROVERBIAL CUNNING IS AT WORK ON 23 HOLDOUTS

It looks as if the Washington players, American league champs, are concentrating on Owner Clark Griffith. By his own admission, 23 of his athletes are still unsigned and spring training only a little more than a month away.

There is something almost prophetic in that number 23, same being the total unsigned athletes. In baseball, Griffith has always been known as the "Old Fox." His cunning is in for a severe test.

"I will start the season with a managerless team of bush leaguers unless Manager Harris and the rest of the holdouts agree to terms," says Griffith from the shade of the sheltering palms in Florida.

Of course he is only kidding, slipping the boys the oil, hoping some of them will fall for it, and get under cover. Incidentally it is hardly possible that Roger Peckinpaugh will be replaced by Buddy Myers or Muddy Ruel by Tate, as rumored.

However, holdouts thrive when the snow is on the ground. Spring with its baseball weather often causes them to forget their winter threats.

WINTER HOLDOUTS

Better pitching is the crying need of every major league ball club. Every big league manager would welcome the addition of one or more capable pitchers.

In their hunt for likely talent many of the major league managers have passed up the thought of recruiting such men from the leagues of higher classification.

With certain exceptions, most of the leading pitchers in the bigger minor leagues are discarded from the

major, hurries just shy of being regarded as regulars.

Last spring when I signed up the Indianapolis club at Plant City, Fla., Manager Donie Bush of that club told me he regarded Pitcher Bill Burwell as one of the most valuable pitchers in the league.

"Burwell is smart, has the courage and mixes them up," said Bush. "His fast ball may not be good enough for the majors, but he is a big winner in the American association."

The averages of the American association recently published certainly made good Bush's prediction.

PITCHERS SCARCE

Bill Burwell, considered not good enough for the St. Louis Browns, won 24 and lost only 9 games, ranking first in the matter of earned runs. Also three other pitchers in the association who won 20 or more games, Ray Kohn, Nick Cullop and Joe DeBerry at various times were members of the St. Louis Browns. All were waived out of the league.

In 1923 Dean of Louisville was the pitching sensation of the association. McGraw recently sent him to Philadelphia in a trade for the veteran Jimmy Ring.

In 1924 Jesse Petty won 29 and lost only 8 games with Indianapolis. He looked great in spring training. Brooklyn gave \$25,000 for him and three players, yet the best he could do in the National last season was break even, winning and losing 9 games.

These concrete examples make it apparent what a tough time major league clubs have in attempting to strengthen their pitching staff.

SIGNING OF SMITH AT AMARILLO IS APPROVED HERE

The announcement which reached here Tuesday from Amarillo to the effect that Lis Smith, veteran West Texas baseball player, had agreed to terms whereby he will have charge of the amateur team to be offered by the North Plains metropolis the coming season, has served at least in a measure to put pep and enthusiasm into the local proponents of amateur ball, adding a spark to the already well-kindled fire.

Lis, slow and easy-going, both on the pitchers' box, where he performs mainly, and otherwise, is the kind of a ball player that draws a crowd to the park, and with possibly one exception, is the best known player in West Texas. This exception is no

other than our own veteran, Sled Allen. Lis evidently carries a horse shoe in his pocket, or at least this has been charged against him time and again by West Texas fans, for when he was with the Amarillo Gassers in the West Texas League and the Panhandle-Pecos Valley League, he was one of the hardest pitchers to handle in either circuit.

Is Well-Liked

But, be this as it may, it cannot be disputed that Lis has the stuff, and dispenses it freely when called upon to do so. He is one of the most universally liked ball players ever to perform before West Texas fans, and will add much to the promotion of amateur ball in this section the coming season.

Simultaneously with this came the announcement also that Jack Wright, another well-known West Texas ball player who performs on the hot corner, is to report to the Philadelphia Athletics at Fort Meyer, Fla., February 20, for spring training.

Was on Lubbock Team

Jack is not the veteran by any means that Liz or Skipper Sled Allen are, but he is a ball player who has strutted his stuff before West Texas fans long enough that they realize he is among the best produced. He appeared once or twice with the Lubbock amateur club, last season, and was a big cog in the machinery sent up to Denver from here that swept everything before them in the tenth annual tournament there.

Jack showed up exceptionally well during the tournament in field play, but did not show so well in hitting, for more than one reason, and the major reason might be listed as the proverbial and inevitable slump with

which any ball player is seized. He just never could hit his hitting stride during the tournament. Wright's home is at Abilene, where he played with the high school Eagles, and for the past three years with the Simmons University Cowboys. He has been offered contracts by the St. Louis Browns, the Houston Buffs and other fast company ball clubs.

Editorials

LIVING LONGER

Figures issued by the census bureau as to the average length of life in the United States offer some interesting material for speculation. Women live longer than men. The average life of an American man is given as 55.23 years, that of a woman as 57.41 years. Why is this?

One unacquainted with the facts might have supposed that women were the shorter lived of the two sexes. They are traditionally the "weaker sex." Their physical organization is more delicately balanced than that of men, and is more easily thrown out of "kilter." They take risks of death or disability which the other sex is not required to take. Probably it is the fact that they lead more sheltered lives than men which gives them the advantage indicated by the figures, an advantage so great that it more than counterbalances the physical disadvantages of their sex.

Color is given this view by the disparity between the increases in the average lengths of life of men and women in the ten years from 1910 to 1920. The former added 2.75 years, while the gain of the latter was only 2.71 years. But during that decade there was an exodus of women from the shelter of the home. More are engaged in business, in office work or factory work than ever before. Perhaps if this change had not occurred woman's average length of life would have increased as much as man's.

A NEW SOLOMON

His Biblical knowledge has come in good stead to a Michigan jurist. Called upon to discriminate between two women claiming the same child, the judge resorted to Solomonic means if not to the true Solomonic device.

He did not call for his chief swordman and, ordering him to cut the disputed infant in twain, scrutinize the reactions of the claimants. Instead he concealed a moving picture camera in the courtroom and took a record of the effect upon the two women of his verdict that the controverted child would be placed in an orphanage.

When the film was later projected on a screen it showed the child's foster mother torn with emotion and tearful from grief. On the film the true mother of the child lost none of her equanimity, her face betraying complete satisfaction with the court's decision. On the strength of this unusual but most modern evidence the court gave the child to its foster parent, who in fact had reared it from the earliest infancy.

In their respective times both devices—the sword and the camera—proved successful. In Solomon's day there was no camera, so the "wisest of the wise men" was compelled to accept the means at hand. Today, had the Michigan judge threatened to divide the child with a knife, the women litigants would have laughed at him. Rulers are no longer permitted, in peace time, to butcher children, so if Solomon was giving out his old brand of justice today he, too, would be compelled to make use of the camera.

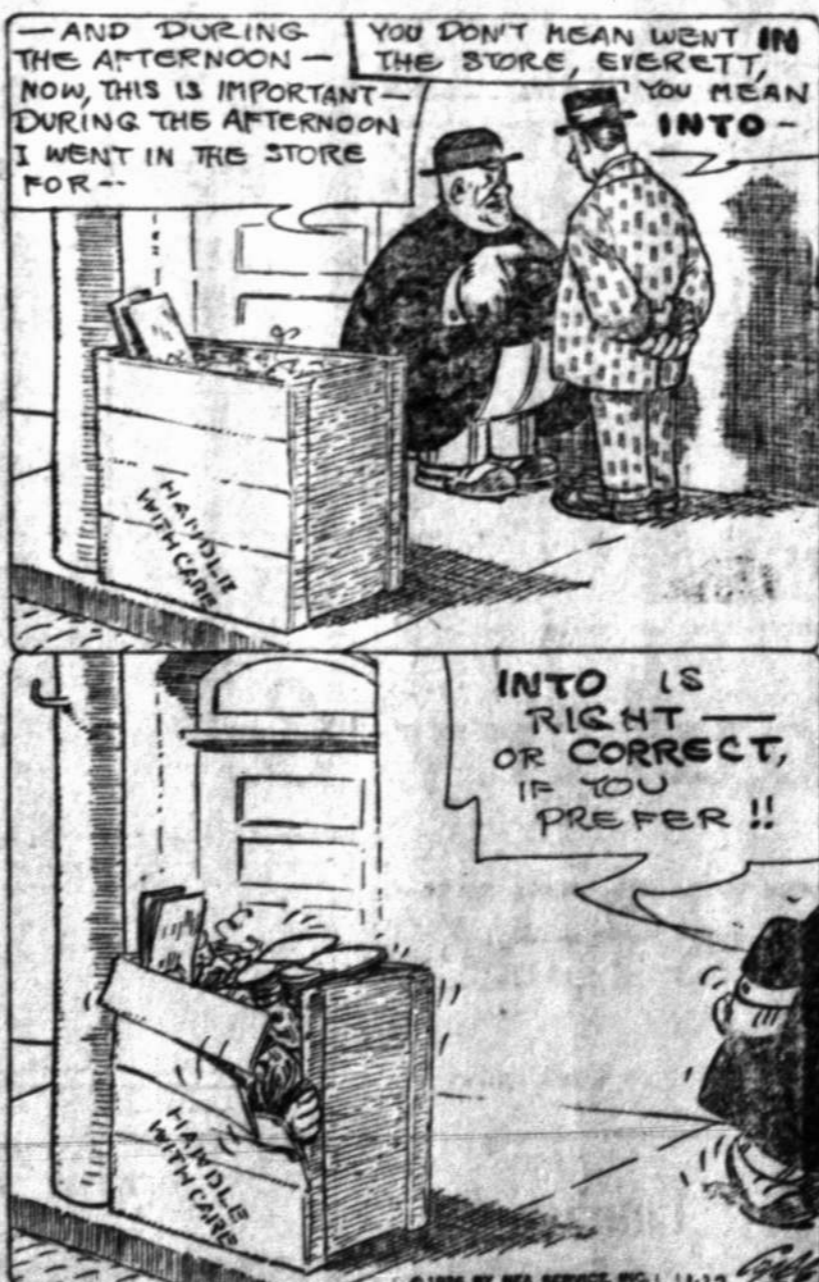

MISSIONARY TELLS EXPERIENCES IN CHINA

Telling of her experiences in China and the changes which have occurred in America during the last six years, Miss Beattie Combs, missionary to China who is at home on a furlough and in council field worker of young people of the Methodist Church this year, talked at the First Methodist Church Tuesday evening. Her lecture was under the auspices of the Senior Epworth League of the church.

Miss Combs had talked on her Chinese experiences at a meeting of the women of the missionary societies of the Lubbock district Tuesday afternoon superintendent of young people called for Tuesday at Lubbock by noon at the church. An all-day meeting of the women of the district had Mrs. C. E. Jameson of Memphis, copile.

The morning session was devoted to talks by representatives from the various churches and the afternoon session was given over chiefly to talks by Miss Combs. She talked first on the work among the young people of the church and said that much of the lack of interest among the young people is due to a lack of interest in them among the adults of the church. She said that the older people of the church need to help the young people more.

Young People Changed "There are two reasons why I decided to work among the young people of the United States while I am in America," Miss Combs said. "One is that they are different from what the young people used to be—and I am glad of it. The other is that the present age of the church has failed to support the missionaries and I want to present the problem to the young people of the church."

Miss Combs is a missionary in a country district of China and she was in the heart of China for six years just previous to her present furlough. She told of some of the surprising changes she found in the United States upon her return.

There were many words which were new to her and many customs. "I had never heard of a flapper until I was returning to America. As I got on a boat at Japan, I was surprised at two American girls who were on the boat. They were typical flappers so I studied them and found them interesting, although I must admit I was shocked at first," she said.

While she is in China, she travels on a house-boat along the waterways of China, eats food with chop sticks and wears Chinese clothing. There are only two ways of traveling where she is located. One is by boat and the other is by walking. She is an evangelist among the Chinese people.

The Chinese call the Christian churches the Jesus-churches, according to Miss Combs.

She told of one Chinese girl whose father was wealthy and therefore had many wives. He had 25 children, lived in a house of 100 rooms and hired a separate tutor and nurse for each child. This girl received the best Chinese education available and decided to attend a mission school to learn English. She was determined not to become a Christian, but she finally accepted the Christian religion and is now a Christian worker among her friends. Her family had been Buddhists.

"The people of the world are looking for something that will satisfy them and it is up to the young people of America to give the message of other nations the same chance they have at Christianity," she concluded.
