## Texas Posses Hunt Slayer Of Sweetheart HEARING OF INDIAN MYSTERY BEGINS

### FIRST OKLAHOMA WITNESS CALLED BEFORE PROBERS

(By Associated Press.)  
**GUTHRIE, Okla., Jan. 7.**—The federal grand jury investigation of the Osage murder mystery opened today. Several minutes after the first witness questioned in connection with the death of a number of Indians had gone before the jury, court attaches admitted the inquiry, twice delayed, had actually started.

The identity of the opening witness was not revealed, but he was said to have been "important."

**GUTHRIE, Okla., Jan. 6.** (AP)—Marking time yesterday while the federal grand jury cleaned up on odds and ends of other matters, the placing of evidence in the Osage murder case before the jury will not start until today. Witnesses ordered to appear yesterday afternoon were dismissed until this morning by Judge John H. Cotterell.

Tuesday's developments brought forth two features, a threatened breach between federal and state officials and revelation at Tulsa of a suit by W. K. Hale, "King of the Osage Hills," and alleged director of the murder plot, to collect \$25,000 insurance on the life of Henry Roan, one of 17 persons mysteriously killed.

### MILLION OWED TO U. S. BY GERALD CHAPMAN

**NEW HAVEN, Conn., Jan. 7.** (AP)—Gerald Chapman, under sentence to be hanged March 3rd for murdering a policeman, owes the United States one million dollars. A judgment for that amount in favor of the government was handed down here yesterday by Federal Judge Edwin S. Thomas, in an action brought by Postmaster General New and John A. Danaher, Hartford, Conn., assistant United States attorney, while Chapman was standing trial in Hartford.

The order of judgment also includes interest on the million dollars at the rate of six per cent per annum from October 24, 1921, and the costs of the court.

He calmly told the men he had suffered a broken leg and wrist and asked them to call an ambulance.

### BONDSMEN QUIT WHITFILL CASE

**Man Held in Jail Here Loses Support Of Friends; Pro Law Violation Charge**  
Deserted by friends, and nothing to do now but await action at the hands of the grand jury that will convene here next Monday, with the probability that he will be called upon for a trial on a charge of manufacturing intoxicating liquors. This is the situation faced by J. W. (Shorty) Whitfill, who was granted bond in his preliminary hearing here recently on the above charge, but who has not yet been successful in negotiating these bonds pursuant to his release.

Arrested at Lockney. Whitfill, who was arrested at Lockney a week ago last Saturday following capture of a huge still at his farm home a few miles northeast of here, apparently is not worried over the situation in the least, and talks freely to officers regarding the matter. And, to make matters worse, the accused man not only has been refused bond in the last case, but his bondsmen who secured his release on four or five previous similar charges, have withdrawn the bonds and refused to renew them.

As she crumpled to the floor, the girl's mother rushed to her side and picked her up. Then the cowboy sent another bullet into the body and fled.

### Blizzard Which Sweeps Mountain States Extends To South Plains

The people of Lubbock and South Plains awoke Thursday morning to find the face of the earth covered with snow and sleet for the second time this season, and although temperatures have not reached the low mark this time that was recorded during the last spell, the snow and sleet was accompanied by a driving wind from the north, making weather conditions exceedingly disagreeable.

The spell, which is probably the outgrowth of blizzards that are sweeping Colorado and other northwestern states, broke last night shortly before midnight in a stinging wind, and the frozen precipitation began to fall just after midnight.

Except for the slippery streets, with the consequent danger of auto accidents, none of which had been reported to the police department at noon, very little inconvenience was experienced here. No damage is believed to have been caused to livestock.

### BIG BOOTLEGGER AIDED JUDGE TO GET JOB, CHARGE

**WASHINGTON, Jan. 7.** (AP)—Three affidavits involving questions related to prohibition enforcement have been filed with the Senate judiciary committee as a part of the effort to block confirmation of Harry B. Anderson as a federal judge for western Tennessee.

One of them, signed by R. B. Thompson, of Memphis, quotes Nelo Grandi, described in the affidavit as "the King of bootleggers" in Memphis, as stating that the appointment of Judge Anderson cost him \$10,000. It also is said that in this affidavit that Grandi acts as bondsmen in most liquor law violation cases in the Western Tennessee district court.

Another affidavit, signed by E. J. Herdel, until recently a deputy clerk in the federal court, charged that Judge Anderson had been too lenient in prohibition cases.

### SLAYING CHARGES FOLLOW FIGHT OVER RUM

**WACO, Jan. 7.** (AP)—Complaint was filed here today against Jordan King, negro charged with murder in connection with the killing near Tours of Bruce T. Whitte, young Waco man. Whitte was shot Tuesday night.

The negro, according to the county attorney, admitted firing the shot that resulted in Whitte's death.

Two white men, O. E. Tannehill, and Tony Uptmore, and Charley Melton, negro, are charged with violating the prohibition law, these complaints resulting from the affray that terminated with the killing of Whitte.

The negro, in his statement, said that he had intervened in an altercation between Uptmore and Tannehill, which resulted when the latter attempted to drive off without paying for whiskey he had bought from Uptmore. He declares he shot through the back of the car, the bullet entering the right side of Whitte's head, who, he said, was not involved in the dispute over the whiskey.

Paris Looks At Seine With Fear

PARIS, Jan. 7. (AP)—Official forecasts three hours ago regarding the water of the Seine, which are slowly but surely rising.

The authorities however, maintain that even at the worst there is no possibility of a disaster, since it will require a rise of nearly 20 feet to equal the 1910 flood mark and from six to twelve feet to reach that of 1924.

The principal sufferers thus far are the eastern suburbs, where thousands of homes have been invaded by flood waters.

Parisians are regarding with considerable apprehension the waters of the Seine, which are slowly but surely rising.

Officials say that the Seine will continue to swell until tomorrow, the Invalides railroad station was closed last night owing to the rising waters.

Traffic was suspended from Paris to Versailles, Rambouillet, Dreux, and Granville, while residents of the island of St. Denis abandoned their homes during the evening.

Hundreds of refugees are sheltered in Fort Vincennes. A rise of about 17 feet in the Seine was registered last night at Austerlitz Bridge.

Along the Old disaster has been brought to the valley, where the water is nearly a mile wide. At Guitte the

people are living in the upper stories of their homes and being rescued by means of boats. Solsons, on the Rhone, is cut off from railroad transportation. The lower quarters of the town have been evacuated. The Marne is way out of banks. Chateau Thierry is badly flooded.

In Belgium with the exception of the territory along the River Escaut, which has a tendency to rise still higher, the situation continues to improve.

Normal conditions are returning slowly. There has been much devastation.

## TECH CAGER CREW TAKING DAILY WORKOUTS AND SQUAD BEING CUT FOR FIRST SCHEDULED ENCOUNTER

The Tech college basketball crew, facing an exceptionally stiff schedule for first year squad, is being groomed for action on the court under Coach Grady Higginbotham by the regular daily routine workout in the college "mule barn" just southwest of the administration building, and even though the first scheduled contest is yet more than two weeks away, the squad is now bidding fair to deal some club misery.

Out of the approximately 90 men that answered the first call to practice about four weeks ago, there is now about forty men who take the daily grind. From this forty, Higginbotham Wednesday afternoon selected about fifteen to whom he will devote the greater portion of his time in the future.

**Athletes Being Hardened**  
The workouts to date have been largely confined to goal shooting, both near and far, and a series of leg hardening exercises. This form of practice, Higginbotham says, is profitable for more than one reason, the first of which is the hardening up process that is very essential to success on the court. Another reason cited by Higginbotham is the fact that the boys "get the feel" of the ball.

Several of the boys remarked Wednesday afternoon just before the slanting process that the quintet was going to be hard to make, for there are a few that not only have had previous experience in college basketball, but are already in condition by virtue of their performances on the football field.

**Only Few From Grid Crew**  
One feature of the cager crew that is of interest is the fact that only about five men who played football are taking training preparatory to entering the basketball arena, and another interesting thing noted was the fact that none of these boys have an absolutely ironclad cinch on the cager squad, for there are many, and the most of them are youngsters who have had very little actual experience, that will give somebody a merry chase for a place on the first string.

Basketball has been left largely in the hands of Coach Higginbotham who had charge of the backfield and offensive tactics of the football team, and he has rigged up a court in the "mule barn" that is almost ideal except that the arena is a little bit narrow. The court is about 25 feet wide, where the official regulations call for 36, but this is counterbalanced somewhat in the length, which is about as many feet over as the court is narrow in width. The building will accommodate several hundred fans with comfortable seats, and is steam heated.

## "Railroads Thwart Bill Of Congress In Charging More For Short Hauls And By Doing So Halt Water-Way Improvements"

WASHINGTON, Jan. 7. (AP)—By taking advantage of the law permitting higher rates for a shorter haul than for a long haul, the railroads are able to thwart the will of Congress for development of inland water transportation, Brigadier General Thomas H. Ashburn, in charge of the government's Mississippi river barge line, told the Senate Interstate Commerce commission today.

Testifying on the Gooding bill, which would prohibit such practices, General Ashburn said there might be a navigable stream on which water transportation lines had not been developed and that railroads paralleling that waterway could prevent development of water competition by making use of the right to impose a low rate on long hauls.

**Case Is Cited.**  
As an illustration of the rail carriers' efforts against the barge line, General Ashburn cited a case arising over cotton shipments from the Oklahoma fields to Gulf ports. Much of this cotton moves over the barge line to New Orleans through joint rate agreements between that line and railroads serving Oklahoma.

"Under the impulse of this threat," he added, "and in the hope of avoiding a foolish waste of revenue through a rate war, the railroads who joined with the barge lines in establishing these low rail and barge rates have been influenced to notify the barge line of their desire to cancel and withhold the joint rates which they have been operating for some months."

FILMS DIE WITH PLAYERS

Hollywood has discovered that the public will not patronize a motion picture when exhibited after the death of the star of the film and is puzzled thereby. The movie producers are unable to distinguish between the film of a dead star and the book of a dead author, or the play of a dead dramatist, or the composition of a deceased musician, and they point out, there are any number of cases where such works have only become popular after the death of their artist creator.

A bit of applied psychology would solve this movieland mystery. The key to the solution rests in the movement launched by certain producers some years ago to substitute "story appeal" for "player appeal" on the screen. Fans will recall the catch-phrase of that movement: "The play is the thing."

People are primarily interested in living being, and death soon divorces that interest. The average fan goes to the movie theater more to see a favorite actor or actress than with the expectation of seeing a good story pictured, or of seeing the latest work of some scenario writer or director. And this public interest in movie folk, being something akin to personal friendship, must inevitably vanish with the death of the star.

The question why interest in the moving picture does not survive its star is equivalent to asking why nobody would read Shakespeare's "Hamlet" if the character of Hamlet would be left out of this immortal tragedy.

SUPERSTITION

When Kepler, one of the greatest of astronomers needed money and instruments with which to study the stars he pretended belief in astrology and obtained both money and equipment from his emperor by "reading" in the heavens good fortune for Napoleon. With the money with which Napoleon endowed the pseudo-science astrology Kepler advanced the true science of astronomy.

This generation is less fortunate. The science of astronomy is not regarded by lack of funds, but the public is fleeced of vast sums annually by fake astrologists, palmists, phrenologists, and other so-called fortune tellers. Thousands of these mountebanks and impostors thrive on American gullibility, and they are even more numerous in other countries. It is significant that as the general intelligence increases the prestige of the fortune teller wanes until it finally disappears entirely.

Those who have faith in the sooth-sayings of fortune tellers usually believe in "signs," swear by the almanac and patronize the quack doctor. They live in constant dread of that "break" in the "life line" on the palm of the hand, plant their gardens by the signs of the zodiac, avoid black cats, throw spilled salt over the shoulder, never open an umbrella in the house, blame their hard luck on the mirror they remember or think they remember having broken years back.

A century or two ago superstition actuated the whole life of all humanity. Today a relatively small minority of mankind has cast out all superstition from its mind, but the great majority is still guided through life in greater or less degree by superstitious belief. When reason enters the human mind superstition must ever be crowded out.

The market eased off early in the morning mainly on realizing and evening up in advance of the holiday in the local market tomorrow. Mix-up Halts Probe Of Rubber Monopoly

WASHINGTON, Jan. 7. (AP)—The House committee investigation foreign monopolies in rubber and other raw materials interrupted itself to straighten out a mix-up over what happened at an executive session yesterday. Aroused over publication of a story in the Washington Post, which said Secretary Hoover had presented at the secret meeting certain communications between the state departments and foreign governments, the committee decided after some discussion to send a letter to Secretary Kellogg, denying that any such documents had been presented.

The Post article got attention because of its assertion that the communications showed how foreign governments had "laughed at" the state department for trying to protect American consumers. While the committee hearing was in progress Secretary Hoover's activities were assailed on the House floor by Representative Black, democrat, New York, as "propagandist" for the rubber interests.

"Here are the expanding tire companies," Mr. Black said, "citing the faithful British lion just when they are about to inflate prices. They want an alibi to gouge the public so they bark at the East Indian planters, whose Empire protects better than the Napoleonic sphinx of the White House, who campaigned on the back of a cow to protect our farmers."

"This last blast of Hoover's is propaganda plus. On the front page he attacks Great Britain and on the financial page the trade writes subliminal price. On the cover in the propaganda, on the inside are the works. The whole automobile trade expects higher prices, the tire companies intend to take from the consumer what they would otherwise save by tax reduction."

Mr. Black asserted the price of crude rubber has little to do with the increase in tire prices, except to furnish an excuse to our extortionists. "A tire that cost \$23 before restriction," he said, "and that had \$2 worth of rubber in it, costs now \$40, with \$5 worth of rubber in it." Our committee will cry "stop thief" at the British while our own business leaders do their pilfering undisturbed."

CLASHES FEATURE REPORT GIVEN TEXANS

(By Associated Press) FORT WORTH, Jan. 7. —A clash between state and national representatives of four matters of governmental policy are reflected in the report of the legislative committee sent to Washington in December at the instance of the unofficial session of the Texas legislature to protest the inheritance tax levy. The report has been sent to each member of the legislature.

The four policies favored by the congressmen and opposed by some Texas legislators are: Congressional regulation of the acts of state legislatures in raising state revenue for state purposes; using the taxing power of government to distribute wealth; passing of dollar matching appropriations by Congress without consulting state legislatures, and the raising by Congress of revenue from capital or property tax levies, such as the inheritance tax. The report declares the Texas congressmen stand for centralization of all governmental power in Washington, while the Texas legislators stand for local self-government and the rights of the several states to manage their own affairs.

Remedy is Recommended The committee, in its report, recommends as remedy for the evils they declare exist and seriously threaten the life of the nation, that the "citizens of Texas take a more active part in the government and oppose detroning state sovereignty and trespassing upon the rights of people; that the congressmen discontinue their encroachments upon the rights of the several states and find a way

### GALVESTON C. C. HEAD CHARGES FRAUD

#### TESTIMONY OF ASHBURN MISREPRESENTATION OF FACTS, SAID

(By Associated Press.)  
 GALVESTON, Jan. 7.—Misrepresentation of the facts in his testimony before the Senate interstate commerce commission yesterday by Brigadier General Thomas H. Ashburn in charge of the Federal Mississippi Barge Line, by E. H. Thornton, traffic manager of the Galveston Chamber of Commerce in a letter to Senator Earle R. Mayfield, a member of the committee, made public today.

Mr. Thornton in his letter stated that the Frisco and Rock Island lines several months ago without the knowledge or consent of any other Texas-Oklahoma port carriers, arbitrarily joined the barge line in establishing through joint rates on cotton from points in Oklahoma to New Orleans, via Memphis and the barge line which are as much as 15 cents per 100 pounds higher than the rates applying on the direct all-rail routes from the same Oklahoma points to Galveston and other Texas ports.

The distance from the Oklahoma points to Memphis is substantially the same via the rail lines from Oklahoma points in the rail rate in the Oklahoma to Texas is 17 1/2 cents per 100 pounds, whereas under the Frisco and Rock Island tariffs, cotton is transported from Oklahoma to Memphis thence transferred to barges and carried to New Orleans for 11 1/2 cents less, a considerably greater distance.

"All that we have asked the Santa Fe and Missouri Kansas and Texas to do," Thornton adds, "is to establish the same rate on cotton from points in Oklahoma to Houston and Galveston as contemporaneously applied for from points in Oklahoma and the Mississippi River barge line."

### AUTO OWNERS ARE URGED TO BUY NEW PLATES

The first warning in connection with the purchase of new auto license plates for 1926 has been issued from the offices of county sheriff H. L. Johnston and Chief of Police T. E. May, who have joined in an effort to see that auto owners of Lubbock county comply with the law in operation of automobiles.

The old plates were legally into the discard January 1, Chief May told the Daily Journal Thursday, but he explained that local officers had been instructed to not use this method until everyone has had an opportunity to make purchase of the new plates.

"We feel, however, that ample time has been granted, and we will now begin to use pressure of an auto owner does not willingly comply with the law in the very near future," the Chief said.

In connection with the purchase of the new plate, it has been explained time and again through newspapers, both local and otherwise, that a receipt, showing that the headlights of the car in question had been tested and met certain requirements laid down by the state highway department, must be presented to the tax collector with the application for the 1926 license plate. Highway department regulations also require that this testing station receipt must not be more than thirty days old when application for the new plate is made.

The tax collectors throughout the state have been instructed to not issue new plates unless auto owners meet this requirement. If you have not purchased your new plate, Mr. Auto Owner, it will be well to do so at once, for it is better to be safe than sorry.

### HUNGARIAN PLOT THREATENING THRONE

#### GOVERNMENT SAYS THERE IS ATTEMPT TO PLACE KING IN CHARGE

(By Associated Press.)  
 BUDAPEST, Jan. 7.—A report that there is a plot to restore the throne of Hungary is in circulation. On the one side it is asserted that the Fascists purpose to endeavor to give the crown to Arch-Duke Albert, while the legitimists are supporting Prince Otto, son of the late King Charles.

The latter report had its origin in Vienna, where a newspaper asserted that a leader of the Hungarian Fascist, Julius Gombos, was some fifty miles southeast of Budapest gathering men for a march on the capital within two or three days. It was added that a Count Bethlin, the Hungarian premier, was conferring with leading legitimists for the purpose of devising means to put down a Fascist attack and elevate Otto to the throne.

### Counterfeiting Plot Bared

Closely connected with the talk of the reestablishment of the monarchy is the thirty million franc case. The socialist charge that the Fascists are at the bottom of the counterfeiting plot and that the money obtained thru the putting of spurious French notes in circulation was to be used in financing Albrecht's ambition.

Since Admiral Horthy, as regent, delivered up Emperor Charles to the powers, who banished him to Madeira, where he died, Premier Bethlin has been wrathful against the regent.

Police Are Ready  
 VIENNA, Jan. 7. (AP)—The streets of Budapest are bristling with armed police, seemingly in expectation of disorders, say reports from the Hungarian capital. The Wiener Tagblatt correspondent reports that the administration of every public building even remotely involved in the great franc counterfeiting plot appears to have passed overnight from civil to military hands without notice.

### Passes Are Demanded

French police agents in Budapest in connection with the investigation complain that they are delayed in the searches by the demands of the military for special passes.

The state attorney is said to have announced that he will sequester the property of all persons implicated in the counterfeiting including the castle of the Prince Ludwig Windisch-Graetz. Budapest officials are exploring miles of passageways and poking into all the corners of the vast rambling castle situated at Sarros Patak.

Various stories are in circulation, one that the spurious notes were printed in Germany during the war with the object of depreciating French currency and that they were turned over to Hungarian Fascist by a kindred organization in Germany. It appears to have been established that beyond the exchange of the false bills in Budapest no attempt was made to circulate them other than in Holland where the first arrests were made.

### Federal Authorities Pooh-Pooh Statement Of W. Wilson Awards

BERLIN, Jan. 7. (AP)—Government circles today dismissed as unfounded reports from America that Foreign Minister Stresemann declined the Woodrow Wilson foundation award for 1925 because he did not desire to accept honors connected with the name of the late American President.

It was pointed out that one condition for acceptance is the presence of the recipient in New York City on Mr. Wilson's birthday and that because of the political situation it was impossible for Dr. Stresemann to make the trip.

The Lokal Anzeiger assumes that similar reasons prompted the declinations by Sir Austen Chamberlain, British foreign secretary, and Premier Briand, of France. The Berliner Tageblatt expresses appreciation of the good will underlying the action of the awarding committee in selecting Dr. Stresemann.

### Vesuvius Puts Out Lava And Rumbling

NAPLES, Jan. 7. (AP)—Vesuvius is rumbling and emitting smoke and lava, but in small quantities. The phenomenon last nighted large crowds of foreigners, who watched the glow from the crater as it enveloped the snow clad mountain. The present eruption is only one of the ordinary outbreaks of the volcano.

**Valued Painting Sought By Many Southern Cities**  
**SAN ANTONIO, Texas, Jan. 7.**—Lovers of art in Houston, Fort Worth, Dallas, St. Louis and San Antonio are attempting to bring to their respective cities the late J. F. McCan's \$50,000 painting of an eagle, "The Monarch of the Golden West."  
 San Antonio has been virtually eliminated from the contest because in two months only 8,340 persons visited an art shop here to see the painting. The stipulated number of visitors was 20,000.  
 There is one avenue to keeping the work here, according to C. D. Saunders, art dealer, and Claude McCan's son of the artist, but it is a small chance. It is that the rest of the McCan collection, 12 paintings, be bought by San Antonians at prices ranging from \$125 to \$1,200.  
 Because the artist's son considers this city typical of the old Southwest, he prefers to have the masterpiece stay here. His father loved the Southwest and painted many pictures of the hill country around Comfort, Boerne and outward to Austin. Sketches of the Guadalupe and Medina rivers and scenes in the hills are among the unsold pictures.  
 Outstanding among the offers for the "Monarch of the Golden West" that of Enrico Cerrachio, Houston sculptor, who proposes building an additional wing to Houston's municipal art museum and calling it the McCan Memorial. Cerrachio told McCan he made the proposal for the city.  
 Most of the McCan paintings sold were bought by persons from other Texas cities, including Corpus Christi and Dilley, Saunders said.

**Hart Asks That His Corpse Be Cremated**  
**WASHINGTON, Jan. 7.**—The will of Major General William H. Hart, quartermaster general of the army, who died here last week, asks that his body be cremated and the ashes cast into the ocean "at any convenient place."
